## EU Turkey Agreement

### **Editor's Note:**

### Europe is imprisoning refugee children

Greece

Norwegian Refugee Council

*"It is outrageous that young and innocent children fleeing war are kept imprisoned behind barbed wire in overcrowded detention facilities on European soil", said Secretary General of the Norwegian Refugee Council Jan Egeland.*

Refugees and migrants arriving on the Greek islands after the EU-Turkey deal came into effect on 20 March are being sent to closed camps – while awaiting a chance to seek asylum or face being returned to Turkey. Some of the men, women and children on the Greek islands have now been kept in detention for up to two weeks.

"The camps in Greece need to be opened immediately. There are no justifications for keeping asylum seekers in Greece in closed facilities and the situation inside the camps is deteriorating rapidly, putting people in danger", said Egeland.

"The way the EU-Turkey deal is being implemented at the moment is a disgrace to Europe", he added. "We would never have accepted this for our own children – and we cannot accept it for others."

NRC and other humanitarian organizations have suspended some activities at the registration center at Chios after it was turned into a detention facility.

"We cannot support the running of enforced detention facilities, but we are ready to assist if the authorities agree to open the camps", said Egeland.

According to the plan, Greece may start returning people to Turkey as early as Monday 4 April, despite concerns that many of those arriving have not had their legal rights explained to them, nor had a chance to receive a fair asylum hearing.

"Europe gave birth to the Refugee Convention when our own forefathers were displaced by war. Now Europe risks becoming the same convention's burial agent. No people should be returned to Turkey before necessary safeguards are in place – and all people who seek asylum in Greece must be secured a fair, individual process, said Egeland.

The agreement with Turkey, aimed at discouraging people from crossing the Mediterranean from Turkey to Greece, may end up putting refugees and migrants at increased risk, argues NRC.

"As long as we are not solving the real problems, the wars in Syria, Iraq and Afghanistan and the desperate situation for refugees in neighbouring countries, people will continue to flee to Europe for protection. We fear people will seek other and more dangerous routes, like going from Libya to Italy or across the Black Sea", said Egeland.

### **UNICEF urges full hearings for refugee and migrant children stranded in Greece**

GENEVA, 6 April 2016 - With the process of returning refugees and migrants from the Greek islands to Turkey underway as part of the EU-Turkey agreement, UNICEF reminds States of their duty to care and protect all children and give them a full and fair hearing when deciding on their future.

UNICEF welcomes a new Greek law, which came into force on 4 April, exempting certain vulnerable groups, including unaccompanied and separated children, children with disabilities, victims of distress and trauma, pregnant women and women who recently gave birth, from "exceptional border procedures" or returns. However more needs to be done.

Currently more than 22,000 refugee and migrant children are stranded in Greece, facing an uncertain future and even forms of detention since the agreement went into effect last month.

UNICEF calls for a well-managed process to be put in place to determine each child's best interests and fulfill the basic needs of all children – including adequate accommodation, health care and protection against trafficking and exploitation in line with international and European laws.

Children have specific grounds to claim international protection; such as if faced with the threat of recruitment to armed forces or forced marriage. The European Commission has stipulated that returns will be in accordance with international and European law.

"Any decision about any child, whether a toddler or a teenager, whether with family or not, should be guided by the best interests of that child," said Marie-Pierre Poirier, Special Coordinator for the Refugee and Migrant Crisis in Europe.

"Children need to be heard. A rushed decision to return can lead to a rash result and going back to a place of fear and violence. Children, no matter where they come from, must have access to basic services at all times," she added.

Capacity to care and support for unaccompanied and separated children has been overstretched in Greece. With nowhere to house them, many are taken into temporary "protective custody", or de facto detention within closed first reception or police facilities, for increasingly extended periods.

"UNICEF is concerned about reports that some children are being detained due to their migration status. Escaping war and seeking survival is never a crime," said Poirier.

Unaccompanied and separated children, are among the most vulnerable and make up about 10 percent of all refugee and migrant children in Greece, or some 2,000, but not all are registered.

Between January and mid-March 2016, 1,156 unaccompanied and separated children had been registered in Greece (an increase of over 300 per cent in the rate of registration compared to the same period in 2015).

The first returns to Turkey from the Greek islands were monitored this week by UNICEF's partners, in Dikili port, Izmir province. UNICEF will continue to work closely with Turkish Government authorities to provide humanitarian assistance. Turkey currently hosts over 2.7 million Syrian refugees.

UNICEF has been helping Syrian refugee children and families since 2012. Last year UNICEF, working with government and civil society partners, provided support to over 400,000 Syrian children with education, protection and basic services.

### **Increasing Economic Growth in Fragile States Can Help Prevent Future Refugee Crises—World Bank President**

BERLIN, April 5, 2016—World Bank Group President Jim Yong Kim today said that the world's powers need to pay far greater attention to boosting developing economies and creating jobs in the most fragile countries in order to give more opportunity to people in those nations and to prevent future refugee crises.

Speaking at the German Institute for Economic Research, Kim noted that boosting inclusive economic growth and reducing extreme poverty was critical to helping avoid an even greater refugee crisis in the coming years. Citing World Bank projections that extreme poverty globally would only fall to 6 percent by 2030 if economic growth mirrors the average growth rate of the last decade, Kim said that would mean that in the most fragile states, the poverty rate would remain extraordinarily high, at 47 percent of the population.

"All of Europe and all of Germany are rightly focused on the refugee crisis on the continent today, but if fragile states still have 47 percent of their people living on less than 2 euros a day by 2030, while the developed world prospers, the flow of migrants and refugees will not stop," said Kim.

Kim stated that how the World Bank Group engages in the fight against poverty will need to change, and that global issues such as forced displacement carry important implications for how the World Bank will operate going forward.

"For instance, our Board – in a groundbreaking decision just last month – offered Jordan, a middle-income country, rates that we had reserved for the poorest countries, because of their enormous generosity in hosting more than 1 million Syrian refugees," Kim stated. "We have provided an initial \$100 million loan at concessional rates normally reserved for only the poorest countries and will provide an additional \$200-400 million dollars in concessional financing to build a special economic enterprise zone, which will help create many thousands of jobs for both Syrian refugees and Jordanians over the next five years. This is a truly novel effort that must now be taken to scale and implemented in other countries as well."...

### **World Bank Group Unveils New Climate Action Plan**

*Plan to Help Countries Meet Paris COP21 Pledges*

WASHINGTON, April 7, 2016—The World Bank Group today announced plans to help developing countries add 30 gigawatts of renewable energy – enough to power 150 million homes – to the world's energy capacity, bring early warning systems to 100 million people and develop climate-smart agriculture investment plans for at least 40 countries – all by 2020.

These are among a number of ambitious targets laid out in the World Bank Group's new *Climate Change Action Plan*, approved today, which aims to accelerate efforts to tackle climate change over the next five years and help developing countries deliver on their national climate plans submitted for the historic climate agreement reached at COP21 in Paris in December last year.

The release of the Climate Change Action Plan comes just two weeks before world leaders officially sign the Paris Agreement in New York. As part of the Paris process, 140 countries working with the Bank Group lodged national climate plans, known as Nationally Determined Contributions, or NDCs.

"Following the Paris climate agreement, we must now take bold action to protect our planet for future generations," said World Bank Group President Jim Yong Kim. "We are moving urgently to help countries make major transitions to increase sources of renewable energy, decrease high-carbon energy sources, develop green transport systems, and build sustainable, livable cities for growing urban populations. Developing countries want our help to implement their national climate plans, and we'll do all we can to help them."

To maximize impact, the Action Plan is focused on helping countries shape national policies and leverage private sector investment. IFC, a member of the World Bank Group, aims to expand its climate investments from the current \$2.2 billion a year to a goal of \$3.5 billion a year, and lead on leveraging an additional \$13 billion a year in private sector financing by 2020. As well its own financing, the World Bank also intends to mobilize \$25 billion in commercial financing for clean energy over the next five years. The Bank Group will also continue to deepen its work to help countries to put a price on carbon pollution to create incentives for public and private sector decision makers to make the right climate choices...

### *Executive summary*

The CPMI-World Bank Group Task Force on the Payment Aspects of Financial Inclusion (PAFI) started its work in April 2014. The Task Force was mandated to examine demand and supply side factors affecting financial inclusion in the context of payment systems and services, and to suggest measures that could be taken to address these issues.

This report is premised on two key points: (i) efficient, accessible and safe retail payment systems and services are critical for greater financial inclusion; and (ii) a transaction account is an essential financial service in its own right and can also serve as a gateway to other financial services. For the purposes of this report, transaction accounts are defined as accounts (including e-money/prepaid accounts) held with banks or other authorised and/or regulated payment service providers (PSPs), which can be used to make and receive payments and to store value.

The report is structured into five chapters. The first chapter provides an introduction and general overview, including a description of the PAFI Task Force and its mandate, a brief discussion of transaction accounts, and the barriers to the access and usage of such accounts. The second chapter gives an overview of the retail payments landscape from a financial inclusion perspective. The third chapter forms the core analytical portion of the report and outlines a framework for enabling access and usage of payment services by the financially excluded. Each component of this framework is discussed in detail in the report.

The fourth chapter of the report describes the key policy objectives when looking at financial inclusion from a payments perspective, and formulates a number of suggestions in the form of guiding principles and key actions for consideration.

In this context, financial inclusion efforts undertaken from a payments angle should be aimed at achieving a number of objectives. Ideally, all individuals and businesses – in particular, micro-sized and small businesses - which are more likely to lack some of the basic financial services or be financially excluded than larger businesses – should be able to have access to and use at least one transaction account operated by a regulated payment service provider:

- (i) to perform most, if not all, of their payment needs;
- (ii) to safely store some value; and
- (iii) to serve as a gateway to other financial services.

The guiding principles for achieving these objectives of improved access to and usage of transaction accounts are the following:

- :: Commitment from public and private sector organisations to broaden financial inclusion is explicit, strong and sustained over time.

- :: The legal and regulatory framework underpins financial inclusion by effectively addressing all relevant risks and by protecting consumers, while at the same time fostering innovation and competition.

- :: Robust, safe, efficient and widely reachable financial and ICT infrastructures are effective for the provision of transaction accounts services, and also support the provision of broader financial services.

:: The transaction account and payment product offerings effectively meet a broad range of transaction needs of the target population, at little or no cost.

:: The usefulness of transaction accounts is augmented with a broad network of access points that also achieves wide geographical coverage, and by offering a variety of interoperable access channels.

:: Individuals gain knowledge, through awareness and financial literacy efforts, of the benefits of adopting transaction accounts, how to use those accounts effectively for payment and store-of-value purposes, and how to access other financial services.

:: Large-volume and recurrent payment streams, including remittances, are leveraged to advance financial inclusion objectives, namely by increasing the number of transaction accounts and stimulating the frequent usage of these accounts.

Finally, the fifth chapter of the report addresses a number of issues in connection with measuring the effectiveness of financial inclusion efforts in the context of payments and payment services, with a particular emphasis on transaction account adoption and usage.

#### [Seven essential guiding principles to boost financial inclusion laid out in new report](#)

...A transaction account is an essential financial service that can serve as a gateway to other financial services such as savings, credit and insurance. However, nearly 40% of the world's adult population – about 2 billion people – still have no account with a bank or authorised non-bank servicer provider.

In addition to outlining principles to help countries advance financial inclusion, the report suggests possible key actions, including providing basic accounts at little or no cost, stepping up efforts to increase financial literacy, and leveraging large-volume payment programmes, such as government payments, by adopting electronic payment services. Financial inclusion efforts are beneficial not only for those who will become financially included, but also for the national payments infrastructure and, ultimately, the economy.

The CPMI and the World Bank Group believe that the guidance developed in this report will be essential to helping central banks and other stakeholders achieve effective financial access and broader financial inclusion. Given that safe, efficient and accessible retail payment systems and services are critical for greater financial inclusion, the report will be instrumental in supporting the goal of achieving Universal Financial Access by 2020.

#### [G20 Leaders Launch Global Partnership and Website to Help Advance Inclusive Business](#)

Nanjing, China, April 6, 2016—The G20 officially launched the Global Platform on Inclusive Business (GPIB) today in Nanjing, China. The Platform is a global partnership that will provide support to policymakers and accelerate the adoption of inclusive business policies and programs globally.

The GPIB is being implemented under the [Chinese 2016 G20 Presidency](#). The creation of the Platform was called for in the [Leaders Call on Inclusive Business](#) issued at the G20 Leaders Summit in November 2015 in Ankara, Turkey. During the Summit, leaders also endorsed the



G20 Inclusive Business Framework. The GPIB will connect policymakers and businesses to better understand the role that governments can play in supporting inclusive companies more effectively.

"The Chinese G20 Presidency is happy to announce the launch of the Global Platform on Inclusive Business", said Zhang Shaogang, Chair of the DWG meeting. "GPIB seeks to connect policy-makers and businesses. It is both pro-poor and pro-business and strives to better understand the role of governments in supporting inclusive business."

Inclusive businesses provide low-income men and women with goods, services, and improved livelihoods by including them in their core business model. Inclusive businesses – by working directly with low-income people – have the potential to be a driving force for inclusion and sustainability. These are companies that extend last-mile water, power, and mobile phone service to customers in rural areas. They train and create markets for small farmers. They treat low-income patients and teach low-income students.

However, companies struggle with challenging operating environments and gaps in the institutional, informational, and infrastructural conditions that are required to make inclusive markets work. These issues prevent companies from reaching the 4.5 billion people who are considered to be living at the base of the economic pyramid.

### **Haiti: Launch of the Humanitarian Response Plan 2016: The Government of Haiti and the humanitarian community seek \$193.8 million to meet the critical needs of 1.3 million people**

Port-au-Prince, April 7, 2016. The Government of Haiti and the Humanitarian Country Team launch today a call for funds of \$ 193.8 million people to meet the critical humanitarian needs of 1.3 million people. This humanitarian planning document aims at ensuring protection and access to basic services to the most vulnerable people, and also strengthening the resilience of the population and the Haitian institutions.

Indeed, 2015 was marked by a deterioration of the humanitarian situation in the country due to multiple factors, including the persistence of cholera, the deterioration of the food insecurity context and the binational mixed migration issue with the Dominican Republic. The high vulnerability to natural disasters and the ongoing presence of about 62,000 people displaced from the 2010 earthquake in 36 camps, have also contributed to worsen this context.

"We appreciate this effort to put together priorities and coordinate the response between national authorities and members of the humanitarian community. The plight of thousands affected by these multiple factors, especially by food insecurity, requires a rapid and effective response to prevent the deterioration of the humanitarian context in a moment where we are laying the foundations of a sustainable development of the country "said Aviol Fleurant, Minister of Planification and External Cooperation.



The ultimate goal of the plan is to reduce the vulnerability of 1.3 million targeted people. Although the priority concerns the most basic humanitarian needs, the plan also anticipates the implementation of structural measures to reduce the vulnerability of the population in need, as well as to advance towards the 2030 Agenda for Sustainable Development and the Sustainable Development Goals (SDGs).

"Structural problems associated with multiple emergencies continue to increase the vulnerability of millions of Haitians. We must act together to allow them to recover, said Mourad Wahba, Humanitarian Coordinator and Deputy Special Representative of the UN Secretary General in Haiti.

To achieve this objective, the [2016 Humanitarian Response Plan](#) identifies a number of humanitarian needs that must be addressed. Thus, it aims to address the severe food insecurity that affects more than 1 million (U\$ 105.5 million in needs expressed) and to ensure the protection and basic services to more than 120,000 deportees / returnees from the Dominican Republic (U\$ 21.2 million) and to 62,000 IDPs living in post-earthquake camps (U\$ 38.2 million). Moreover, the plan envisages providing a rapid and effective response to cholera epidemics and to counteract the vulnerability to cholera in high-risk areas (U\$ 20 million). Lastly, funds will be mobilized to support the preparation for natural disasters (U\$ 4.1 million) and strengthen the humanitarian coordination (2.9 millions). As part of this response, 100,000 people amongst the 500,000 that may be affected by natural disasters in 2016 are also targeted.

In a global context with increasingly large humanitarian crises, funding for humanitarian aid in Haiti risks to diminish. Hence, the humanitarian community calls for the strengthening of the commitment of partners. "We urge Haiti's partners to have a sustained commitment to the country. This deepened commitment will help to enhance the resilience of vulnerable communities and to maintain the progress achieved in the recent years. In addition, it will help to initiate a sustainable exit from the multiple humanitarian challenges while continuing the process of sustainable development for the country", concluded Mr. Wahba.

### **Key Nuclear Security Agreement to Enter Into Force on 8 May**

A nuclear security agreement that will take effect on 8 May will reduce the risk of a terrorist attack on a nuclear power plant and make it harder to smuggle nuclear material.

The entry into force of the Amendment to the Convention on the Physical Protection of Nuclear Material (CPPNM) was secured today with the deposit of the instrument of ratification by Nicaragua, which brought the number of adherences to 102 States Parties to the CPPNM, the threshold required for the agreement to come into effect in 30 days. The Amendment, adopted more than a decade ago, will make it legally binding on countries to protect nuclear facilities. It will also extend the CPPNM's application to nuclear material in domestic use, storage and transport.

"This is an important day for efforts to strengthen nuclear security around the world," said IAEA Director General Yukiya Amano in a [statement](#). The Amendment "will help reduce the risk of a terrorist attack involving nuclear material, which could have catastrophic consequences."

The CPPNM, the only legally binding international undertaking in the area of physical protection of nuclear material, entered into force in 1987. It focuses on the physical protection of nuclear material used for peaceful purposes during international transport, but does not cover the protection of nuclear facilities or nuclear material in domestic use, storage and transport. In July 2005, the Parties to the CPPNM adopted the Amendment. The adherence of two-thirds of the States Parties to the CPPNM was required for entry into force of the Amendment. Currently, there are 152 State Parties to the Convention.

"The entry into force of the Amendment demonstrates the determination of the international community to act together to strengthen nuclear security globally," Mr Amano said. He urged States Parties that have not yet done so to adhere to the Amendment.

#### *What States have to do under the Amendment*

The Amendment makes it legally binding for States to establish, implement and maintain an appropriate physical protection regime applicable to nuclear material and nuclear facilities under their jurisdiction. It provides for the criminalization of new and extended specified acts, and requires countries to put in place measures to protect nuclear material and nuclear facilities against sabotage.

The Amendment expands the existing offences identified in the CPPNM, including the theft and robbery of nuclear material, and establishes new ones, such as the smuggling of nuclear material and the actual or threatened sabotage of nuclear facilities. A number of the offences were also expanded to include substantial damage to the environment.

GENEVA (8 April 2016) –Tunisia's efforts to establish a functioning independent body to monitor places of detention will be the focus of the first visit to the country by the United Nations Subcommittee on Prevention of Torture (SPT) from 12 to 14 April.

Tunisia ratified the Optional Protocol to the Convention against Torture in June 2011 and, as part of its treaty obligations, has to set up such a monitoring body, officially known as a National Preventive Mechanism (NPM). Tunisia passed legislation in 2013 to establish the body and its 16 members were appointed in March this year.

"Tunisia is the first country in the region to establish, albeit with some delay, a national preventive mechanism. We see this as a hugely positive step and look forward to advising the Government, as well as other stakeholders, on the next steps to ensure the body is swiftly able to function effectively," said Hans-Jörg Bannwart, who will head the three-member SPT delegation. "We are especially looking forward to meeting the newly elected members of the NPM in order to discuss with them the challenges they will face in setting up and starting work," he added.

### **UN human rights expert to assess freedom of expression situation in Japan**

GENEVA (8 April 2016) – United Nations Special Rapporteur expert David Kaye will carry out his first visit to Japan, from 12 to 19 April 2016, to assess the situation of the right to freedom of opinion and expression in the country.

"I look forward to visiting Japan and learning at first-hand about its norms and policies in the area of freedom of expression as well as the main challenges faced in the country today," said the independent expert designated by the UN Human Rights Council to monitor and report on violations of the right to freedom of opinion and expression.

"The independence and the freedom of the Japanese media, the space for protesting and the access of the public to information held by the State are among the issues I will study during my stay in Japan," he noted.

### **What is permissible and what is not when countering terrorism? UN experts welcome new African guidelines**

GENEVA (7 April 2016) – A group of eighteen United Nations independent experts\* has welcomed the new Principles and Guidelines on Human Rights while Countering Terrorism in Africa launched this year by the African Commission on Human and Peoples' Rights (ACHPR). Speaking ahead of an upcoming ACHPR's panel discussion in Banjul, The Gambia (11 April), in which Member States will be briefed on the new Principles and Guidelines, the UN experts called on all African governments to fully implement the Commission's recommendations in order to respect human rights in the context of fighting terrorism.

In the framework of open access, a conference on the open access movement and the future of Africa's knowledge economy took place in Dakar at the Council for the Development of Social Science Research in Africa (CODESRIA) from 30 March to April 1, 2016. During this conference Senegal played a key role.

Aware of the lack of open access policies in African countries and the challenge of access to scientific and educational information on the Continent, the Ministry of Posts and Telecommunications of Senegal, in consultation with all national stakeholders concerned and with the technical support of UNESCO, has decided to begin the process to ensure the establishment of a national open access policy. The result of this policy will encourage the creation of open platforms free and accessible for all researchers, innovators, teachers, students, media professionals and the public and will encourage collaboration, production, dissemination, and knowledge economies.

Senegal will be the first African country to establish an open access policy, which represents an important lever for accelerated development in the country and positions Senegal as a leader in this domain.

**Statement of the Prosecutor of the International Criminal Court, Fatou Bensouda, regarding Trial Chamber's decision to vacate charges against Messrs William Samoei Ruto and Joshua Arap Sang without prejudice to their prosecution in the future**

*[2007-2008 election violence in Kenya]*

...The Chamber declined to acquit the accused due to the special circumstances of this case. In so doing, the Chamber endorsed the Prosecution's position that this case has been severely undermined by witness interference and politicisation of the judicial process. The decision further noted that other evidence may have been available to the Prosecution "had it been able to prosecute the case in a different climate, less hostile to the Prosecution, its witnesses and the Court in general."



The Chamber made it clear that their decision is without prejudice to the presumption of innocence or the Prosecution bringing the case on the basis of the same charges in the future, or in a different form, in light of new evidence.

We regret that due to deliberate and concerted efforts to derail this case through witness interference, the Judges have been prevented from determining the guilt or innocence of the Accused on the full merits of the case. What is also troubling is that the onslaught against this case has – for now – denied the victims of the 2007-2008 election violence in Kenya the justice they so rightly deserve....

:: Striking the right balance between traditional and innovative approaches to conservation is a process that requires experimentation and course corrections.

:: Donor partnerships and coordinated grantmaking around common objectives can enhance collective impact. Working in a donor collaborative helped us to establish a common, and sometimes more sophisticated, understanding of the threats and opportunities in a region.

:: A universal theory of change is most useful for developing and communicating a grantmaking strategy; it is less helpful to guide grantmaking in a given problem and geographic context. The product of a global theory of change may be too broad, and too simplistic, to usefully guide regional grantmaking, where opportunities, threats, and players shift quickly.

:: When investing in science, good planning will determine the conservation payoff. Scientific analysis and communication are valuable, but insufficient means to ensure effective environmental conservation.

:: Defining an appropriate grantmaking niche is critical to success.

***Abstract***

During the recent outbreak of Ebola virus disease (EVD) in west Africa, we established an Ebola treatment center (ETC) with improved ward architecture. The ETC was built with movable prefabricated boards according to infectious disease unit standard requirements. The clinical staff ensured their own security while providing patients with effective treatment. Of the 180 admissions to the ETC, 10 cases were confirmed with EVD of which six patients survived. None of the clinical staff was infected. We hope that our experience will enable others to avoid unnecessary risks while delivering EVD care.

***Abstract***

Immigrants may be carriers of infectious diseases because of the prevalence of these diseases in their country of origin, exposure during migration, or conditions during resettlement, with this prevalence being particularly high in sub-Saharan Africans. We performed a retrospective review of 180 sub-Saharan immigrants screened for infectious diseases at an International

Health Center from January 2009 to December 2012. At least one pathogenic infectious disease was diagnosed in 72.8% patients: 60.6% latent tuberculosis infection, 36.8% intestinal parasites (intestinal protozoa or helminths), 28.1% helminths, 14.8% hepatitis B surface antigen positive, 1.2% anti-hepatitis C virus positive, 1.2% human immunodeficiency virus-positive, and 1.2% malaria. Coinfections were present in 28.4%. There was significant association between eosinophilia (absolute count or percentage) or hyper-IgE and the presence of helminths ( $P < 0.001$ ). Relative eosinophilia and hyper-IgE were better indicators of helminth infection than absolute eosinophilia, particularly for schistosomiasis and strongyloidiasis. We found a high prevalence of infectious diseases in sub-Saharan immigrants, which could lead to severe health problems (in the absence of prompt treatment), representing a high cost to the public health system and possible transmission in the host country. Accurate screening and tailored protocols for infectious diseases are recommended in sub-Saharan immigrants.

#### ***Abstract***

The 2014–2015 Ebola epidemic has been the most protracted and devastating in the history of the disease. To prevent future outbreaks on this scale, it is imperative to understand the reasons that led to eventual disease control. Here, we evaluated the shifts of Ebola dynamics at national and local scales during the epidemic in Liberia. We used a transmission model calibrated to epidemiological data between June 9 and December 31, 2014, to estimate the extent of community and hospital transmission. We found that despite varied local epidemic patterns, community transmission was reduced by 40–80% in all the counties analyzed. Our model suggests that the tapering of the epidemic was achieved through reductions in community transmission, rather than accumulation of immune individuals through asymptomatic infection and unreported cases. Although the times at which this transmission reduction occurred in the majority of the Liberian counties started before any large expansion in hospital capacity and the distribution of home protection kits, it remains difficult to associate the presence of interventions with reductions in Ebola incidence.

*Abstract*

Pearl millet is a major cereal in the arid and semi-arid regions of Asia and Africa. It is primarily cultivated for grain production, but its stover is also valued as dry fodder. Pearl millet is resilient to climate change due to its inherent adaptability to drought and high temperatures. It is also tolerant of saline and acid soils, and is well adapted to marginal lands with low productivity. Pearl millet germplasm exhibits large genetic variability for yield components; and various agronomic, adaptation and nutritional traits. Open pollinated varieties and hybrids are two important cultivar options, but higher productivity is realized through hybrids. Pearl millet has fewer pest and disease problems compared to other cereals and is suited to different cropping

systems. It is highly responsive to improved crop management practices, as witnessed in parts of India where it is grown as an irrigated summer crop that produces higher yields and better quality grain. Pearl millet has high nutritional value in terms of high levels of energy, dietary fibre, proteins with a balanced amino acid profile, many essential minerals, some vitamins, and antioxidants. These play a significant role in prevention of important human ailments such as diabetes, cancer, cardiovascular and neurodegenerative diseases. There is great potential for harnessing these positive attributes through genetic improvement, improved crop management, and grain processing and food products technologies. These should help to develop greater global awareness of the importance of this crop for food and nutritional security.

#### **[A review of postharvest handling and losses in the fresh tomato supply chain: a focus on Sub-Saharan Africa](#)**

#### *Abstract*

The mitigation of postharvest losses in the Sub-Saharan Africa (SSA) tomato industry has the potential to improve profit margins, livelihoods and food security. This review focuses on the current status of postharvest handling of tomatoes in SSA. Recent peer-reviewed, industry, government and non-governmental organisations' documents were consulted. Descriptive and quantitative approaches were used to present the information from the literature. Postharvest losses in the fresh tomato supply chain in SSA occur predominantly at the pre-consumer level, in contrast to similar supply chains in developed countries. Overall, recent estimations of losses in fresh market tomatoes were similar across SSA; 9.5 % in East Africa, 9.8 % in Central and Southern Africa, and 10.04 % in West Africa. Examples of individual countries showed estimated losses of 10.1 % in Kenya, 10.2 % in South Africa and 13.4 % in Nigeria representing multi-million dollar losses from these supply chains. Inadequate monitoring and quantifying of losses was noted in SSA. This document identifies postharvest challenges and presents possible interventions and opportunities for both large and small-scale producers. Overall, the implementation of any solutions in the SSA tomato supply chains will have to account for the specific contexts of each chain and level of production.

#### **[An assessment by subsistence farmers of the risks to food security attributable to climate change in Makwanpur, Nepal](#)**

#### *Abstract*

The potential impacts of climate change on the food security of subsistence farmers is a serious concern. This article explores the food security situations of two categories of subsistence farm households, vegetable- and cereal-based farming systems, in the Makwanpur district of Nepal in the context of climate change. Local climate data for the past 30 years were analyzed. Interviews with local farmers and key informants, and focus group discussions were carried out to collect the primary data. Empirical data showed that changes in climate variables for the study period were in line with farmers' perceptions and that farming communities were negatively impacted. Perceived impacts were erratic rainfall, increased frequency of floods and droughts, soil degradation and insect pests, weeds and diseases. Farmers have modified traditional cropping patterns and calendar, changed crop varieties and increased fertilizer and pesticide applications in order to maintain crop yields. They have also sought off-farm employment. However, agricultural productivity in the area is declining and only one third of all

households in the area were food secure. Household food insecurity was at mild to moderate levels, but vegetable-based households were more secure than cereal-based ones. At the household level, locally successful adaptive measures, such as rainwater harvesting, mulching, planting date adjustments, off-farm opportunities, including infrastructure and extension support, could increase production and contribute to reversing the impact of increased risk attributed to climate change.

**Improved food quality, quantity and security among Kenyan orphans and vulnerable children: associations with participation in a multisectoral community-based program, age, gender, and sexual risk**

*Abstract*

The present study evaluates factors associated with improved food quantity, quality and diversity among participants in a 3-year multisectoral program targeting sibling families of orphans and vulnerable children in rural Kenya. This cross-sectional study evaluates food adequacy and diversity using the World Food Programme's Food Consumption Score, food access over the previous year, and food dependence on outside-household resources among 1060 families of orphan or vulnerable siblings. The primary comparison group was program-enrolled households who had not yet received any program inputs. Mixed effects logistic models were used to assess the association of food quantity, quality and security with program participation, program inputs and respondent characteristics. Increased time in the program was significantly associated with improved food quantity, quality and security. Other covariates significantly predicting improved food quantity, quality and security included using program-funds to cultivate small-holder farms, increased monthly income, self-efficacy and the number of partners in previous year. After adjusting for monthly income and other covariates, duration of program participation remained a significant predictor of improved food consumption, quality and security. The study presents a unique community-based intervention, hybridizing insights from multiple disciplines that warrants further study to improve the food quantity, quality and security of orphans and vulnerable children across sub-Saharan Africa.

Tuberculosis (TB) is now the single biggest infectious disease killer in the world, surpassing malaria and HIV/AIDS. In 2014, there were an estimated 9.6 million incident TB cases and 1.5 million deaths.<sup>1</sup> It is not widely appreciated that TB is also a major cause of disease and death in young children.<sup>2,3</sup> New estimates from the World Health Organization (WHO) are that 1 million children developed TB during 2014.<sup>1</sup> This is disconcerting because children have poor access to TB services in most resource-limited settings and paediatric cases provide an accurate reflection of uncontrolled TB transmission within communities.

#### *Abstract*

This paper offers robust empirical evidence of a Darwinian pro-natalist mechanism: parents can improve their old-age support with an additional child. Using the incidence of first-born twins as an instrument for fertility outcomes, I find that Chinese senior parents with more children receive more financial transfers and are more likely to co-reside with an adult child. They are also less likely to work past retirement age. The estimated effects are large, despite the evidence that adult children from larger families are less educated and earn significantly less. Interestingly, the effect of an increase in the number of children on old-age support does not depend on the child's gender.

*Abstract*

The vast majority of the world's poor live in rural areas of developing countries with little access to financial services. Setting up Village Savings and Loan Associations (VSLAs) has become an increasingly widespread intervention aimed at improving local financial intermediation. Using a cluster randomized trial we investigate the impact of VSLAs in Northern Malawi over a two year period. We find evidence of positive and significant intention-to-treat effects on several outcomes, including the number of meals consumed per day, household expenditure as measured by the USAID Poverty Assessment Tool, and the number of rooms in the dwelling. This effect is linked to an increase in savings and credit obtained through the VSLAs, which has increased agricultural investments and income from small businesses.

*Abstract*

We provide empirical evidence that Rwandans use the mobile phone network to transfer airtime to those affected by unexpected shocks. Using an extensive dataset on mobile phone activity in Rwanda and exploiting the quasi-random timing and location of natural disasters, we show that individuals make transfers and calls to people affected by disasters. The magnitude of these transfers is small in absolute terms, but statistically significant; in response to the Lake Kivu earthquake of 2008, we estimate that roughly US\$84 in airtime was transferred to individuals in the affected region, that 70% of these transfers were immediately used to make outgoing calls, and that US\$16,959 was spent calling those near the epicenter. Unlike other forms of interpersonal transfers, mobile airtime is sent over large geographic distances and in response to covariate shocks. Transfers are more likely to be sent to wealthy individuals, and are sent predominantly between pairs of individuals with a strong history of reciprocal favor exchange.

*Abstract*

This paper examines the relationship between witchcraft beliefs, a deep-rooted cultural phenomenon, and various elements of social capital. Using novel survey data from nineteen countries in Sub-Saharan Africa we establish a robust negative association between the prevalence of witchcraft beliefs and multiple measures of trust which holds after accounting for country fixed effects and potential confounding factors at the individual, regional, and ethnic-group levels. This finding extends to other metrics of social capital, namely charitable giving and participation in religious group activities. Such coexistence of witchcraft beliefs and antisocial attitudes stands in stark contrast to a well-explored alternative cultural equilibrium characterized by religious prosociality. Evidence from societies beyond Africa shows that in preindustrial communities where witchcraft is believed to be an important cause of illness, mistrust and other antisocial traits are inculcated since childhood. Furthermore, second-

generation immigrants in Europe originating from countries with widespread witchcraft beliefs are generally less trusting.

*Summary*

**Background**

One of the global targets for non-communicable diseases is to halt, by 2025, the rise in the age-standardised adult prevalence of diabetes at its 2010 levels. We aimed to estimate worldwide trends in diabetes, how likely it is for countries to achieve the global target, and how changes in prevalence, together with population growth and ageing, are affecting the number of adults with diabetes.

**Methods**

We pooled data from population-based studies that had collected data on diabetes through measurement of its biomarkers. We used a Bayesian hierarchical model to estimate trends in diabetes prevalence—defined as fasting plasma glucose of 7·0 mmol/L or higher, or history of diagnosis with diabetes, or use of insulin or oral hypoglycaemic drugs—in 200 countries and territories in 21 regions, by sex and from 1980 to 2014. We also calculated the posterior probability of meeting the global diabetes target if post-2000 trends continue.

**Findings**

We used data from 751 studies including 4 372 000 adults from 146 of the 200 countries we make estimates for. Global age-standardised diabetes prevalence increased from 4·3% (95% credible interval 2·4–7·0) in 1980 to 9·0% (7·2–11·1) in 2014 in men, and from 5·0% (2·9–7·9) to 7·9% (6·4–9·7) in women. The number of adults with diabetes in the world increased from 108 million in 1980 to 422 million in 2014 (28·5% due to the rise in prevalence, 39·7% due to population growth and ageing, and 31·8% due to interaction of these two factors). Age-standardised adult diabetes prevalence in 2014 was lowest in northwestern Europe, and highest in Polynesia and Micronesia, at nearly 25%, followed by Melanesia and the Middle East and north Africa. Between 1980 and 2014 there was little change in age-standardised diabetes prevalence in adult women in continental western Europe, although crude prevalence rose because of ageing of the population. By contrast, age-standardised adult prevalence rose by 15 percentage points in men and women in Polynesia and Micronesia. In 2014, American Samoa had the highest national prevalence of diabetes (>30% in both sexes), with age-standardised

adult prevalence also higher than 25% in some other islands in Polynesia and Micronesia. If post-2000 trends continue, the probability of meeting the global target of halting the rise in the prevalence of diabetes by 2025 at the 2010 level worldwide is lower than 1% for men and is 1% for women. Only nine countries for men and 29 countries for women, mostly in western Europe, have a 50% or higher probability of meeting the global target.

#### Interpretation

Since 1980, age-standardised diabetes prevalence in adults has increased, or at best remained unchanged, in every country. Together with population growth and ageing, this rise has led to a near quadrupling of the number of adults with diabetes worldwide. The burden of diabetes, both in terms of prevalence and number of adults affected, has increased faster in low-income and middle-income countries than in high-income countries.

#### Summary

##### Background

Between October, 2013, and April, 2014, French Polynesia experienced the largest Zika virus outbreak ever described at that time. During the same period, an increase in Guillain-Barré syndrome was reported, suggesting a possible association between Zika virus and Guillain-Barré syndrome. We aimed to assess the role of Zika virus and dengue virus infection in developing Guillain-Barré syndrome.

##### Methods

In this case-control study, cases were patients with Guillain-Barré syndrome diagnosed at the Centre Hospitalier de Polynésie Française (Papeete, Tahiti, French Polynesia) during the outbreak period. Controls were age-matched, sex-matched, and residence-matched patients who presented at the hospital with a non-febrile illness (control group 1; n=98) and age-matched patients with acute Zika virus disease and no neurological symptoms (control group 2; n=70). Virological investigations included RT-PCR for Zika virus, and both microsphere immunofluorescent and seroneutralisation assays for Zika virus and dengue virus. Anti-glycolipid reactivity was studied in patients with Guillain-Barré syndrome using both ELISA and combinatorial microarrays.

##### Findings

42 patients were diagnosed with Guillain-Barré syndrome during the study period. 41 (98%) patients with Guillain-Barré syndrome had anti-Zika virus IgM or IgG, and all (100%) had neutralising antibodies against Zika virus compared with 54 (56%) of 98 in control group 1 ( $p<0.0001$ ). 39 (93%) patients with Guillain-Barré syndrome had Zika virus IgM and 37 (88%) had experienced a transient illness in a median of 6 days (IQR 4–10) before the onset of neurological symptoms, suggesting recent Zika virus infection. Patients with Guillain-Barré syndrome had electrophysiological findings compatible with acute motor axonal neuropathy

(AMAN) type, and had rapid evolution of disease (median duration of the installation and plateau phases was 6 [IQR 4–9] and 4 days [3–10], respectively). 12 (29%) patients required respiratory assistance. No patients died. Anti-glycolipid antibody activity was found in 13 (31%) patients, and notably against GA1 in eight (19%) patients, by ELISA and 19 (46%) of 41 by glycoarray at admission. The typical AMAN-associated anti-ganglioside antibodies were rarely present. Past dengue virus history did not differ significantly between patients with Guillain-Barré syndrome and those in the two control groups (95%, 89%, and 83%, respectively).

#### Interpretation

This is the first study providing evidence for Zika virus infection causing Guillain-Barré syndrome. Because Zika virus is spreading rapidly across the Americas, at risk countries need to prepare for adequate intensive care beds capacity to manage patients with Guillain-Barré syndrome.

#### **Increasing value and reducing waste in biomedical research: who's listening?**

#### Summary

The biomedical research complex has been estimated to consume almost a quarter of a trillion US dollars every year. Unfortunately, evidence suggests that a high proportion of this sum is avoidably wasted. In 2014, The Lancet published a series of five reviews showing how dividends from the investment in research might be increased from the relevance and priorities of the questions being asked, to how the research is designed, conducted, and reported. 17 recommendations were addressed to five main stakeholders—funders, regulators, journals, academic institutions, and researchers. This Review provides some initial observations on the possible effects of the Series, which seems to have provoked several important discussions and is on the agendas of several key players. Some examples of individual initiatives show ways to reduce waste and increase value in biomedical research. This momentum will probably move strongly across stakeholder groups, if collaborative relationships evolve between key players; further important work is needed to increase research value. A forthcoming meeting in Edinburgh, UK, will provide an initial forum within which to foster the collaboration needed.

### **Catalyzing a Reproductive Health and Social Justice Movement**

#### *Abstract*

**Objectives** The maternal and child health (MCH) community, partnering with women and their families, has the potential to play a critical role in advancing a new multi-sector social movement focused on creating a women's reproductive and economic justice agenda. Since the turn of the twenty-first century, the MCH field has been planting seeds for change. The time has come for this work to bear fruit as many states are facing stagnant or slow progress in reducing infant mortality, increasing maternal death rates, and growing health inequities. **Methods** This paper synthesizes three current, interrelated approaches to addressing MCH challenges—life course theory, preconception health, and social justice/reproductive equity. **Conclusion** Based on these core constructs, the authors offer four directions for advancing efforts to improve MCH outcomes. The first is to ensure access to quality health care for all. The second is to facilitate change through critical conversations about challenging issues such as poverty, racism, sexism, and immigration; the relevance of evidence-based practice in disenfranchised communities; and how we might be perpetuating inequities in our institutions. The third is to develop collaborative spaces in which leaders across diverse sectors can see their roles in creating equitable neighborhood conditions that ensure optimal reproductive choices and outcomes for women and their families. Last, the authors suggest that leaders engage the MCH workforce and its consumers in dialogue and action about local and national policies that address the social determinants of health and how these policies influence reproductive and early childhood outcomes.

### **What Can We Expect from Value-Based Funding of Medicines? A Retrospective Study**

*Abstract*

Objective

Deciding on public funding for pharmaceuticals on the basis of value for money is now widespread. We suggest that evidence-based assessment of value has restricted the availability of medicines in Australia in a way that reflects the relative bargaining power of government and the pharmaceutical industry. We propose a simple informal game-theoretic model of bargaining

between the funding agency and industry and test its predictions using a logistic multiple regression model of past funding decisions made by the Pharmaceutical Benefits Advisory Committee in Australia.

#### Method

The model estimates the probability of a drug being recommended for subsidy as a function of incremental cost per quality-adjusted life-year (QALY), as well as other drug and market characteristics. Data are major submissions or resubmissions from 1993 to 2009 where there was a claim of superiority and evidence of a difference in quality of life. Independent variables measure the incremental cost per QALY, the cost to the public budget, the strength and quality of the clinical and economic evidence, need as measured by severity of illness and the availability of alternative treatments, whether or not a resubmission, and newspaper reports as a measure of public pressure. We report the odds ratio for each variable and calculate the ratio of the marginal effect of each variable to the marginal effect of the cost per QALY as a measure of the revealed willingness to pay for each of the variables that influence the decision.

#### Results

The results are consistent with a bargaining model where a 10,000 Australian dollar (\$A) fall in value (increase in cost per QALY) reduces the average probability of public funding from 37 to 33 % (95 % CI 34–32). If the condition is life threatening or the drug has no active comparator, then the odds of a positive recommendation are 3.18 (95 % CI 1.00–10.11) and 2.14 (95 % CI 0.95–4.83) greater, equivalent to a \$A33,000 and a \$A21,000 increase in value (fall in cost per QALY). If both conditions are met, the odds are increased by 4.41 (95 % CI 1.28–15.24) times, equivalent to an increase in value of \$A46,000. Funding is more likely as time elapses and price falls, but we did not find clear evidence that public or corporate pressure influences decisions.

#### Conclusion

Evidence from Australia suggests that the determinants of public funding and pricing decisions for medicines reflect the relative bargaining power of government and drug companies. Value for money depends on the quality of evidence, timing, patient need, perceived benefit and opportunity cost; these factors reflect the potential gains from striking a bargain and the risk of loss from not doing so

*Abstract*

Real-time vaccination following an outbreak can effectively mitigate the damage caused by an infectious disease. However, in many cases, available resources are insufficient to vaccinate the entire at-risk population, logistics result in delayed vaccine deployment, and the interaction between members of different cities facilitates a wide spatial spread of infection. Limited vaccine, time delays, and interaction (or coupling) of cities lead to tradeoffs that impact the overall magnitude of the epidemic. These tradeoffs mandate investigation of optimal strategies that minimize the severity of the epidemic by prioritizing allocation of vaccine to specific



subpopulations. We use an SIR model to describe the disease dynamics of an epidemic which breaks out in one city and spreads to another. We solve a master equation to determine the resulting probability distribution of the final epidemic size. We then identify tradeoffs between vaccine, time delay, and coupling, and we determine the optimal vaccination protocols resulting from these tradeoffs.

*Significance*

Fisheries management must avoid adverse impacts on the ecosystem. Doing so can be challenging in highly complex systems, particularly if the target species serves an important ecosystem function. Caribbean coral reefs provide a classic example in which herbivorous parrotfish are both an important fishery and key driver of ecosystem resilience. We developed and tested a multispecies fisheries model of parrotfish and linked it to a coral reef ecosystem experiencing climate change. We found that corals can remain resilient if less than 10% of the fishable parrotfish biomass is harvested and a minimum size of 30 cm is implemented. To our knowledge, this work is the first attempt to identify harvest levels that have little adverse effect on corals.

*Abstract*

Many countries are legally obliged to embrace ecosystem-based approaches to fisheries management. Reductions in bycatch and physical habitat damage are now commonplace, but mitigating more sophisticated impacts associated with the ecological functions of target fisheries species are in their infancy. Here we model the impacts of a parrotfish fishery on the future state and resilience of Caribbean coral reefs, enabling us to view the tradeoff between harvest and ecosystem health. We find that the implementation of a simple and enforceable size restriction of >30 cm provides a win:win outcome in the short term, delivering both ecological and fisheries benefits and leading to increased yield and greater coral recovery rate for a given harvest rate. However, maintaining resilient coral reefs even until 2030 requires the addition of harvest limitations (<10% of virgin fishable biomass) to cope with a changing climate and

induced coral disturbances, even in reefs that are relatively healthy today. Managing parrotfish is not a panacea for protecting coral reefs but can play a role in sustaining the health of reefs and high-quality habitat for reef fisheries.

*Summary*

A big yellow fever outbreak in Angola has depleted the world's emergency vaccine stockpile and raised worries that future outbreaks of the mosquito-borne virus could be impossible to control. The Angolan outbreak has caused 490 confirmed cases and 198 deaths so far, but experts say the real toll may be 10 times as high. A vaccination campaign has already reached 6 million people in Luanda, where the outbreak began, but the disease has spread to other provinces as well and the vaccine is running out. Only four facilities in the world produce yellow fever vaccine, and their production methods are antiquated and difficult to scale up. Additional outbreaks in other African cities, or in Asia, where yellow fever has never gained a foothold, could be catastrophic, experts say.
