### **ADDRESSING THE NEEDS OF UNACCOMPANIED MINORS (UAMs) IN GREECE**

International Organization for Migration Office in Greece

Foreword *[Excerpt]*

Children are among of the most vulnerable members of our society and it is our shared responsibility to protect, nurture and care for them. Children separated from their caregivers are particularly susceptible to exploitation, abuse and neglect. Our collective duty of protection towards all children, especially those unaccompanied by an adult parent or guardian is recognized in various international and European legal instruments. It should be emphasized however that both the UN Convention on Rights of the Child, signed by every Member State of the European Union (EU), and the Charter of Fundamental Rights of the EU provide children with specific inalienable rights. It is our obligation to ensure that these rights are fully respected. To achieve this we need to work together as organizations, as governments, as society and individuals. IOM Greece has been following the migration flows for more than 50 years by responding to the needs of the migrant population as they arise and differ over time.

The European Union has faced unprecedented migratory pressures at its borders in the past years, characterized by complex mixed migratory flows. For instance, in 2011, more than 56.000 migrants arrived to Greece by land and sea, and more than 34.000 in 2012. As a result, in January 2013, the European Commission entrusted IOM Greece to address the challenging issue of unaccompanied minors in Greece. The 21-month Programme "Addressing the needs of unaccompanied minors in Greece" included enhanced family tracing and family assessment procedures which, along with the views of the children, could be used in determining whether it was in their best interest to be provided with assistance to voluntary return and be reintegrated in their country of origin. Throughout the implementation of this programme, our main objective was to ensure that each child exercised his or her right to be heard, provided with the necessary care and support they needed and, that ultimately, the best interest of the child was taken into consideration throughout the assistance process and that the outcome of each case was based on the best interest of that child as well.

For the purposes of this programme, IOM Greece worked with many committed organizations and individuals, in Greece and abroad, assuring cross-border multi-disciplinary cooperation. Working closely with the Prosecutor for Minors in Greece and with other relevant national authorities, our office also received support from IOM missions in the countries of origin, from Embassies and diplomatic missions, as well as from civil society organisations.

Equally significant factor for the implementation of this Programme, IOM Greece was able to support the Government of Greece in establishing and implementing common standard operating procedures to find durable solutions and ensure the right to the safe and dignified return as part of the protection of unaccompanied children.

The Programme "Addressing the needs of unaccompanied minors in Greece was funded 90% by the Emergency Funds of the European Return Fund and 10% by the Netherlands, the United Kingdom, Denmark and Sweden. We are grateful to all donors of the project for their support in managing migration in Greece in the context of international migration and protection of children, and in providing with viable alternatives the unaccompanied children, their families and their communities.

Thanks to this Programme, IOM Greece was given a unique opportunity to learn more about unaccompanied children in Greece. We gained valuable insight about the motivations which led children to leave behind their families and countries, and what motivated them to choose Europe as their final destination. It also provided us with evidence that almost all unaccompanied children view Greece as a transit country on the way to other European countries.

With this report, we attempt to capitalise and document our experience and findings from the implementation of this Programme, and provide an in-depth understanding of the situation of unaccompanied children in Greece and the related migration trends, in the hopes that the lessons learned will be a useful guide for other countries.

Greece - IOM Greece has published a report based on interviews with 1,206 unaccompanied child migrants in Greece. Some 508 said that they would not consider returning to their countries of origin because it was their intention to reach a northern European country and 282 expressed the wish to return back to their country of origin. The remainder initially expressed willingness to return home but later changed their minds and decided to stay in Greece.

By the end of the project in late 2014, which was designed to develop standard operating procedures for assisted voluntary return and reintegration of unaccompanied migrant children, 59 of the children returned home with IOM return and full reintegration assistance. Another 41 from Egypt returned home and received post arrival reintegration assistance.

The report: Addressing the Needs of Unaccompanied Minors (UAMs) in Greece showed that the 508 were intent on reaching their final destination no matter what services were made available to them in Greece, as they thought that they would have a better future in another European country.

Of these, some 32 percent said that their final destination would be Germany, 23 percent the United Kingdom, 22 percent Sweden, 9 percent Norway, 5 percent France and 9 percent other European countries, such as Austria, Belgium, the Netherlands, Denmark and Finland.

The majority of those who intended to continue their journey to northern Europe were boys aged between 15 and 17, primarily from Afghanistan and Pakistan.

"As per IOM Guidelines on the Protection of Unaccompanied Migrant Children, we had to confirm the identity of the legal guardians in the country of origin, have IOM or a partner NGO

in the country of origin complete a family assessment, share the material with Greek authorities, get the child's opinion, and along with the Prosecutor of Minors, explore whether it was in the best interests of the child to return home," said IOM Greece Chief of Mission Daniel Esdras.

...During the project, IOM Greece worked closely with various organizations in the public sector, as well as with Greek NGOs, Embassies in Greece and IOM missions in the countries of origin. The project, which was funded by the European Union, the Netherlands, the United Kingdom, Denmark and Sweden, ran from February 2013 to October 2014.

### **[Horn of Africa: World Bank \\$175 Million Financing Supports Regional Initiative on Communities Hosting Refugees](#)**

WASHINGTON, May 31, 2016—The World Bank Board of Executive Directors today approved \$175 million in financing to help mitigate the impact of forced displacement on refugee-hosting communities in the Horn of Africa.

"While much of the world's attention has been on the refugees' crises in the Middle East, we must do much more to help African countries respond to the long-term forced displacement of millions of people," said World Bank Group President Jim Yong Kim. "Our financing for countries hosting refugees in the Horn of Africa should bring more stability to the region and offer more economic opportunities for people living in these areas."

The funding comes from the International Development Association (IDA), the World Bank's fund for the poorest, and includes \$100 million to Ethiopia, \$50 million to Uganda, \$20 million to Djibouti – all at low to no-interest -- and a \$5 million grant to the Intergovernmental Authority on Development (IGAD).

Despite rich human, social, and natural capital, the Horn of Africa region, home to 242 million inhabitants, suffers weak governance, insecurity, increasing environmental degradation, entrenched poverty, and other persistent development challenges. Conflict remains endemic, compounded by population growth and migration, high youth unemployment, imbalanced service provision, competition for scarce natural resources, and harsh climatic conditions, with increasingly frequent and severe droughts and floods.

The Development Response to Displacement Impacts Project (DRDIP) will help improve access to basic social services, expand economic opportunities, and enhance environmental management for communities hosting refugees in target areas of the three countries. This project is the first phase of an expanded program to include other countries affected by forced displacement.

The Horn currently hosts an estimated 9.5 million displaced persons, including more than 6.5 million internally displaced persons (IDPs) and about 3 million refugees. The majority are women and children, with many female-headed households. The presence of refugees strains already weak public services and economic opportunities, jeopardizing the resilience of host communities.

...The project supports the World Bank Regional Horn of Africa Initiative by developing interventions that help refugee-hosting areas. It focuses on building resilience by addressing negative environmental and economic impacts, and by investing in infrastructure to improve

economic opportunities for refugees and host communities. Global experience shows that self-reliant refugees are better prepared to return to their countries of origin. The project also supports close collaboration with the UNHCR in seeking durable solutions to the refugee crisis. Ethiopia has Africa's largest refugee population, and Uganda the third-largest. These refugees are settled close to international borders in communities facing extreme poverty. The project will improve these communities' access to basic social services and economic infrastructure, and help promote economic self-reliance and social development for refugees. It will make innovative use of government financing systems, structures, and institutions to deliver a development response to forced displacement.

The grant to IGAD will establish a regional secretariat for Forced Displacement and Mixed Migration to support a holistic regional response, backed by data, to influence interventions in both refugee-hosting and refugee-producing countries. It will support policy dialogue with member states and academic and research institutions on transitional and progressive solutions to displacement. It will help build countries' and institutions' capacities in the Horn and forge partnerships between humanitarian and development actors. IGAD's own capacity will also be strengthened to act both regionally and internationally on issues affecting the Horn of Africa.

### **"AIDS epidemic still being driven by human rights violations" – UN experts warn**

GENEVA (3 June 2016) – In a public statement\* ahead of the High-Level Meeting on ending AIDS by 2030 (New York, 8-10 June), a group of United Nations independent experts has warned that the AIDS epidemic is still driven by human rights violations around the world, including discrimination, violence, punitive laws, policies and practices.

The UN Special Rapporteurs on the right to health Dainius Pūras; on human rights defenders, Michel Forst; on extreme poverty, Philip Alston; and on violence against women Dubravka Šimonović; and the Chairperson of the UN Working Group on Discrimination against women, Frances Raday, urged all Governments to remove punitive laws, policies and practices, including overly broad criminalization of HIV transmission, third-party notification requirements, mandatory testing and others that block key populations' access to health services, goods and information.

"Such laws and practices impede, and sometimes altogether bar, certain populations from accessing information, as well as health goods and services that are critical to the prevention, treatment, and care of HIV," they said.

The UN experts noted that AIDS response has shown the importance of human rights when it comes to overcoming barriers that block effective responses to HIV, for better health and for advancing rights. "Using the power of human rights, people living with HIV and HIV/AIDS defenders have secured important victories, including access to medicines, law reform and the inclusion of human rights programmes in HIV responses."

"But the HIV epidemic continues to be a metaphor for great inequalities within and between countries," the human rights experts underlined. "Ending the AIDS epidemic in a way that leaves no one behind requires reaching out to populations that are deeply marginalized, even criminalized."

"Regrettably, over the past few years, we are witnessing a trend of increased criminalization of key populations most affected by HIV in certain parts of the world which fuels stigma, discrimination and violence against them," they said.

Specific populations that continue to be left out and bear the brunt of the epidemic include people who inject drugs, who are 24 times more likely to acquire HIV; women in prostitution/sex workers, who are 10 times more likely to acquire HIV; men who have sex with men, who are 24 times more likely to acquire HIV than adults in the general population; transgender people, who are 18 times more likely to acquire HIV; and prisoners, who are five times more likely to be living with HIV than the general population.

Evidence shows that health care settings are among the most frequent environments where people experience HIV-related stigma, discrimination, and even violence, the experts noted. Examples include denial of health care and unjust barriers in service provision, extreme violations of autonomy and bodily integrity such as forced abortions and sterilizations, undue third party authorizations for accessing services, and mandatory treatment; or compulsory detention.

"Globally, women and girls are still the most affected by the AIDS epidemic and women living with HIV report higher levels of stigma, discrimination and violence than men living with HIV," the human rights experts underlined...

### **European Commission and IT Companies announce Code of Conduct on illegal online hate speech**

Brussels, 31 May 2016

The Commission together with Facebook, Twitter, YouTube and Microsoft ("the IT companies") today unveil a code of conduct that includes a series of commitments to combat the spread of illegal hate speech online in Europe.

The IT Companies support the European Commission and EU Member States in the effort to respond to the challenge of ensuring that online platforms do not offer opportunities for illegal online hate speech to spread virally. They share, together with other platforms and social media companies, a collective responsibility and pride in promoting and facilitating freedom of expression throughout the online world. However, the Commission and the IT Companies recognise that the spread of illegal hate speech online not only negatively affects the groups or individuals that it targets, it also negatively impacts those who speak out for freedom, tolerance and non-discrimination in our open societies and has a chilling effect on the democratic discourse on online platforms.

In order to prevent the spread of illegal hate speech, it is essential to ensure that relevant national laws transposing the Council Framework Decision on combating racism and xenophobia are fully enforced by Member States in the online as well as in the offline environment. While the effective application of provisions criminalising hate speech is dependent on a robust system of enforcement of criminal law sanctions against the individual perpetrators of hate speech, this work must be complemented with actions geared at ensuring that illegal hate speech online is expeditiously reviewed by online intermediaries and social media platforms,

upon receipt of a valid notification, in an appropriate time-frame. To be considered valid in this respect, a notification should not be insufficiently precise or inadequately substantiated.

Věra Jourová, EU Commissioner for Justice, Consumers and Gender Equality, said, "The recent terror attacks have reminded us of the urgent need to address illegal online hate speech. Social media is unfortunately one of the tools that terrorist groups use to radicalise young people and racist use to spread violence and hatred. This agreement is an important step forward to ensure that the internet remains a place of free and democratic expression, where European values and laws are respected. I welcome the commitment of worldwide IT companies to review the majority of valid notifications for removal of illegal hate speech in less than 24 hours and remove or disable access to such content, if necessary."

Twitter's Head of Public Policy for Europe, Karen White, commented: "Hateful conduct has no place on Twitter and we will continue to tackle this issue head on alongside our partners in industry and civil society. We remain committed to letting the Tweets flow. However, there is a clear distinction between freedom of expression and conduct that incites violence and hate. In tandem with actioning hateful conduct that breaches Twitter's Rules, we also leverage the platform's incredible capabilities to empower positive voices, to challenge prejudice and to tackle the deeper root causes of intolerance. We look forward to further constructive dialogue between the European Commission, member states, our partners in civil society and our peers in the technology sector on this issue."

Google's Public Policy and Government Relations Director, Lie Junius, said: "We're committed to giving people access to information through our services, but we have always prohibited illegal hate speech on our platforms. We have efficient systems to review valid notifications in less than 24 hours and to remove illegal content. We are pleased to work with the Commission to develop co- and self-regulatory approaches to fighting hate speech online."

Monika Bickert, Head of Global Policy Management at Facebook said: "We welcome today's announcement and the chance to continue our work with the Commission and wider tech industry to fight hate speech. With a global community of 1.6 billion people we work hard to balance giving people the power to express themselves whilst ensuring we provide a respectful environment. As we make clear in our Community Standards, there's no place for hate speech on Facebook. We urge people to use our reporting tools if they find content that they believe violates our standards so we can investigate. Our teams around the world review these reports around the clock and take swift action."

John Frank, Vice President EU Government Affairs at Microsoft, added: "We value civility and free expression, and so our terms of use prohibit advocating violence and hate speech on Microsoft-hosted consumer services. We recently announced additional steps to specifically prohibit the posting of terrorist content. We will continue to offer our users a way to notify us when they think that our policy is being breached. Joining the Code of Conduct reconfirms our commitment to this important issue."

By signing this code of conduct, the IT companies commit to continuing their efforts to tackle illegal hate speech online. This will include the continued development of internal procedures and staff training to guarantee that they review the majority of valid notifications for removal of illegal hate speech in less than 24 hours and remove or disable access to such content, if necessary. The IT companies will also endeavour to strengthen their ongoing partnerships with civil society organisations who will help flag content that promotes incitement to violence and hateful conduct. The IT companies and the European Commission also aim to continue their

work in identifying and promoting independent counter-narratives, new ideas and initiatives, and supporting educational programs that encourage critical thinking.

The IT Companies also underline that the present code of conduct is aimed at guiding their own activities as well as sharing best practices with other internet companies, platforms and social media operators.

**The code of conduct includes the following public commitments:**

:: The IT Companies, taking the lead on countering the spread of illegal hate speech online, have agreed with the European Commission on a code of conduct setting the following public commitments:

:: The IT Companies to have in place clear and effective processes to review notifications regarding illegal hate speech on their services so they can remove or disable access to such content. The IT companies to have in place Rules or Community Guidelines clarifying that they prohibit the promotion of incitement to violence and hateful conduct.

:: Upon receipt of a valid removal notification, the IT Companies to review such requests against their rules and community guidelines and where necessary national laws transposing the Framework Decision 2008/913/JHA, with dedicated teams reviewing requests.

:: The IT Companies to review the majority of valid notifications for removal of illegal hate speech in less than 24 hours and remove or disable access to such content, if necessary. In addition to the above, the IT Companies to educate and raise awareness with their users about the types of content not permitted under their rules and community guidelines. The use of the notification system could be used as a tool to do this.

:: The IT companies to provide information on the procedures for submitting notices, with a view to improving the speed and effectiveness of communication between the Member State authorities and the IT Companies, in particular on notifications and on disabling access to or removal of illegal hate speech online. The information is to be channelled through the national contact points designated by the IT companies and the Member States respectively. This would also enable Member States, and in particular their law enforcement agencies, to further familiarise themselves with the methods to recognise and notify the companies of illegal hate speech online.

:: The IT Companies to encourage the provision of notices and flagging of content that promotes incitement to violence and hateful conduct at scale by experts, particularly via partnerships with CSOs, by providing clear information on individual company Rules and Community Guidelines and rules on the reporting and notification processes. The IT Companies to endeavour to strengthen partnerships with CSOs by widening the geographical spread of such partnerships and, where appropriate, to provide support and training to enable CSO partners to fulfil the role of a "trusted reporter" or equivalent, with due respect to the need of maintaining their independence and credibility.

:: The IT Companies rely on support from Member States and the European Commission to ensure access to a representative network of CSO partners and "trusted reporters" in all Member States helping to help provide high quality notices. IT Companies to make information about "trusted reporters" available on their websites.

:: The IT Companies to provide regular training to their staff on current societal developments and to exchange views on the potential for further improvement.

::: The IT Companies to intensify cooperation between themselves and other platforms and social media companies to enhance best practice sharing.

::: The IT Companies and the European Commission, recognising the value of independent counter speech against hateful rhetoric and prejudice, aim to continue their work in identifying and promoting independent counter-narratives, new ideas and initiatives and supporting educational programs that encourage critical thinking.

:: The IT Companies to intensify their work with CSOs to deliver best practice training on countering hateful rhetoric and prejudice and increase the scale of their proactive outreach to CSOs to help them deliver effective counter speech campaigns. The European Commission, in cooperation with Member States, to contribute to this endeavour by taking steps to map CSOs' specific needs and demands in this respect.

:: The European Commission in coordination with Member States to promote the adherence to the commitments set out in this code of conduct also to other relevant platforms and social media companies.

The IT Companies and the European Commission agree to assess the public commitments in this code of conduct on a regular basis, including their impact. They also agree to further discuss how to promote transparency and encourage counter and alternative narratives. To this end, regular meetings will take place and a preliminary assessment will be reported to the High Level Group on Combating Racism, Xenophobia and all forms of intolerance by the end of 2016...

### **The Productivity-Inclusiveness Nexus**

#### **EXECUTIVE SUMMARY *[Excerpt]***

1. Eight years on from the start of the economic and financial crisis, the international economic context remains challenging, with growth still modest in advanced economies and continuing to slow in key emerging markets. While this weakness is in part cyclical, reflecting the realities of the post-crisis environment, it also results from a worrying slowdown in productivity growth which predates the crisis. Indeed, some 90% of OECD countries experienced a decline in trend labour productivity growth after the turn of the millennium, and the slowdown has now also spread to emerging market economies, despite their comparatively low productivity levels and continued scope for catch up.

2. Of equal cause for concern is the fact that this decline in productivity growth has played out against a global backdrop of rising, or persistently high, inequalities of income, wealth and well-being. In 2012, the average income of the top 10% of earners in the OECD area grew to just under 10 times that of the bottom 10%, up from around 7 times in the mid-1980s. In terms of wealth, the situation is considerably starker, with the top 10% controlling half of all total household wealth in 2012 in the 18 OECD countries with comparable data.

3. Among the myriad challenges facing our economies, few pose greater obstacles to better economic performance than the productivity slowdown and the rise in inequalities. Both have been exacerbated in recent years, as the climate of low investment and high unemployment bequeathed by the crisis has taken its toll, but they also reflect more fundamental challenges with the way our economies function.

4. In such a context, we can no longer take it for granted that technological advances, and the related innovations in processes and business models, will automatically lead to better economic performance and stronger productivity growth. At the same time, there is no guarantee that the benefits of higher levels of growth, or higher levels of productivity in certain sectors, when they materialise, will be broadly shared across the population as a whole. On the

contrary, there is a risk of a vicious cycle setting in, with individuals with fewer skills and poorer access to opportunities often confined to operate in low productivity, precarious jobs, and - in many emerging-market countries - in the informal economy. This reduces aggregate productivity, widens inequality, and ultimately undermines policy efforts to increase productivity and growth.

5. This report on the Productivity-Inclusiveness Nexus gathers the most recent empirical evidence on the main factors behind slowing productivity gains and rising inequality; it suggests possible common foundations and linkages between these two trends; it draws preliminary conclusions on the type of policy packages that are needed and on the implications for policy making, and it also suggests the specific areas where more research may be needed.

6. The main message of this report is a call for policy makers to adopt a broader, more inclusive, approach to productivity growth that considers how to expand the productive assets of an economy by investing in the skills of its people and providing an environment where all firms have a fair chance to succeed, including in lagging regions. The overriding aim behind this is to broaden the productive base of the economy to generate strong and sustainable future productivity gains that everyone is empowered to contribute to, whilst also ensuring that productivity growth benefits all parts of society, in terms of improved living standards and opportunities. Achieving this will require a comprehensive policy framework to account for the multiple interactions between inequalities and productivity and how these interactions play out across countries, regions, firms and between individuals. Such a framework can help policy makers to put in place ex-ante and ex-post measures to promote synergies and deal with trade-offs when productivity policies impact on inequality...

[New 'nexus' approach needed to tackle productivity and inequality challenges, says OECD report](#)  
31/05/2016 - *Declining productivity growth and rising inequality are two of the biggest obstacles to improved economic performance, according to a new OECD report.*

The Productivity-Inclusiveness Nexus explores the root causes behind each of these challenges, examining the extent to which they are connected, and at how to take a coherent policy response. In particular, it signals the need to expand the productive assets in an economy by investing in the skills of people and in an environment where all firms and regions have a chance to succeed.

The report discusses possible complementary explanations for the slowdown in productivity growth, which has affected some 90% of OECD countries since the turn of the millennium and has now spread to emerging market economies. It says the failure to translate rapid technological change into productivity growth reflects a mix of cyclical and structural factors.

One cyclical factor has been the persistently low investment in physical capital, in a context of weak global demand. On the structural side, there has been growing dispersion in productivity performance between leading, or 'frontier' firms, and other companies that are lagging behind.

The report finds several, possibly complementary, explanations for the dispersion in productivity growth, such as the breakdown of technology diffusion and the possibility of growing capture of rents by the frontier firms. A related issue is the a lack of competition in certain markets, which may have on the one hand, allowed poorly-performing firms to linger, trapping valuable human and capital resources in unproductive activities, entrenching inequalities of income, while on the other increasing leading firms market power and raising barriers to entry.

Indeed, the Nexus report also shows that inequalities of income, wealth, well-being and

opportunities have increased in a majority of countries. It highlights how different aspects of inequality tend to feed off of each other, hindering efforts to improve individual well-being and undercutting our economies' productive potential. It notes in particular how low income groups and regions that have fallen behind tend to accumulate economic and social disadvantages...

### **Joint Letter: Freedom House Joins a Call to Repeal China's NGO Law**

June 1, 2016

To delegates of the National People's Congress:

We, the undersigned, oppose in the strongest terms the Law on the Management of Overseas Non-Governmental Organizations' Activities within Mainland China ("the Overseas NGO Law" or "the law", 《中华人民共和国境外非政府组织境内活动管理法》), adopted by the Standing Committee of the 12th National People's Congress (NPC) on April 28, 2016, and we call on NPC delegates to repeal this law.

A stable and effective Chinese society depends on diverse citizen-led organizations, free to operate independent of government intervention and free to seek the support of overseas NGOs, which can provide important resources, training and advocacy. The Overseas NGO Law severely harms Chinese civil society by attacking these principles. The law tasks Chinese civil society organizations with carrying out state control of overseas NGOs, converting local NGOs into instruments of the public security apparatus. This diverts NGOs' efforts away from their important work to improve the lives of the Chinese people.

The law also impairs the ability of Chinese NGOs, universities, businesses, and even the Chinese government to engage with the global community. Efforts to gain information or resources, including technical expertise and partnerships, will often be monitored. Many aspects of programming and bank accounts are subject to tracking and intervention by the state. The law also draws an unclear and arbitrary division between so-called "welcome" and "unwelcome" NGOs. When combined with substantial police powers, these features leave the regulation of civil society vulnerable to politicization, and are inconsistent with international law principles set out by the UN Human Rights Council in Resolution 24/2014, which calls for States to create and maintain, in law and in practice, a safe and enabling environment for civil society.

This law constrains opportunities for Chinese citizens, including together with overseas NGO partners, to develop new approaches to social problems affecting their country—social problems that, if left unchecked by civil society, could lead to greater instability and burden on the state.

During the past several years, Chinese public security has increasingly monitored and obstructed both domestic and overseas NGOs. This law now formalizes many of the problematic bureaucratic tools already in use against Chinese civil society organizations, and legalizes arbitrary police actions against domestic and overseas NGOs. Some of these previously informal practices now given a legal basis include:

- :: The Public Security Bureau can monitor and investigate NGOs at will;
- :: Police can detain NGO staff accused of conducting activities deemed to be 'creating rumors,' 'engaging in defamation,' or make 'other situations that endanger state security or damage the national or public interest';
- :: NGO activities carried out without prior approval are punishable as a crime;
- :: NGOs must report new employees to authorities;
- :: NGOs found to violate these vague rules may be banned from future activities in China.

The law's vague provisions grant broad enforcement authority to China's public security apparatus and legalize perpetual surveillance on Chinese NGO employees who seek to advance dignity and prosperity for their compatriots. Formalizing restrictions will further impede civil society's ability to provide support to many Chinese that currently benefit from NGO programs, including women, internal migrants, minorities, and those concerned with other issues such as public health and education.

In addition to minimizing civil society's influence as a body of independent citizens, this law, together with the recently passed Charity Law, signifies that the PRC government views civil society with suspicion. The state should see civil society organizations as partners who offer value and capacity to address many of the issues confronting Chinese society today.

We call on the NPC to restore trust in the Chinese people and repeal the Overseas NGO Law in order to allow Chinese NGOs greater freedom in their activities and advocacy.

## **New MacArthur Competition to Award \$100 Million to Help Solve a Critical Problem of Our Time**

Published June 2, 2016

A new competition launched today will award a \$100 million grant to a single proposal designed to help solve a critical problem affecting people, places, or the planet. The Foundation's competition, called 100&Change, is open to organizations working in any field of endeavor anywhere. Applicants must identify both the problem they are trying to solve, as well as their proposed solution. Competitive proposals will be meaningful, verifiable, durable, and feasible.

"Solving society's most pressing problems isn't easy, but we believe it can be done," said MacArthur President Julia Stasch. "Potential solutions may go unnoticed or under resourced and are waiting to be brought to scale. Every three years, we plan to award \$100 million to help make one of these solutions a reality. Through 100&Change, we want to inspire, encourage, and support other people's ideas, here in our hometown Chicago, across the nation and around the world, about how to address major challenges and enable real progress toward a solution." The selection process for 100&Change is rigorous, fair, and transparent. Each valid proposal will be reviewed by a panel of expert judges from a variety of fields, and evaluated according to a strict set of criteria designed to favor proposals that maximize measurable impact in their chosen areas. Information about the judges and their evaluation methodology will be shared publicly via the [competition website](#). Participants will receive feedback on their proposals from the judges.

"We believe that 100&Change can have a ripple effect beyond what a single \$100 million grant enables," said Cecilia Conrad, MacArthur's Managing Director leading the competition. "Setting audacious goals is inspiring. Clear evidence of impact can encourage other funders to invest in solvable problems more broadly, and applicants who do not receive the \$100 million grant will still receive valuable feedback on and attention to their ideas."

100&Change will consider applications from across the United States and around the world. Nonprofit and for-profit organizations can apply, subject to eligibility rules. The competition will not accept applications from individuals or government agencies.

To participate, applicants must first register on the website by September 2, 2016. Then they must complete a substantive online application, detailing the problem, solution, and budget, along with posting a video pitch. Proposals will be accepted through October 3, 2016. Semi-finalists will be announced in December. Each semi-finalist will receive assistance from an expert team to identify and address questions about technical and organizational capacity required to implement each proposed solution, including specific plans to monitor, evaluate, and learn during implementation. Each semi-finalist will also be asked to show significant, authentic engagement with affected communities. MacArthur's Board of Directors will select finalists in the summer of 2017. Finalists will present their solutions during a live event in the fall of 2017, after which the Board will make the final decision about the \$100 million grant recipient.

*Annual Report of the Secretary-General on children and armed conflict*

New York – In his Annual report on children and armed conflict covering the year 2015, the UN Secretary-General expressed his shock at the scale of grave violations committed against children in countries such as Afghanistan, Iraq, Somalia, South Sudan, Syria and Yemen.

Emerging and escalating crises had a horrific impact on boys and girls. The situation in Yemen was particularly worrisome with a five-fold increase in the number of children recruited and six times more children killed and maimed compared to 2014. Violations committed by the Islamic State of Iraq and the Levant (ISIL) continued to have a devastating impact on children, including persistent child recruitment and use and boys featured as child soldiers in social media and in some cases as executioners. In Nigeria, Boko Haram increased suicide attacks, including by using 21 girls as suicide bombers in crowded public spaces. The armed group spread its activities from northeastern Nigeria to neighboring countries, causing a significant number of casualties among civilians and large-scale displacements.

“In several situations of conflict, aerial operations contributed to creating complex environments in which large numbers of children were killed and maimed. State-allied armed groups and militia have also increasingly been used to fight in support of Government forces, in some cases recruiting and using children,” said Leila Zerrougui, the UN Special Representative of the Secretary-General for Children and Armed Conflict.

In Syria, thousands of children have been killed during over five years of war. Afghanistan recorded the highest number of child deaths and injuries since the UN started systematically documenting civilian casualties in 2009. In Somalia, there was a 50% increase in the number of recorded violations against children. In South Sudan, children were victims of gruesome violations, particularly during brutal military offensives against opposition forces.

“I am also gravely concerned by the increasing number of children deprived of liberty for their alleged association with parties to conflict. I call upon Member States to treat these children primarily as victims to ensure the full protection of their human rights and to urgently put in place alternatives to detention and prosecution of children,” declared Leila Zerrougui...

NEW YORK/GENEVA, 3 June 2016—The AIDS epidemic has defined the global health agenda for an entire generation. The first AIDS-related deaths were diagnosed over 30 years ago and HIV rapidly became a global crisis. The epidemic threatened all countries and had the power to destabilize the most vulnerable nations. By 2000, AIDS had wiped out decades of development gains.

Today, many nations have taken great steps in getting ahead of the epidemic. South Africa, for example, has reduced the number of new HIV infections from 600 000 in 2000 to 340 000 in 2014. Life expectancy has risen in many of the most severely affected countries in sub-Saharan Africa as access to HIV prevention, testing and treatment has been scaled up. Worldwide, there are now more than 17 million people living with HIV accessing life-saving antiretroviral treatment.

But as world leaders grapple with a growing number of global concerns and threats, including massive displacement, climate change and an uncertain economic outlook—it would be a misstep to let up on the response to HIV. Following the intensive dialogue that has been ongoing with the Polish authorities since 13 January, the Commission has deemed it necessary to formalise its assessment of the current situation in this Opinion. As foreseen in the Rule of Law Framework, this is the first step taken by the Commission in this process. ### **Leaders Must do More to Address Growing Human Trafficking Crisis; Women Most Affected**

:: World Economic Forum on ASEAN highlights a growing problem of human trafficking in South-East Asia

Kuala Lumpur, Malaysia, 1 June 2016 – In a session on human trafficking on the opening day of the World Economic Forum on ASEAN, participants were told that tougher action is needed by regional governments to address the growing problem. In the session on forced slavery and human trafficking in the ASEAN region, Nenette Motus, Regional Director for Asia and the Pacific, International Organization for Migration (IOM), said: “Trafficking is the third most profitable crime business in the world next to guns and drugs. We have a shared responsibility. Trafficked people need our help to get them out of poverty.”

Amid revelations of slavery within the fishing industry in South-East Asia and the growing migration crisis in Europe, Motus applauded the recent move by the 10-member ASEAN bloc to sign the ASEAN Convention Against Trafficking in Persons, Especially Women and Children (ACTIP) but added that more needs to be done. “We need to take a deeper look – at the economic components, at job creation, at recruitment, and at how to stop people being re-trafficked,” she said.

The ACTIP was passed by the ASEAN bloc in November 2015 – just months after the region was faced with a crisis of thousands of ethnic Rohingya stranded at sea – but has still to be ratified by all member states.

Christopher Ng, Regional Secretary of Asia and the Pacific at the UNI Global Union, welcomed the conversation and said he hoped it would lead to implementation of the ACTIP. “If people want to move to other countries, it should be by choice not circumstance,” he said. “What is needed is a code of conduct to regulate recruitment agencies, so there is a way to evaluate practices on the ground.”

Social entrepreneur Pierre Tami, Founder of 360, Cambodia, highlighted the lack of country-specific knowledge which has led to the misallocation of resources. He said this perpetuates violence against vulnerable people, especially women and children.

International donors tend to prioritize funds for those who have already been trafficked, he noted, but often it is women who are victims of sexual violence that later become the most vulnerable to trafficking. “So these issues really need to be seen in a context of violence against women,” he said.

Buddhist leader Kirinde Dhammaratana Nayaka Maha Thero, Founder Ti-Ratana Welfare Society, Malaysia, said religious leaders also had a role to play. He encouraged leaders from all faiths to come forward and collaborate to stop “the scourge” of human trafficking. “Sometimes you might think, why is there a religious leader in the forum,” he said. “But we can contribute to society in many ways too. We can provide shelter, food and counselling. Human trafficking is a very serious issue, and a human-being created problem.”

### **Making Complex Reforms Work: Seven Principles for Public-Private Cooperation**

:: Over 70 leaders from business, government, academia and civil society met at the World Economic Forum to steward an action-oriented agenda on the Middle East and North Africa's most pressing challenges.

:: Oil-price shifts have created an unprecedented opportunity for reforms in oil-importing and oil-exporting countries.

:: The World Economic Forum's communities have defined seven principles for public-private cooperation to promote an effective and inclusive reform process.

Geneva, Switzerland, 1 June 2016 – A select group of over 70 leaders from business, government, academia and civil society met at World Economic Forum headquarters in Geneva to steward an action-oriented agenda on the Middle East and North Africa's most pressing challenges. Held under the theme “Redesigning Public-Private Cooperation for the Middle East and North Africa”, the meeting focused on two imperatives for the region: peace and prosperity.

Given the instability and geopolitical disruptions posing unprecedented challenges to prosperity in the region, participants explored the fragile security and humanitarian context. They agreed on the need for collaborative diplomatic action to help resolve conflicts in Syria, Iraq, Libya and Yemen, and for private-sector innovation in humanitarian aid delivery. “The World Economic Forum is committed to providing the international community a platform for greater public-private collaboration to respond to humanitarian and diplomatic imperatives,” said Klaus Schwab, Founder and Executive Chairman of the World Economic Forum.

The current reform momentum created by low oil prices is seen as a key enabler for prosperity in the region. The reform needs are well recognized but, due to their complex nature, how to successfully implement them is not. In addition, the broad range of social issues in the Middle East and North Africa makes it challenging to find political consensus for undertaking successful reforms, especially for unpopular but needed ones.

#### *Seven Principles for Public-Private Cooperation*

In a pledge to make complex reforms work, representatives of the World Economic Forum's communities, including leaders from government, business and civil society, defined the following seven principles for public-private cooperation to promote an effective and inclusive reform process:

1. Create a clear vision– Leadership's vision and political commitment are the most important prerequisites for successful reforms and provide the framework for planning and implementation
2. Establish an environment for trust– The decision-making process needs to be transparent and provide confidence that the reforms will genuinely benefit social and economic progress
3. Foster inclusive collaboration - Reform implementation needs to be a collaborative process among government, policy-makers, the private sector and civil society with the objective of generating balanced benefits for all citizens
4. Consult public beforehand and maintain momentum through regular communication– Along with effective communication, it is important to consult the public before planning reforms, continuously communicate during the process, and inform the public about the results achieved
5. Enable an ecosystem for accountability– Social and economic progress requires the government to establish an ecosystem that encourages and validates citizen demand for accountability
6. Attract and promote talent – Considering the national interest and complexity of reforms needed, their design and implementation call for consulting the best experts available
7. Build foundations for stability – Greater public-private collaboration is imperative to address the humanitarian crisis and build regional cohesion because peace is fundamental to prosperity.

"The principles defined by our core communities take the agenda for public-private cooperation to a new level, consistent with the needs of the region today," said Miroslav Dusek, Head of Middle East and North Africa and Member of the Executive Committee, World Economic Forum.

Washington—The Pew Charitable Trusts warned today that the Consumer Financial Protection Bureau's proposed rule on payday and auto title lending lacks clear product safety standards, makes it too easy for payday lenders to continue making harmful loans, and fails to encourage banks and credit unions to enter the market and make lower-cost loans.

Payday lenders have direct access to a borrower's checking account or, in the case of auto title lenders, the power to repossess a borrower's vehicle. Each year, 12 million Americans take out payday loans, spending \$9 billion on loan fees. An additional 2.5 million take out auto title loans annually at a cost of \$3 billion.

Pew's small-dollar loans project has conducted extensive research on this high-cost loan market over the past five years, and the findings show that although payday and auto title loans offer quick cash, the unaffordable payments lead consumers to take out additional loans to cover expenses, creating a cycle of debt. Both borrowers and the general public strongly favor payday loan reform. The CFPB draft rule, released June 2, is the first federal proposal to regulate payday and auto title loan...

**[Pew Analysis Shows Many States Looking to Increase Opportunities for Retirement Savings](#)**

*More than 30 million full-time private sector employees lack access to workplace retirement plans*

WASHINGTON—At least half of state governments in the United States are exploring or implementing programs to provide retirement savings options for private sector workers who do not have retirement plans through their employers, according to a report released today by The Pew Charitable Trusts. These state efforts—which are intended to increase savings during employees' working years and reduce poverty among retirees—often require policymakers to balance multiple and sometimes conflicting priorities, the report found.

No major federal legislation to increase retirement savings has passed since the Pension Protection Act of 2006, so some state policymakers are looking for opportunities to fill the gap. Many states are considering what are essentially state-backed individual retirement accounts that build savings through regular deductions from workers' paychecks. Illinois, Massachusetts, Oregon, and Washington have enacted such programs.

**Objective**

To assess, within communities experiencing Ebola virus outbreaks, the risks associated with the disposal of human waste and to generate recommendations for mitigating such risks.

**Methods**

A team with expertise in the Hazard Analysis of Critical Control Points framework identified waste products from the care of individuals with Ebola virus disease and constructed, tested and confirmed flow diagrams showing the creation of such products. After listing potential hazards associated with each step in each flow diagram, the team conducted a hazard analysis, determined critical control points and made recommendations to mitigate the transmission risks at each control point.

**Findings**

The collection, transportation, cleaning and shared use of blood-soiled fomites and the shared use of latrines contaminated with blood or bloodied faeces appeared to be associated with particularly high levels of risk of Ebola virus transmission. More moderate levels of risk were associated with the collection and transportation of material contaminated with bodily fluids other than blood, shared use of latrines soiled with such fluids, the cleaning and shared use of fomites soiled with such fluids, and the contamination of the environment during the collection and transportation of blood-contaminated waste.

**Conclusion**

The risk of the waste-related transmission of Ebola virus could be reduced by the use of full personal protective equipment, appropriate hand hygiene and an appropriate disinfectant after careful cleaning. Use of the Hazard Analysis of Critical Control Points framework could facilitate rapid responses to outbreaks of emerging infectious disease.

**Objective**

To investigate delays in first and third dose diphtheria–tetanus–pertussis (DTP1 and DTP3) vaccination in low-birth-weight infants in Ghana, and the associated determinants.

**Methods**

We used data from a large, population-based vitamin A trial in 2010–2013, with 22 955 enrolled infants. We measured vaccination rate and maternal and infant characteristics and compared three categories of low-birth-weight infants (2.0–2.4 kg; 1.5–1.9 kg; and < 1.5 kg) with infants weighing ≥ 2.5 kg. Poisson regression was used to calculate vaccination rate ratios for DTP1 at 10, 14 and 18 weeks after birth, and for DTP3 at 18, 22 and 24 weeks (equivalent to 1, 2 and 3 months after the respective vaccination due dates of 6 and 14 weeks).

#### Findings

Compared with non-low-birth-weight infants (n = 18 979), those with low birth weight (n = 3382) had an almost 40% lower DTP1 vaccination rate at age 10 weeks (adjusted rate ratio, aRR: 0.58; 95% confidence interval, CI: 0.43–0.77) and at age 18 weeks (aRR: 0.63; 95% CI: 0.50–0.80). Infants weighing 1.5–1.9 kg (n = 386) had vaccination rates approximately 25% lower than infants weighing ≥ 2.5 kg at these time points. Similar results were observed for DTP3. Lower maternal age, educational attainment and longer distance to the nearest health facility were associated with lower DTP1 and DTP3 vaccination rates.

#### Conclusion

Low-birth-weight infants are a high-risk group for delayed vaccination in Ghana. Efforts to improve the vaccination of these infants are warranted, alongside further research to understand the reasons for the delays.

#### Abstract

Governments in low- and middle-income countries are legitimizing the implementation of universal health coverage (UHC), following a United Nation's resolution on UHC in 2012 and its reinforcement in the sustainable development goals set in 2015. *Abstract*

*SUMMARY*

Recent polio outbreaks in Syria and Ukraine, and isolation of poliovirus from asymptomatic carriers in Israel have raised concerns that polio might endanger Europe. We devised a model to calculate the time needed to detect the first case should the disease be imported into Europe, taking the effect of vaccine coverage – both from inactivated and oral polio vaccines, also considering their differences – on the length of silent transmission into account by deriving

an 'effective' case/infection ratio that is applicable for vaccinated populations. Using vaccine coverage data and the newly developed model, the relationship between this ratio and vaccine coverage is derived theoretically and is also numerically determined for European countries. This shows that unnoticed transmission is longer for countries with higher vaccine coverage and a higher proportion of IPV-vaccinated individuals among those vaccinated. Assuming borderline transmission ( $R = 1.1$ ), the expected time to detect the first case is between 326 days and 512 days in different countries, with the number of infected individuals between 235 and 1439. Imperfect surveillance further increases these numbers, especially the number of infected until detection. While longer silent transmission does not increase the number of clinical diseases, it can make the application of traditional outbreak response methods more complicated, among others.

*Extract*

In the first 10 months of 2015 the total number of asylum applications to the European Asylum Support Office (EASO) recorded by European Union (EU) countries exceeded the 1 million mark, an unprecedented level since the establishment of the EU. Syria has been the most common country of origin of asylum applications, followed by Afghanistan and Iraq.<sup>1</sup> However, these figures do not take unregistered migrants into account: in the same time period, 500 000 undocumented border crossing detections were recorded on the EU's external borders, according to Frontex.<sup>2</sup> In the light of these developments, the European Centre for Disease Prevention and Control (ECDC) assessed the public health needs of migrants or individuals that are applying for asylum or refugee status, through: (i) interviews with 14 experts from Member States and Non-Governmental Organizations with first-hand experience working with migrant populations (7–11 August 2015); (ii) a non-systematic review of available evidence (peer-reviewed publications and relevant ECDC risk assessments); and (c) an expert meeting on the prevention of infectious diseases among newly arrived migrants in the EU and European Economic Area (EEA) (12–13 November 2015).<sup>3–5</sup>

### **Reception system for newly arrived migrants**

A recurrent theme across all the expert consultations conducted by ECDC was the need to establish a reception system for newly arrived migrants. In primary reception centres, a health assessment should be carried out immediately upon arrival. Equipping these reception areas with primary care and public health services facilitates screening, vaccination and treatment (if required) of individuals free of charge. The organisers of reception areas should consider adequately stocking them with rapid tests (e.g. for malaria) and providing instant treatment and

care to patients. Such rapid interventions are the best course of action to detect and prevent onwards spread of cases of infectious disease, through the identification and management of infectious diseases with potential for ...

**ABSTRACT**

Human trafficking is a global problem and constitutes a grave human rights violation, affecting more than 20 million individuals worldwide. This brutal crime often results in both short- and long-term physical and psychological harm to its victims. We provide a systematic review of U.S. laws that address education about human trafficking and/or mandatory reporting requirements that affect healthcare providers and other professionals across the United States. Thirteen U.S. states now have laws that address education about human trafficking, while seven specifically require mandatory reporting of minors who are victims of trafficking. The findings are instructive to not only practicing physicians and other professionals, who are now mandated reporters of trafficking victims in some states, but also to regulatory and legislative bodies contemplating enacting such laws in an effort to address trafficking.

The risk of acquisition and transmission of respiratory tract infections including influenza is considerably enhanced among attendees of the Hajj pilgrimage.<sup>1</sup> Influenza vaccine has been recommended by the Saudi Ministry of Health since 2005 for all pilgrims, particularly for those at increased risk of severe disease.<sup>2</sup> The Saudi Ministry of Health is now seriously considering mandating influenza vaccine for all pilgrims,<sup>3</sup> and the Saudi Thoracic Society has already urged consideration of a “strict vaccination strategy” for Hajj and Umrah visitors.

*Summary*

*Background*

Little information is available about the effect of pneumococcal conjugate vaccines (PCVs) in low-income countries. We measured the effect of these vaccines on invasive pneumococcal disease in The Gambia where the 7-valent vaccine (PCV7) was introduced in August, 2009, followed by the 13-valent vaccine (PCV13) in May, 2011.

*Methods*

We conducted population-based surveillance for invasive pneumococcal disease in individuals aged 2 months and older who were residents of the Basse Health and Demographic Surveillance System (BHDSS) in the Upper River Region, The Gambia, using standardised criteria to identify and investigate patients. Surveillance was done between May, 2008, and December, 2014. We compared the incidence of invasive pneumococcal disease between baseline (May 12, 2008–May 11, 2010) and after the introduction of PCV13 (Jan 1, 2013–Dec 31, 2014), adjusting for changes in case ascertainment over time.

*Findings*

We investigated 14 650 patients, in whom we identified 320 cases of invasive pneumococcal disease. Compared with baseline, after the introduction of the PCV programme, the incidence of invasive pneumococcal disease decreased by 55% (95% CI 30–71) in the 2–23 months age group, from 253 to 113 per 100 000 population. This decrease was due to an 82% (95% CI 64–91) reduction in serotypes covered by the PCV13 vaccine. In the 2–4 years age group, the incidence of invasive pneumococcal disease decreased by 56% (95% CI 25–75), from 113 to 49 cases per 100 000, with a 68% (95% CI 39–83) reduction in PCV13 serotypes. The incidence of non-PCV13 serotypes in children aged 2–59 months increased by 47% (–21 to 275) from 28 to 41 per 100 000, with a broad range of serotypes. The incidence of non-pneumococcal bacteraemia varied little over time.

## Interpretation

The Gambian PCV programme reduced the incidence of invasive pneumococcal disease in children aged 2–59 months by around 55%. Further surveillance is needed to ascertain the maximum effect of the vaccine in the 2–4 years and older age groups, and to monitor serotype replacement. Low-income and middle-income countries that introduce PCV13 can expect substantial reductions in invasive pneumococcal disease.

## Summary

### Background

Dengue is the most common arbovirus infection globally, but its burden is poorly quantified. We estimated dengue mortality, incidence, and burden for the Global Burden of Disease Study 2013.

### Methods

We modelled mortality from vital registration, verbal autopsy, and surveillance data using the Cause of Death Ensemble Modelling tool. We modelled incidence from officially reported cases, and adjusted our raw estimates for under-reporting based on published estimates of expansion factors. In total, we had 1780 country-years of mortality data from 130 countries, 1636 country-years of dengue case reports from 76 countries, and expansion factor estimates for 14 countries.

### Findings

We estimated an average of 9221 dengue deaths per year between 1990 and 2013, increasing from a low of 8277 (95% uncertainty estimate 5353–10 649) in 1992, to a peak of 11 302 (6790–13 722) in 2010. This yielded a total of 576 900 (330 000–701 200) years of life lost to premature mortality attributable to dengue in 2013. The incidence of dengue increased greatly between 1990 and 2013, with the number of cases more than doubling every decade, from 8·3 million (3·3 million–17·2 million) apparent cases in 1990, to 58·4 million (23·6 million–121·9 million) apparent cases in 2013. When accounting for disability from moderate and severe acute dengue, and post-dengue chronic fatigue, 566 000 (186 000–1 415 000) years lived with disability were attributable to dengue in 2013. Considering fatal and non-fatal outcomes together, dengue was responsible for 1·14 million (0·73 million–1·98 million) disability-adjusted life-years in 2013.

## Interpretation

Although lower than other estimates, our results offer more evidence that the true symptomatic incidence of dengue probably falls within the commonly cited range of 50 million to 100 million cases per year. Our mortality estimates are lower than those presented elsewhere and should be considered in light of the totality of evidence suggesting that dengue mortality might, in fact, be substantially higher.

### ***Summary***

The number of infants infected with HIV is declining with the rise in interventions for the elimination of paediatric HIV infection, but the number of uninfected infants exposed to HIV through their HIV-infected mothers is increasing. Interest in the health outcomes of HIV-exposed, uninfected infants has grown in the past decade, with several studies suggesting that these infants have increased mortality rates, increased infectious morbidity, and impaired growth compared with HIV-unexposed infants. However, heterogeneous results might reflect the inherent challenges in studies of HIV-exposed, uninfected infants, which need large populations with appropriate, contemporaneous comparison groups and repeated HIV testing throughout the period of breastfeeding. We review the effects of HIV exposure on mortality, morbidity, and growth, discuss the immunological abnormalities identified so far, and provide an overview of interventions that could be effective in this susceptible population. As the number of infants infected with HIV declines, the health needs of HIV-exposed, uninfected infants should be prioritised further, to ensure that post-2015 Sustainable Development Goals are achieved.

Clinical trials are our best vehicle for turning medical information that we may think is true into evidence that we know, within reasonable limits, to be true. Since the introduction of random assignments to treatment in the 1930s,<sup>1</sup> the clinical trial has been in continuous evolution. Among the major milestones have been the development of methods to perform randomization; the convening of data and safety monitoring committees; the formulation of stopping guidelines for safety, efficacy, and futility; and many others. Indeed, the clinical trial landscape is far different today from what it was over 80 years ago, when investigators first confronted the conundrum of how to obtain unbiased data that could be used to guide clinical practice. Today, trials range from a single person<sup>2</sup> to 100,000 people, from a single lab to hundreds of centers around the world, from simple two-arm randomizations to increasingly complex study designs.

In this issue, we inaugurate a series of articles called “The Changing Face of Clinical Trials,” in which we examine the current challenges in the design, performance, and interpretation of clinical trials. The series will deal with contemporary challenges that affect clinical trialists today. It is not meant to be a course in clinical trial performance; rather, the articles are written by trialists for trialists about issues that face us all. ### **[Maintaining Maternal and Child Health Services During the Ebola Outbreak: Experience from Pujehun, Sierra Leone](#)**

**Background:** During the Ebola outbreak the overall confidence of the population in the national health system declined in Sierra Leone, with a reduction in the use of health services. The objective of this study is to provide information on understanding of how Ebola impacted maternal and child health services in Sierra Leone. Data come from an operational setting which is representative of the communities affected by the outbreak.

**Methods:** By integrating hospital registers and contact tracing form data with healthcare workers and local population interviews, the transmission chain was reconstructed. Data on the utilization of maternal and neonatal health services were collected from the local district's Health Management Information System. The main measures put in place to control the Ebola epidemic were: the organization of a rapid response to the crisis by the local health authorities; triage, contact tracing and quarantine; isolation, clinical management and safe burials; training and community sensitization.

**Results:** A total of 49 case patients were registered between July and November 2014 in the Pujehun district. Hospitalization rate was 89%. Overall, 74.3% of transmission events occurred between members of the same family, 17.9% in the community and 7.7% in hospital. The mean number of contacts investigated per case raised from 11.5 in July to 25 in September 2014. The 2014 admission trend in the pediatric ward shows a decrease after beginning of June: the reduction was almost significant in the period July-December ( $p = 0.05$ ). The admission in the maternity ward showed no statistical differences in comparison with the previous year ( $p = 0.07$ ). Also the number of deliveries appeared to be similar to the previous year, without significant variations ( $p = 0.41$ ).

**Conclusion:** The Ebola outbreak reduced the number of patients at hospital level in Pujehun district. However, the activities undertaken to manage Ebola, reduced the spread of infection and the impact of the disease in mothers and children. A number of reasons which may explain these results are presented and discussed.

#### ***ABSTRACT***

This study first examined the prevalence of psychological symptoms among Syrian refugee children (N = 64) and assessed the effect of an art therapy intervention on post-traumatic stress, depression and anxiety symptoms. The Stressful Life Events (SLE) Questionnaire was used to measure stressful and traumatic experiences. The main outcome measures were UCLA Post-Traumatic Stress Disorder Parent version, Child Depression Inventory and State-Trait Anxiety Scale. After the baseline assessment, a five-day art therapy intervention, which is based on Skills for Psychological Recovery, was implemented. Findings of the study indicated that 60.3% (N = 35) of Syrian children who participated had high risk to develop post-traumatic stress disorder (PTSD) according to the SLE scale. The 23.4% of the children had PTSD symptoms while the 17.6% showed severe depression symptoms. Moreover, the 14.4% of the children showed severe levels of state anxiety symptoms and the 31.1% showed severe levels of trait anxiety symptoms. Findings of the study indicated that trauma, depression and trait anxiety symptoms of children were significantly reduced at the post-assessment. However, for state anxiety scores, significant differences between pre- and post-assessments did not appear. Therefore, it could be said that art therapy may be an effective method to reduce post-traumatic stress disorder, depression and trait anxiety symptoms among refugee children.

## ABSTRACT

The goal of this exploratory study was to identify health problems experienced by children whose mothers are trafficked or in sex work in the U.S. and the proportion of the children who experience these health problems. Participants were adult survivors of sex trafficking and adult women in sex work. They were asked about the health of children whose mothers were trafficked or in sex work but not about their own children. This approach allows participants to discuss sensitive issues but without having to share potentially negative information about their own children. Participants were asked to identify the common and serious health problems among the children based on their observations, to rank the problems in order of seriousness, to estimate the percentages of the children who experience certain health problems, and to identify the causes of death among the children. There were numerous reports of birth defects, fetal alcohol syndrome, blindness, neonatal abstinence syndrome, and physical and sexual abuse. Nearly a third of respondents (31%) knew of the death of a child whose mother was trafficked or in sex work, and 11% reported they knew of the death of a child due to physical abuse. The majority of respondents (89%) reported that some daughters are trafficked into prostitution. The median estimate of the percentage of daughters who are trafficked was 50%. Children born to trafficked adolescents and adult female sex workers in the U.S. are potentially at high risk for many serious and fatal health problems. The magnitude of these health problems is poorly understood but warrant urgent attention.
