<u>Solutions to World's Problems Lie in Upholding Universal Declaration of Human Rights,</u> <u>Secretary-General emphasizes in Observance Message</u>

Following are UN Secretary-General António Guterres' remarks at the high-level event to commemorate the seventieth anniversary of the Universal Declaration of Human Rights, in Marrakesh, Morocco today:

The profound language and the symbolic significance of the Universal Declaration of Human Rights have made it the world's most widely translated document. Its adoption marked the first time that countries had ever come together to recognize that all people, everywhere, share fundamental, inalienable rights.

The economic, social, cultural, civil and political rights enshrined in this foundational document belong to everyone, regardless of race, colour, gender, language, faith or opinion. Over seven decades, the Universal Declaration of Human Rights has inspired millions of women and men to demand their rights and contest the forces of oppression, exploitation, discrimination and injustice. It has given rise to a rich body of legally binding international human rights treaties and it continues to be an inspiration to people around the world.

But the Universal Declaration is much more than a source of inspiration and a statement of principles. Its 30 articles constitute practical measures for advancing peace and inclusive sustainable development. It has given birth to movements by groups of all kinds, from indigenous peoples to persons with disabilities. Its principles are embedded in national legislations and regional treaties, and more than 90 states have enshrined its language in their Constitutions.

No one ever loses their human rights, no matter what they do or who they are. So, it is apt that the first day of this conference to adopt the Global Compact for Migration is taking place on the seventieth anniversary of the General Assembly's adoption of the Universal Declaration.

The Compact is a new and important step towards safety and dignity for millions of people. It sets out in practical terms how Member States and other stakeholders can respect, protect and fulfil the human rights of all migrants, in line with the Universal Declaration.

Seventy years ago, after the Holocaust and the carnage of the Second World War, our forebears drafted 30 articles that lay out the "foundation of freedom, justice and peace in the world". They

hoped the lessons of war would spare their children, and successive generations, from a similar fate. We ignore these lessons and this guidance at our peril.

It saddens me to say that, in this year marking the seventieth anniversary of the Universal Declaration of Human Rights, the human rights agenda is losing ground and authoritarianism is on the rise. People all over the world still endure constraints on — or even total denial — of their human rights. Torture, extrajudicial killings, detention without trial and other egregious human rights violations still persist. Gender inequality remains a pressing issue — with untold women and girls facing daily insecurity, violence and violation of their rights. We are also seeing a groundswell of xenophobia, racism and intolerance, including anti-Semitism and anti-Muslim hatred.

I am particularly concerned about the growth of intolerance and the shrinking space for civil society. Today human rights and their defenders are under increasing pressure in all regions. This will not solve any of the challenges the world faces. The solutions to society's problems lie in staying bound to our shared commitment to uphold the human rights and the inherent dignity and equality of each human being.

Human rights are the cornerstone of State sovereignty; they are a tool to help States and societies grow and be resilient. They help empower women and girls. They help advance development. They help prevent conflict and ensure a just, equitable and prosperous world.

But much remains to be done to make human rights a reality for all. As true custodians of the Universal Declaration of Human Rights, your continued commitment to the rights it enshrines is critical. Let us all keep the beacon of this towering document alight so it can guide us all on the path of peace, dignity, security and opportunity for all. Thank you.

# 70th Anniversary of the Universal Declaration of Human Rights

Statement by UN High Commissioner for Human Rights Michelle Bachelet Geneva (6 December 2018) –

On 10 December, we mark the 70th anniversary of that extraordinary document, the Universal Declaration of Human Rights.

It is, I firmly believe, as relevant today as it was when it was adopted 70 years ago.

Arguably even more so, as over the passing decades, it has passed from being an aspirational treatise into a set of standards that has permeated virtually every area of international law.

It has withstood the tests of the passing years, and the advent of dramatic new technologies and social, political and economic developments that its drafters could not have foreseen...

...Born out of the devastation of two World Wars, the Great Depression of the 1930s, and the Holocaust, the Universal Declaration is geared to prevent similar disasters, and the tyranny and violations which caused them. It sets out ways to prevent us from continuing to harm each other, and aims to provide us with "freedom from fear and want."

It sets limits on the powerful, and inspires hope among the powerless.

Over the seven decades since its adoption, the Universal Declaration has underpinned countless beneficial changes in the lives of millions of people across the world, permeating some 90 national Constitutions and numerous national, regional and international laws and institutions.

But, 70 years after its adoption, the work the Universal Declaration lays down for us to do is far from over. And it never will be.

In 30 crystal-clear articles, the Universal Declaration shows us the measures which will end extreme poverty, and provide food, housing, health, education, jobs and opportunities for everyone.

It lights the path to a world without wars and Holocausts, without torture or famine or injustice. A world where misery is minimized and no one is too rich or powerful to evade justice.

A world where every human has the same worth as every other human, not just at birth but for the duration of their entire lives.

The drafters wanted to prevent another war by tackling the root causes, by setting down the rights everyone on the planet could expect and demand simply because they exist – and to spell out in no uncertain terms what cannot be done to human beings...

I am convinced that the human rights ideal, laid down in this Declaration, has been one of the most constructive advances of ideas in human history — as well as one of the most successful. But today, that progress is under threat.

We are born 'free and equal,' but millions of people on this planet do not stay free and equal. Their dignity is trampled and their rights are violated on a daily basis.

In many countries, the fundamental recognition that all human beings are equal, and have inherent rights, is under attack. The institutions so painstakingly set up by States to achieve common solutions to common problems are being undermined.

And the comprehensive web of international, regional and national laws and treaties that gave teeth to the vision of the Universal Declaration is also being chipped away by governments and politicians increasingly focused on narrow, nationalist interests.

We all need to stand up more energetically for the rights it showed us everyone should have – not just ourselves, but all our fellow human beings – and which we are at constant risk of eroding through our own, and our leaders' forgetfulness, neglect or wanton disregard.

I will end, where the Universal Declaration begins, with the powerful promise – and warning – contained in the first lines of its Preamble:

- "...Recognition of the inherent dignity and of the equal and inalienable rights of all members of the human family is the foundation of freedom, justice and peace in the world.
- "...Disregard and contempt for human rights have resulted in barbarous acts which have outraged the conscience of mankind and the advent of a world in which human beings shall enjoy freedom of

speech and belief, and freedom from fear and want has been proclaimed as the highest aspiration of the common people.

"...It is essential, if man is not to be compelled to have recourse as a last resort to rebellion against tyranny and oppression that human rights should be protected by the rule of law."

And we would do well to pay more attention to the final words of that same Preamble:

"...every individual and every organ of society keeping this Declaration constantly in mind shall strive by teaching and education to promote respect for these rights and freedoms and by progressive measures, national and international, to secure their universal and effective recognition and observance both among the peoples of Member States themselves and among the peoples of territories under their jurisdiction."

We have come a long way down this path since 1948. We have taken many of progressive measures prescribed by the Universal Declaration at the national and international levels.

But we still have a long way to go, and too many of our leaders seem to have forgotten these powerful and prophetic words. We need to rectify that, not just today, not just on the 70th anniversary next Monday, but every day, every year.

Human rights defenders the world over are on the frontlines of defending the Universal Declaration through their work, their dedication and their sacrifice. No matter where we live or what our circumstances are, most of us do have the power to make a difference – to make our homes, communities, countries, and our world better – or worse – for others. Each of us needs to do our part to breathe life into the beautiful dream of the Universal Declaration.

For this was the gift of our ancestors, to help us avoid ever having to go through what they went through.

The Universal Declaration of Human Rights (UDHR) was adopted by the UN General Assembly at the Palais de Chaillot in Paris three years after the end of World War II. It was the product of 18 months' work by a drafting committee, with members and advisers from all across the world, and – in the words of one of its principal architects, René Cassin – "at the end of one hundred sessions of elevated, often impassioned discussion, was adopted in the form of 30 articles on December 10, 1948."

On International Human Rights Day, we recommit ourselves towards meeting the shared commitments of the Universal Declaration of Human Rights, reiterate our offer of assistance to those in need, and call on every country to respect the human rights and dignity of all people.

# <u>We are former senators. The Senate has long stood in defense of democracy — and must</u> again

### Dear Senate colleagues,

As former members of the U.S. Senate, Democrats and Republicans, it is our shared view that we are entering a dangerous period, and we feel an obligation to speak up about serious challenges to the rule of law, the Constitution, our governing institutions and our national security.

We are on the eve of the conclusion of special counsel Robert S. Mueller III's investigation and the House's commencement of investigations of the president and his administration. The likely convergence of these two events will occur at a time when simmering regional conflicts and global power confrontations continue to threaten our security, economy and geopolitical stability. It is a time, like other critical junctures in our history, when our nation must engage at every level with strategic precision and the hand of both the president and the Senate.

We are at an inflection point in which the foundational principles of our democracy and our national security interests are at stake, and the rule of law and the ability of our institutions to function freely and independently must be upheld.

During our service in the Senate, at times we were allies and at other times opponents, but never enemies. We all took an oath swearing allegiance to the Constitution. Whatever united or divided us, we did not veer from our unwavering and shared commitment to placing our country, democracy and national interest above all else.

At other critical moments in our history, when constitutional crises have threatened our foundations, it has been the Senate that has stood in defense of our democracy. Today is once again such a time. Regardless of party affiliation, ideological leanings or geography, as former members of this great body, we urge current and future senators to be steadfast and zealous guardians of our democracy by ensuring that partisanship or self-interest not replace national interest.

World Leaders Adopt First-Ever Global Compact on Migration, Outlining Framework to Protect Millions of Migrants, Support Countries Accommodating Them

MARRAKECH, Morocco, 10 December — World leaders adopted the Global Compact for Safe, Orderly and Regular Migration today, laying out the first-ever global cooperation framework for sharing responsibility to protect the world's 258 million people on the move — 3.4 per cent of its population — and supporting the host communities working to accommodate them...

# The Global Compact for Safe, Orderly and Regular Migration

The Global Compact for Migration is the first-ever UN global agreement on a common approach to international migration in all its dimensions. The global compact is non-legally binding. It is grounded in values of state sovereignty, responsibility-sharing, non-discrimination, and human rights, and recognizes that a cooperative approach is needed to optimize the overall benefits of migration, while addressing its risks and challenges for individuals and communities in countries of origin, transit and destination.

The global compact comprises 23 objectives for better managing migration at local, national, regional and global levels. The compact:

- :: aims to mitigate the adverse drivers and structural factors that hinder people from building and maintaining sustainable livelihoods in their countries of origin;
- :: intends to reduce the risks and vulnerabilities migrants face at different stages of migration by respecting, protecting and fulfilling their human rights and providing them with care and assistance;

:: seeks to address the legitimate concerns of states and communities, while recognizing that societies are undergoing demographic, economic, social and environmental changes at different scales that may have implications for and result from migration;

:: strives to create conducive conditions that enable all migrants to enrich our societies through their human, economic and social capacities, and thus facilitate their contributions to sustainable development at the local, national, regional and global levels.

The list of the 23 objectives can be found in paragraph 16 of the Global Compact for Migration:

# Objectives for Safe, Orderly and Regular Migration

- ...16. With the New York Declaration for Refugees and Migrants we adopted a political declaration and a set of commitments. Reaffirming that Declaration in its entirety, we build upon it by laying out the following cooperative framework comprised of 23 objectives, implementation, as well as follow-up and review. Each objective contains a commitment, followed by a range of actions considered to be relevant policy instruments and best practices. To fulfil the 23 objectives, we will draw from these actions to achieve safe, orderly and regular migration along the migration cycle.
  - (1) Collect and utilize accurate and disaggregated data as a basis for evidence-based policies
  - (2) Minimize the adverse drivers and structural factors that compel people to leave their country of origin
  - (3) Provide accurate and timely information at all stages of migration
  - (4) Ensure that all migrants have proof of legal identity and adequate documentation
  - (5) Enhance availability and flexibility of pathways for regular migration
  - (6) Facilitate fair and ethical recruitment and safeguard conditions that ensure decent work
  - (7) Address and reduce vulnerabilities in migration
  - (8) Save lives and establish coordinated international efforts on missing migrants
  - (9) Strengthen the transnational response to smuggling of migrants
  - (10) Prevent, combat
  - (11) Manage borders in an integrated, secure and coordinated manner
  - (12) Strengthen certainty and predictability in migration procedures for appropriate screening, assessment and referral
  - (13) Use migration detention only as a measure of last resort and work towards alternatives
  - (14) Enhance consular protection, assistance and cooperation throughout the migration cycle
  - (15) Provide access to basic services for migrants
  - (16) Empower migrants and societies to realize full inclusion and social cohesion
  - (17) Eliminate all forms of discrimination and promote evidence-based public discourse to shape perceptions of migration
  - (18) Invest in skills development and facilitate mutual recognition of skills, qualifications and competences
  - (19) Create conditions for migrants and diasporas to fully contribute to sustainable development in all countries
  - (20) Promote faster, safer and cheaper transfer of remittances and foster financial inclusion of migrants
  - (21) Cooperate in facilitating safe and dignified return and readmission, as well as sustainable reintegration
  - (22) Establish mechanisms for the portability of social security entitlements and earned

benefits

(23) Strengthen international cooperation and global partnerships for safe, orderly and regular migration

### Sweden suspends funding for UN Aids agency as Britain urged to follow suit

Swedish minister calls for Michel Sidibé to step down after report alleging harassment and favouritism at agency

The Swedish government has announced it is to withhold funding to a UN agency until its director resigns in a row over his "dysfunctional leadership".

UNAids, which spearheads the global fight against Aids and HIV, will receive no further funding until its executive director, Michel Sidibé, stands down, said Isabella Lövin, Sweden's minister for international development cooperation and climate.

The warning follows a scathing report that condemned a patriarchal culture within the organisation. Britain has been attacked by campaigners for not taking a similarly strong stance. The UK's Department for International Development (DfID), is also a key donor.

Sweden, UNAid's second biggest donor after the US, <u>contributed 260m Swedish krona</u> (£22m) in 2017.

UNAids was thrown into an unprecedented crisis after an independent review <u>released on Friday</u> warned of "a patriarchal culture tolerating harassment and abuse of authority".

Calling for a change of leadership, the report said Sidibé had set a tone of "favouritism, preferment, opaqueness, license for wrongdoing, and retaliation against those who speak up against such practices".

The report, commissioned following multiple allegations of sexual harassment and bullying, is being discussed by the agency's oversight body, the Programme Coordinating Board (PCB), this week.

During the session, which began on Tuesday, Sidibé announced that the next board meeting, in June 2019, would be his last, but did not specify when he plans to step down...

# <u>UNAIDS Board calls for immediate implementation of UNAIDS agenda for change</u> *Press release*

GENEVA, 13 December 2018—The UNAIDS Programme Coordinating Board (PCB) has called on UNAIDS to fully implement the management response (<u>UNAIDS agenda for change</u>) to address harassment, including sexual harassment, bullying and abuse of power, at the UNAIDS Secretariat which was presented to Board members by the Executive Director of UNAIDS on Tuesday 11 December.

The decision was agreed by the members of the PCB at the conclusion of the 43rd meeting of the PCB in Geneva, Switzerland, today. The PCB agreed to establish a working group to oversee the immediate implementation of the management response and to discuss the report of the Independent Expert Panel in a special PCB meeting before March 2019. The PCB also welcomed the statement of the

UNAIDS Secretariat Staff Association and the critical role they played in bringing to the PCB's attention the issue of harassment at the workplace.

"We don't have a moment to lose in moving forward our management response. Our actions will make UNAIDS stronger and better," said Michel Sidibé, Executive Director of UNAIDS. "I look forward to working with all staff to make UNAIDS a model workplace for staff in all their diversity. I look forward to an inclusive, transparent and open dialogue and collaboration with staff in shaping a new UNAIDS."

The Executive Director of UNAIDS also told the PCB that he wanted to have an orderly transition of leadership at UNAIDS in the final year of his term. He informed the UNAIDS Board that its meeting in June 2019 would be his last Board meeting and he would complete his duties at the end of June 2019.

"I am proud of the successes of UNAIDS. In the past 10 years we have been instrumental in saving millions of lives and averting millions of new HIV infections. The staff of UNAIDS are our greatest asset and I am privileged to serve alongside them," said Mr Sidibé. "I will work to ensure a smooth transition and pledge to keep my focus on our staff and delivering results for the people we serve."

UNAIDS' agenda for change will be critical in ensuring that the staff of UNAIDS can continue to build on these successes and deliver maximum results for people living with and affected by HIV. It focuses on five action areas: a staff-centred approach, compliance and standards, leadership and governance, management and capacity. Each area outlines key actions that the UNAIDS Secretariat will undertake.

UNAIDS reiterates its commitment to lead by example in eliminating all forms of harassment, bullying and abuse of power by creating a respectful, transparent and accountable environment that enables all staff to contribute their full potential to deliver for the people they serve.

# Agenda item 3: Prevention of and response to harassment, including sexual harassment, bullying and abuse of power at the UNAIDS Secretariat

- 5.1 *Recognizes* the important contribution and commitment of the UNAIDS Secretariat staff to implement the UNAIDS Strategy and support Member States to achieve the 2016 Political Declaration on Ending AIDS;
- 5.2 *Commits* to zero tolerance against harassment, including sexual harassment, bullying and abuse of power to ensure the highest standards in order to create an exemplary workplace in the UNAIDS Secretariat;
- 5.3 *Welcomes* the earlier request of the Executive Director to establish the Independent Expert Panel (IEP) on prevention of and response to harassment, including sexual harassment, bullying and abuse of power at the UNAIDS Secretariat;
- 5.4 *Recalls* that the PCB endorsed the steps taken by the PCB Bureau in response to this request and agreed that the priority should be for the IEP to be enabled and empowered to provide an authoritative review and a comprehensive set of recommendations pertaining to harassment, including sexual harassment, bullying and abuse of power at the UNAIDS Secretariat;
- 5.5 Notes that the IEP has presented its report and recommendations to the PCB;
- 5.6 Notes that the UNAIDS Secretariat has presented its Management Response to the PCB;
- 5.7 *Welcomes* the statement by the UNAIDS Secretariat Staff Association (USSA), and *recognizes* the critical role of the USSA in bringing the PCB's attention to this important issue;
- 5.8 *Highlights* both, the limited circulation time of these important reports and the divergent, varied and differing views expressed by the PCB members and observers;
- 5.9 *Emphasizes* that there is consensus on the need for action to address harassment, including sexual harassment, bullying and abuse of power;

# 5.10 *Recognizes* with remorse the negative impact of harassment, including sexual harassment, bullying and abuse of power on the staff of the UNAIDS Secretariat and their ability to deliver on the critical mandate of the Joint Programme;

- 5.11 *Notes* that some of the recommendations of the IEP and the Management Response have broader implications for the United Nations system;
- 5.12 *Notes* that, as part of the Joint Programme's commitment to transparency and accountability, the IEP report is in the public domain and has been transmitted to the UN Secretary-General by the UNAIDS Secretariat;
- 5.13 *Decides* that, at a special session of the PCB no later than March 2019, the PCB after complete consideration of the IEP report may elect or choose to bring specific recommendations to the attention of the UN Secretary-General;

5.14 *Decides* to establish a working group of the PCB to oversee the immediate implementation of the management response and to further review the conclusions and recommendations contained in the IEP report, and the management response, proposing options to the next PCB meeting, for strengthening the PCB's monitoring and evaluation role on the UNAIDS Secretariat with the view of ensuring zero tolerance against harassment, including sexual harassment, bullying and abuse of power at the UNAIDS Secretariat;

#### 5.15 Calls on the UNAIDS Secretariat to:

a. Fully implement the actions set out in the Management Response, and develop a more detailed, fully costed Management Action plan, complete with review mechanisms and timeline, with regards to the IEP recommendations, which are under its responsibility, in a robust, measurable, timely and ambitious way for consideration by the PCB by intersessional decision making;

# b. Operate to the highest standards to tackle harassment, including sexual harassment, bullying and abuse of power;

c. Provide a Progress Report to the next regular session of the PCB on the implementation of the above actions;

# <u>UNICEF's Innovation Fund announces first cohort of blockchain investments in emerging</u> markets

Press release

New York/ 10 December 2018 - Six companies in developing and emerging economies will receive investment from UNICEF's Innovation Fund to solve global challenges using blockchain technology.

The UNICEF Innovation Fund will invest up to \$100,000 USD in the six companies; <u>Atix Labs</u>, <u>Onesmart, Prescrypto, Statwig, Utopixar</u> and <u>W3 Engineers</u> to deliver open-source prototypes of blockchain applications within 12-months.

Selected from more than 100 applications across 50 countries, these six companies will build prototypes and systems for global problems like transparency in health-care delivery, affordable access to mobile phone connectivity, and the ability to direct finances and resources to social-impact projects. They join 20 other technology startups currently under management by the Fund in fields from data science and machine learning, to virtual reality, to drones.

"Blockchain technology is still at an early stage -- and there is a great deal of experimentation, failure, and learning ahead of us as we see how, and where, we can use this technology to create a better world," said Chris Fabian, Principal Adviser, UNICEF Innovation. "That's exactly the stage when UNICEF Innovation Fund invests: when our financing, technical support, and focus on vulnerable populations can help a technology grow and mature in the most fair and equitable way possible."

- :: Atix Labs (Argentina) will develop a platform for small to medium-sized enterprises to gain access to funding while creating traceability into where the funds are used and measuring the impact.
- :: Onesmart (Mexico) will address the misappropriation of funds in emerging markets with the scale of its prototype application, which ensures the delivery of state-provided social services to children and young people.
- ::Prescrypto (Mexico) will provide a digital solution to the lack of electronic prescriptions in developing countries with a platform that allows medical services providers to view one common history of a patient, and improve the level of care.
- :: Statwig (India) will use blockchain solutions to ensure the efficient delivery of vaccines through an enhanced supply-chain management system.
- :: Utopixar (Tunisia) will deliver a social collaboration tool for communities and organisations to facilitate participative decision-making and value transfer.

W3 Engineers (Bangladesh), will improve connectivity within the refugee and migrant communities through an offline mobile networking platform without the use of sim cards and internet connection. These investments are part of UNICEF's larger blockchain explorations of using smart-contracts for organizational efficiencies, creating distributed decision-making processes, and working to build knowledge and understanding of distributed ledger technology both in the United Nations and in the countries where UNICEF works.

In addition to funding the start-up companies, UNICEF's Innovation Fund will provide product and technology assistance, support with business growth, and access to a network of experts and partners. The Fund also actively seeks second-round investment and support for companies it has invested in, as well as the opportunity to scale-up these technologies, when they are successful, in the more than 190 countries and territories where UNICEF operates...

# Gavi and Germany partner to harness blockchain technology

German government and the Vaccine Alliance to explore the application of blockchain technology to increase efficiency of immunisation programmes.

Abu Dhabi, 11 December 2018 – Gavi, the Vaccine Alliance and the German Federal Ministry for Economic Cooperation and Development (BMZ), through the KfW Development Bank, announced at Gavi's high-level 2018 <a href="mid-term review">mid-term review</a> conference in Abu Dhabi, UAE, that they will partner to explore the application of blockchain technology to Gavi's cash support and supply chain management systems.

Before a vaccine can protect a child, immunisation programmes involve complex planning and procedures. Outdated vaccine supply and distribution systems can delay and limit the impact that vaccines have on people's health. BMZ, KfW and Gavi recognise that blockchain technology could radically transform health systems by reducing wastage and creating trust amongst development partners, funders and countries.

"Blockchain technology could help us understand in real-time all the steps taken while a vaccine is being delivered," said Dr Seth Berkley, CEO of Gavi, the Vaccine Alliance. "This technology has the potential to increase efficiency and reduce costs for developing countries but, most importantly, it could save lives."

Nearly 30 million sick and premature newborns in dire need of treatment every year Global coalition calls for better care and stronger legislation to save babies on the brink of death NEW DELHI/ GENEVA /NEW YORK, 13 December 2018: Nearly 30 million babies are born too soon, too small or become sick every year and need specialized care to survive, according to a new report by a global coalition that includes UNICEF and the World Health Organization (WHO).

"When it comes to babies and their mothers, the right care at the right time in the right place can make all the difference," said Omar Abdi, UNICEF Deputy Executive Director. "Yet millions of small and sick babies and women are dying every year because they simply do not receive the quality care that is their right and our collective responsibility."

The report, <u>Survive and Thrive: Transforming care for every small and sick newborn</u>, finds that among the newborn babies most at risk of death and disability are those with complications from prematurity, brain injury during childbirth, severe bacterial infection or jaundice, and those with congenital conditions. Additionally, the financial and psychological toll on their families can have detrimental effects on their cognitive, linguistic and emotional development.

"For every mother and baby, a healthy start from pregnancy through childbirth and the first months after birth is essential," said Dr Soumya Swaminathan, Deputy Director General for Programmes at WHO. "Universal health coverage can ensure that everyone – including newborns – has access to the health services they need, without facing financial hardship. Progress on newborn health care is a winwin situation – it saves lives and is critical for early child development thus impacting on families, society, and future generations."

Without specialized treatment, many at-risk newborns won't survive their first month of life, according to the report. In 2017, some 2.5 million newborns died, mostly from preventable causes. Almost two-thirds of babies who die were born premature. And even if they survive, these babies face chronic diseases or developmental delays. In addition, an estimated 1 million small and sick newborns survive with a long-term disability.

With nurturing care, these babies can live without major complications. The report shows that by 2030, in 81 countries, the lives of 2.9 million women, stillborns and newborns can be saved with smarter strategies. For example, if the same health team cares for both mother and baby through labour, birth and beyond, they can identify problems early on.

In addition, almost 68 per cent of newborn deaths could be averted in 2030 with simple fixes such as exclusive breastfeeding; skin-to-skin contact between the mother or father and the baby; medicines and essential equipment; and access to clean, well-equipped health facilities staffed by skilled health

workers. Other measures like resuscitating a baby who cannot breathe properly, giving the mother an injection to prevent bleeding, or delaying the cutting of the umbilical cord could also save millions.

According to the report, the world will not achieve the global target to achieve health for all unless it transforms care for every newborn. Without rapid progress, some countries will not meet this target for another 11 decades. To save newborns, the report recommends:

- :: Providing round-the-clock inpatient care for newborns seven days a week.
- :: Training nurses to provide hands-on care working in partnership with families.
- :: Harnessing the power of parents and families by teaching them how to become expert caregivers and care for their babies, which can reduce stress, help babies gain weight and allow their brains to develop properly.
- :: Providing good quality of care should be a part of country policies, and a lifelong investment for those who are born small or sick.
- :: Counting and tracking every small and sick newborn allows managers to monitor progress and improve results.
- :: Allocating the necessary resources, as an additional investment of US\$ 0.20 cents per person can save 2 of every 3 newborns in low- and middle-income countries by 2030.

Almost three decades ago, the <u>Convention on the Rights of the Child</u> guaranteed every newborn the right to the highest standard of health care, and it is time for countries around the world to make sure the legislative, medical, human and financial resources are in place to turn that right into a reality for every child, the report says.

<u>Associations between sex work laws and sex workers' health: A systematic review and meta-analysis of quantitative and qualitative studies</u>

Sex workers are at disproportionate risk of violence and sexual and emotional ill health, harms that have been linked to the criminalisation of sex work. We synthesised evidence on the extent to which sex work laws and policing practices affect sex workers' safety, health, and access to services, and the pathways through which these effects occur...

Together, the qualitative and quantitative evidence demonstrate the extensive harms associated with criminalisation of sex work, including laws and enforcement targeting the sale and purchase of sex, and activities relating to sex work organisation. There is an urgent need to reform sex-work-related laws and institutional practices so as to reduce harms and barriers to the realisation of health.

- :: To our knowledge there has been no evidence synthesis of qualitative and quantitative literature examining the impacts of criminalisation on sex workers' safety and health, or the pathways that realise these effects.
- :: This evidence is critical to informing evidenced-based policy-making, and timely given the growing interest in models of decriminalisation of sex work or criminalising the purchase of sex (the latter recently introduced in Canada, France, Northern Ireland, Republic of Ireland, and Serbia).

### What did the researchers do and find?

- :: We undertook a mixed-methods review comprising meta-analyses and qualitative synthesis to measure the magnitude of associations, and related pathways, between criminalisation and sex workers' experience of violence, sexual (including HIV and sexually transmitted infections [STIs]) and emotional health, and access to health and social care services.
- :: We searched bibliographic databases for qualitative and quantitative research, categorising lawful and unlawful police repression, including criminal and administrative penalties within different legislative models.
- :: Meta-analyses suggest that on average repressive policing practices of sex workers were associated with increased risk of sexual/physical violence from clients or other partners across 9 studies and 5,204 participants.
- :: Sex workers who had been exposed to repressive policing practices were on average at increased risk of infection with HIV/STI compared to those who had not, across 12,506 participants from 11 studies. Repressive policing of sex workers was associated with increased risk of condomless sex across 9,447 participants from 4 studies.
- :: The qualitative synthesis showed that in contexts of any criminalisation, repressive policing of sex workers, their clients, and/or sex work venues disrupted sex workers' work environments, support networks, safety and risk reduction strategies, and access to health services and justice. It demonstrated how policing within all criminalisation and regulation frameworks exacerbated existing marginalisation, and how sex workers' relationships with police, access to justice, and negotiating powers with clients have improved in decriminalised contexts.

#### What do these findings mean?

- :: The quantitative evidence clearly shows the association between repressive policing within frameworks of full or partial sex work criminalisation—including the criminalisation of clients and the organisation of sex work—and adverse health outcomes.
- :: Qualitative evidence demonstrates how repressive policing of sex workers, their clients, and/or sex work venues deprioritises sex workers' safety, health, and rights and hinders access to due process of law. The removal of criminal and administrative sanctions for sex work is needed to improve sex workers' health and access to services and justice.
- :: More research is needed in order to document how criminalisation and decriminalisation interact with other structural factors, policies, and realities (e.g., poverty, housing, drugs, and immigration) in different contexts, to inform appropriate interventions and advocacy alongside legal reform.

# <u>Tanzania is first African country to reach an important milestone in the regulation of</u> medicines

News Release

Brazzaville / 10 December 2018: Tanzania is the first confirmed country in Africa to achieve a well-functioning, regulatory system for medical products according to the World Health Organization (WHO). This means that the Tanzania Food and Drug authority (TFDA) has made considerable improvements in recent years in ensuring medicines in the healthcare system are of good quality, safe and produce the intended health benefit.

"This is a major African milestone and we are very proud of Tanzania's achievement, which we hope will inspire other countries in the region," says Dr Matshidiso Moeti, WHO Regional Director for Africa. "Access to medicines alone, without quality assurance, is not enough. With this milestone Tanzania makes a big step towards improving the quality of its health care services."

Medicines are used to prevent illnesses and treat diseases, helping many people to lead full and productive lives. However, if produced, stored or transported improperly, if falsified, or used incorrectly or abused, medicines can be hazardous and can lead to hospitalization and even death. For these reasons, it is important to have effective regulatory systems that also serve to promote timely access to quality medicines.

Fewer than 30% of the world's medicines regulatory authorities are considered to have the capacity to perform the functions required to ensure medicines, vaccines and other health products actually work and do not harm patients. For that reason, WHO and African governments have intensified efforts to bolster the capacity of regulating medicines in the region.

Over the past years WHO has been supporting African countries, including Tanzania to strengthen their regulatory entities.

"The core of WHO's work is to empower countries through support and knowledge transfer so that they can expand access to health services for their populations," says Mariangela Simao, WHO Assistant Director General for Access to Medicines, Vaccines and Pharmaceuticals. "If countries want to improve health outcomes, they first need to ensure access to safe and quality medical products that actually work and benefit patients."...

Oral health care is deemed important by the parents, however, the target group experiences barriers accessing oral hygiene. This is particularly important when refugee children first arrive in their new country.

Fifty to 90% of children globally are affected by dental caries. Refugee children are at increased risk of poor oral health due to the adversity they have experienced early in life. The aim of this review is to report the oral health status of children of refugee background resettled in high-income refugee-receiving countries and to describe the oral health beliefs, knowledge and practices of them and their families, as well as oral health interventions taking place in such countries. Twelve studies were identified that reported on the oral health of children of likely refugee background or their parents out of which only one study an oral healthcare professional was involved in the screening. Evidence surrounding the current oral health status of resettled refugee children is limited. Parents acknowledged the importance of maintaining good oral practices, however, barriers in accessing traditional forms of oral hygiene were noted. All studies suggest that there is a high need for dental care when children first arrive in their new country. Impact of interventions was not reported in the studies reviewed.

Seeded by \$125 million donation by the late Paul G. Allen, the Allen Institute for Immunology will study human immune health, cancer, and autoimmune diseases

The Allen Institute today announced the launch of the Allen Institute for Immunology, a new division of the Institute that is dedicated to studying the human immune system. Seeded by a generous commitment of \$125 million by Allen Institute founder, the late Paul G. Allen, the new Institute will work to understand the dynamic balancing act of the human immune system, how it senses friend from foe and what goes wrong when we're ill.

"Paul Allen always challenged us to go after the really hard problems, to do work that would have a significant impact in our scientific fields," said Allan Jones, Ph.D., President and Chief Executive Officer of the Allen Institute. "Understanding the human immune system in detail and figuring out what goes wrong in disease is an incredibly complex but solvable problem. I'm thrilled to see us launch into this new area of complexity in biology with a real opportunity to directly impact human health."

The Allen Institute for Immunology's goal is to improve human immune health and lay the groundwork for better ways to diagnose, treat and prevent immune-related diseases. In its initial phase, the Institute will focus on studies of two cancers, multiple myeloma and melanoma, and three autoimmune disorders, rheumatoid arthritis and inflammatory bowel disease, specifically, ulcerative colitis and Crohn's disease. The researchers will also take a deep dive into the immune systems of healthy volunteers with the goal of understanding what makes a "normal" immune baseline and how to help patients return to that healthy state.

Thomas F. Bumol, Ph.D., is the Executive Director for the Allen Institute for Immunology. Bumol joins the Institute from Lilly Research Laboratories where he worked for more than 35 years, most recently as Senior Vice-President of the Biotechnology and Immunology Research component and the Site Head of Lilly's Biotechnology Center of San Diego. His work at Lilly focused on drug discovery and early clinical development of treatments for many disease areas including diabetes, pain and immune-related diseases such as psoriasis, lupus, rheumatoid arthritis and inflammatory bowel disease.

"By unraveling the mysteries of the dynamic immune system in healthy individuals and focusing the same cutting-edge tools on patients in various disease states, we believe we will find new ways to diagnose and ultimately treat disease," Bumol said. "We are looking at problems that have large unmet needs. Patients are not only suffering from these immune-based illnesses, patients are dying from some of these disorders, and we would like to change that."

### A long-term effort to understand the role of marine microbes in the world's oceans

Fifteen years ago, ocean scientists were wrestling with a fundamental ecological challenge: how can we catalog the tremendous microbial diversity in the world's oceans and begin to comprehend how these microbes affect global nutrient cycles? At the same time, the life sciences were entering a new era of DNA sequencing and genomics, expanding possibilities for scientific research – including for the nascent field of marine microbial ecology. Through conversations with pioneers inside and outside the field, an opportunity was identified: to apply these new sequencing tools to advance knowledge of marine microbial communities and reveal how they support and influence ocean ecosystems. In 2004, our Marine Microbiology Initiative was launched, becoming the first initiative of the foundation's Science Program.

"When we started the foundation, we knew we wanted to support basic scientific research and select an area where we could have a significant impact," said Ken Moore, foundation trustee. "Our path to marine microbiology was a confluence of new technology that could accelerate science and an opportunity to support a field that was not well funded, so we took a chance. We also saw the longterm potential for research in this field to benefit other areas of science, including the environment."

### Philanthropy: A Critical Player in Supporting Scientific Research [Alliance blog]

Marc Kastner is president of the Science Philanthropy Alliance

As former dean of science at MIT and now as president of the Science Philanthropy Alliance, I have spent a lot of time thinking about how to support the best, most innovative science. The role that various funders, including government, industry, academia, and philanthropy play in funding scientific research is thus very important to me.

Three authors have recently published books questioning philanthropists' influence in our society. David Callahan, author of "The Givers," discusses the sway of big philanthropy. Anand Giriharadas, author of "Winners Take All," says that philanthropy may simply be a way for the rich to preserve the status quo. Rob Reich, in "Just Giving: Why Philanthropy is Failing Democracy and How It Can Do Better," considers how philanthropy can undermine democratic values.

What about philanthropic funding of scientific research? Is science philanthropy, and specifically philanthropy to support basic science, as negative a story as these authors claim for philanthropy as a whole? My experience tells me that that this is not the case, that philanthropy plays a critical role in funding science...

## **Economic evaluations in community aged care: a systematic review**

This paper reports the methods and findings from a systematic review of economic evaluations conducted in the community aged care sector between 2000 and 2016...

Eleven studies reporting upon economic evaluations of service delivery interventions in community aged care were identified; the majority of which were undertaken in Europe. Critical appraisal of the identified studies highlighted the methodological rigour in these evaluations.

This systematic review highlights the paucity of economic evaluation studies conducted to date in the community aged care sector. The findings highlight the importance of cost utility analysis methodology as it allows for a uniform outcome measure, that facilitates the comparison of different interventions. In addition, multi-attribute utility measures that represent those quality of life domains that are most important to older people should be used and attention must be paid to the inclusion of informal care costs and outcomes as this is a key resource in community aged care service delivery.

# **Pharmacovigilance: An Overview**

Abstract Purpose

Pharmacovigilance (PV) is a relatively new discipline in the pharmaceutical industry. Having undergone rapid growth over the past 2 decades, PV now touches many other disciplines in the research and development enterprise. With its growth has come a heightened awareness and interest in the medical community about the roles that PV plays. This article provides insights into the background and inner workings of PV.

Methods

This narrative review covers the core PV activities and other major areas of the pharmaceutical enterprise in which PV makes significant contributions.

**Findings** 

Drug safety monitoring activities were organized by the US Food and Drug Administration and academic medical centers in the early 1950s in response to growing concern over the occurrence of aplastic anemia and other blood dyscrasias associated with the use of chloramphenicol. This experience was codified in the 1962 Kefauver-Harris Amendments to the Federal Food, Drug and Cosmetic Act as adverse event evaluation and reporting requirements. The ensuing decades have seen the development of core PV functions for pharmaceutical companies: case management, signal management, and benefit-risk management. A broader scope of PV has developed to include the following major activities: support of patient safety during the conduct of clinical trials through assuring proper use of informed consent and institutional review boards (ethics committees); selection of the first safe dose for use in humans, based on pharmacologic data obtained in animal studies; development of the safety profile for proper use of a new molecular entity and appropriate communication of that information to the range of relevant stakeholders; attendance to surveillance activities through a set of signal management processes; monitoring the manufactured product itself through collaborative activities with manufacturing professionals; management of benefit-risk to assure appropriate use in medical care after marketing; and maintenance of inspection readiness as a corporate cultural process.

## **Implications**

The extent and pace of change promise to accelerate with the integration of biomedical informatics, analytics, artificial intelligence, and machine learning. This progress has implications for the development of the next generation of PV professionals who will need to be trained in entirely new skill sets to lead continued improvements in the safe use of pharmaceuticals.

<u>Projecting future demand for informal care among older people in China: the road towards a sustainable long-term care system</u>

**Abstract** 

The long-term care system in China relies heavily on informal care provided by family members. This study makes projections on the demand for informal care among Chinese older people between 2015 and 2035 and quantifies the level of long-term care resources needed to meet their needs. The data come from longitudinal information in a nationally representative sample, China Health and Retirement Longitudinal Survey 2011 and 2013. The macrosimulation approach (PSSRU model) and the Markov approach are integrated into one Bayesian modelling framework. The Monte Carlo simulation technique is used to capture parameter uncertainty. We project that the demand for informal care will increase from 41.3 million people (95% CI: 39.9–42.7) in 2015 to 82.6 million people (95% CI: 78.3–86.9) in 2035. The long-term care system faces unbalanced pressure of demand for informal care from different groups of older people. The projected demand is sensitive to changes in older people's disability trajectory and the availability of formal care provided by the government, but less sensitive to an increase in singleton households in the future. We discuss possible policy measures to alleviate the mounting pressure on the demand for informal care.

# <u>Trends in ageing and ageing-in-place and the future market for institutional care:</u> <u>scenarios and policy implications</u>

Abstract

In several OECD countries the percentage of elderly in long-term care institutions has been declining as a result of ageing-in-place. However, due to the rapid ageing of population in the next decades future demand for institutional care is likely to increase. In this paper we perform a scenario analysis to examine the potential impact of these two opposite trends on the demand for institutional elderly care in the Netherlands. We find that the demand for institutional care first declines as a result of the expected increase in the number of low-need elderly that age-in-place. This effect is strong at first but then peters out. After this first period the effect of the demographic trend takes over, resulting in an increase in demand for institutional care. We argue that the observed trends are likely to result in a growing mismatch between demand and supply of institutional care. Whereas the current stock of institutional care is primarily focussed on low-need (residential) care, future demand will increasingly consist of high-need (nursing home) care for people with cognitive as well as somatic disabilities. We discuss several policy options to reduce the expected mismatch between supply and demand for institutional care.

# Rohingya refugees in Bangladesh: the humanitarian response

More than 700,000 Rohingya refugees have arrived in Bangladesh since 25 August 2017 fleeing violence and persecution in Rakhine State, Myanmar. Over a million are sheltering in overcrowded camps without adequate assistance or protection. Stateless in Myanmar and denied refugee status in Bangladesh, the Rohingya have few rights or freedoms. Monsoons and cyclones are causing landslides, destroying shelters and infrastructure and disrupting services.

This edition of Humanitarian Exchange focuses on the humanitarian response to the Rohingya crisis. In the lead article, <u>Mark Bowden</u> outlines the historical, local and national political context in Bangladesh, and its operational implications. <u>Amal de Chickera</u> highlights the links between statelessness and displacement, and the international community's failure to prioritise human rights in its dealings both with Bangladesh and with Myanmar. <u>Puttanee Kangkun and John Quinley</u> document the persistent persecution and denial of rights the Rohingya have faced for decades. <u>Jeff Crisp</u> reflects on the premature, involuntary and unsafe return of Rohingya refugees to Myanmar in the 1970s and 1990s, and asks whether this could happen again.

Sally Shevach and colleagues explore how the 'localisation' agenda has influenced the operational response, and Kerrie Holloway draws on research by the Humanitarian Policy Group to test the common assumption that local actors necessarily have a better understanding of people's needs. Nasif Rashad Khan and colleagues and Ashish Banik reflect on their experiences of engaging with the international humanitarian response system. Margie Buchanan-Smith and Marian Casey-Maslen discuss evaluation findings relating to communication and community engagement, a theme taken up by Nick Van Praag and Kai Hopkins, who report on a Ground Truth survey on refugees' perceptions of assistance. Julia Brothwell discusses the British Red Cross/Bangladesh Red Crescent involvement in disaster preparedness and risk reduction during the monsoon season, and Gina Bark, Kate White and Amelie Janon outline the consequences of long-term exclusion from basic healthcare services in increasing vulnerability to preventable diseases. Matthew Wencel and colleagues round off the issue with reflections on data collection coordination and other challenges associated with monitoring large concentrations of refugees.

**Abstract** 

This article analyses how disability human rights protections and processes under the United Nations Convention on the Rights of Persons with Disabilities (crpd) have responded to the heightened vulnerability created when disability intersects with indigeneity. It considers the evolution of international human rights law instruments for indigenous persons with disabilities. It further examines the drafting history of the crpd related to indigenous-specific content and examines the crpd Committee's engagement with the human rights protections and violations of indigenous persons with disabilities. It demonstrates that the crpd Committee has advanced these rights by acknowledging the rights of indigenous persons in the general course of its work, but has fallen short of adequately recognising the special vulnerabilities that are created when disability and indigeneity intersect. This evaluation is illustrated by expounding on the crpd Committee's recommendation in Noble v Australia, a communication brought by an indigenous person with a 'mental and intellectual disability' whose indigenous status was not engaged.

The jurisdiction of the African Court of Justice and Human and Peoples' Rights (acjhpr) will include international crimes of conflict-related sexual violence (crsv). <u>Abstract</u>

The article provides a critical insight into the legal framework for the prevention of torture in Africa, with specific reference to the Robben Island Guidelines (rig) and its special mechanism, the Committee for the Prevention of Torture in Africa (cpta). The Guidelines undoubtedly represent a milestone in the development of a torture preventive work in Africa. They bring together a number of provisions covering different aspects of the prohibition and prevention of torture. However they do not elaborate and clarify what is meant by prevention as a concept and what it entails as a legal obligation. Furthermore the cpta's interpretative drive has largely focused on the other, normatively more robust, areas of intervention, namely the prohibition of torture and redress for victims, at times conflating prevention with the prohibition of torture. If it is to live up to its name, the cpta needs to expand its understanding of prevention of torture. This in turn will allow it to play an important role in detecting, collecting, analysing data and information on situations of risk in Africa, and formulating new and appropriate context-sensitive strategies for the effective prevention of torture.

Human Rights Day is recognised annually on Dec 10, and this year is especially important since it is the 70th anniversary of the day that the UN General Assembly adopted the Universal Declaration of Human Rights. The Declaration, through its 30 Articles, proclaims the rights that everyone is entitled to as a human being, regardless of race, colour, religion, sex, language, political or other opinion, national or social origin, property, birth, or other status. Today, Lawrence Gostin and colleagues, including the director-general of WHO, look back at the evolution of human rights in global health over the past 70 years and outline key messages for the future of health as a human right.

Gostin and colleagues describe how human rights became embedded in global health governance, beginning with WHO's Constitution in 1946, which enshrined "the highest attainable standard of health" as one of the fundamental rights of every human being. But the Cold War superpowers took divergent positions on human rights and although the Declaration of Alma-Ata reaffirmed health as a right in 1978, many governments proved unable to implement appropriate policies. Gostin and colleagues describe how it was not until the AIDS pandemic in the 1980s that momentum grew behind universal access to treatment. Global health law, such as the WHO Framework Convention on Tobacco Control, and security, through the International Health Regulations, helped to embed health-related rights.

Now, WHO considers universal health coverage through strengthened primary health care as core to the right to health and to achieving the sustainable development goals.

Recognition of the importance of human rights in protecting health is fundamental and is as crucial today as it was in 1948. As a common standard of achievement for all nations, promoting respect for these rights and freedoms is critical. But with constant rights violations taking place worldwide, and global threats such as climate change, armed conflict, and mass migration, the future of rights-based global health efforts is in the balance.

With one billion people on the move or having moved in 2018, migration is a global reality, which has also become a political lightning rod. Although estimates indicate that the majority of global migration occurs within low-income and middle-income countries (LMICs), the most prominent dialogue focuses almost exclusively on migration from LMICs to high-income countries (HICs). Nowadays, populist discourse demonises the very same individuals who uphold economies, bolster social services, and contribute to health services in both origin and destination locations. Those in positions of political and economic power continue to restrict or publicly condemn migration to promote their own interests. Meanwhile nationalist movements assert so-called cultural sovereignty by delineating an us versus them rhetoric, creating a moral emergency.

## Widespread but heterogeneous responses of Andean forests to climate change

With global warming, Andean forests are changing to include more trees of low-elevation, heat-loving species but rates of compositional change are not uniform across elevations and are insufficient to keep species in equilibrium with climate.

Global warming is forcing many species to shift their distributions upward, causing consequent changes in the compositions of species that occur at specific locations. This prediction remains largely untested for tropical trees. Here we show, using a database of nearly 200 Andean forest plot inventories spread across more than 33.5° latitude (from 26.8° S to 7.1° N) and 3,000-m elevation (from 360 to 3,360 m above sea level), that tropical and subtropical tree communities are experiencing directional shifts in composition towards having greater relative abundances of species from lower, warmer elevations. Although this phenomenon of 'thermophilization' is widespread throughout the Andes, the rates of compositional change are not uniform across elevations. The observed heterogeneity in thermophilization rates is probably because of different warming rates and/or the presence of specialized tree communities at ecotones (that is, at the transitions between distinct habitats, such as at the timberline or at the base of the cloud forest). Understanding the factors that determine the directions and rates of compositional changes will enable us to better predict, and potentially mitigate, the effects of climate change on tropical forests.

# **Economic impact of dengue in Mexico considering reported cases for 2012 to 2016**

Abstract

Background

Given that dengue disease is growing and may progress to dengue hemorrhagic fever (DHF), data on economic cost and disease burden are important. However, data for Mexico are limited.

Methodology/Principal findings

Burden of dengue fever (DF) and DHF in Mexico was assessed using official databases for epidemiological information, disabilities weights from Shepard et al, the reported number of cases and deaths, and costs. Overall costs of dengue were summed from direct medical costs to the health system, cost of dengue to the patient (out-of-pocket expenses [medical and non-medical], indirect costs [loss of earnings, patient and/or caregiver]), and other government expenditures on prevention/surveillance. The first three components, calculated as costs per case by a micro-costing approach (PAATI; program, actions, activities, tasks, inputs), were scaled up to overall cost using epidemiology data from official databases. PAATI was used to calculate cost of vector control and prevention, education, and epidemiological surveillance, based on an expert consensus and normative construction of an ideal scenario.

Disability-adjusted life years (DALYs) for Mexico in 2016 were calculated to be 2283.46 (1.87 per 100,000 inhabitants). Overall economic impact of dengue in Mexico for 2012 was US\$144 million, of which US\$44 million corresponded to direct medical costs and US\$5 million to the costs from the patient's perspective. The estimated cost of prevention/surveillance was calculated with information provided by federal government to be US\$95 million. The overall economic impact of DF and DHF showed an increase in 2013 to US\$161 million and a decrease to US\$133, US\$131 and US\$130 million in 2014, 2015 and 2016, respectively.

Conclusions/Significance

The medical and economic impact of dengue were in agreement with other international studies, and highlight the need to include governmental expenditure for prevention/surveillance in overall cost analyses given the high economic impact of these, increasing the necessity to evaluate its effectiveness.

## **Author summary**

Dengue fever is caused by a flavivirus transmitted predominantly by the mosquito Aedes aegypti. Infection causes a broad spectrum of clinical signs and symptoms, from mild disease, such as dengue fever to a life threatening form known as dengue hemorrhagic fever. The disease is widespread in tropical regions. Measures such as vector control can slow the spread of infection, and most countries where the disease is endemic, Mexico included, have programs in place to this end. However, faced with other health issues that also require attention, it is important to quantify the suffering caused by dengue and also its economic costs. In this study, we aimed to produce detailed figures for Mexico to complement and refine those available from international studies. Such information will help guide how the money budgeted for health in dengue is spent.

<u>Social identity mediates the positive effect of globalization on individual cooperation:</u>

**Abstract** 

Globalization is defined for individuals as their connectivity in global networks. Social identity is conceptualized as attachment and identification with a group. We measure individual involvement with global networks and local, national, and global social identity through a questionnaire. Propensity to cooperate is measured in experiments involving local and global others. Firstly, we analyze possible determinants of global social identity. Overall, attachment to global identity is significantly lower than national and local identity, but there is a significant positive correlation between global social identity and an index of individual global connectivity. Secondly, we find a significant mediating effect of global social identity between individual global connectivity and propensity to cooperate at the global level. This is consistent with a cosmopolitan hypothesis of how participation in global networks reshapes social identity: Increased participation in global networks increases global social identity and this in turn increases propensity to cooperate with others. We also show that this model receives more support than alternative models substituting either propensity to associate with others or general generosity for individual global connectivity. We further demonstrate that more globalized individuals do not reduce contributions to local accounts while increasing contributions to global accounts, but rather are overall more generous. Finally, we find that the effect of global social identity on cooperation is significantly stronger in countries at a relatively low stage of globalization, compared to more globalized countries.

# Global synthesis of conservation studies reveals the importance of small habitat patches for biodiversity

Expansive development for urbanization, agriculture, and resource extraction has resulted in much of the Earth's vegetation existing as fragmented, isolated patches. Conservation planning typically deprioritizes small, isolated patches, as they are assumed to be of relatively little ecological value, instead focusing attention on conserving large, highly connected areas. Yet, our global analysis shows that, if we gave up on small patches of vegetation, we would stand to lose many species that are confined to those environments, and biodiversity would decline as a result. We should rethink the way we prioritize conservation to recognize the critical role that small, isolated patches play in conserving the world's biodiversity. Restoring and reconnecting small isolated vegetation patches should be an immediate conservation priority.

#### **Abstract**

Island biogeography theory posits that species richness increases with island size and decreases with isolation. This logic underpins much conservation policy and regulation, with preference given to conserving large, highly connected areas, and relative ambivalence shown toward protecting small, isolated habitat patches. We undertook a global synthesis of the relationship between the conservation value of habitat patches and their size and isolation, based on 31 systematic conservation planning studies across four continents. We found that small, isolated patches are inordinately important for biodiversity conservation. Our results provide a powerful argument for redressing the neglect of small, isolated habitat patches, for urgently prioritizing their restoration, and for avoiding simplistic application of island biogeography theory in conservation decisions.

Summary

"Freedom in a commons brings ruin to all." So argued ecologist Garrett Hardin in "The Tragedy of the Commons" in the 13 December 1968 issue of Science (1). Hardin questioned society's ability to manage shared resources and avoid an environmentally and socially calamitous free-for-all. In the 50 years since, the essay has influenced discussions ranging from climate change (see page 1217) to evolution, from infectious disease to the internet, and has reached far beyond academic literature—but not without criticism. Considerable work, notably by Nobelist Elinor Ostrom (2), has challenged Hardin,

particularly his emphasis on property rights and government regulatory leviathans as solutions. Instead, research has documented contexts, cases, and principles that reflect the ability of groups to collectively govern common resources. To mark this anniversary and celebrate the richness of research and practice around commons and cooperation, Science invited experts to share some contemporary views on such tragedies and how to avert them. —Brad Wible

Summary

Earth is in the throes of a mass extinction event and climate change upheaval, risking a planetary shift into conditions that will be extremely challenging, if not catastrophic, for complex life (1). Although responsibility for the present trajectory is unevenly distributed, the overarching drivers are rapid increases in (i) human population, (ii) consumption of food, water, energy, and materials, and (iii) infrastructural incursions into the natural world. As the "trends of more" on all these fronts continue to swell, the ecological crisis is intensifying (2–4). Given that human expansionism is causing mass extinction of nonhuman life and threatening both ecological and societal stability, why is humanity not steering toward limiting and reversing its expansionism?
