#### **Protection – Children in Conflict Zones**

## World has failed to protect children in conflict in 2018: UNICEF

Widespread violations against children in conflict continue in shocking year-on-year trend NEW YORK, 28 December 2018 – The futures of millions of children living in countries affected by armed conflict are at risk, as warring parties continue to commit grave violations against children, and world leaders fail to hold perpetrators accountable – UNICEF said today.

"Children living in conflict zones around the world have continued to suffer through extreme levels of violence over the past 12 months, and the world has continued to fail them," said Manuel Fontaine, UNICEF Director of Emergency Programmes. "For too long, parties to conflict have been committing atrocities with near-total impunity, and it is only getting worse. Much more can and must be done to protect and assist children."

Children living in countries at war have come under direct attack, have been used as human shields, killed, maimed or recruited to fight. Rape, forced marriage and abduction have become standard tactics in conflicts from Syria to Yemen, and from the Democratic Republic of the Congo to Nigeria, South Sudan and Myanmar.

#### Over the course of 2018:

- :: In **Afghanistan**, violence and bloodshed remain a daily occurrence, with some 5,000 children killed or maimed within the first three quarters of 2018, equal to all of 2017, and children making up 89 per cent of civilian casualties from explosive remnants of war.
- :: **Cameroon** has seen an escalation of the conflict in the North-West and South-West regions of the country, with schools, students and teachers often coming under attack. In November, more than 80 people, including many children, were abducted from a school in Nkwen, in the north-west of the country and released a few days later. To date, 93 villages have allegedly been partially or totally burned due to conflict in the areas, with many children experiencing extreme levels of violence.
- :: In the **Central African Republic**, a dramatic resurgence in fighting has enveloped much of the country, with two out of three children in need of humanitarian assistance.

- :: In the **Democratic Republic of the Congo**, inter-ethnic violence and clashes between security forces and armed groups/militia in the Great Kasai-region and in the eastern provinces of Tanganyika, South Kivu, Nord Kivu and Ituri have had a devastating impact on children. The response to the ongoing Ebola outbreak has been seriously hindered by violence and instability in eastern DRC. In addition, an estimated 4.2 million children are at risk of severe acute malnutrition (SAM). The situation is compounded by violations of children's rights, including forced recruitment by armed groups and sexual abuse.
- :: In **Iraq**, even as fighting has largely subsided, four children were killed in November in the north of the country when the truck they were travelling to school in came under attack. Children and families returning to their homes in areas previously impacted by heavy violence continue to be exposed to the danger of unexploded ordnance. Thousands of families remain displaced and now face the additional threats of freezing winter temperatures and flash floods.
- :: In the **Lake Chad basin**, ongoing conflict, displacement and attacks on schools, teachers and other education facilities have put the education of 3.5 million children at risk. Today in northeast Nigeria, the Lake region of Chad, extreme north of Cameroon and Diffa region of Niger, at least 1,041 schools are closed or non-functional due to violence, fear of attacks, or unrest, affecting nearly 445,000 children.
- :: A recent surge in violence in the border region between **Mali, Burkina Faso** and **Niger** has left 1,478 schools closed.
- :: In **Myanmar**, the UN continues to receive reports of ongoing violations of the rights of Rohingya remaining in northern Rakhine State, which include allegations of killings, disappearances and arbitrary arrests. There are also widespread restrictions on the rights to freedom of movement and barriers to access health and education including in central Rakhine State. Ensuring children have access to quality education and other essential services will avert a 'lost generation' of Rohingya children; otherwise, they will lack the skills they need to contribute to society.
- :: In northeast **Nigeria**, armed groups, including Boko Haram factions, continue to target girls, who are raped, forced to become wives of fighters or used as 'human bombs'. In February, the group abducted 110 girls and one boy from a technical college in Dapchi, Yobe State. While most of the children have since been released, five girls died and one is still being held captive as a slave. In Palestine, over 50 children were killed and hundreds more injured this year, many whilst demonstrating against deteriorating living conditions in Gaza. Children in Palestine and Israel have been exposed to fear, trauma and injuries.
- :: In **South Sudan**, relentless conflict and insecurity throughout the annual lean season pushed 6.1 million people into extreme hunger. Even with the advent of the rainy season, more than 43 per cent of the population remain food insecure. While the promise of a revitalized peace-agreement offers a glimmer of hope for children, reports of extreme violence against women and children continue, most recently in Bentiu, where more than 150 women and girls reported suffering horrific sexual assault.
- :: In **Somalia**, more than 1,800 children were recruited by parties to the conflict in the first nine months of the year, with 1,278 children abducted.

- :: In **Syria**, between January and September, the UN verified the killing of 870 children the highest number ever in the first nine months of any year since the start of the conflict in 2011. Attacks continued throughout the year, including the killing of 30 children in the eastern village of Al Shafa in November.
- :: In eastern **Ukraine**, more than four years of conflict have taken a devastating toll on the education system, destroying and damaging hundreds of schools and forcing 700,000 children to learn in fragile environments, amidst volatile fighting and the dangers posed by unexploded weapons of war. The situation is particularly severe for 400,000 children who live within 20km of the "contact line", which divides the government and non-government-controlled areas and where shelling and extreme levels of mine-contamination pose a lethal threat.
- :: and in **Yemen**, the UN has verified 1,427 children killed or maimed in attacks, including an 'unconscionable' attack on a school bus in Sa'ada. Schools and hospitals have come under frequent attack or been used for military purposes, denying children access to their right to education and health care. This is further fueling a crisis in a country where every 10 minutes, a child dies due to preventable diseases, and 400,000 children suffer from severe acute malnutrition.

"2019 marks the 30th anniversary of the landmark Convention on the Rights of the Child and the 70th anniversary of the Geneva Conventions, yet today, more countries are embroiled in internal or international conflict than at any other time in the past three decades. Children living through conflict are among the least likely to be guaranteed their rights. Attacks on children must end," Fontaine said. UNICEF calls on all warring parties to abide by their obligations under international law to immediately end violations against children and the targeting of civilian infrastructure, including schools, hospitals and water infrastructure. UNICEF also calls on states with influence over parties to conflict to use that influence to protect children.

"Much more needs to be done to prevent wars, and to end the many disastrous armed conflicts devastating children's lives. Yet even as wars continue, we must never accept attacks against children. We must hold warring parties to their obligation to protect children. Otherwise, it is children, their families and their communities who will continue to suffer the devastating consequences, for now, and for years to come," Fontaine said.

Across all these countries, UNICEF works with partners to provide the most vulnerable children with health, nutrition, education and child protection services. For example, in October, UNICEF helped to secure the release of 833 children recruited into armed forces in northeast Nigeria, and are working these children to reintegrate them into their communities. Since conflict broke out in South Sudan five years ago, UNICEF has reunited almost 6,000 unaccompanied and separated children with their families. In Bangladesh, in 2018, UNICEF reached thousands of Rohingya refugee children with mental health and psychosocial support. In Iraq, UNICEF is working with partners to provide specialized services to women and children affected by gender-based violence.

## Yemen needs a concrete plan-now

The Lancet Global Health

More than 3 years into the current conflict, the situation in Yemen has reached catastrophic proportions. These have been exacerbated by the collapse of the national economy and by intense fighting around Hodeidah, the country's principal port on the Red Sea where most commodities, including food and medicines, enter the largely import-based Yemeni market. The planned peace negotiations are dependent on the goodwill of two warring parties whose disregard for international law has already led to large civilian casualties and the destruction of essential infrastructure such as health facilities, water systems, roads, and markets. As the world barely watches, at the convergence of all these events, an estimated 14 million Yemeni people—half of the country's population—have now been brought to pre-famine conditions.

The global apathy in the face of Yemen's continuing struggle has been disrupted in recent weeks. Increased media attention to the plight of hundreds of thousands of severely malnourished children has led to renewed concerns about the fate of the Yemeni people. On Nov 26, the CEOs of five international non-governmental organisations openly called out the role of US geopolitics and trade in the killing of innocent civilians, spurring discussions on the global responsibility for the war. And probably because one number sometimes speaks louder than words, earlier on Nov 21, Save The Children presented in a press release their straightforward estimation for the number of deaths due to untreated severe acute malnutrition between April 2015 and October 2018: close to 85 000 children under 5 may have died a preventable death in that period.

In truth, most health-related numbers coming from Yemen cannot be more than estimations—how could a collapsed health system generate robust data? But we know that the Yemeni people are suffering. Of all the scourges affecting Yemen, the prospect of a famine seems to have taken centre-stage in the media again, but there are many other enduring ones. We know that civilians are dying in the conflict, though unofficial data are vague and largely underestimated. We know there are outbreaks of diphtheria, measles, and probably other vaccine-preventable diseases. We also know that the cholera epidemic that started in April 2016 is still going on: the <u>latest report</u> available from the WHO Eastern Mediterranean Regional Office indicates that there were over 240 000 cases in the first 42 weeks of 2018. This cholera epidemic, the largest documented in history, illustrates how a weakened population, and a crippled health system, can be swiftly and durably overpowered in the midst of conflict. However, it is also an opportunity to learn, in the hope that this situation can be reversed in Yemen, and prevented elsewhere.

Thankfully, such learnings are happening. In May 2018, *The Lancet Global Health* published a modelling study by Anton Camacho and colleagues in which surveillance data were used to identify the drivers of the cholera epidemic, linking rainfall to the second wave of the epidemic, generating potentially important information for timing and enhancing control efforts. In a subsequent exchange of letters with <u>Fekri Dureab and colleagues</u>, the <u>authors</u> evoke the difficulties in identifying the mechanisms of transmission, in spite of robust modelling, in part because the war's disruption of water and sewerage systems confounds the analysis.

Also importantly, in a report released on December 4, the Johns Hopkins Center for Humanitarian Health presents a detailed evaluation, based on an in-depth review and data gathered through 71 key

informants, of the epidemic preparedness and response up until the second wave in July 2018. It brings forth unsurprising but sobering facts, among them the likely association between the conflict and increased cholera transmission; the lack of preparedness in terms of surveillance and response capacity; or coordination issues between international and national actors of the response. The 20 global and Yemen-specific recommendations cover the fundamental need of addressing insecurity, of urgently clarifying and harmonising coordination and preparedness, and of making the response more agile by improving surveillance. They include specifics of a targeted WASH and vaccination response and rely on strong integration of planning across sectors, all sensible responses to the issues identified in the analysis.

These concrete, action-related reports should be precious input in tackling this and future outbreaks, particularly in war-torn areas. But Yemen needs even more—and the time is now.

## **Ebola - Democratic Republic of the Congo**

## 21: Situation report on the Ebola outbreak in North Kivu

27 December 2018 [Excerpts]

Situation Update

...As of 25 December 2018, a total of 585 EVD cases, including 537 confirmed and 48 probable cases (Table 1), were reported from 16 health zones in the two neighbouring provinces of North Kivu and Ituri (Figure 1), of which 13 reported at least one confirmed case in the last 21 days (5-25 December 2018). Over this period, 117 confirmed cases were reported from 13 health zones, the majority of which were concentrated in major urban centres and towns in Katwa (30), Komanda (20), Beni (15), Butembo (15), and Mabalako (15), which remain the main hotspots of this outbreak.

Trends in case incidence reflect the continuation of the outbreak across these geographically dispersed areas. The general decrease in the weekly incidence observed in Beni since late October is continuing; however, the outbreak is intensifying in Butembo and Katwa, and new clusters have emerged in other health zones.

Forty-one additional deaths among confirmed and probable cases occurred since our last report on 18 December 2018. Overall, 356 cases have died (case fatality 61%), including 308 among confirmed cases. As of 25 December 2018, 201 patients have recovered and been discharged from ETCs.

A healthcare worker from Mabalako has been reported among the new cases, bringing the number of healthcare workers affected to 54, with 18 deaths...

### **DONs Ebola virus disease – Democratic Republic of the Congo**

28 December 2018

[Excerpt]

#### ...WHO risk assessment

This outbreak of EVD is affecting north-eastern provinces of the country bordering Uganda, Rwanda and South Sudan. Potential risk factors for transmission of EVD at the national and regional levels

include: travel between the affected areas, the rest of the country, and neighbouring countries; the internal displacement of populations. The country is concurrently experiencing other epidemics (e.g. cholera, vaccine-derived poliomyelitis, malaria), and a long-term humanitarian crisis. Additionally, the security situation in North Kivu and Ituri at times limits the implementation of response activities. WHO's risk assessment for the outbreak is currently very high at the national and regional levels; the global risk level remains low. WHO continues to advice against any restriction of travel to, and trade with, the Democratic Republic of the Congo based on currently available information.

As the risk of national and regional spread is very high, it is important for neighbouring provinces and countries to enhance surveillance and preparedness activities. The International Health Regulations (IHR 2005) Emergency Committee has advised that failing to intensify these preparedness and surveillance activities would lead to worsening conditions and further spread. WHO will continue to work with neighbouring countries and partners to ensure that health authorities are alerted and are operationally prepared to respond.

2019 will be a critical year for the 2030 Agenda for Sustainable Development. UN DESA will be fully engaged in the preparation of the two High-level Political Forums, one in July under the auspices of the Economic and Social Council (ECOSOC), completing its first cycle, and one in September at the summit level under the auspices of the General Assembly. We must seize the momentum to implement the 2030 Agenda and use this opportune year to assess progress and to strengthen our political will to act to achieve the Sustainable Development Goals (SDGs) in all regions.

Many countries are aligning their national policies and institutions behind the Goals to improve people's lives. Businesses are taking action to invest in new technologies, opening up new markets, and building the sustainable and inclusive economy of the 21st century. Civil society organizations and other stakeholders are also using these Goals to drive change at the local, subnational and national levels and holding their Governments accountable.

Even though progress is being made, gaps are evident. The world remains on a trajectory of increasing inequality, and it is facing armed conflicts, humanitarian and environmental crises, as well as economic, financial and climate challenges.

Moreover, the scale and pace of change in public and private investment in sustainable development remain alarmingly insufficient. We, therefore, urgently need a surge in financing, investments and technological innovation.

In 2019, UN DESA will launch the Global Sustainable Development Report, an analysis by an independent group of scientists undertaken every four years to assess where we stand. Additionally, over the next months, the department will release several other analytical reports to assess progress made towards the SDGs to provide context to this year's high-level discussions...

### Calling on governments to scale up oral TB treatment

Geneva — Médecins Sans Frontières (MSF) today welcomed new World Health Organization (WHO) treatment guidelines that recommend drug-resistant tuberculosis (DR-TB) be treated with oral drugs only, including newer, more potent drugs with fewer side effects, such as bedaquiline.

Two injectable drugs known to cause deafness and other severe side effects are no longer recommended in the new guideline – an important step towards more tolerable treatment for all patients.

The recommended 18 to 20-month treatment regimen includes more potent drugs – bedaquiline, linezolid, levofloxacin and moxifloxacin – that can help improve cure rates, reduce deaths and cause people far fewer side effects.

MSF called on countries with large numbers of people with DR-TB to urgently start implementing these new treatment guidelines for at least half of new DR-TB cases by September 2019, and to make efforts to reach all people in need by March 2020...

## The use of evidence synthesis in the humanitarian field

...The GESI Secretariat at the American University of Beirut aims to enhance the capacity to produce and use cross-sectoral evidence synthesis in low- and middle-income countries across the world. They have identified some local practitioners who are able to identify or produce evidence to inform decision-making in non-health fields; and the current regional conflict and influx of refugees to Lebanon has pushed the GESI Secretariat to talk to stakeholders in the field about their views on evidence. They have produced a video blog "The Use of Evidence Synthesis in the Humanitarian Field" to present the experience with evidence of two of the GESI Secretariat's main national stakeholders in the humanitarian field.

One of these is Mr Hussein Ismail, a humanitarian expert who, after four years of field work, was interested in focusing on the "evidence part of the humanitarian field". He noticed the gap between what is implemented and what is published online by academic researchers. In his opinion, humanitarian practitioners need to learn more about humanitarian evidence and be more exposed to methods such as systematic and scoping reviews. He believes that this will help them to take better

strategic decisions when planning interventions, and to identify those areas for which evidence is needed but lacking...

## **Novartis Provides Data to SPARK, Pew's Platform for Antibiotic Discovery Research**

Information will aid in search for urgently needed new antibiotics

WASHINGTON—The Pew Charitable Trusts announced today that Novartis has shared data from its antibiotic research programs on Pew's open-access <u>Shared Platform for Antibiotic Research and Knowledge (SPARK)</u>. The move follows <u>Achaogen's commitment in October</u> to provide SPARK with data from its own discontinued antibiotic research program, and further expands the free, interactive resource, which scientists around the world are using to pursue antibiotic research.

Novartis shared data from its LpxA, LpxD, and LpxK antibacterial programs that explored new ways to attack Gram-negative bacteria, a class of pathogens that includes some of the most dangerous superbugs because of their tough defense mechanisms. These research programs were discontinued earlier this year.

"Antibiotic resistance is among the world's most pressing public health challenges, and figuring out how to defeat antibiotic-resistant Gram-negative bacteria is essential to meeting this challenge," said Allan Coukell, Pew's senior director of health programs. "Our hope is that the data from these early research programs will reinvigorate the pipeline of antibiotics in development. Novartis's willingness to make this contribution ensures that its scientific investment can be used by any researcher in the quest to solve the global problem of antibiotic resistance." ...

# National age-of-consent laws and adolescent HIV testing in sub-Saharan Africa: a propensity-score matched study

### **Abstract**

Objective

To estimate the association between legal age of consent and coverage of human immunodeficiency virus (HIV) testing among adolescents in countries with high HIV-burden.

Methods

We analysed data from adolescents aged 15–18 years, who participated in Demographic and Health Surveys or AIDS Indicator Surveys between 2011 and 2016, in 15 sub-Saharan African countries. To improve balance in the distribution of measured individual- and country-level characteristics, we used propensity score matching between adolescents in countries with more versus less restrictive age-of-consent laws ( $\leq$  15 years versus  $\geq$  16 years). We estimated the percentage of individuals who self-reported that they have done an HIV test in the past 12 months and compared the differences in such testing rates among adolescents exposed to lower versus higher age-of-consent laws. We also investigated effect modifications by sex and age.

#### Findings

Legal age of consent below 16 years was associated with an 11.0 percentage points higher coverage of HIV testing (95% confidence interval, CI: 7.2 to 14.8), corresponding to a rate ratio of 1.74 (95% CI: 1.35 to 2.13). HIV testing rate had a stronger association with lower age of consent among females than males. The testing rates differences were 14.0 percentage points (95% CI: 8.6 to 19.4) for females and 6.9 percentage points (95% CI: 1.6 to 12.2) for males (P-value for homogeneity = 0.07). Conclusion

This study provides evidence to support the recent World Health Organization's recommendations that countries should examine current laws and address age-related barriers to uptake of sexual and reproductive health services.

**Abstract** 

Now is a good time to take stock of the global progress made toward achieving the ideals enshrined in the Universal Declaration of Human Rights (UDHR), which was passed by the UN General Assembly seventy years ago. Though the UDHR has played a vital role in advancing human rights globally, threats to human rights are ever present. Two issues in particular stand out as barriers to further progress. The first is state sovereignty, which presents a fundamental challenge to any effort to establish universal norms. Without strong global institutional mechanisms to ensure implementation,

UDHR's impact remains limited. The second major concern is the "siloing" of human rights efforts, whereby civil and political rights have been given primacy over social and economic rights. Emphasis on some principles to the exclusion of others undermines the comprehensive advancement of human rights. The current state of affairs is a product of the collective failure to address human rights holistically and to implement real monitoring and accountability measures for states, which are directly charged with upholding them within their borders.

# Rohingya refugees in Bangladesh: the humanitarian response

More than 700,000 Rohingya refugees have arrived in Bangladesh since 25 August 2017 fleeing violence and persecution in Rakhine State, Myanmar. Over a million are sheltering in overcrowded camps without adequate assistance or protection. Stateless in Myanmar and denied refugee status in

Bangladesh, the Rohingya have few rights or freedoms. Monsoons and cyclones are causing landslides, destroying shelters and infrastructure and disrupting services.

This edition of Humanitarian Exchange focuses on the humanitarian response to the Rohingya crisis. In the lead article, <u>Mark Bowden</u> outlines the historical, local and national political context in Bangladesh, and its operational implications. <u>Amal de Chickera</u> highlights the links between statelessness and displacement, and the international community's failure to prioritise human rights in its dealings both with Bangladesh and with Myanmar. <u>Puttanee Kangkun and John Quinley</u> document the persistent persecution and denial of rights the Rohingya have faced for decades. <u>Jeff Crisp</u> reflects on the premature, involuntary and unsafe return of Rohingya refugees to Myanmar in the 1970s and 1990s, and asks whether this could happen again.

<u>Sally Shevach and colleagues</u> explore how the 'localisation' agenda has influenced the operational response, and <u>Kerrie Holloway</u> draws on research by the Humanitarian Policy Group to test the common assumption that local actors necessarily have a better understanding of people's needs. <u>Nasif Rashad Khan</u> and colleagues and <u>Ashish Banik</u> reflect on their experiences of engaging with the international humanitarian response system. <u>Margie Buchanan-Smith and Marian Casey-Maslen</u> discuss evaluation findings relating to communication and community engagement, a theme taken up by <u>Nick Van Praag and Kai Hopkins</u>, who report on a Ground Truth survey on refugees' perceptions of assistance. <u>Julia Brothwell</u> discusses the British Red Cross/Bangladesh Red Crescent involvement in disaster preparedness and risk reduction during the monsoon season, and <u>Gina Bark, Kate White and Amelie Janon</u> outline the consequences of long-term exclusion from basic healthcare services in increasing vulnerability to preventable diseases. <u>Matthew Wencel and colleagues</u> round off the issue with reflections on data collection coordination and other challenges associated with monitoring large concentrations of refugees.

**Abstract** 

Clinical trials in emergency situations present unique challenges, because they involve enrolling individuals who lack capacity to consent in the context of acute illness or injury. The US Department of Health and Human Services and Food and Drug Administration regulations allowing an Exception from Informed Consent (EFIC) in these circumstances contain requirements for community consultation, public disclosure and restrictions on study risks and benefits. In this paper, we analyse an issue raised in the regulations that has received little attention or analysis but is ethically complex. This challenge is when to solicit and honour objections to EFIC trial enrolment, including from non-legally appointed representatives. We address novel questions involving whose objections should be honoured, what level of understanding is necessary for objections to be considered valid and how hard investigators should work to offer an opportunity to object. We present a set of criteria that provide conceptual and practical guidance. We argue that objections should be honoured if they undermine one of the key assumptions that allows for the permissibility of EFIC trials: that individuals would likely not object to enrolment based on their values or preferences. Reducing inequalities in health and the determinants of health is a widely acknowledged health policy goal, and methods for measuring inequalities and inequities in health are well developed. Yet, the evidence base is weak for how to achieve these goals. There is a lack of high-quality randomised controlled trials (RCTs) reporting impact on the distribution of health and non-health benefits and lack of methodological rigour in how to design, power, measure, analyse and interpret distributional impact

in RCTs. Our overarching aim in this paper is to contribute to the emerging effort to improve transparency and coherence in the theoretical and conceptual basis for RCTs on effective interventions to reduce health inequity. We endeavour to achieve this aim by pursuing two more specific objectives. First, we propose an overview of three broader health equity frameworks and clarify their implications for the measurement of health inequality in RCTs. Second, we seek to clarify the relationship between theory and translational challenges that researchers would need to attend to, in order to ensure that equity-relevant RCTs are coherently grounded in theory.

# **Group flow: A scoping review of definitions, theoretical approaches, measures and findings**

Many people enjoy the state of total immersion in a task accompanied by an optimal level of functioning, be it at work (e.g., [1]), in sports (for an overview, see [2]), in music (for an overview, see [3]), during leisure time (e.g., [4]) or potentially in any other imaginable context of our everyday life [5]. This state is referred to as flow. Flow is associated with a variety of positive outcomes, such as positive affect and enhanced performance (for an overview, see [6]). In the past decades, a multitude of studies has examined and established a concept of flow in individuals (which we refer to as individual flow) based on the initial work of Csikszentmihalyi [7]. Additionally, in recent years, there has been growing interest in flow that emerges during group situations. This kind of flow, henceforth referred to as group flow, has often been described in metaphorical terms [8], such as a state in which "things [in a group] are *clicking* or in *sync*" (p. 157) and wherein "everything [in the group] seems to come naturally" (p. 158) for example. However, as stated earlier by Nakamura and Csikszentmihalyi [9], there is not yet a clear and consistent concept for group flow. Therefore, the overall purpose of

the present paper is to systematically review the recent literature on group flow in order to pave the way for a more common understanding and examination of group flow in the future..

# **Engaging a Community Leader to Enhance Preparation for In-Depth Interviews With Community Members**

In-depth interviews allow for rich exploration of stakeholders' experiences. Preparation for in-depth interviews generally consists of literature reviews and researchers' review of their own culture and understanding of a topic. We supplemented these strategies with serial "ethnographic interviews" with a single community leader to enhance our preparation for community-based in-depth interviews with Latina, immigrant, Spanish-speaking mothers and to facilitate stakeholder engagement in a research project. After an extensive literature review, we conducted a series of four 1-hour interviews with a key informant in preparation for individual in-depth interviews with 12 parents. The ethnographic interviews with the community leader provided insight into environmental context, cultural categories, and stakeholder priorities, which helped shape the research question, in-depth interview guide, sampling strategy, and interpretive analytic process. We found that ethnographic interviews can provide critical insights for preparing in-depth interview guides and can enhance the information gained while facilitating meaningful stakeholder engagement.

# From voluntary commitments to ocean sustainability

Voluntary commitments by states, governmental or nongovernmental organizations, and other actors, aiming to deliver outcome-oriented activities, have become a well-recognized mechanism in international sustainability policy (1–3). For ocean governance, the calling for and pledging of voluntary commitments could become a game changer, with two major international processes harnessing such voluntary contributions in recent years: the Our Ocean conferences, an annual high-level series initiated by U.S. Secretary of State John Kerry in 2014, and the United Nations (UN) Ocean Conference, which took place for the first time in June 2017. Such calls and commitments provide opportunities to raise awareness, promote engagement, and catalyze political will for action on the part of states as well as public and private sectors. However, without effective and transparent review systems, it is difficult to link pledged commitments to actual implementation. Quality control and ensuring that commitments are effective and impactful will be difficult to achieve. A uniform global process is required to register and assess commitments, including consistent reporting and monitoring systems with clear targets, baselines, and review systems.
