#### **Migration: Greece-Turkey Border**

## <u>Greece-Turkey Border: Migrants must not be used as a political tool. The EU and Member</u> States must act in solidarity now.

Geneva/Budapest, 3 March 2020 – Women, children and men caught up in the ongoing humanitarian crisis at the land border between Greece and Turkey, in the Greek islands and in the Aegean Sea must not be "used as a political tool", the International Federation of Red Cross and Red Crescent Societies (IFRC) warned today.

Speaking of the deteriorating humanitarian situation, IFRC President Francesco Rocca said: "It is unacceptable that children and families are exposed to tear gas and violence or have to risk their lives in the Aegean Sea. We will not be silent in the face of this dire humanitarian situation, which may become even worse in the next hours and days."

The IFRC is deeply concerned that thousands of people, including vulnerable children, may suffer the consequences of the recent surge of migrants trying to cross the border between Turkey and Greece. While Governments have the right and responsibility to set migration policies and to control their own borders, steps should be taken to ensure the implementation of such policies do not increase suffering.

"EU Member States should respond in a spirit of solidarity to the recent increase in numbers of people seeking refuge at the EU's external borders. They must enact their responsibilities in protecting people and saving lives. EU governments cannot turn their backs on Turkey and Greece. Southern European States cannot be left alone. All States have a responsibility to protect people and save lives," President Rocca said.

"We call on the EU and the national Governments to avoid using migrants as a political tool, to ensure that asylum seekers can apply for international protection, in line with international and EU laws. Access to humanitarian assistance and essential services, including healthcare, ought to be guaranteed for all people, in particular children and other vulnerable groups," he ended.

## EU must address migration emergency as Greek islands reach breaking point

Statement 4 Mar 2020

In recent days, the Greek government took a series of harsh measures to push back thousands of asylum seekers and migrants attempting to enter from Turkey. Greece sent military forces to the border, said it would suspend asylum applications, and deport migrants who entered irregularly. One

child died and 47 migrants were rescued after their boat capsized off the island of Lesbos, the Greek coastguard said. Separately, video footage released by the Turkish government appears to show members of the Greek coastguard shooting into the water near migrants. The United Nations High Commissioner for Refugees has urged authorities not to use excessive or disproportionate force and is calling for continued resources from other European states.

Stefano Argenziano, Médecins Sans Frontières (MSF) operations coordinator for Greece, gave the following statement calling on the Greek government and other European Union (EU) member states to take immediate action to address the ongoing emergency facing people trapped in horrific conditions:

"It is now almost four years since the EU-Turkey statement traded human lives for political gains."

Once again, Médecins Sans Frontières (MSF) sees that EU member states are willing to deter people from seeking safety at all cost, rather than providing the most basic assistance to men, women and children in need. This deterrence places them in further danger. In recent days, this has culminated with the death of a child, teargassing people at land-borders, and reports of coastguards violently interfering with, instead of helping, boats in distress.

With 40,000 people trapped on the Greek islands, the situation has reached breaking point for asylum seekers and local communities alike who have both been abandoned by European leaders for the sake of the EU-Turkey deal. Consequently, increased tensions have led to riots, roadblocks and attacks on those trying to provide assistance.

People in need on the islands are deprived of critical assistance as MSF teams and others have had to limit the volume of activity due to safety concerns. The Greek Government and the European Union must take immediate action to de-escalate the situation.

The emergency measures announced by the Greek government will have devastating consequences as they remove the right to claim protection and aim to push people fleeing war back to Turkey. This will only lead to more chaos, deaths at sea, escalating violence and a worsening humanitarian disaster.

EU member states must address the real emergency: evacuate people from the islands to EU countries, deliver an asylum system that works, and stop trapping people in horrific conditions.

MSF teams in Lesbos are currently adjusting their activities on daily basis according to the security conditions around Moria and Mytilene. We are committed to staying on Lesbos to ensure that asylum seekers receive the medical and mental healthcare they need."

## <u>Lack of Quality Data Compounds Risks Facing Millions of Refugee and Migrant Children</u> 2020-03-03 13:15

UNICEF, IOM, UNHCR, OECD, various countries and other partners join forces to protect children through the International Data Alliance on Children on the Move

New York - The widespread lack of quality data on millions of displaced and migrant children is compounding the serious risks they face, a coalition of international organizations announced today in New York during the launch of the **International Data Alliance on Children on the Move**.

The Alliance – led by UNICEF, IOM, UNHCR (the UN Refugee Agency) and OECD, and currently including about 30 members from government agencies, NGOs, civil society and other partners – aims to improve data and statistics on this vulnerable group of children to support evidence-based policymaking that protects and empowers them.

Improving the availability of data on migrants in vulnerable situations, including children, was one of the main themes discussed during the second International Forum on Migration Statistics in Cairo earlier this year.

"Tens of millions of children have migrated across borders or been forcibly displaced, but in so many cases, we don't have the information needed to keep them safe," said Mark Hereward, UNICEF Associate Director for Data and Analytics. "If we don't know who they are, where they've come from or whether they're alone, how can we ensure they are protected and get the support they need? Improving data quality, availability and analysis is essential to properly identifying and reaching these children."

"Between 2014 and 2018 more than 1,825 children – an average of almost one every day – were reported dead or missing. Many more such incidents go unrecorded. This is a grim reminder that children are among the most vulnerable groups of migrants," said Frank Laczko, Director of IOM's GMDAC.

The work of the Alliance will also support implementation of the two Global Compacts on Migration and Refugees as well as the child migration relevant targets of the 2030 Agenda for Sustainable Development.

"Leaving no one behind is the central promise of the 2030 Agenda and its SDGs. We need more harmonised data, as a prerequisite for making sound policy decisions. This is the only way to show the extent of the challenges children on the move face and their vulnerability," said Deputy Director General of Statistics Netherlands, Dr Bert Kroese.

Over the next two years, the Alliance will work to achieve three primary objectives:

- [1] Support countries and regions to strengthen their capacities to collect, analyze and use data on migrant and refugee children.
- [2] Produce an annual flagship report with data on migrant and refugee children to monitor global progress in improving data and highlight key knowledge gaps.
- [3] Convene an annual conference and establish a global network to facilitate the exchange of local, national, regional and international good practices on data collection, analysis and dissemination to support data initiatives between and within countries.

The Alliance will also coordinate and work closely with other established groups and networks focusing on data in migration and displacement, including the UN Migration Network, the UN Expert Group on Migration Statistics (EGMS), the Expert Group on Refugee and IDP Statistics (EGRIS), and the Global Compact on Youth in Humanitarian Action...

# World Could Achieve 'Gender Dividend' of \$172 Trillion from Closing Lifetime Earnings Gaps

WASHINGTON, March 3, 2020 —A new report from the World Bank Group released ahead of International Women's Day shows that the world could achieve a 'gender dividend' of \$172 trillion by closing gaps in lifetime labor earnings between women and men.

The study, "How Large is the Gender Dividend? Measuring Selected Impacts and Costs of Gender Inequality," finds that if women earned the same as men, global human capital wealth could increase by about one-fifth, and women's human capital wealth could increase by more than half.

"This report builds on past research to highlight the cost of the gender earnings gap, which holds countries back from achieving their full potential," said Caren Grown, Senior Director of Gender at the World Bank Group. "Improving women's lifetime earnings opportunities can be achieved by taking actions that redistribute and balance care responsibilities, create a pipeline of talent by closing the gender gap in employment and entrepreneurship, and tackling discriminatory laws and restrictive social norms that hold back girls and women."

'How Large is the Gender Dividend?,' supported by Global Affairs Canada, examines other domains of gender inequality in addition to the earnings gap, including: educational attainment, child marriage and early childbearing; fertility and population growth; health, nutrition, well-being, and violence; and agency, decision-making, and social capital.

#### It shows:

- :: Gender inequality impacts women throughout their lives but is especially detrimental in adolescence.
- :: Child marriage and early childbearing have lasting negative impacts on the health of young women and their children, and entrench gender inequalities.
- :: Gender inequality affects many development outcomes, with large intergenerational impacts...

#### NEW REPORT: Freedom in the World 2020 finds established democracies are in decline

Kev Findings

- :: Of the 195 countries assessed, 83 (43 percent) were rated Free, 63 (32 percent) were Partly Free, and 49 (25 percent) were Not Free. The share of Free countries has declined by 3 percentage points over the last decade, while the percentage of Partly Free and Not Free countries rose by two and one points, respectively.
- :: **The gap between setbacks and gains widened.** People in 64 countries experienced deterioration in their political rights and civil liberties in 2019, while those in just 37 countries experienced improvements. The difference was smaller in 2018, when 68 countries declined and 50 made gains.
- :: The countries with the year's largest gains and declines were concentrated in Africa.

  Benin, Mozambique, and Tanzania suffered from flawed elections and state repression of dissent, while Sudan, Madagascar, and Ethiopia benefited from progress toward reform and more democratic rule.

- :: **Most established democracies have experienced declines over the past 14 years.** Of the world's 41 established democracies as of 2005, defined as those that had been rated Free for each of the previous 20 years, 25 have since suffered net score declines.
- :: Mass protests yielded mixed results for each country or territory's overall score. For example, Hong Kong slipped by four points due in part to acts of repression by police and progovernment thugs. Sudan's score improved by five points after its protest movement paved the way for a power-sharing transitional government.
- :: As democratic states display faltering support for freedom on the international stage, **authoritarian powers have expanded their global influence** through proxy wars, election interference, and censorship beyond their borders.

"The report shows clearly once again, democracy is in decline," said Abramowitz. "Political rights and civil liberties are threatened in free societies and repressive ones alike. It is possible to turn the tide on this trend, but it is going to take concerted efforts from governments, pressure from the people, and partnership from the business community."

#### Authoritarianism, outbreaks, and information politics

Are autocratic states such as China better equipped than their more democratic counterparts to respond to disease outbreaks? On Dec 31, 2019, China alerted WHO to an outbreak of pneumonia of unknown cause in the city of Wuhan in Hubei province. The epidemic quickly spread, with cases of a novel coronavirus (2019-nCoV) confirmed throughout China and elsewhere in Asia, Europe, North America, and Australia. The Chinese Government's forceful response has drawn praise from global health officials. Scholars and health leaders have long debated whether democracy improves, hinders, or is immaterial for public health. 1, 2, 3 Does this signal an authoritarian advantage in tackling outbreaks?

On the surface, the power of authoritarianism is on display in China's response to 2019-nCoV. The Huanan seafood market suspected as the outbreak source was closed and decontaminated within a day of the announcement. Within 3 days of confirmed human-to-human transmission, with cases rising and the world's largest mass travel event underway for the lunar new year Spring Festival, the Chinese Government imposed an unprecedented cordon sanitaire. Movement of more than 50 million people across Hubei province was rapidly restricted, curtailing transportation inside cities and outbound transportation by air, train, and bus. Authorities halted Spring Festival celebrations in Beijing and restricted movement into other major cities. Two 1000-bed hospitals were built within days. These moves reflect a level of control only available to authoritarian governments. WHO officials have congratulated China for setting "a new standard for outbreak response".5

Yet, time is key to controlling outbreaks; getting good information and acting on it rapidly can halt outbreaks before they need emergency measures. The early history of the 2019-nCoV outbreak raises questions about whether this situation is an example of beneficial autocracy.

For Amartya Sen, authoritarian states face serious challenges in information and accountability. Governments in closed political systems, without open media and opposition parties, struggle to receive accurate information in a timely manner and to convey urgent information to the public. Governments can be the victims of their own propaganda, because the country's political institutions provide incentives to local officials to avoid sharing bad news with their central bosses and await instructions before acting.

Information politics in China undermined a rapid response to the 2019-nCoV outbreak. Health-care workers suspected an outbreak in early December, 2019,7 but information with which the public might have taken preventive measures was suppressed, and communication channels that might have alerted senior officials to the growing threat were shut down.8 Police detained a clinician and seven other people posting reports on 2019-nCoV, threatening punishment for spreading so-called rumors. Social media was censored; a preliminary analysis of Weibo and WeChat published on China's biggest online platform9 showed outbreak discussions were nearly non-existent through much of January, 2020, until the Chinese Government changed its official stance on Jan 20, 2020.

Through much of January, 2020, the Wuhan Municipal Health Commission reported no evidence of human-to-human transmission, no infection among health workers, that severe cases of disease caused by 2019-nCoV infection were confined to those with underlying conditions and older people, and that the Huanan seafood market was the source. 11 Reports in The Lancet and New England Journal of Medicine, 12 however, show that half of patients admitted to intensive-care units were aged 25–49 years, and two-thirds had no underlying illnesses. Human-to-human transmission and health-worker infection were evident before the Chinese Government made an announcement. 12 This information either did not make it to authorities or the public were misinformed. The Mayor of Wuhan has said publicly that not only was information not revealed in a timely manner but also they did not use information effectively. 10 By the time quarantine went into effect on Jan 23, 2020, five million people had left the city of Wuhan for holiday travel. 10 Outbreaks were subsequently reported throughout China.

Without open media and an opposition to check on bureaucratic hierarchy, knowledge from the front lines of the 2019-nCoV outbreak did not reach Beijing. Weeks into the outbreak, leaders were forced to publicly threaten that officials withholding information "will be nailed on the pillar of shame for eternity".

Is there an authoritarian advantage in disease response? It seems that authoritarian information politics inhibited a rapid response to the 2019-nCoV outbreak in China, which could have limited the crisis. It is not yet clear if the extraordinary cordons and influx of resources enabled by autocratic rule will prove a successful public health strategy. Yet, in building capacity to prevent, detect, and respond to outbreaks, democratic openness and competitive politics seem more asset than inadequacy.

## World Bank Group Announces Up to \$12 Billion Immediate Support for COVID-19 Country Response

Fast Track Financing for Developing Countries

ASHINGTON, March 3, 2020 — As COVID-19 reaches more than 60 countries, the World Bank Group is making available an initial package of up to \$12 billion in immediate support to assist countries coping with the health and economic impacts of the global outbreak. This financing is designed to help member countries take effective action to respond to and, where possible, lessen the tragic impacts posed by the COVID-19 (coronavirus).

Through this new fast track package, the World Bank Group will help developing countries strengthen health systems, including better access to health services to safeguard people from the epidemic, strengthen disease surveillance, bolster public health interventions, and work with the private sector to reduce the impact on economies. The financial package, with financing drawn from across IDA, IBRD and IFC, will be globally coordinated to support country-based responses.

The COVID-19 support package will make available initial crisis resources of up to \$12 billion in financing — \$8 billion of which is new — on a fast track basis. This comprises up to \$2.7 billion new financing from IBRD; \$1.3 billion from IDA, complemented by reprioritization of \$2 billion of the Bank's existing portfolio; and \$6 billion from IFC, including \$2 billion from existing trade facilities. It will also include policy advice and technical assistance drawing on global expertise and country-level knowledge.

"We are working to provide a fast, flexible response based on developing country needs in dealing with the spread of COVID-19," said World Bank Group President David Malpass. "This includes emergency financing, policy advice, and technical assistance, building on the World Bank Group's existing instruments and expertise to help countries respond to the crisis."...

# <u>CEPI welcomes UK Government's funding and highlights need for \$2 billion to develop a vaccine against COVID-19</u>

06 Mar 2020

"It is increasingly clear that containment measures for COVID-19 can only slow down its spread and the virus is now entering a stage of unprecedented threat in terms of its global impact. While we heartily support the range of public health measures that governments are putting in place to protect their populations, it is critical that we also invest in the development of a vaccine that will prevent people from getting sick in the first place. Working as part of the global response, CEPI has committed \$100 million of its own funds and moved with unprecedented speed to initiate a programme of vaccine development with the goal of having vaccine candidates in early stage clinical trials in as little as 16 weeks. However, these funds will be fully allocated by the end of March and without immediate additional financial contributions the vaccine programmes we have begun will not be able to progress and ultimately will not deliver the vaccines that the world needs.

In response to this call, the UK government today announced £20m of additional funding and urged other donors to join the efforts to find a vaccine. This builds on £30 million of funding the UK Government has previously given to CEPI to support its vaccine development work against COVID-19 and other emerging infectious diseases.

### Funding call

CEPI was founded as a global partnership between public, private, philanthropic, and civil society organisations to accelerate the development of vaccines against emerging infectious diseases and enable equitable access to these vaccines for people during outbreaks. CEPI has become the lead actor on COVID-19 vaccine development and has the institutional expertise, networks, and agility to move rapidly. However, while CEPI has begun the process by supporting 4 vaccine candidates with more programmes due to be announced, without additional funding no programme will be able to progress through the earliest phase of clinical testing.

Today's call for \$2 billion of new funding will enable CEPI to expand the number of vaccine candidates at the outset to increase our chances of success, and to fund the clinical trials for these candidate vaccines. Our ambition is to have at least 3 vaccine candidates, which could be submitted to regulatory authorities for licensure for general use/use in outbreaks.

## CEPI has identified five funding phases:

### \$100m immediately, to support

o Vaccine development for 8 candidates through phase 1 clinical trials

### \$375m by END OF MARCH, to support

- o Manufacturing of clinical trial material for phase 2/3 trials for 4-6 vaccine candidates
- o Preparation of phase 2/3 trials for 4-6 vaccine candidates (potential initiation of phase
- 2 trial for 1 candidate)
- o Initial investments to expand global manufacturing capacity. These investments are needed to ensure the vaccine is ultimately available at scale and globally

## \$400m by END OF JUNE, to support

- o Execution of phase 2/3 trials for at least 2 candidates
- o Preparation of phase 2/3 clinical trials in a number of locations globally
- o Production of additional phase 2/3 clinical trial material
- o Further investment in scaling up / technology transfer of manufacturing process for up to 6 candidates

#### \$400m by END OF SEPTEMBER, to support

- o Conduct of phase 2/3 clinical trials for additional 4 candidates in a number of locations globally
- o Investment in large-scale manufacturing capacity for at least 3 vaccine candidates

### \$500-750m in 2021, to support

- o Enhancing global manufacturing capacity with tech transfer to geographically distributed locations of up to 3 candidates
- o Completion of clinical trial testing
- o Completion of regulatory and quality requirements for at least 3 vaccines
- o Preparation of regulatory dossiers for emergency authorization/licensure submission

To ensure availability of funds and reflecting the many uncertainties that still surround COVID-19, the World Bank has created a financial vehicle whereby funds can be returned to donors if not used for the response or if the epidemiological picture changes and vaccine development is deemed unwarranted.

Alternatively, at the donor's discretion, funds may be retained at the World Bank for use in a future Disease X scenario...

#### Situation Update

From 24 February to 1 March 2020, no new confirmed cases of Ebola virus disease (EVD) were reported in the Democratic Republic of the Congo (Figure 1). In the past 21 days (10 February to 1 March), the outbreak has been confined to a relatively small geographic area. During this period, two new confirmed cases were reported from one health area in Beni Health Zone, North Kivu Province (Figure 2, Table 1). It has been more than 42 days since new cases were detected in all health zones except Beni and Mabalako, though surveillance activities are ongoing in all health zones to avoid resurgence of the outbreak...

#### ...Conclusion

While there is room for cautious optimism around the absence of new confirmed cases this week, the outbreak remains active and risks of additional cases emerging remain high. Response activities must be maintained in all health zones.

#### Polio this week as of 04 March 2020

:: In May 2019, Iran reported an isolation of a wild poliovirus type1 in a sewage sample from Sistan & Balochistan province. The virus was confirmed to be genetically linked to the wild poliovirus from Karachi, Pakistan. This development, per existing global polio programme guidelines, triggered opening of an 'Event'. After months of consultations and a high level of poliovirus surveillance sensitivity, the event has now been declared closed therefore eliminating Iran from the list of outbreak countries.

# <u>Statement by Charlotte Petri Gornitzka, UNICEF Deputy Executive Director for Partnerships, on coronavirus misinformation</u>

NEW YORK, 6 March 2020 – "All around the world, people are taking necessary precautions to protect themselves and their families from coronavirus. Sound preparation, based on scientific evidence, is what is needed at this time.

"However, while many people are sharing information about the virus and how to protect against it, only some of that information is useful or reliable. Misinformation during times of a health crisis can spread paranoia, fear, and stigmatization. It can also result in people being left unprotected or more vulnerable to the virus.

"For example, a recent erroneous online message circulating in several languages around the world and purporting to be a UNICEF communication appears to indicate, among other things, that avoiding ice cream and other cold foods can help prevent the onset of the disease. This is, of course, wholly untrue.

"To the creators of such falsehoods, we offer a simple message: STOP. Sharing inaccurate information and attempting to imbue it with authority by misappropriating the names of those in a position of trust is dangerous and wrong.

"To members of the public, we ask that you seek accurate information about how to keep yourself and your family safe from verified sources, such as UNICEF or WHO, government health officials and trusted healthcare professionals; and that you refrain from sharing information from untrustworthy or unverified sources...

Today, the U.S. Agency for International Development (USAID) announced our first-ever Policy on Protection from Sexual Exploitation and Abuse (PSEA). Sexual exploitation and abuse of beneficiaries undermines the goals of international development and humanitarian assistance, and runs counter to our core values. This new Policy articulates how we will ensure people have safe access to USAID-funded services and activities.

# <u>USAID Announces an Additional \$10 Million in Humanitarian Assistance to Control Locusts in East Africa</u>

March 6, 2020

The U.S. Government, through the U.S. Agency for International Development (USAID), is providing an additional \$10 million in humanitarian assistance to support regional operations to control desert locusts in the Federal Democratic Republic of Ethiopia, the Republic of Kenya, and the Federal Republic of Somalia. This announcement brings the U.S. Government's humanitarian response to the infestation of locusts to a total of \$19 million. By helping to reduce the size of the swarms, this aid is expected to have a positive impact on affected communities throughout the Horn of Africa.

## <u>Statement: America Announces New Humanitarian Assistance for the Syria Crisis Response</u> March 3, 2020

Today in Turkey, the U.S. Representative to the United Nations, Ambassador Kelly Craft, announced \$108 million in additional humanitarian assistance for the people of Syria in response to the ongoing crisis caused by Assad regime, Russian, and Iranian forces. This includes nearly \$56 million from the State Department's Bureau of Population, Refugees, and Migration and more than \$52 million from the U.S. Agency for International Development (USAID). It brings the total U.S. humanitarian response to more than \$10.6 billion since the start of the Syria crisis. The United States remains the largest single donor of humanitarian assistance - both in Syria and around the world. This assistance is a component of our National Security Strategy to prioritize the reduction of human suffering. We appreciate all donors who have stepped up and continue to encourage both traditional and new donors to increase their efforts to help meet growing needs.

# <u>Statement by USAID Administrator Mark Green on the Commitment of \$37 Million in Assistance to Respond to Novel Coronavirus COVID-19</u>

March 2, 2020

The U.S. Government announced today a commitment of \$37 million in financing from the Emergency Reserve Fund for Contagious Infectious Diseases at the U.S. Agency for International Development (USAID) for 25 countries affected by novel coronavirus COVID-19 or at high risk of its spread. The U.S. Government is providing these funds to the World Health Organization, other multilateral institutions, and programs led by USAID's implementing partners. These are the first U.S. Government funds committed from the pledge of up to \$100 million announced by the U.S. Department of State on February 7, 2020. Because an infectious-disease threat anywhere can be a threat everywhere, we call on other donors to contribute to the effort to combat COVID-19 as well.

This edition of <u>Humanitarian Exchange</u> focuses on the crisis in Yemen. Since the war there began in 2014, thousands of civilians have been killed or injured and air strikes and ground operations have destroyed hospitals, schools and critical infrastructure. An estimated 80% of Yemenis need humanitarian assistance.

In the lead article, Laurie Lee highlights the critical role Yemenis and Yemeni organisations are playing in addressing the humanitarian challenges in the country, and how NGOs can better support them. Genevieve Gauthier and Marcus Skinner reinforce this point with reference to two local organisations, the Yemen Women's Union and Al Hikma. Warda Saleh, the founder of another Yemeni grassroots organisation, discusses the increased risk of gender-based violence facing women and girls, while Ibrahim Jalal and Sherine El Taraboulsi-McCarthy focus on internal displacement and the opportunities for a more effective humanitarian response. Reflecting on child protection programming in Yemen, Mohammed Alshamaa and Amanda Brydon conclude that multisectoral approaches with local authorities result in better and more sustainable outcomes. Padraic McCluskey and Jana Brandt consider the ethical dilemmas Médecins Sans Frontières (MSF) faced in trying to balance quality and coverage in a mother and child hospital in Taiz. Lindsay Spainhour Baker and colleagues reflect on the <u>challenges involved in gathering and analysing information on the humanitarian situation</u> while Lamis Al-Iryani, Sikandra Kurdi and Sarah Palmer-Felgate discuss the findings from an evaluation of the Yemen Social Fund for Development (SFD) Cash for Nutrition programme. An article by Kristine Beckerle and Osamah Al-Fakih details Yemeni and international organisations' efforts to document and mitigate harm to civilians caught up in the conflict. The edition ends with a piece by Fanny Pettibon, Anica Heinlein and Dhabie Brown outlining CARE's advocacy on the arms trade.

Finally, readers will note that this edition is shorter than usual, largely because it was very difficult to persuade potential authors to write on the Yemen crisis. Many of the individuals and organisations we contacted were either too busy responding or were concerned that writing frankly about their work could negatively affect their operations. HPN has covered many similarly sensitive contexts in Humanitarian Exchange over the last 26 years, but this is the first time we have experienced such reluctance to engage. A worrying sign.

Findings

In this cross-sectional study that compared the profits of 35 large pharmaceutical companies with those of 357 large, nonpharmaceutical companies from 2000 to 2018, the median net income (earnings) expressed as a fraction of revenue was significantly greater for pharmaceutical companies compared with nonpharmaceutical companies (13.8% vs 7.7%).

Meaning

Large pharmaceutical companies were more profitable than other large companies, although the difference was smaller when controlling for differences in company size, research and development expense, and time trends.

## **Abstract**

**Importance** 

Understanding the profitability of pharmaceutical companies is essential to formulating evidence-based policies to reduce drug costs while maintaining the industry's ability to innovate and provide essential medicines.

Objective

To compare the profitability of large pharmaceutical companies with other large companies.

Design, Setting, and Participants

This cross-sectional study compared the annual profits of 35 large pharmaceutical companies with 357 companies in the S&P 500 Index from 2000 to 2018 using information from annual financial reports. A statistically significant differential profit margin favoring pharmaceutical companies was evidence of greater profitability.

Exposures Large pharmaceutical vs nonpharmaceutical companies.

Main Outcomes and Measures

The main outcomes were revenue and 3 measures of annual profit: gross profit (revenue minus the cost of goods sold); earnings before interest, taxes, depreciation, and amortization (EBITDA; pretax profit from core business activities); and net income, also referred to as earnings (difference between all revenues and expenses). Profit measures are described as cumulative for all companies from 2000 to 2018 or annual profit as a fraction of revenue (margin).

Results

From 2000 to 2018, 35 large pharmaceutical companies reported cumulative revenue of \$11.5 trillion, gross profit of \$8.6 trillion, EBITDA of \$3.7 trillion, and net income of \$1.9 trillion, while 357 S&P 500 companies reported cumulative revenue of \$130.5 trillion, gross profit of \$42.1 trillion, EBITDA of \$22.8 trillion, and net income of \$9.4 trillion. In bivariable regression models, the median annual profit margins of pharmaceutical companies were significantly greater than those of S&P 500 companies (gross profit margin: 76.5% vs 37.4%; difference, 39.1% [95% CI, 32.5%-45.7%]; P < .001; EBITDA margin: 29.4% vs 19%; difference, 10.4% [95% CI, 7.1%-13.7%]; P < .001; net income margin: 13.8% vs 7.7%; difference, 6.1% [95% CI, 2.5%-9.7%]; P < .001). The differences were smaller in regression models controlling for company size and year and when considering only companies reporting research and development expense (gross profit margin: difference, 30.5% [95% CI, 20.9%-40.1%]; P < .001; EBITDA margin: difference, 9.2% [95% CI, 5.2%-13.2%]; P < .001; net income margin: difference, 3.6% [95% CI, 0.011%-7.2%]; P = .05).

Conclusions and Relevance

From 2000 to 2018, the profitability of large pharmaceutical companies was significantly greater than other large, public companies, but the difference was less pronounced when considering company size, year, or research and development expense. Data on the profitability of large pharmaceutical companies may be relevant to formulating evidence-based policies to make medicines more affordable.

**Abstract** 

Through a case study on Za'atari camp in Jordan, this paper joins a growing body of critical studies highlighting discrepancies between developmental humanitarian policies promoting the resilience and empowerment of refugees vis-à-vis realities inside camps. It shows how camp authorities incrementally unwound and stifled refugee self-governance structures and informal entrepreneurialism. It also highlights the influence of Jordanian state priorities over the aid operation and the supportive role played by the UN Refugee Agency in affirming state priorities. The paper argues that even if well-intentioned developmental humanitarianism can ultimately diminish the scope for meaningful refugee empowerment.

# **COVID-19: too little, too late?**

Although WHO has yet to call the outbreak of SARS-CoV-2 infection a pandemic, it has confirmed that the virus is likely to spread to most, if not all, countries. Regardless of terminology, this latest coronavirus epidemic is now seeing larger increases in cases outside China. As of March 3, more than 90 000 confirmed cases of COVID-19 have been reported in 73 countries. The outbreak in northern Italy, which has seen 11 towns officially locked down and residents threatened with imprisonment if they try to leave, shocked European political leaders. Their shock turned to horror as they saw Italy become the epicentre for further spread across the continent. As the window for global containment closes, health ministers are scrambling to implement appropriate measures to delay spread of the virus. But their actions have been slow and insufficient. There is now a real danger that countries have done too little, too late to contain the epidemic.

By striking contrast, the WHO-China joint mission report calls China's vigorous public health measures toward this new coronavirus probably the most "ambitious, agile and aggressive disease containment effort in history". China seems to have avoided a substantial number of cases and fatalities, although there have been severe effects on the nation's economy. In its report on the joint mission, WHO recommends that countries activate the highest level of national response management protocols to ensure the all-of-government and all-of-society approaches needed to contain viral spread. China's success rests largely with a strong administrative system that it can mobilise in times of threat,

combined with the ready agreement of the Chinese people to obey stringent public health procedures. Although other nations lack China's command-and-control political economy, there are important lessons that presidents and prime ministers can learn from China's experience. The signs are that those lessons have not been learned.

SARS-CoV-2 presents different challenges to high-income and low-income or middle-income countries (LMICs). A major fear over global spread is how weak health systems will cope. Some countries, such as Nigeria, have so far successfully dealt with individual cases. But large outbreaks could easily overwhelm LMIC health services. The difficult truth is that countries in most of sub-Saharan Africa, for example, are not prepared for an epidemic of coronavirus. And nor are many nations across Latin America and the Middle East. Public health measures, such as surveillance, exhaustive contact tracing, social distancing, travel restrictions, educating the public on hand hygiene, ensuring flu vaccinations for the frail and immunocompromised, and postponing non-essential operations and services will all play their part in delaying the spread of infection and dispersing pressure on hospitals. Individual governments will need to decide where they draw the line on implementing these measures. They will have to weigh the ethical, social, and economic risks versus proven health benefits.

The evidence surely indicates that political leaders should be moving faster and more aggressively. As Xiaobo Yang and colleagues <a href="https://have.shown">have shown</a>, the mortality of critically ill patients with SARS-CoV-2 pneumonia is substantial. As they wrote recently in The Lancet Respiratory Medicine, "The severity of SARS-CoV-2 pneumonia poses great strain on critical care resources in hospitals, especially if they are not adequately staffed or resourced." This coronavirus is not benign. It kills. The political response to the epidemic should therefore reflect the national security threat that SARS-CoV-2 represents.

National governments have all released guidance for health-care professionals, but published advice alone is insufficient. Guidance on how to manage patients with COVID-19 must be delivered urgently to health-care workers in the form of workshops, online teaching, smart phone engagement, and peer-to-peer education. Equipment such as personal protective equipment, ventilators, oxygen, and testing kits must be made available and supply chains strengthened. The European Centre for Disease Prevention and Control recommends that hospitals set up a core team including hospital management, an infection control team member, an infectious disease expert, and specialists representing the intensive care unit and accident and emergency departments.

So far, evidence suggests that the colossal public health efforts of the Chinese Government have saved thousands of lives. High-income countries, now facing their own outbreaks, must take reasoned risks and act more decisively. They must abandon their fears of the negative short-term public and economic consequences that may follow from restricting public freedoms as part of more assertive infection control measures.

# Children on the move—a call for active screening in migrants

Paediatricians, general practitioners, and family doctors are increasingly confronted with medical symptoms previously not on their radar, because of a rise in migration. In the past 5 years, an

estimated 1 million displaced children and adolescents have entered the EU and European Economic Area (EEA), many of them unaccompanied. This vulnerable group faces great challenges and health risks. Societies should welcome migrant families, and medical professionals should help integrate migrant children into health-care systems to ensure high quality care is delivered sustainably. Besides obvious benefits for the individual, it is in the interest of societies to prevent increased incidence of infectious diseases that are currently well controlled, such as tuberculosis. Three infectious diseases—tuberculosis, schistosomiasis, and strongyloidiasis—are particularly relevant and should be seen as priorities for screening and treatment in migrant children.

# Child and adolescent health in the digital age

On 18 February, 2020, The Lancet published the report of the WHO-UNICEF-Lancet Commission, calling for a refocus of the Sustainable Development Goals (SDGs) around child and adolescent health. All sectors are responsible for children's wellbeing, with digital platforms and artificial intelligence (AI) playing an increasing role in child and adolescent health.

The Commission argues that open dialogue across generations is essential to understand the needs of children and adolescents, especially in low- and middle-income countries (LMICs) where 90% of the global youth population currently live. Digital technologies, such as social media and AI-based chatbots, have much to offer in this regard. The Commission highlights that adolescents are enthusiastic users of technology, with those aged 11–16 years posting on social media on average 26 times a day. With a predicted 40 times increase of their global volume of data, adolescents who might seldom access traditional health services, could more easily be reached through digital health platforms. For example, the Commission describes U-Report, a mobile-based online poll for real-time data collection, which collates opinions from approximately 1 million youths from over 50 LMICs to better communicate with government officials to strengthen public health campaigns, such as immunisation awareness.

Despite the development of promising digital interventions, the Commission calls for further research to understand ways to positively engage with adolescents about health issues using digital technology. A paper in The Lancet Digital Health, by Maree Teesson and colleagues, reported a cluster-randomised controlled trial in 71 schools in Australia, which showed efficacy of an online digital intervention for prevention of substance use, depression, and anxiety in adolescents. This digital intervention allows scaling up of prevention programmes, which could reduce costs and increase accessibility to lower resource settings. However, further trials are necessary to determine whether this intervention is cost effective and if the benefits are sustained beyond the trial phase.

The Commission cites several digital interventions that have shown potential in engaging adolescents about health issues; however, the report does not mention augmented reality, a burgeoning area of research in child and adolescent health. In The Lancet Digital Health, Kollins and colleagues describe a randomised controlled trial to test the efficacy of a video game-like interface designed to support children with attention deficit hyperactivity disorder. The results of the trial show that this digital intervention can increase attentional functioning of children with the disorder, but future trials are necessary to examine the durability and time course of the intervention.

The prevalent use of digital platforms, such as social media, has encouraged speculation that their regular use might negatively effect child and adolescent health, a concern echoed within the Commission. However, current evidence supporting this idea is controversial due to the nature of the large-scale social datasets used in many studies which could be prone to potential false positives and conflicting results. A study attempted to address these challenges using three large-scale social datasets and found no significant correlational evidence for detrimental effects of digital technology on adolescent health.

The Commission ends with the quote "what gets measured, gets done", which highlights a well known barrier to achieving the SDGs: inability to collect the necessary quality and volume of data to monitor progress. Open data is needed to overcome the barriers to collect and share data for SDG progress, and the Commission authors rightly demand better use of data from publicly available sources. However, there are concerns regarding the few safeguards to protect children's data, especially against data manipulation through black box and biased algorithms. The Commission also highlights the shortcomings of current data privacy regulations, emphasising that public sector bodies and commercial organisations have failed to ensure privacy, transparency, security, and redress when handling children's data. The assurance of privacy and security of data is key to the success of digital innovation and transformation of health care.

Digital platforms and AI are necessary tools to enable children and adolescents to be agents of change, encouraging open dialogue between children, international agencies, and governments to achieve the SDGs for a better future.

# 3D technology and telemedicine in humanitarian settings

In 2017, the Médecins Sans Frontières (MSF) Foundation initiated a pilot project with the MSF Reconstructive Surgery Program (RSP; established in 2006) in Amman, Jordan, to help to provide comprehensive rehabilitation services for patients with facial burns and upper limb differences. A multidisciplinary team, spanning specialists with expertise in prosthetics and orthotics, physical and occupational therapy, rehabilitation medicine, surgery, and biomedical engineering, collaborated on development of personalised prosthetic and orthotic devices using 3D technologies and telemedicine (appendix).

...Despite the many challenges, our experience suggests that 3D technologies and telemedicine can serve as useful tools for increasing access to comprehensive rehabilitation care in certain humanitarian contexts. However, more objective measures and longer-term follow-up are needed to determine the efficacy and effectiveness of implementing this technology to deliver prosthetics and orthotics. Well designed randomised control trials are needed to determine whether the digital approach can improve clinical outcomes or reduce cost without compromising the quality of care. Also, patients living in low-resource settings often require more durable devices that can withstand difficult conditions with minimal maintenance. Lastly, implementing a programme that focuses entirely on delivering devices and neglects the need for comprehensive rehabilitation care would probably result in rejection of the devices and inadequate patient care...

# **Challenges of coronavirus disease 2019**

Yet again, the world is experiencing a global viral epidemic of zoonotic origin. As of Feb 12, 45 204 confirmed cases of coronavirus disease 2019 (COVID-19) and 1116 deaths had been reported in 25 countries. The majority of cases and, at the time of writing, all but one death have been in China, despite efforts in the country to halt transmission through shutting down transport, quarantining entire cities, and enforcing the use of face masks. International flights have been cancelled and affected cruise ships quarantined. At this stage, it is unclear whether the severe acute respiratory syndrome coronavirus (SARS-CoV)-2 outbreak will run its course, as SARS-CoV did in 2003, or will become an endemic cause of viral pneumonia.

In our January issue we announced the formation of The Lancet Infectious Diseases Commission on Preparedness for Emerging Epidemic Threats. The Commission will revisit global preparedness planning and assumptions underlying agreements such as the International Health Regulations. It aims to account for new challenges in preparing for and responding to infectious disease outbreaks. These challenges, which are political and institutional, social, environmental, technological, and pathogen-related, are being brought to the foreground by the SARS-CoV-2 outbreak.

One issue is how prepared the world's health systems are to respond to an outbreak of this scale. It's clear the large number of cases of COVID-19 is testing the health system in China. Yet, China was able to build a hospital for affected patients in a matter of days. No other country could mobilise resources and manpower at such speed. While health systems in high-income countries would be stretched by the outbreak, the most devastating effects would be in countries with weak health systems, ongoing conflicts, or existing infectious disease epidemics.

In these countries, it is imperative to rapidly detect and contain the virus at points of entry to prevent community transmission and health systems from being overwhelmed. Health authorities in Africa are on high alert for the virus, given the continent's extensive trade and transport links with Asia. The capacity in Africa to screen, isolate, and treat patients and perform contact tracing is being built under the leadership of the Africa Centres for Disease Control and Prevention and WHO.

As in all outbreaks, there is an urgent need to develop effective diagnostics, therapeutics, and vaccines. Several experimental diagnostic platforms are already in use in China and elsewhere. The whole-genome sequence of SARS-CoV-2 had been obtained and shared widely by mid-January, a feat not possible at such speed in previous infectious disease outbreaks. This sequence will allow fine-tuning of existing technologies and development of better diagnostics and targeted therapeutics. Several potential treatments have been proposed, including a Janus kinase inibitor known as <u>baricitinib</u>. However, no antiviral treatment has been approved for coronaviruses, and despite two outbreaks of

novel coronaviruses in the past two decades, vaccine development is still in its infancy. WHO has announced that a vaccine for SARS-CoV-2 should be available in 18 months, but achieving this will require funding and public interest to be maintained even if the threat level falls.

Social media and sensationalist reporting are challenging outbreak response efforts. Misinformation and conspiracy theories spread on social media have generated panic and mistrust among the general public, diverted attention away from the outbreak response, and impeded the activities of health-care workers. WHO Director-General Tedros Adhanom Ghebreyesus said WHO is tackling the spread of false information with a "four-pronged approach", including using its WHO Information Network for Epidemics platform to track misinformation in multiple languages and collaborating with social and digital companies such as Facebook, Weibo, and Twitter to filter out false information.

How prepared the world was for the SARS-CoV-2 outbreak will surely be discussed in its aftermath. The initial response in China to contain the virus was applauded by WHO and considered much improved compared with its response to the 2003 SARS-CoV epidemic. Internationally, we have seen rapid generation and sharing of knowledge to the benefit of the outbreak response, but also counterproductive actions by some countries, including limiting trade and shutting of borders, to its detriment. With the increasing frequency of zoonotic spillovers leading to human infections and transmission, it's apparent that pandemic preparedness has become a priority for the global health agenda.

# Saturation point

Tropical forests, such as the one in the Democratic Republic of the Congo pictured, are important carbon sinks, removing about 15% of anthropogenic carbon dioxide over the course of the 1990s and early 2000s. In this week's issue, Wannes Hubau and his colleagues examine the rates at which such forests in Africa and Amazonia have taken up carbon between 1983 and 2015 — and find marked differences between the two regions. They reveal that the ability of forests in Africa to act as a carbon sink was stable until the 2010s when it began to decline, in contrast to the previously documented decline in Amazonian forests since the 1990s. They conclude that both continents show a pattern of carbon-sink saturation and decline, with asynchronous timing and different rates of reduction. The researchers extrapolate their findings to predict that by 2030 the carbon sink in Africa will have shrunk by 14% compared with 2010–15, and that the Amazonian sink will reach zero in 2035. This decline has significant implications for the goal of limiting global warming to below 2 °C

# <u>Maternal perceptions of father involvement among refugee and disadvantaged families in</u> Beirut, Lebanon

**Abstract** 

The role of fathers in (co-)parenting their children among refugee and disadvantaged families in low and middle-income countries (LMICs) remains poorly understood. This study sought to examine the associations among mothers' perceptions of their husband's involvement (hereafter referred to as paternal involvement), and her perceptions of her own well-being and a number of other variables, as well as observed mother-child interactions in families living in refugee and disadvantaged communities in Beirut, Lebanon. We analyzed baseline data from 104 mother-child dyads (mean age of children = 4.34 years; range = 2.05 to 7.93 years of age) who participated in a randomized controlled trial aimed at evaluating the impact of the Mother-Child Education Program in Beirut. In addition to the mother's perception of paternal involvement and the videotaped mother-child interactions, data were collected concerning the mother's well-being and her level of social support, as well as her level of stress as a parent and the way her children were disciplined in the family. Mother-child pairs were videotaped while completing a puzzle together and dyadic interactions were coded. Path analysis showed that paternal involvement was significantly associated with a higher level of maternal well-being and lower distress levels. In addition, higher levels of maternal distress were associated with higher levels of harsh discipline and parenting stress. Correlation analysis showed that higher perceptions of paternal involvement were associated with more positive affect displayed by the child, more positive regard for the child, and better mother-child synchrony during the dyadic interactions. Limitations include the cross-sectional design and the modest sample size, which hinder causal inferences and generalizability of the findings. These preliminary findings suggest that higher levels of paternal involvement may have an impact on markers of maternal mental health and positive mother-child interactions in families living in disadvantaged communities or humanitarian settings. Paternal involvement should be considered when designing and implementing parenting programs in LMICs.
