## **Involvement of Children in Armed Conflict: 20 Years After the Adoption of OPAC**

Monday, 25 May 2020

Joint Statement by the African Union Commissioner for Peace and Security, the European Parliament Intergroup on Children's Rights and the Special Representative of the Secretary-General for Children and Armed Conflict

Today marks the 20th anniversary of the adoption of the Optional Protocol to the Convention on the Rights of the Child (CRC) on the involvement of children in armed conflict (OPAC). In this juncture, the African Union Commissioner for Peace and Security, H.E. Smaïl Chergui and the Co-Chair of the European Parliament Intergroup on Children's Rights, Mr. David Lega join their voices with the Special Representative of the United Nations Secretary-General for Children and Armed Conflict, Ms. Virginia Gamba to urge all outstanding Member States to sign and ratify the OPAC and fulfill the promise made to children two decades ago that they would not be involved in armed conflict. The adoption of OPAC was a milestone and within the past 20 years has contributed to releasing more than 145,000 boys and girls from armed forces and armed groups and preventing the recruitment and use of more millions of children.

Since its adoption, the Optional Protocol has become a lighthouse to guide the efforts of States in ending and preventing the involvement of children in armed conflict and to counter the long-lasting effects conflict has on children. "As we mark this anniversary, we must pause and remember what the world was like before OPAC's adoption," said the three officials. "We must also take time to note its remarkable achievements and enormous potential for the next decade. Indeed, the Decade of Action calls to accelerate sustainable solutions to the world's biggest challenges; eradicating the recruitment and use of children allows countries to focus on the actual needs of children such as education, healthcare and future livelihood opportunities."

While OPAC paved the way for countries to ensure that children were not taking part in hostilities, its relevance and implementation in today's world continue to be critical, especially as countries are seeking to reach the Sustainable Development Goals (SDGs). The protection of conflict-affected children should be an active part of the Humanitarian-Development-Peace Nexus to ensure that the vulnerability of children is addressed before, during and after conflicts. Ending and preventing the recruitment and use of children is only the first step: supporting the sustainable reintegration of released boys and girls into their communities is essential for their future, but also for the future of the entire society.

"As we mark OPAC's 20th anniversary, we urge Member States that are not yet parties to OPAC to become one, and to do so on behalf of their children and countries future," said the three officials. "We also urge State Parties that have ratified OPAC to implement the obligations contained in this treaty and ensure that they do not remain dead letters. By ratifying the OPAC, Member States commits to align their legal frameworks with international standards, pursue accountability for violations of children's fundamental rights and prevent the recruitment and use of children in armed conflict. With only 17 Member States that are yet to become a party to this important treaty, it is evident that universal ratification is more achievable than before," they said.

"The next twenty years must reflect the translation of OPAC's commitments into tangible actions. We must ensure that children are not only freed from the threat of recruitment and use but are also provided with options to enjoy a better future and not left without support or subsistence; conflict-affected children need our support in every aspect of their growth. The Optional Protocol should thus remain our beacon and serves to remind us that if children are not allowed to be children and forced into taking part in hostilities, we have not only failed them but have betrayed our own hopes for a brighter future."

# <u>Precision Medicine Vision Statement</u> :: A Product of the World Economic Forum Global Precision Medicine Council

The benefits of precision medicine in terms of superior health and healthcare outcomes are increasingly clear, but there are challenges to the equitable and widespread dissemination of precision medicine tools, technologies and solutions.

The World Economic Forum convened more than 40 leaders from the public and private sectors, civil society and academia in a Global Precision Medicine Council (the Council) in 2019 to help shape the governance of precision medicine in the public interest. This document is the Council's synthesis of the key policy and governance gaps, and its vision for the solutions to overcome them. It should serve as a reference for the greater healthcare community with an interest in helping deliver these benefits on a global basis.

# These five governance gaps are:

- 1) data sharing and interoperability;
- 2) ethical use of technology;
- 3) patient and public engagement and trust;
- 4) access, delivery, value, pricing and reimbursement;
- 5) responsive regulatory systems.

Using illustrative examples of solutions or analytical frameworks to overcome these five gaps, the Council provides areas of opportunity to accelerate precision medicine approaches globally. The main considerations and recommendations include:

- Increasing awareness of the benefits of data standardization and interoperability and fostering trusted mechanisms of collaboration involving patients to unlock the vast amounts of data needed
- Learning lessons from research efforts that were discriminatory or hurtful and focusing new efforts on inclusivity and representativeness to support ethical technology development
- Building public and patient trust and engagement by encouraging deliberation and mechanisms on if/how genetic and other sensitive health data are accessed or used by commercial companies and law enforcement
- Innovating intellectual property protection regimes for biomarkers and algorithms as part of the process of incentivizing investment in foundational new diagnostics
- Funding and publicly reporting post-market clinical trials and studies for fast-track therapeutics that allow healthcare providers to clearly understand the value of precision medicine treatments and receive payments based on performance
- Designing and implementing consistent and appropriate regulatory frameworks that protect the health information generated from direct-to-consumer genetic services in a way that support the values of patients and participants

Unfortunately, more than half of the world's population still has no access to precision medicine and is unable to reap the benefits. We must be ever vigilant about increasing the capabilities of many countries and populations to join this global movement towards more personalized and targeted ways of screening, preventing, diagnosing, treating and curing patients with disease. The importance of worldwide access and of addressing these inequities is urgent. With this in mind, the Council aims to contribute positively to the global debate and activity by framing solutions that may be scalable and useful in many settings, as well as by identifying ongoing challenges that remain resistant to solutions in order to focus new creativity on finding appropriate paths forward.

# <u>Blockchain Principles Launched to Preserve and Protect User Rights</u> – *The Presidio Principles*

World Economic Forum News 22 May 2020

- 16 user rights make up the newly launched Presidio Principles: the foundational values for a decentralized future
- This 'Blockchain Bill of Rights' establishes a global baseline for building blockchain applications that respect participant rights, safeguard data and protect users
- It was developed for over a year by the World Economic Forum Global Blockchain Council, which brings together individuals with varying interests and perspectives on the current state and future of blockchain; it was workshopped globally with technologists and civil society
- Early adopters include public and private sector companies, international organizations, NGOs and civil society and global call issued.

### The Presidio Principles

Applications built on top of blockchain-based systems should preserve the following participant rights.

A participant should have access to information that would enable them to:

- Understand how a service is operated, including potential risks of the service, availability of source code, and the rules and standards upon which it is based.
- Understand the potential risks and benefits of a service's use of blockchain technology.
- Understand system performance expectations and where the responsibility for service delivery lies.
- Understand the rights and obligations of different participants in the system.

# A participant should be able to:

- Create, manage, and independently store cryptographic keys.
- Manage consent of data stored in third-party systems.
- Port data between interoperable systems or parts of a system.
- Revoke consent for future data collection.
- Have access to information sufficient to facilitate system interoperability.
- Assess if their data is at risk through appropriate disclosure procedures, which may include, but are not limited to, an examination of audit results, certifications, or source code.
- Have their data protected in accordance with internationally recognized technical security standards.
- Limit data collection to that which is necessary and data use to the purpose for which it was provided.
- Verify through third-party or self-created tools that operations have been completed and confirmed in accordance with the system's rules.
- Access information needed to: (a) understand the system's governance and rules and (b) pursue effective recourse mechanisms.
- Opt-out of using applications that don't treat data in accordance with internationally recognized governance and data protection standards.
- Rectify demonstrably false, inaccurate, or incomplete data when necessary.

The Principles include a menu of options for how organizations or individuals can take action. A list of signatories is <u>available</u> to view and self-regulate/hold others accountable.

### **UNESCO Report :: Museums Around the World in the Face of COVID-19**

May 2020 :: 31 pages

SUMMARY

In recent months, the COVID-19 crisis has profoundly affected societies around the world, plunging the global economy into a deep recession.

With the majority of cultural institutions forced to close their doors, the cultural sector has been one of the most affected. Tourism has largely ceased, impacting surrounding communities both socially and economically, and plunging artists and cultural professionals into a state of extreme economic and social fragility. Confined populations, unable to share and celebrate their heritage – notably their intangible cultural heritage – have suffered the loss of fundamental and structuring cultural elements of their daily social and individual lives.

Despite the challenges posed by this unprecedented crisis, many cultural institutions and professionals have continued to serve as a source of resilience and support to communities, devising new ways to provide access to culture and education in the context of containment measures. However, it should be noted that these innovations have not addressed the severe economic shortfalls experienced by cultural professionals. Moreover, almost half of the world's population currently has no access to the Internet, resulting in unequal access to cultural resources.

Museums have been particularly affected by the COVID-19 pandemic, with nearly 90% of them, or more than 85,000 institutions worldwide, having closed their doors during the crisis. The impact of these closures is not only economic, but also social. Museums play a vital role in our societies. They not only preserve our common heritage, but also provide spaces that promote education, inspiration and dialogue. Based on values of respect and cultural diversity, museums strengthen social cohesion, foster creativity and are conveyors of collective memory. Moreover, their role in the promotion of tourism is a key driver of sustainable economic development, both locally and nationally, which will be essential to overcoming the crisis in the coming months and years.

Faced with this situation, UNESCO launched a study to assess, on the basis of contributions from states and museum professionals, the impact of COVID-19 on museums and museum institutions. This initiative also seeks to understand how the sector has adapted to the constraints imposed by the pandemic and to explore ways of supporting affected institutions in the aftermath of the crisis. This report presents a first assessment of the impact of COVID-19 on the museum sector.

# <u>Launch of UNESCO Report on museums around the world in the face of COVID-19</u> 27/05/2020

UNESCO launched a new <u>Report on Museums Around the World in the Face of COVID-19</u>, fruit of an international survey targeting museums, culture professionals and Member States.

This Report, presenting a first evaluation of the impact of COVID-19 across the museum sector, sheds new light on the key trends of the world's museums, their reaction in the face of the crisis, their capacity for resilience, and the challenges of accessing culture.

The study reveals that the number of museums is estimated at around 95,000 in 2020, which represents a 60% increase compared to 2012. They are, however, very unevenly distributed across the globe. Museums have been particularly affected by the pandemic, as 90% of them closed their doors during the crisis and, according to the International Council of Museums (ICOM), more than 10% may never reopen. Facing the crisis, museums acted quickly to develop their presence on the Internet. However the digital divide is more evident than ever: only 5% of museums in Africa and the Small Island Developing States (SIDS) were able to propose online content.

"This report not only provides a better understanding of the impact of the COVID-19 pandemic on museum institutions and the challenges they will face following the health crisis, but also explores the ways to support museums in the aftermath of the crisis," declared Audrey Azoulay, Director-General of UNESCO. "There is an urgent need to strengthen policies that support this sector, which plays an essential role in our societies for the dissemination of culture, education, social cohesion and support to the creative economy."

With a view to gather information on how the ongoing COVID-19 outbreak affects the culture sector, the International Council of Museums (ICOM) launched a global survey to analyze the impact of the quarantine measures. The <a href="ICOM report">ICOM report</a> provides information on the situation of museums and their staff, the predicted economic impact, digitization and communication, museum security and the conservation of collections, and the situation of independent museum professionals.

This common reflection and inter-institutional cooperation provides updated data on museums and museum institutions, that are all the more important in this period of global challenge brought about by COVID-19.

Health professionals stand united in support of a pragmatic, science-based approach to managing the COVID-19 pandemic. In that same spirit, we also stand united in support of a #HealthyRecovery from this crisis.

We have witnessed first-hand how fragile communities can be when their health, food security and freedom to work are interrupted by a common threat. The layers of this ongoing tragedy are many, and magnified by inequality and underinvestment in public health systems. We have witnessed death, disease and mental distress at levels not seen for decades.

These effects could have been partially mitigated, or possibly even prevented by adequate investments in pandemic preparedness, public health and environmental stewardship. We must learn from these mistakes and come back stronger, healthier and more resilient.

Before COVID-19, air pollution – primarily from traffic, inefficient residential energy use for cooking and heating, coal-fired power plants, the burning of solid waste, and agriculture practices – was already weakening our bodies. It increases the risk of developing, and the severity of: pneumonia, chronic obstructive pulmonary disease, lung cancer, heart disease and strokes, leading to seven million premature deaths each year. Air pollution also causes adverse pregnancy outcomes like low birth weight and asthma, putting further strain on our health care systems.

A truly healthy recovery will not allow pollution to continue to cloud the air we breathe and the water we drink. It will not permit unabated <u>climate change and deforestation</u>, <u>potentially unleashing new health threats upon vulnerable populations</u>.

In a healthy economy and civil society the most vulnerable among us are looked after. Workers have access to well-paying jobs that do not exacerbate pollution or nature degradation; cities prioritise pedestrians, cyclists and public transport, and our rivers and skies are protected and clean. Nature is thriving, our bodies are more resilient to infectious diseases, and nobody is pushed into poverty because of healthcare costs.

To achieve that healthy economy, we must use smarter incentives and disincentives in the service of a healthier, more resilient society. If governments were to make major reforms to current fossil fuel subsidies, shifting the majority towards the production of clean renewable energy, our air would be cleaner and climate emissions massively reduced, powering an economic recovery that would spur global <u>GDP gains of almost 100 trillion US dollars</u> between now and 2050.

As you direct your attention to the post-COVID response, we ask that your chief medical officer and chief scientific advisor are directly involved in the production of all economic stimulus packages, report on the short- and long-term public health repercussions that these may have, and give their stamp of approval.

The enormous investments your governments will make over the coming months in key sectors like health care, transport, energy and agriculture must have health protection and promotion embedded at their core.

What the world needs now is a #HealthyRecovery. Your stimulus plans must be a prescription for just that.

International community rallies to support open research and science to fight COVID-19

WHO and Costa Rica launch landmark COVID-19 Technology Access Pool

Thirty countries and multiple international partners and institutions have signed up to support the COVID-19 Technology Access Pool (C-TAP) an initiative aimed at making

# vaccines, tests, treatments and other health technologies to fight COVID-19 accessible to all.

The Pool was first proposed in March by President Carlos Alvarado of Costa Rica, who joined WHO Director-General Dr Tedros Adhanom Ghebreyesus today at the official launch of the initiative.

"The COVID-19 Technology Access Pool will ensure the latest and best science benefits all of humanity," said President Alvarado of Costa Rica. "Vaccines, tests, diagnostics, treatments and other key tools in the coronavirus response must be made universally available as global public goods".

"Global solidarity and collaboration are essential to overcoming COVID-19," said WHO Director-General Dr Tedros Adhanom Ghebreyesus. "Based on strong science and open collaboration, this information-sharing platform will help provide equitable access to life-saving technologies around the world."

**The COVID-19 (Technology) Access Pool will be voluntary and based on social solidarity.** It will provide a one-stop shop for scientific knowledge, data and intellectual property to be shared equitably by the global community.

The aim is to accelerate the discovery of vaccines, medicines and other technologies through openscience research, and to fast-track product development by mobilizing additional manufacturing capacity. This will help ensure faster and more equitable access to existing and new COVID-19 health products.

# There are five key elements to the initiative:

- :: Public disclosure of gene sequences and data;
- :: Transparency around the publication of all clinical trial results;
- :: Governments and other funders are encouraged to include clauses in funding agreements with pharmaceutical companies and other innovators about equitable distribution, affordability and the publication of trial data;
- :: Licensing any potential treatment, diagnostic, vaccine or other health technology to the Medicines Patent Pool a United Nations-backed public health body that works to increase access to, and facilitate the development of, life-saving medicines for low- and middle-income countries.
- :: Promotion of open innovation models and technology transfer that increase local manufacturing and supply capacity, including through joining the Open Covid Pledge and the Technology Access Partnership (TAP).

With supportive countries across the globe, C-TAP will serve as a sister initiative to the Access to COVID-19 Tools (ACT) Accelerator and other initiatives to support efforts to fight COVID-19 worldwide.

WHO, Costa Rica and all the co-sponsor countries have also issued a "Solidarity Call to Action" asking relevant stakeholders to join and support the initiative, with recommended actions for key groups, such as governments, research and development funders, researchers, industry and civil society...

To date, the COVID-19 Technology Access Pool is now supported by the following countries: Argentina, Bangladesh, Barbados, Belgium, Belize, Bhutan, Brazil, Chile, Dominican Republic, Ecuador, Egypt, El Salvador, Honduras, Indonesia, Lebanon, Luxembourg, Malaysia, Maldives, Mexico, Mozambique,

Norway, Oman, Pakistan, Palau, Panama, Peru, Portugal, Saint Vincent and Grenadines, South Africa, Sri Lanka, Sudan, The Netherlands, Timor-Leste, Uruguay, Zimbabwe,

#### Situation Update

From 18 to 24 May 2020, no new confirmed cases of Ebola virus disease (EVD) have been reported in the Democratic Republic of the Congo. The definitive source of infection of the cluster reported in April 2020 remains unidentified. In the last seven days, two historic probable cases were validated, from people who had onset of symptoms in March 2019 and July 2019....

#### Conclusion

Investigations into the origin of the last cluster of cases in Beni Health Zone are ongoing. The Ministry of Health began the 42-day countdown to the declaration of the end of the EVD outbreak on 14 May 2020. Given the long duration and large magnitude of the Ebola outbreak in North Kivu, South Kivu and Ituri Provinces, as well as the fact that the virus is present in animal reservoirs in the region, there is a risk of re-emergence of the virus in the period leading up to, and beyond, the declaration of the end of the outbreak. In the coming weeks it is crucial to maintain a strong and robust surveillance system in order to detect, isolate, test and treat new suspected cases as early as possible, to improve outcome of potential cases, and to break new chains of transmission. Continued coordination, communication among partners, authorities and affected communities along with EVD survivor advocacy remain essential in this outbreak response.

Geneva — Unitaid welcomes the call by WHO and the President of Costa Rica for the voluntary pooling of knowledge, intellectual property and data for COVID-19 health technologies to help ensure equitable access to global public goods.

WHO Director-General Dr Tedros Adhanom Ghebreyesus and President Carlos Alvarado Quesada of Costa Rica <u>launched the initiative at a digital event on Friday 29 May</u>, together with the support of a large number of Member States and international organisation. The 'Solidarity Call to Action' targets governments, public and private sector funders of research, pharmaceutical industry, as well as researchers themselves.

Marisol Touraine, Chair of the Unitaid Executive Board and former French health minister said, "Equitable access to better medicines, tests and preventive methods is at the heart of Unitaid's work – not just for COVID-19 but for HIV, tuberculosis, malaria and other diseases." She continues, "We very much support the call for non-exclusive and global voluntary licensing through the Unitaid-established and supported Medicines Patent Pool, as well as through other mechanisms such as the UN Technology Bank-WHO TechAccess Partnership."

Speaking at the launch, Dr Philippe Duneton, Unitaid Executive Director a.i., said. "Voluntary pooling is an important step in towards equitable access to COVID-19 medicines and tests. Intellection property rights are not the problem here, it is the way in which they are used. We expect the pharmaceutical industry to turn IP rights into solutions. Unitaid has created and supported MPP, and it has shown the way for the HIV response; this model is also key for the COVID-19 response". He continues, "Global threats need global solutions. Many have to choose between health and hunger. It also affects the income of aid agencies, and the lack of aid leads to additional hardship. Covid often comes on top of other crises; for example locust swarms in Africa and Asia, or ongoing conflicts and displacement. Doing remote research in crises when researcher's and participant's mobility is limited is hard but not impossible. Qualitative enquiry is particularly difficult but no less needed in a crisis which is as much a social and medical phenomenon. Ethical issues such as consent and confidentiality remain crucial but also require new thinking. Our week's special on remote research gives some ideas.

#### **Economic vulnerability and payment for research participation**

There has been significant analysis of the ethical and regulatory issues involved with paying research participants, but less attention has been focused specifically on paying economically vulnerable individuals and the unique challenges it may present. This is important, as individuals of lower socioeconomic standing are present in all disease groups and study populations. Moreover, clinical research is often conducted in economically under-developed locales, such as lower- or middle-income countries as well as impoverished locales of otherwise wealthy nations (such as, for example, rural Appalachia in the United States). Is it ethical to offer payment in such contexts? What are the ethical considerations relevant for determining payment rates and practices to individuals who are economically vulnerable? We offer an analysis of these issues, focusing on four unique areas of concern: (1) whether the risk of undue influence is greater for economically vulnerable individuals than for wealthier ones; (2) whether payment unacceptably raises the risk of 'unjust influence' or disproportionate representation of poor people in clinical research; (3) the positive reasons in favor of paying economically vulnerable people that stem from the ethical value of fairness; and (4) appropriate compensation rates for economically vulnerable populations. Our analysis supports the position that payment to economically vulnerable populations is ethically justified and indeed desirable when certain conditions are met.

## A systematic literature review of the ethics of conducting research in the humanitarian setting

Abstract Background

Research around humanitarian crises, aid delivery, and the impact of these crises on health and well-being has expanded dramatically. Ethical issues around these topics have recently received more attention. We conducted a systematic literature review to synthesize the lessons learned regarding the ethics of research in humanitarian crises.

#### Methods

We conducted a systematic review using the Preferred Reporting Items for Systematic Reviews and Meta-analysis (PRISMA) guidelines to identify articles regarding the ethics of research in humanitarian contexts between January 1, 1997 and September 1, 2019. We analyzed the articles to extract key themes and develop an agenda for future research.

#### Results

We identified 52 articles that matched our inclusion criteria. We categorized the article data into five categories of analysis: 32 were expert statements, 18 were case studies, 11 contained original research, eight were literature reviews and three were book chapters. All included articles were published in English. Using a step-wise qualitative analysis, we identified 10 major themes that encompassed these concepts and points. These major themes were: ethics review process (21 articles, [40.38%]); community engagement (15 articles [28.85%]); the dual imperative, or necessity that research be both academically sound and policy driven, clinical trials in the humanitarian setting (13 articles for each, [25.0%)]; informed consent (10 articles [19.23%]); cultural considerations (6 articles, [11.54%]); risks to researchers (5 articles, [9.62%]); child participation (4 articles [7.69%]); and finally mental health, and data ownership (2 articles for each [3.85%]).

#### Conclusions

Interest in the ethics of studying humanitarian crises has been dramatically increasing in recent years. While key concepts within all research settings such as beneficence, justice and respect for persons are crucially relevant, there are considerations unique to the humanitarian context. The particular vulnerabilities of conflict-affected populations, the contextual challenges of working in humanitarian settings, and the need for ensuring strong community engagement at all levels make this area of research particularly challenging. Humanitarian crises are prevalent throughout the globe, and studying them with the utmost ethical forethought is critical to maintaining sound research principles and ethical standards.

## [Excerpt]

#### Informed consent

Like formal ethical review, informed consent is another core component of modern research ethics and was separately discussed in ten articles [21,22,23, 27, 37, 38, 44, 46, 65, 66]. Our results highlight several unique considerations when contemplating informed consent in humanitarian settings. For

example, Western norms of written consent might be impossible if research is carried out in a population with low literacy rates or when written consent can violate the need for complete anonymity or expeditious research [21, 22, 44]. Controversy surrounding traditional ideas of informed consent were highlighted by Chiumento et al. in their literature review [22]. The authors explain that despite the general consensus that informed consent was central to ethical research, there were some authors who emphasized a more informal process that considered "consent as a partnership between researchers and participants" [22]. Some authors surveyed in the study supported flexibility in informed consent by utilizing a "consent framework" that presumably ensures norms such as autonomy and capacity, but allows some latitude for the researcher to adapt to the circumstances. Germane to this point is what Black et al. describe as "dynamic consent"—where a participant's willingness to be involved in a project is constantly reassessed [44].

Chiumento et al. explain that because of cultural norms, the typical processes of consent may be undesirable or even impossible [21]. In their case study of research conducted in a post-conflict setting in South Asia, they explain that the procurement of informed consent first required permission from gatekeepers (i.e. household males and village elders) [21]. They outline the concept of negotiated consent in which collaboration with researchers helps to distil what exactly culturally specific consent would look like and proceed with an ad-hoc consent process [21].

Our results suggest that special attention be paid to informed consent during clinical trials conducted in the humanitarian setting [29, 46, 51]. Particularly illustrative is the idea of informed consent for experimental therapies during the Ebola outbreak in West Africa in 2014–2015 [46]. Authors raise the question as to whether or not informed consent, free of coercion, can really be possible when potential subjects are faced with such a deadly disease [23].

The use of participatory visual methods (PVM) poses specific challenges with regard to informed consent. The methods ask researchers to encourage subjects to engage in creative forms of communication and expression, such as drama, photography, film, drawing, design, creative writing and music. The products can then be used to engage the community and answer research questions. However, as participants are synthesizing novel content during the study, and are often encouraged to draw on traumatic experiences as inspiration for this content, fully informed consent is impossible. This is because neither participants nor investigators can completely anticipate which direction their facilitated creative endeavors might turn [44, 65]. This type of research may require more creative or dynamic forms of consent such as frequent check-ins with participants, or "dynamic consent", as described above...

Measuring Modern Slavery: Law, Human Rights, and New Forms of Data

**ABSTRACT** 

This article argues that many of the lessons learned and achievements made in the measurement of human rights over the past four decades are equally applicable to the measurement of modern slavery. It shows that modern slavery encompasses a significant subset of human rights found in international law, the parameters of which can be delineated and operationalized in ways that make the phenomenon amenable to measurement across a wide range of different data. These include events-based data, standards-based data, survey-based data, and new forms of data made possible through machine learning and artificial intelligence (AI) applications. The article shows that the measurement of modern slavery needs to overcome many of the same challenges that confront efforts at measuring human rights, including the fundamental problem of unobservability, inherent bias through the use of convenience reporting, and the specification of the concept of modern slavery itself. ## "Sleeping Beauty": The Right to Science as a Global Ethical Discourse1

## Responding to Ebola in the Democratic Republic of Congo

This edition of Humanitarian Exchange, co-edited with Anne Harmer, focuses on the response to the Ebola outbreak in the Democratic Republic of Congo (DRC). Although at the time of publication the outbreak appeared to have ended, over its course it claimed 2,200 lives, with more than 3,300 infected, making this the world's second largest outbreak ever.

In the lead article, Natalie Roberts reflects on the extent to which humanitarian actors have applied learning from the outbreak in West Africa in 2014–2016. Richard Kojan and colleagues report on the NGO ALIMA's flexible, patient-centred approach to reducing mortality, Marcela Ascuntar reflects on lessons learned from community feedback and Bernard Balibuno, Emanuel Mbuna Badjonga and Howard Mollett highlight the crucial role faith-based organisations have played in the response. In their article, Theresa Jones, Noé Kasali and Olivia Tulloch outline the work of the Bethesda counselling centre in Beni, which provides support to grieving families. Emanuele Bruni and colleagues describe the development of a new monitoring and evaluation framework for strategic response planning. The edition ends with an article by Adelicia Fairbanks, who argues for an acceptance strategy in the DRC to improve security and access for responding agencies.

The key issues for increasing the number of vaccinated people worldwide, especially children, is to increase the supply of available vaccines, assure funding and affordability for lower-income countries, improve distribution and storage networks, assure the availability of healthcare workers to administer vaccines, improve the ability of the population to access vaccination centers, and minimize refusal / hesitation to maximize acceptability of vaccines.

It is noteworthy that among these key issues, all involve physical activities except for the final issue, which is the subject of this Special Issue. Vaccine acceptance / hesitation / refusal is unique in being a state of mind for the potential vaccinee or caregiver, such that different methods must be applied to improve acceptability. The ability of workers in the field to improve acceptability will be directly reflected in increased vaccinations with concomitant reductions in morbidity and mortality from vaccine-preventable diseases. This is a major public health challenge for the coming decade and beyond, which also will be very important for the success of new vaccines in the development pipeline.

## **Engaging men to promote resilient communities among Syrian refugees in Lebanon**

Engaging Men programmes seek to challenge the social norms, attitudes and practices that increase the risk of gender-based violence against girls and women while also harnessing positive male power to prevent violence and promote safety. This paper examines the impact of an Engaging Men intervention that engaged 1028 Syrian refugee and 440 Lebanese men in a 12-week training course structure.

There were four core objectives: promoting peaceful interactions with others, reducing violence and gender-based violence, child protection and caregiving, and increasing community safety and harmony through a community project. Focus group discussions were conducted with 130 men, 28 wives, and 17 children of male participants, 10 family visits and 20 individual interviews by peer researchers. The findings were that programmes facilitated a safe emotional space for men to meet collectively to talk about their problems, to become more attuned and reflective about their relationships with their wives and children, which resulted in improved patterns of interaction and communication, increased openness and greater tolerance by men of changing gender roles in families as a result of displacement. The discussion calls for greater integration of psychosocial programming with other forms of programming from livelihoods to political advocacy and that programmes incorporate clear guidance on perpetrator accountability.

Key implications for practice

- :: An intervention engaging with 1500 Syrian and Lebanese men reduced stress and improved family relations. Changes to gender-equitable attitudes were less clear.
- :: Interventions to engage refugee men should address refugee men's psychosocial needs in addition to viewing men's engagement as a means to protecting women and children.
- :: Findings highlight the importance of clearly defining the focus, aims and scope of interventions engaging with men, and that programmes incorporate clear guidance on perpetrator accountability.

In this week's issue, four papers provide in-depth insights gleaned from the Genome Aggregation Database (gnomAD). A successor to 2016's ExAC database, which held the exomes of 60,706 individuals, gnomAD aggregates 125,748 exomes and 15,708 whole-genome sequences. This increase in size and scope has allowed the gnomAD Consortium to catalogue not only single nucleotide variants between individuals but also more complex structural variants, made up of 50 or more nucleotides. In the main paper, Konrad Karczewski and colleagues review the database and explore variants that can inactivate protein-coding genes. In a second paper, Beryl Cummings and co-workers show that RNA expression data can be used to guide variant interpretation. In another paper, Eric Minikel and colleagues probe how the gnomAD data might help to identify genetic targets for drugs. And in the fourth paper, Ryan Collins and co-workers set out a catalogue of 433,371 structural variants and analyse them for their influence on physiological traits.

Summary

Digital epidemiology—the use of data generated outside the public health system for disease surveillance—has been in use for more than a quarter century [see supplementary materials (SM)]. But several countries have taken digital epidemiology to the next level in responding to COVID-19.
