# Secretary Antony J. Blinken on the Release of the 2021 Country Reports on Human Rights Practices

Antony J. Blinken April 12, 2022 Press Briefing Room Washington, D.C. [Excerpt; ]

...This report is just one of the ways that we're working to achieve it. It contains individual chapters on nearly 200 countries and territories, each of which offers factual, objective, and thorough accounting of their records on internationally recognized human rights. Whether a country is a friend or one with which we have real differences, the measuring stick we apply is the same.

That reflects a core principle of human rights: they're universal. People of every nationality, race, gender, disability, and age are entitled to these rights no matter what they believe, whom they love, or any other characteristics. This is especially important as a number of governments continue to claim, falsely, that human rights need to be applied based on the local context. Little coincidence that many of the same governments are among the worst abusers of human rights.

The universal nature of human rights also means that we have to hold ourselves accountable to the same standards. Even as this report looks outward to countries around the world, we've acknowledged from day one of this administration that we have challenges here in the United States. We take seriously our responsibility to address these shortcomings, and we know that the way to do it matters: together with citizens and communities, out in the open, transparently – not trying to pretend problems don't exist or sweeping them under a rug...

So with that context, let me highlight some of the most alarming findings of the report, which I want to emphasize covers the events of 2021.

**Governments are growing more brazen in reaching across borders to threaten and attack critics**. To give just a few examples, over the last year alone, Iranian intelligence agents plotted to kidnap an Iranian American journalist from her home in Brooklyn; the Assad regime threatened Syrians who were cooperating with efforts in Germany's courts to prosecute former officials for atrocities; the Lukashenka regime in Belarus forcibly diverted an international commercial flight to arrest an independent journalist.

**Governments are locking up more critics at home**. Today, more than a million political prisoners are being held in over 65 countries. They include more than 600 people unjustly imprisoned in Cuba for taking part in peaceful protests last July; countless Russian anti-corruption activists and opposition leaders, including Aleksey Navalny; opposition presidential candidates in Benin; and Egyptian advocates like human rights lawyer Mohamed El-Bager.

We've also seen a rise in governments arbitrarily detaining individuals to try to gain leverage in bilateral relationships, to use them as human pawns.

**The Chinese Government** continues to commit genocide and crimes against humanity in Xinjiang against predominantly Muslim Uyghurs, among other minority groups, to erode fundamental freedoms and autonomy in Hong Kong, and to carry out systematic repression in Tibet.

**In Afghanistan,** the Taliban's takeover precipitated a humanitarian crisis, and has resulted in serious erosion of human rights, from arbitrary detentions of women, protesters, and journalists, to reprisals against security forces for the former government, to growing restrictions on where women and girls can study or work.

**In Ethiopia,** all parties to the country's conflict, as well as Eritrean forces, have committed atrocities, and thousands of Ethiopians are being unjustly detained in life-threatening conditions.

We invest so much effort into documenting these and other abuses year after year, not only because it aligns our most sacred values, **but also because respect for human rights is a fundamental part of upholding the international rules-based order**, which is crucial to America's enduring security and prosperity. Governments that violate human rights are almost always the same ones that flout other key parts of that order, just as – such as invading, coercing, or threatening trade rules – excuse me – threatening other countries or breaking trade rules. So our interest in standing up for human rights isn't only principled; it is vital to our national security...

We methodically collect, preserve, and analyze evidence of atrocities and make this information available to the appropriate bodies. Indeed, it was the department's rigorous documentation, which included our own fact finding and reports by a range of independent, impartial sources, including human rights organizations, that provided a basis for my determination last month that Burma's military committed genocide and crimes against humanities against Rohingya.

We work with business to foster greater respect for human rights, both by encouraging compliance with labor standards and discouraging exports to governments and other entities that may use those goods or services to commit abuses.

We're fully engaged in multilateral institutions, even flawed ones. After regaining a seat on the UN Human Rights Council, we just led a successful effort to suspend Russia from

**that body**, because a country that's perpetrating gross and systematic violations of human rights shouldn't sit on a body whose job it is to protect those rights.

And we're working to strengthen democracy, human rights, and the fight against corruption through the Summit for Democracy. Last December, President Biden convened 100 world leaders, as well as representatives from civil society and the private sector, for the first summit. That kicked off a year of action that we're in the midst of pursuing. We're focused on delivering progress, not just pronouncements, by encouraging countries to make concrete commitments to advance human rights and democracy. And we're holding one another to our pledges...

### **Ukraine - Humanitarian Crisis**

<u>Humanitarian Crisis in Ukraine Deteriorating at Alarming Speed, Briefers Tell Security Council, Calling for Attacks on Civilians to Stop</u>

19 April 2022 SC/14865

As the humanitarian situation in Ukraine continues to deteriorate — at an alarming scale and speed of displacement not seen since the Second World War — briefers and delegates in the Security Council today called for the Russian Federation to uphold their international-law obligations, cease attacks on civilians and end the war.

Kelly T. Clements, United Nations Deputy High Commissioner for Refugees, briefed the Council via video-teleconference from Hungary, where almost a half million Ukrainians have fled — a fraction of the almost 5 million who have been forced to leave their country and the 7 million people displaced within Ukraine. The United Nations also estimates that 13 million more Ukrainians are in the hardest hit areas, many unable to move and difficult to safely reach with aid. The sheer scale and speed of displacement are immense, with women, children, and the aged having left behind their homes, lives, sons, fathers and husbands, forced to make impossible, heart-breaking decisions.

However, she cited remarkable acts of humanity in many States, with borders kept open and local authorities, communities and individuals providing food, medicine, transportation and a place to sleep. While commending the courage and strength of the refugees themselves, she recalled that Martin Griffiths, Emergency Relief Coordinator, had described the chilling scene in Bucha in the Council last week. As well, Filippo Grandi, United Nations High Commissioner for Refugees, called for the Government of Ukraine to scale up assistance to reach 360,000 people inside the country. "But no pile of blankets, no sum of cash, no amount of medicine is going to halt the death and destruction," she emphasized, adding: "While we will continue our job to deliver aid, we need this Council to do its job too" — calling on all Member States to find a way to end this horrific and senseless war.

Antonio Vitorino, Director-General of the International Organization for Migration (IOM), also briefing the Council via video-teleconference, noted that more than one quarter of Ukraine's total population has been forced to leave their homes in little more than seven weeks — a speed and magnitude of displacement not seen in Europe since the end of the Second World War. Expressing concern over the deteriorating humanitarian situation, he called on parties to the conflict to uphold their international-law obligations to protect civilians, their homes and civilian infrastructure. The situation of women and children is particularly concerning; trafficking in

persons was a known phenomenon in the region. He urged all neighbouring and impacted countries to ensure the immediate identification and registration of unaccompanied and separated children fleeing from Ukraine.

Because internally displaced people tend to move to urban areas in search of work opportunities and social services, he highlighted the urgent need to scale-up services to meet the needs of an increased population. Cash-based interventions are one of the most efficient and effective ways to reach people in need both inside Ukraine and in neighbouring countries. The IOM has already started providing multi-purpose cash assistance in Ukraine and in several neighbouring countries, intending to reach up to 500,000 individuals in the next three months. Moving forward, it is necessary to better understand the intentions of those fleeing.


In the ensuing debate, Council members stressed the importance of the Secretary-General's call for a nationwide ceasefire, voicing their shock at the destruction of Bucha and Mariupol and the escalating violence in the Donbas region. A number of delegates highlighted the dangers of gender-based violence, sexual exploitation and human trafficking driven by the displacement throughout Ukraine...

The delegation is one of our key humanitarian diplomacy hubs around the world, building dialogue with the Russian authorities, academic and expert circles, and other influential people and organizations in order to support our mission to protect and assist people affected by armed conflict and other violence around the world. Like any other diplomatic hub, we talk to political and military decision makers on how we can use our experience and expertise, to make a difference to the lives of people affected by humanitarian crises around the globe.

### FOREWORD [excerpt]

Russia and the International Committee of the Red Cross (ICRC) share a long history, dating back to 1867 when Russia acceded to the original Geneva Convention for the Amelioration of the Condition of the Wounded in Armies in the Field. That same year, one of the first voluntary societies to care for wounded soldiers was formed in the Russian Empire. The Russian Red Cross Society, now more than 150 years old, remains our closest partner in the country and, like the ICRC, is proud to be among the more than 190 members of the International Red Cross and Red Crescent Movement. Over the years,

Russia has taken an active role in developing international humanitarian law, and these developments govern conduct in armed conflicts even today...

### ...HUMANITARIAN DIPLOMACY [excerpt]

Because of our neutral, impartial and independent humanitarian action, we can go where many others cannot — helping people affected by armed conflict and other violence even in the most inaccessible places in the world. In Moscow, we discuss these people's needs and concerns through the dialogue we maintain with state officials, practitioners and researchers. Our discussions cover many issues, including the protection of civilians and respect for IHL, modern weapons and warfare, use of new technologies and tracing missing people.

We interact with the authorities, civil society, scholars and the media through round tables, exhibitions, conferences, competitions and training events. The regional delegation also hosts a dedicated space — the Humanitarium — which welcomes Russian and international scholars, experts and practitioners. The ICRC also takes part in key Russian-led international events, such as the annual Moscow Conference on International Security or the Saint Petersburg International Economic Forum, both of which offer a platform for discussing humanitarian issues.

The ICRC cooperates with the regional institutions Russia is a member of, such as the Collective Security Treaty Organization and the Commonwealth of Independent States, helping member states to step up integration of IHL into their domestic policies and activities. All these efforts translate theory — knowledge, analysis and opinions — into concrete practice that helps people, whether they be in Afghanistan, Ukraine, Syria or Nagorno-Karabakh...

# <u>Digital Services Act: Commission welcomes political agreement on rules ensuring a safe</u> and accountable online environment - European Commission

Press release

23 April 2022 Brussels

The Commission welcomes the swift political agreement reached today between the European Parliament and EU Member States on the proposal on the Digital Services Act (DSA), <u>proposed by the Commission</u> in December 2020. The DSA sets out an unprecedented new standard for the accountability of online platforms regarding illegal and harmful content. It will provide better protection for internet users and their fundamental rights, as well as define a single set of rules in the internal market, helping smaller platforms to scale up.

European Commission President Ursula von der Leyen said: "Today's agreement on the Digital Services Act is historic, both in terms of speed and of substance. **The DSA will upgrade the ground-rules for all online services in the EU. It will ensure that the online environment remains a safe space, safeguarding freedom of expression and opportunities for digital businesses. It gives practical effect to the principle that what is illegal offline, should be illegal online.** The greater the size, the greater the responsibilities of online platforms. Today's agreement – complementing the political agreement on the Digital Markets Act last month – sends a strong signal: to all Europeans, to all EU businesses, and to our international counterparts."...

### A new framework for digital services

The new framework under the DSA is founded on European values, including the respect of human rights, freedom, democracy, equality and the rule of law. It will rebalance the rights and responsibilities of users, online intermediaries, including online platforms as well as very large online platforms, and public authorities.

The DSA contains EU-wide due diligence obligations that will apply to all digital services that connect consumers to goods, services, or content, including new procedures for faster removal of illegal content as well as comprehensive protection for users' fundamental rights online.

**In scope of the DSA are various online intermediary services.** Their <u>obligations</u> under the DSA depend on their role, size, and impact on the online ecosystem.

### These online intermediary services include:

- Intermediary services offering network infrastructure: Internet access providers, domain name registrars;
- Hosting services such as cloud computing and webhosting services;
- Very large online search engines with more than 10% of the 450 million consumers in the EU, and therefore, more responsibility in curbing illegal content online;
- Online platforms bringing together sellers and consumers such as online marketplaces, app stores, collaborative economy platforms and social media platforms;
- Very large online platforms, with a reach of more than 10% of the 450 million consumers in the EU,
   which could pose particular risks in the dissemination of illegal content and societal harms.

### **Concretely, the DSA contains:**

- Measures to counter illegal goods, services or content online, such as:
  - :: a mechanism for users to easily flag such content and for platforms to cooperate with so-called 'trusted flaggers';
  - :: new obligations on traceability of business users in online market places;
- New measures to empower users and civil society, including:
  - :: the possibility to challenge platforms' content moderation decisions and seek redress, either via an out-of-court dispute mechanism or judicial redress;
  - :: provision of access to vetted researchers to the key data of the largest platforms and provision of access to NGOs as regards access to public data, to provide more insight into how online risks evolve;
  - :: transparency measures for online platforms on a variety of issues, including on the algorithms used for recommending content or products to users;
- Measures to assess and mitigate risks, such as:
  - :: obligations for very large platforms and very large online search engines to take risk-based action to prevent the misuse of their systems and undergo independent audits of their risk management systems;
  - :: mechanisms to adapt swiftly and efficiently in reaction to crises affecting public security or public health;
  - :: new safeguards for the protection of minors and limits on the use of sensitive personal data for targeted advertising.
- Enhanced supervision and enforcement by the Commission when it comes to very large online platforms. The supervisory and enforcement framework also confirms important role for the independent Digital Services Coordinators and Board for Digital Services.

### **Next Steps**

The political agreement reached by the European Parliament and the Council is now subject to formal approval by the two co-legislators. **Once adopted, the DSA will be directly applicable across the** 

**EU and will apply fifteen months or from 1 January 2024**, whichever later, after entry into force. As regards the very large online platforms and very large online search engines the DSA will apply from an earlier date, that is four months after their designation.

### ... China Rising

...Speaking at a recent news conference, Li Qun, the director of the National Cultural Heritage Administration, explained that the fourteenth five-year plan for cultural heritage is, for the first time, "a national-level plan, which reflects the country's great emphasis on the field". Footnote <sup>6</sup> Specific announcements included compulsory archaeological investigation in advance of major urban developments to ensure that the "protection of relics will always be the priority". Li also announced the intention to commence 80-100 new research excavations annually over the next five years, in addition to the hundreds of rescue excavations undertaken each year. With as few as 1800 registered archaeologists in China licensed to direct such projects, the plan also makes provision by 2025 for the training of an additional 4000 archaeologists and a 25 per cent increase in the number of lab-based researchers to expand capacity for analysis, including dating and DNA. Were such targets only half met, they would still represent an astonishing growth in the numbers of professional archaeologists in China and in the value placed on their research. The new five-year plan therefore reinforces a marked contrast in the fortunes of archaeology in China compared to the current situation in many other countries. But while it is no secret that the Chinese government has sought in recent years to promote China's past for both domestic and international audiences, many of the challenges Chinese archaeologists face are the same as those elsewhere in the world such as the effects of climate change...

# Remote sensing and ground survey of archaeological damage and destruction at Nineveh during the ISIS occupation

**Abstract** 

Without rapid international action to curb greenhouse gas emissions, climate scientists have predicted catastrophic sea-level rise by 2100. Globally, archaeologists are documenting the effects of sea-level rise on coastal cultural heritage. Here, the authors model the impact of 1m, 2m and 5m sea-level rise on China's coastal archaeological sites using data from the Atlas of Chinese Cultural Relics and Shanghai City's Third National Survey of Cultural Relics. Although the resulting number of endangered sites is large, the authors argue that these represent only a fraction of those actually at risk, and they issue a call to mitigate the direct and indirect effects of rising sea levels.




Figure 3. Categories of damage detected and dated by comparing the results of satellite imagery from 2015 and the latter part of 2016 (figure by S. Campana).

<u>Child immunization programme reaches Rohingya refugee children on Bhasan Char island</u> DHAKA, 21 April 2022 – This week, Rohingya refugee children on Bhasan Char in Bangladesh are receiving vaccinations through a routine childhood immunization programme.

UNICEF provides technical and financial assistance to the Government of Bangladesh in support of childhood immunizations on Bhasan Char. While Rohingya refugee children have received some vaccinations since arriving on the island through two ad hoc campaigns, this week marks the inauguration of the first regular childhood immunization programme on Bhasan Char...

"The routine childhood vaccination programme on Bhasan Char follows the Bangladesh Government's national Expanded Programme on Immunization (EPI). This includes vaccinations against diphtheria, pertussis, tetanus, hepatitis-B, Hib, polio, pneumonia, tuberculosis, measles and rubella," said Dr Md. Shamsul Haque, Line Director for Maternal Neonatal Child and Adolescent Health, Ministry of Health and Family Welfare.

Rohingya refugee families began to be relocated from the refugee camps in Cox's Bazar to the island of Bhasan Char just over a year ago. Estimations are that there are now well over 10,000 children on the island. UNICEF, UNHCR, WHO and other partners are working together to support the Government to deliver health and other services on Bhasan Char...



Globally, the number of new COVID-19 cases and deaths has continued to decline since the end of March 2022. During the week of 11 through 17 April 2022, over 5 million cases and over 18 000 deaths were reported across the six WHO regions, a 24% and 12% decrease respectively, as compared to the previous week.

As of 17 April 2022, over 500 million confirmed cases and over 6 million deaths have been reported globally.

**Highlights** 

- Humanitarian partners have not been able to move any additional aid supplies into Tigray by road since the convoy entered on 1 and 2 April.
- About 36 metric tons of HIV medical supplies were airlifted to Mekelle, the first time since July 2021. It will be enough to provide treatment for 46,000 patients for six months.
- Authorities in Amhara relocated more than 20,000 people out of the planned 70,000 people in North Wello and Wag Hamra zones to new designated sites since mid-March.
- WFP assisted over 35,000 people with food in Gulina, Barahle and Dalole woredas in Afar during the reporting period, reaching over 235,000 people since last week of February.
- More than 11,000 children under five and pregnant and lactating women received supplementary nutrients in Wag Harma and North Wello zones in Amhara between 1 and 10 April.

From remote work to green energy to ending conflicts, young people must be at the forefront of planning for a truly transformed, post-COVID-19 future, speakers told the Economic and Social Council's annual Youth Forum today, while warning against resorting to tokenism or including youth voices to merely "tick a box".

Overview

This report summarizes the themes emerging from wide-ranging discussions at the 5th WHO Infodemic Management Conference, which was virtually conducted in November 2021. ICC Prosecutor, Karim A.A. Khan QC, notifies Pre-Trial Chamber I of a request from the Bolivarian Republic of Venezuela to defer his investigation under article 18(2) of Rome Statute and confirms intention to apply for authority to resume investigations

On 16 April 2022, I received a request from the Bolivarian Republic of Venezuela ("Venezuela") to defer my Office's investigations with respect to the Situation in Venezuela I, in favour of the actions carried out by the national authorities of Venezuela. Specifically, Venezuela has triggered the procedure under article 18 of the Rome Statute whereby a State may inform the International Criminal Court ("ICC" or "the Court") that it is investigating or has investigated its nationals or others within its jurisdiction with respect to criminal acts which may constitute crimes within the jurisdiction of the Court, and may formally request that the ICC Prosecutor defer to the State's investigation of those persons. The Statute requires that I either accept the deferral request or that I make an application to the Pre-Trial Chamber requesting authorisation to resume my own investigations.

I have yesterday <u>notified Venezuela's deferral request to the Pre-Trial Chamber</u>, as well as my intention to apply, as soon as possible, for authority to resume my investigations. In my notification I communicated this determination because, having reviewed the basis of the deferral request, I have concluded that no new information had been submitted that would warrant a revision of my earlier complementarity assessment that relevant potential cases that would arise from an investigation into the situation would be admissible.

It will be for the Pre-Trial Chamber to decide on the procedure to be followed once I have submitted my application to proceed with the investigation, including any responses from Venezuela, as well as relevant observations by victims, their legal representatives, and other interested parties...

Seattle, April 19, 2022—PATH today welcomed a grant of close to US\$ 5 million to enable expanded introduction of the RTS,S/AS01 (RTS,S) malaria vaccine through the pilot program currently underway in areas of Ghana, Kenya, and Malawi. The grant would support use of RTS,S in pilot areas that have not yet received the vaccine.

The grant to PATH was recommended by <u>GiveWell</u>, a US-based non-profit, for funding by <u>Open Philanthropy</u>, also based in the United States. The award will provide each pilot country with funds to plan for and implement the expansion of malaria vaccination through the end of 2023, the formal end of the pilot program. The grant also will allow PATH and the World Health Organization (WHO) to provide technical assistance to the countries. #### Denial of health care amounts to torture, says WMA

An immediate investigation into reports of deliberate denial of health care in Iranian prisons, amounting to torture, has been called for by the World Medical Association.

In a statement today, the WMA denounces the reported practices as 'horrifying' and called for an immediate investigation by the Iranian authorities.

WMA President Dr. Heidi Stensmyren said: 'This methodical denial of healthcare constitutes nothing less than a form of torture. A recent report by Amnesty International refers to sick prisoners left to die in substandard prison clinics or in isolation, as well as the abuse of psychotropic drugs in prisons and the use of electric shocks in psychiatric hospitals

'These reports are horrifying. Prison doctors who have alerted the authorities about prisoners at risk of serious harm or death are being ignored by prison staff. Regrettably, it appears as well that some physicians, charged with the medical care of prisoners are failing to observe principles of medical ethics to protect prisoners against torture and other ill-treatment'.

'The international medical community must raise its concern about such appalling practices...

This diversity is also expressed in population health data: some health indicators suggest advantages of Latinx community membership while other data demonstrate inequitable disease burden and maldistribution of environmental and occupational risk. Legacies of colonial conquest of the Americas persist in discrimination and marginalization today and are embodied by members of our Latinx communities.

...Speaking at a recent news conference, Li Qun, the director of the National Cultural Heritage Administration, explained that the fourteenth five-year plan for cultural heritage is, for the first time, "a national-level plan, which reflects the country's great emphasis on the field". Footnote 6 Specific announcements included compulsory archaeological investigation in advance of major urban developments to ensure that the "protection of relics will always be the priority". Li also announced the intention to commence 80–100 new research excavations annually over the next five years, in addition to the hundreds of rescue excavations undertaken each year. #### Malaria in 2022: a year of opportunity

The theme of this year's World Malaria Day, April 25, is "Harness innovation to reduce the malaria disease burden and save lives." WHO is calling for investment and innovation in vector control, diagnostics, and treatments to help countries eliminate malaria after several years of stalled progress. In 2015, the World Health Assembly adopted a strategy to guide efforts towards elimination. But the first milestone—to achieve a 40% global reduction in malaria mortality rate and case incidence by 2020—was missed. Funding for malaria control has levelled off. Malaria mortality and incidence rates have not changed appreciably since 2015. There were an estimated 627 000 malaria deaths and 241 million malaria cases in 2020 (a 12% and 7% increase, respectively, compared with 2015). Given the stagnation of recent years, what cause is there to hope for a real change now?

The devastating setbacks to malaria programmes resulting from the COVID-19 pandemic might prompt a pessimistic answer. In April, 2020, WHO projected a doubling of malaria deaths during the pandemic if no actions were taken. Major global health organisations working on malaria—led by the Global Fund, along with the RBM Partnership to End Malaria, and the US President's Malaria Initiative—put together the COVID-19 Response Mechanism, a massive effort to restructure resources and activities to avert the worst-case scenario. Still, there were 14 million more malaria cases and 69 000 more deaths in 2020 compared with 2019. An estimated 68% of the excess deaths were linked to service disruptions due to COVID-19. The pandemic diverted resources, overwhelmed health systems, and exacerbated inequalities, not only for malaria, but also for HIV and tuberculosis.

Even before COVID-19, concerns had been voiced about the slowed progress of malaria programmes. Nevertheless, in 2019 a Lancet Commission on malaria eradication reaffirmed that eradication—an ambitious permanent reduction of the global incidence to zero—is possible, worthwhile, affordable, and necessary. It recommended an immediate, firm commitment to malaria eradication, especially an increase in funding and closer more strategic collaboration between major malaria organisations. And there have been some notable achievements. The WHO European region was certified malaria-free in 2016, as was Sri Lanka in 2016, Argentina in 2019, and China in 2021. However, 96% of the world's

malaria cases and deaths each year occur in Africa; it is there that the success or failure will be decided.

Scientific advances are providing new tools for malaria control. RTS,S—the world's first effective malaria vaccine—was approved last year. Last month, The Lancet published results of a clinical trial showing the effectiveness of a new chlorfenapyr long-lasting insecticidal net that could help to mitigate the impact of insecticide resistance among mosquitoes. The roll-out of new interventions such as these is crucial to curtail malaria mortality, but it is not possible without funding.

In December, 2021, the Gavi board approved an initial investment for the procurement and delivery of RTS,S to sub-Saharan Africa. Later this year, the Global Fund will host its seventh replenishment meeting. It is asking for US\$18 billion to support its 2024–26 programmes for malaria, HIV, and tuberculosis, to strengthen health systems, and to reinforce pandemic preparedness. Modelling by the Global Fund predicts that, if it is fully funded, the malaria mortality rate would drop by 66% by 2026, and case incidence by 69%. By contrast, a counterfactual scenario of continued COVID-19 disruption would see a rapid and severe resurgence of malaria deaths and cases, resulting in an additional 2 million deaths and 654 million cases that could have been avoided. The replenishment scenario makes ambitious assumptions about the scale-up of malaria treatment and bednet distribution, as well as roll-out of the RTS,S vaccine. But the model presents countries and donors with a stark choice.

The case for commitment to investment and global collaboration for malaria is clear. Although COVID-19 has harmed malaria programmes and squeezed budgets, new technologies mean that 2022 is also a year of opportunity—if the opportunity is taken. To "harness innovation", as WHO puts it, will require substantial funding support both domestically and from donors. It will also require meaningful policy commitments from countries to reaffirm the idea of ceasing mortality and morbidity due to malaria. The UN Sustainable Development Goal of ending malaria as a public health threat by 2030 is at stake, and, with it, the lives of hundreds of thousands of people each year.
