The Ministerial meeting on the 10 May will take place in person in Brussels, while the Day of Dialogue on 9 May will be held in a hybrid format to provide an opportunity for the broadest participation by civil society organisations in the region.

Message from the United Nations humanitarian, refugee, and development chiefs on the situation in Syria and the region

Statement by the Under-Secretary-General for Humanitarian Affairs and Emergency Relief Coordinator, Martin Griffiths, the UN High Commissioner for Refugees, Filippo Grandi, and the Administrator of the United Nations Development Programme (UNDP), Achim Steiner

10 May 2022

Brussels, New York, Geneva – As the Syrian crisis enters its 12th year without a solution, it is the Syrian people who are paying the price. Within the country, and across the region, the outlook for Syrians is deteriorating. Needs are far greater than ever.

Syria remains an enormous humanitarian and displacement crisis. More than 6.9 million people have fled their homes inside the country, and over 6.5 million remain outside Syria, of whom 5.7 million are refugees in the region, still being hosted by neighbours.

Since 2020, there has been a surge in humanitarian needs inside Syria, now at their most acute since the crisis began. And this even while the conflict ebbs in intensity.

Today, 14.6 million people in Syria rely on aid, 1.2 million more than a year before; more than 90 percent of Syrians live in poverty. Gender-based violence and risks to children are on the rise, while potential exposure to explosive ordnance remains high, with one in two at risk. Food insecurity has

touched new records; 13.9 million people go hungry every day, a misery compounded by wheat shortages partly due to war in Ukraine. Nearly one in two Syrian children are out of school and vulnerable to child labour, early and forced marriages, trafficking, and recruitment by armed actors. In Turkey, Lebanon, Jordan, Iraq and Egypt, who have generously hosted refugees and continue to do so, socio-economic pressures have pushed the numbers of Syrian refugees and host communities needing humanitarian assistance to 20 million in 2022 from 10.4 million in 2021. Our appeal will directly target approximately 12 million out of those in need.

To keep the displaced afloat, the international community has shown real generosity – and much has been achieved to provide rudimentary services. To assist the people in need, investments in early recovery inside Syria are needed, alongside humanitarian aid. Investing in communities, including sustainable livelihoods, and improving safe access to basic services will support socioeconomic resilience and social cohesion, and give Syrians a chance to live in dignity and secure a future for their children.

Our overriding message today is: now is not the time to turn away from Syrians, making theirs a forgotten crisis. Apathy is not an option. Millions in Syria and the region need our help, more than ever. The solution to the crisis will, of course, have to be political. The UN, under the leadership of the Special Envoy, is working to advance that track. But the people of Syria, refugees and neighbouring host countries, deserve continued international solidarity and support.

That is why we – the chiefs of the United Nations humanitarian, refugee and development agencies – speak up again this year, on the day of the pledging day of the Brussels VI Conference “Supporting the future of Syria and the region”.

Together we lead the implementation of the UN-coordinated response to the Syria crisis. Our appeals – the Humanitarian Response Plan for Syria (HRP) and Regional Refugee and Resilience Plan (3RP) - ask for a combined US\$10.5 billion for 2022.

In 2022, the 3RP seeks US\$ 6.1 billion — its largest budget request since inception in 2015 — to address the growing needs of approximately 7.1 million refugees, asylum seekers and stateless people, including 5.7 million registered Syrian refugees, and 12.9 million vulnerable host community members. The appeals are currently funded at 8 per cent (HRP) and 11 per cent (3RP).

Pledges

The international community pledged close to €6.4 billion for 2022 and beyond during the sixth Brussels Conference on 'Supporting the future of Syria and the Region', organised by the European Union. The funding will help people in Syria and the neighbouring countries hosting Syrian refugees. Out of this amount, over €4.8 billion were pledged by the EU, with over €3.1 billion coming from the European Commission and €1.7 billion from the EU Member States. The EU and its Member States have remained the largest donors supporting people in Syria and the region since the beginning of the crisis in 2011, mobilising €27.4 billion overall.

[Visit to Lebanon - Report of the Special Rapporteur on extreme poverty and human rights, Olivier De Schutter*](#)

Human Rights Council, Fiftieth session, 13 June–8 July 2022, Agenda item 3

Promotion and protection of all human rights, civil, political, economic, social and cultural rights, including the right to development

Summary

:: Lebanon is immersed in one of the worst economic and financial crises in history. The destruction of the national currency, exorbitant price increases and the collapse of the banking sector have led to the generalized impoverishment of the population amid sectarian political stasis. With most of the population now hoping to leave the country, those who stay and endure the consequences have been pushed to the brink.

:: The Lebanese State, including its Central Bank, is responsible for human rights violations, including the unnecessary immiseration of the population, that have resulted from this man-made crisis. Pre-crisis Lebanon was already characterized by appalling levels of wealth concentration at the top; tax policies that favour evasion and benefit the wealthy; chronically neglected public education and health-care services; an inadequate social protection system; and a failed electricity sector.

:: Lebanon needs to change course. The misery inflicted on the population can be reversed with leadership that places social justice, transparency and accountability at the core of its actions. The international community can and should provide support, but such support will only have an impact if structural reforms are adopted to put an end to the process of impoverishment.

[Lebanon: UN expert warns of 'failing State' amid widespread poverty](#)

GENEVA (11 May 2022) – The destructive actions of Lebanon's political and financial leaders are responsible for forcing most of the country's population into poverty, in violation of international human rights law, the UN Special Rapporteur on extreme poverty and human rights, Olivier De Schutter, said in a report published today.

The report follows a country visit to Lebanon and an investigation into the root causes and impacts of the country's worst economic and financial crisis in history.

"Impunity, corruption, and structural inequality have been baked into a venal political and economic system designed to fail those at the bottom, but it doesn't have to be that way," said De Schutter, an independent expert appointed by the UN Human Rights Council.

"The political establishment knew about the looming cataclysm for years but did little to avert it. Well-connected individuals even moved their money out of the country, facilitated by a legal vacuum that allowed capital to flow out of the country. Truth and accountability must be sought as a matter of human rights."

With parliamentary elections on 15 May, the UN expert called on the next government to place accountability and transparency at the "heart and centre of its actions," starting with publicly disclosing its own finances and conflicts of interest and demanding that Central Bank officials do the same.

Lebanon's man-made economic crisis started in 2019, and today the country stands as "a failing State", the UN expert said. He cited current estimates that put four in every five people in poverty.

"Political connections with the banking system are pervasive, pointing at serious concerns about conflicts of interest in their handling of the economy and people's savings," De Schutter said.

"There is no accountability built into the latest rescue plan, critical to restoring the lost confidence of the population and the financial sector. We're talking about national wealth that belongs to the public in Lebanon and that was squandered over decades of mismanagement and misplaced investments by the Government and the Central Bank.

"Central Bank policies, in particular, led to a downward spiral of the currency, the devastation of the economy, the wiping out of people's lifetime savings and to plunging the population into poverty. The conclusion of my report is that the Central Bank has brought the Lebanese State into clear contravention of international human rights law.

"Political leadership is completely out of touch with reality, including with the desperation they've created by destroying people's lives. Lebanon is also one of the most unequal countries in the world, yet leadership seems unaware of this at best, and comfortable with it at worst."...

Climate - Children

Climate-Responsible Finance – A moral imperative and responsibility to all children and the living world

Statements - 09 May 2022 - UN Environmental Program

In October 2021, an inter-religious message and appeal acknowledged the need to align financial investments with environmentally and socially responsible standards, ensuring greater accountability and transparency, and moving away from investments in fossil fuels and toward investments in renewable energy and restorative agriculture.

Accordingly, **we, leaders of the undersigned organisations, affirm our commitment to engaging with the financial institutions through which we bank, invest, and seek insurance coverage, to ensure that our financial dealings are aligned with the Paris Agreement objective of limiting global warming to 1.5° C.**

In response to the gravity of the Intergovernmental Panel on Climate Change's 6th Assessment Report, we expect all financial service providers working for our organisations to ensure their activities are promoting a just transition to a sustainable future and not contributing to the climate crisis and harming vulnerable populations, children and future generations of life on earth. As documented by UNICEF, one billion children at 'extremely high risk' of the impacts of the climate crisis"

We ask our financial service providers to invest in renewable energies and innovative environmental solutions that are sustainable for people, communities and ecosystems.

We will review our pension, banking, insurance and other financial service arrangements to ensure evidence-based accountability in this regard, as a moral imperative and responsibility to all children and the living world. We call upon our financial service providers to take urgent and effective action to transition out of fossil fuel financing – in line with decarbonisation pathways as established by the scientific community¹ – while positioning investment portfolios in ways that will help to meet net-zero GHG emissions by 2050, by

- investing in renewable energies and research for climate solutions

- adopting a commitment to fully phase-out financial services and exposure to coal no later than 2030 for European Union and the Organisation for Economic Co-operation and Development Member States, and no later than 2040 worldwide, and requesting a corresponding, dated phase-out commitment from all coal-linked companies remaining in their portfolios.
- ending all financing towards any new oil and gas projects exploration and extraction projects, as established by the latest climate change mitigation science and modelling.¹
- requiring oil and gas companies to stop all new development or expansion projects beyond 2022, including especially all such projects in the Arctic region.
- joining the UN-convened Net Zero Asset Owner, Banking and/or Insurance Alliances², depending on the type of financial institution concerned, if they are not yet part of them.

We urge the financial institutions working with our organisations to regularly report on progress, including establishing intermediate targets every five years³ in line with the Paris Agreement Article 4.9.

We invite all members of our constituencies and all our partners to do likewise, so that together we may move beyond words to effective action and be the change for which we call.

The Russian invasion of Ukraine: a humanitarian tragedy and a tragedy for science

The Invasion of Ukraine prompts us to support our Ukrainian colleagues but also to keep open communication with the Russian scientists who oppose the war.

[Excerpt]

... Even though the priority must be to help Ukrainians, we must also think of students and colleagues in Russia who oppose the war and are affected by the sanctions. As the Iron Curtain closes again, we have to think differently about our ongoing and future collaborations. Although freezing most, if not all, research collaborations with official Russian organizations is justified, it would be a mistake to extend these sanctions to all scientists and students. There is already an exodus of Russian and Belarusian scholars, which will only accelerate in the next months and years, and accepting scientists who ask for political asylum will be beneficial for Europe.

The fraction of Russian society in open opposition to the war is, unfortunately, smaller than that officially in support of it. At the beginning of the war, a number of Russian scientists published an open letter on the internet, in which they condemn this war (<https://t-invariant.org/2022/02/we-are-against-war/>). They clearly state that "The responsibility for unleashing a new war in Europe lies entirely with Russia. There is no rational justification for this war", and "demand an immediate halt to all military operations directed against Ukraine". At the same time, other prominent Russian science and education officials signed the "Statement of the Russian Union of University Rectors (Provosts)", which expressed unwavering support for Russia, its president and its Army and their goal to "to achieve demilitarization and denazification of Ukraine and thus to defend ourselves from the ever-growing military threat" (<https://www.rsr-online.ru/news/2022-god/obrashchenie-rossiyskogo-soyuza-rektorov1/>).

Inevitably, Russian scientists must decide themselves how to live and continue their scientific work under the increasingly tight surveillance of the Kremlin regime. History is repeating itself. Not long ago, during the Cold War, Soviet scientists were largely isolated from the international research community and worked in government-controlled research. In some fields, no one knew what they were working on or where. However, even in those dark times, courageous individuals such as Andrei Sakharov spoke out against the regime and tried to educate the next generation about the importance of free will. Many Soviet geneticists had been arrested under Stalin's regime of terror and as a result of Lysenkoism and were executed or sent to the Gulag or had to emigrate, such as Nikolaj Timofeev-Resovskij, one of the great geneticists of his time and an opponent of communism. As a result of sending dissident scientists to Siberia, great educational institutions were created in the region, which trained many famous scientists. History tells us that it is impossible to kill free will and the search for truth.

The Russian invasion of Ukraine is a major humanitarian tragedy and a tragedy for science at many levels. Our hope is that the European science community, policymakers, and funders will be prepared to continue and expand support for our colleagues from Ukraine and eventually help to rebuild the bridges with Russian science that have been torn down.

Tackling psychosocial and capital constraints to alleviate poverty

Psychosocial measures improve the cost-effectiveness of multi-faceted interventions against extreme poverty.

Abstract

Many policies attempt to help extremely poor households build sustainable sources of income. Although economic interventions have predominated historically^{1,2}, psychosocial support has attracted substantial interest^{3,4,5}, particularly for its potential cost-effectiveness. Recent evidence has shown that multi-faceted 'graduation' programmes can succeed in generating sustained changes^{6,7}. Here we show that a multi-faceted intervention can open pathways out of extreme poverty by relaxing capital and psychosocial constraints. We conducted a four-arm randomized evaluation among extremely poor female beneficiaries already enrolled in a national cash transfer government programme in Niger. The three treatment arms included group savings promotion, coaching and entrepreneurship training, and then added either a lump-sum cash grant, psychosocial interventions, or both the cash grant and psychosocial interventions. All three arms generated positive effects on economic outcomes and psychosocial well-being, but there were notable differences in the pathways and the timing of effects. Overall, the arms with psychosocial interventions were the most cost-effective, highlighting the value of including well-designed psychosocial components in government-led multi-faceted interventions for the extreme poor.

Weekly epidemiological update on COVID-19 - 11 May 2022

Overview

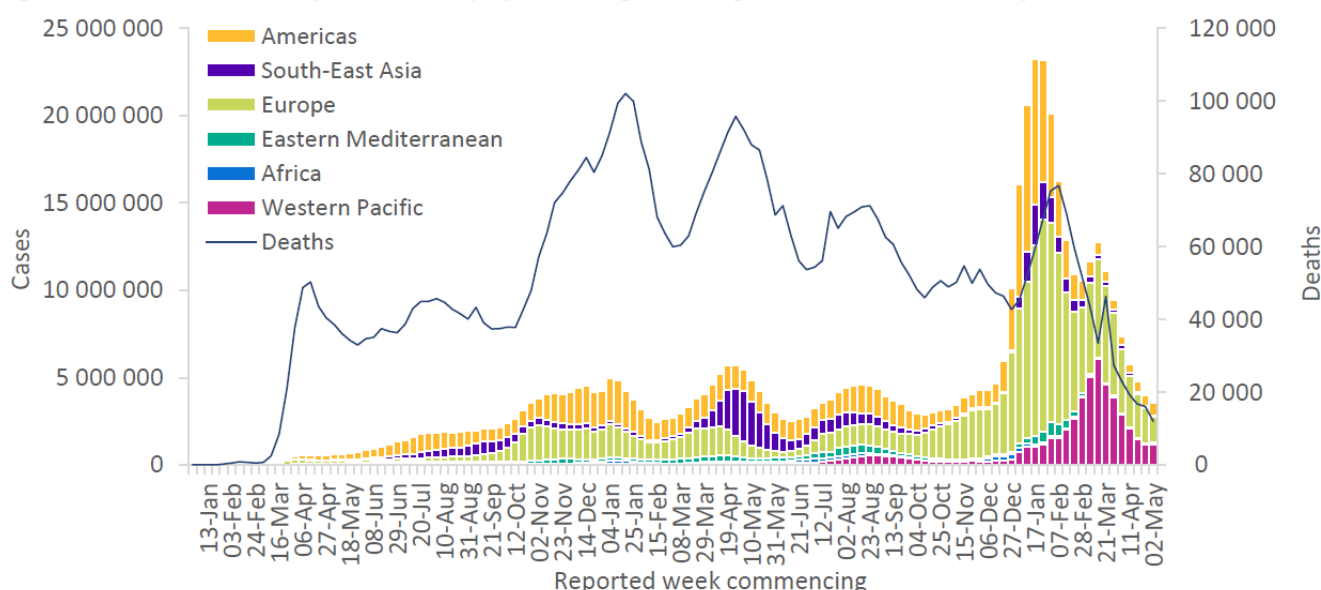
Globally, the number of new COVID-19 cases and deaths has continued to decline since the end of March 2022.

During the week of 2 through 8 May 2022, over 3.5 million cases and over 12 000 deaths were reported, decreases of 12% and 25% respectively, as compared to the previous week. However, an increase in the number of new weekly cases was reported from the Region of the Americas (+14%) and the African Region (+12%) and an increase in the number of weekly deaths was reported from the African Region (+84%).

As of 8 May 2022, over 514 million confirmed cases and over six million deaths have been reported globally.

In this edition, we provide an update on the geographic distribution of circulating SARS-CoV-2 variants of concern (VOCs), including the prevalence and summary of current evidence of the Omicron variant. We also provide updates on vaccine effectiveness for the Omicron variant.

Ethiopia - Northern Ethiopia Humanitarian Update Situation Report, 12 May 2022

HIGHLIGHTS

- Humanitarian partners continue to move additional aid supplies into Tigray via the Semera-Abala-Mekelle road bringing 250 trucks since 1 April.
- Only 1.5 million people or 24 per cent of the total caseload assisted with food in Tigray since mid-October. 115 trucks of food required a day to reach all in need by end of May.
- Amhara authorities continued with the relocation of displaced people, at a slower pace, relocating over 20,000 people from Kobo and over 4,000 people from Sekota since mid-March.
- Over 10.4 million people out of the 11.6 million target caseload reached with food assistance in Amhara under the current food distribution which started on 22 December 2021.
- About 90,000 people in Afar assisted with water trucking with the support of 23 trucks operating at displacement sites and Woredas with water shortage during the reporting period.

Ukraine

Ukraine: Situation Report - Last updated: 12 May 2022

- Eastern Ukraine continues to face the fiercest fighting. Attacks were also reported in southern, south-eastern and central parts of Ukraine.
- On 8 May, over 170 civilians were evacuated from Mariupol (Donetska oblast) and surrounding areas as part of the third evacuation operation coordinated by the UN and ICRC.
- As of 3 May, the International Organization for Migration estimates that slightly over 8 million people have been displaced within Ukraine.
- On 7 May, the World Food Programme reported that it has supported over 3.4 million people across Ukraine with food and cash assistance since 24 February.
- As of 6 May, the UN Children's Fund has supported 1.3 million people with access to safe water.

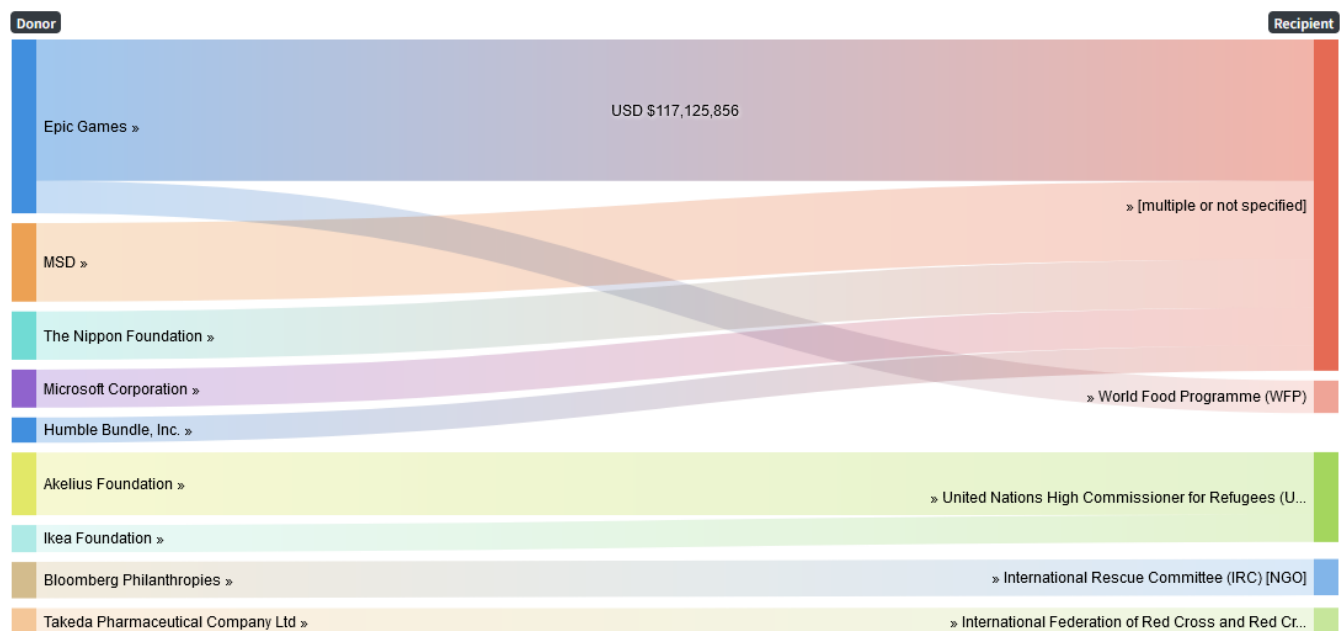

Overview

Estimating the true mortality burden of COVID-19 for every country in the world is a difficult, but crucial, public health endeavor. Attributing deaths, direct or indirect, to COVID-19 is problematic. A more attainable target is the “excess deaths”, the number of deaths in a particular period, relative to that expected during “normal times”, and we estimate this for all countries on a monthly time scale for 2020 and 2021. The excess mortality requires two numbers, the total deaths and the expected deaths, but the former is unavailable for many countries, and so modeling is required for these countries, and the expected deaths are based on historic data and we develop a model for producing expected estimates for all countries. We allow for uncertainty in the modeled expected numbers when calculating the excess.

We describe the methods that were developed to produce World Health Organization (WHO) excess death estimates. To achieve both interpretability and transparency we developed a relatively simple overdispersed Poisson count framework, within which the various data types can be modeled. We use data from countries with national monthly data to build a predictive log-linear regression model with time-varying coefficients for countries without data. For a number of countries, subnational data only are available, and we construct a multinomial model for such data, based on the assumption that the

fractions of deaths in specific sub-regions remain approximately constant over time. Our inferential approach is Bayesian, with the covariate predictive model being implemented in the fast and accurate INLA software. The subnational modeling was carried out using MCMC in Stan or in some nonstandard data situations, using our own MCMC code. Based on our modeling, the 95% interval estimate for global excess mortality, over 2020–2021, is 13.3–16.6 million.

PATH's commitments at the US COVID-19 Summit

To support these goals, PATH is proud to announce additional commitments, namely:

- PATH will help vaccinate the world by supporting COVID-19 vaccination campaigns. We will provide training, mentorship, and supervision to health workers tasked with vaccination and deploy and scale digital tools to track vaccination and generate demand through targeted social media campaigns. This includes a US\$5 million investment to reach an estimated 20 million vaccine-hesitant individuals in 2 years.
- **We will also support the development of a new affordable COVID-19 vaccine that could be manufactured in Brazil, Thailand, and Vietnam.**

Geneva – Unitaid welcomes the Clinton Health Access Initiative (CHAI) announcement on agreements with leading generic manufacturers to make nirmatrelvir/ritonavir available to low- and middle-income countries (LMICs) at under US\$25 per treatment course. The agreements also settle on production guarantee and allocation capacity for 4.5 million treatment courses per month for LMICs.

Pfizer's oral COVID-19 treatment — a combination of nirmatrelvir and ritonavir tablets sold under the name Paxlovid — was strongly recommended by the World Health Organization (WHO) last month, based on evidence on prevention of hospitalization and death for mild-to-moderate COVID-19 patients

at high risk of developing severe forms of the disease, when administered in early stages of the infection.

These agreements represent an important step in the global COVID-19 response, building on the groundwork Unitaid and partners of the [Access to COVID-19 Tools \(ACT\) Accelerator's](#) therapeutics pillar have laid to ensure equitable, rapid and affordable access to new treatment options. Focused efforts are aimed at introducing those treatments in LMICs alongside adequate testing to realize the promise of test-and-treat strategies in decentralized settings...

Background

Recent research shows that psychological distress is on the rise globally as a result of the COVID-19 pandemic and restrictions imposed on populations to manage it. We studied the association between psychological distress and social support among conflict refugees in urban, semi-rural and rural settlements in Uganda during the COVID-19 pandemic.

Conclusion

There is a settlement-inequality (i.e. rural vs. urban) in psychological distress and social support among conflict refugees in Uganda. To address psychological distress, Mental Health and Psychosocial Support Services (MHPSS) should focus on strategies which strengthen the existing social networks among refugees. Variations in social support are a key predictor of distress which should guide tailored need-adapted interventions instead of duplicating similar and generic interventions across diverse refugee settlements.

The World After the War

The war in Ukraine has forced a fresh confrontation with risks and threats once dismissed as relics.

As this issue goes to press, the war in Ukraine is far from over. It seems likely to go on for weeks or months or even years, whether as a grinding back-and-forth conflict, an insurgency fighting to overturn an occupation, or a global cataclysm. Yet since the moment the first missiles were fired, it has been clear that the invasion marked the start of a new era—one that will be defined not just by the outcome on the ground in Ukraine but also by the global response. In their resistance to the Russian assault, Ukrainians have powerfully demonstrated what's at stake for them. The rest of the world is still grappling with what's at stake for it.

For Americans, argues Robert Kagan, the war serves as a stark reminder "that they are part of a never-ending power struggle, whether they wish to be or not"—and "that there really are worse things than U.S. hegemony." For the international order, writes Tanisha Fazal, the war threatens the principle that has underpinned stability for decades: "The norm against territorial conquest has been tested in the most threatening and vivid way since the end of World War II." And for Western policymakers, contends Stacie Goddard, the war underscores the value of "institutional realpolitik"—a strategy that, rather than scrapping the existing international system, would deploy it to contain the coordinated yet distinct revisionist challenges mounted by China and Russia.

For Vladimir Putin, the war reflects what Daniel Treisman describes as "an emerging pattern—one that features anti-Western nationalism; angry, self-justifying speeches; and increasingly open uses of force," first at home and then abroad. And for Ukrainians, the war represents an assault on, among much else, their history, with Putin, as Anna Reid explains, "resorting to military force and totalitarian censorship in a vain attempt to make reality closer to the myth."

For all of us, meanwhile, the war has forced a fresh confrontation with risks and threats once dismissed as relics. It turns out, as Stephen Kotkin puts it in his sweeping analysis of geopolitics past and present, that "the West's relatively brief respite from great-power competition with Russia constituted a historical blink of an eye."

Offline: Bill Gates and the fate of WHO

Bill Gates was not shy about his disdain for WHO. Of its staff he said, "If you're not very good, you'll stay working there for a long time." Gates fired his broadside during the London launch of his book, *How to Prevent the Next Pandemic*. The audience laughed. But as someone who has been welcomed into the global health family, there was something cheap and unpleasant about his remark. It diminished him. Gates was there to promote the idea of GERM—a Global Epidemic Response and Mobilization team. It would comprise 3000 full-time epidemiologists and geneticists, vaccine developers and rapid response workers, dedicated to preventing future pandemics. Despite his views about WHO, Gates would still make the agency responsible for GERM, although with a "special personnel system" to

attract “the best staff possible”. GERM would be given the authority to declare a pandemic and coordinate the global response. Gates estimates the cost would be US\$1 billion annually. With an estimated net worth of \$127 billion, he could afford to fund GERM for its first 5 years, bringing in new financing as the initiative proved its value. The next big grant from his Foundation?

On the same day that Gates made his pitch, WHO published a white paper on Strengthening the Global Architecture for Health Emergency Preparedness, Response, and Resilience. It was timed to provoke debate in advance of the World Health Assembly later this month. WHO has reviewed over 300 recommendations made by recent international commissions and panels, synthesising their ideas into ten proposals. WHO suggests the formation of a Global Health Emergency Council, led by heads of state, to “break the cycle of panic and neglect that has characterized the response to previous global health emergencies”. The agency recommends revision of the International Health Regulations, stronger independent monitoring of national preparedness programmes, formation of a new global health emergency workforce (akin to GERM, but without decision-making power), and the creation of new financing instruments. These are important reforms that deserve support. But there is one assumption threaded through the white paper that should be subject to scrutiny—the idea that WHO itself should be at “the centre” of emergency preparedness. The existential anxiety within WHO is palpable. Repeated warnings about duplication and competition are designed to dissuade member states from “creating a parallel structure, which could lead to further fragmentation”. For example, according to WHO, the Global Health Emergency Council should be aligned (read *subservient*) to the constitution and governance of WHO and be supported (read *controlled*) by WHO's Secretariat in Geneva. A new Standing Committee on Health Emergencies to complement the work of the Council would exist only as a subcommittee of WHO's Executive Board. WHO concludes, “Finally, it is clear that at the heart of the HEPR [health emergency preparedness and response] architecture, the world needs a strengthened WHO, with the authority, financing and accountability to effectively fulfil its unique mandate as the directing and coordinating authority on international health work.” WHO's white paper is an ambitious land grab for power.

Neither Gates nor WHO seem to understand the nature or true scale of this pandemic. First, SARS-CoV-2 thrived on inequality. There is no serious discussion about the way this virus exploited deep disparities across societies and why attacking these disparities must be part of preparedness planning. Second, COVID-19 is a disease that normalised inequity—for testing, vaccines, and now antivirals. There is no sense of urgency to advance equity. And third, COVID-19 is a zoonotic disease. There is no recognition that preventing a pandemic means redefining the relationship between humans, wildlife, and the viruses that pass among us. One final warning. Do not assume that governments will be willing to invest in preparedness, despite the catastrophe we have endured. Countries are already resisting calls to invest in the next replenishment round for the Global Fund to Fight AIDS, Tuberculosis and Malaria. If governments are unwilling to support an initiative with one of the best track records in global health, it is questionable whether they will make speculative investments to prevent a future pandemic. The disagreeable truth is that we are living at a very dangerous moment, one in which careless self-satisfaction is the reward we have given ourselves for this illusory triumph.

Tackling psychosocial and capital constraints to alleviate poverty

Psychosocial measures improve the cost-effectiveness of multi-faceted interventions against extreme poverty.

Abstract

Many policies attempt to help extremely poor households build sustainable sources of income. Although economic interventions have predominated historically^{1,2}, psychosocial support has attracted substantial interest^{3,4,5}, particularly for its potential cost-effectiveness. Recent evidence has shown that multi-faceted 'graduation' programmes can succeed in generating sustained changes^{6,7}. Here we show that a multi-faceted intervention can open pathways out of extreme poverty by relaxing capital and psychosocial constraints. We conducted a four-arm randomized evaluation among extremely poor female beneficiaries already enrolled in a national cash transfer government programme in Niger. The three treatment arms included group savings promotion, coaching and entrepreneurship training, and then added either a lump-sum cash grant, psychosocial interventions, or both the cash grant and psychosocial interventions. All three arms generated positive effects on economic outcomes and psychosocial well-being, but there were notable differences in the pathways and the timing of effects. Overall, the arms with psychosocial interventions were the most cost-effective, highlighting the value of including well-designed psychosocial components in government-led multi-faceted interventions for the extreme poor.

Abstract

Metacognition and mentalizing are both associated with meta-level mental state representations. Conventionally, metacognition refers to monitoring one's own cognitive processes, while mentalizing refers to monitoring others' cognitive processes. However, this self-other dichotomy is insufficient to delineate the 2 high-level mental processes. We here used functional magnetic resonance imaging (fMRI) to systematically investigate the neural representations of different levels of decision uncertainty in monitoring different targets (the current self, the past self [PS], and others) performing a perceptual decision-making task. Our results reveal diverse formats of internal mental state representations of decision uncertainty in mentalizing, separate from the associations with external cue information. External cue information was commonly represented in the right inferior parietal lobe (IPL) across the mentalizing tasks. However, the internal mental states of decision uncertainty attributed to others were uniquely represented in the dorsomedial prefrontal cortex (dmPFC), rather than the temporoparietal junction (TPJ) that also represented the object-level mental states of decision inaccuracy attributed to others. Further, the object-level and meta-level mental states of decision uncertainty, when attributed to the PS, were represented in the precuneus and the lateral frontopolar cortex (IFPC), respectively. In contrast, the dorsal anterior cingulate cortex (dACC) represented currently experienced decision uncertainty in metacognition, and also uncertainty about the estimated decision uncertainty (estimate uncertainty), but not the estimated decision uncertainty per se in mentalizing. Hence, our findings identify neural signatures to clearly delineate metacognition and mentalizing and further imply distinct neural computations on internal mental states of decision uncertainty during metacognition and mentalizing.
