### **Global Food Security – Global Hunger Crisis**

#### **Secretary-General Warns of Unprecedented Global Hunger Crisis, with 276 Million Facing Food Insecurity, Calling for Export Recovery, Debt Relief**

*Following is the text of UN Secretary-General António Guterres' video message to the ministerial conference titled "Response to the Multiple Challenges to Global Food Security", in Berlin today: [Excerpts]*

...We face an unprecedented global hunger crisis. **The war in Ukraine has compounded problems that have been brewing for years: climate disruption; the COVID-19 pandemic; the deeply unequal recovery.** This was already apparent when I visited the Sahel region of Africa last month. Leaders warned me that unless we act now, a dangerous situation could turn into a catastrophe. The Horn of Africa is also suffering its worst drought in decades.

According to the World Food Programme (WFP), in the past two years, the **number of severely food-insecure people around the world has more than doubled to 276 million.** There is a real risk that multiple famines will be declared in 2022. **And 2023 could be even worse.**

The main costs to farmers are fertilizers and energy. Fertilizer prices have risen by more than half in the past year, and energy prices by more than two thirds. All harvests will be hit, including rice and corn — affecting billions of people across Asia, Africa and the Americas. **This year's food access issues could become next year's global food shortage. No country will be immune to the social and economic repercussions of such a catastrophe.**

**Humanitarian support is essential, but it is not enough.** Because this is not just a food crisis. It goes beyond food and requires a coordinated multilateral approach, with multidimensional solutions.

**First, there can be no effective solution to the global food crisis without reintegrating Ukraine's food production,** as well as the food and fertilizer produced by Russia, into world markets — despite the war. I have been in intense contact with Ukraine, Russian Federation, Turkey, United States, European Union and others on this issue.

The Secretary-General of the United Nations Conference on Trade and Development (UNCTAD), Rebeca Grynspan, and my humanitarian chief, Martin Griffiths, are continuing the talks, aiming to achieve a package deal that will enable Ukraine to export food, not only by land, but through the Black Sea, and will bring Russian food and fertilizer to world markets without restrictions. I will not go into details because public statements could hinder success in the talks that are taking place.

**Second, solving the food crisis requires solving the finance crisis in the developing world.** Hundreds of millions of people on the poverty line have been crushed by this crisis — informal workers who are mainly women; small holder farmers; micro and small business owners; people with disabilities. Developed countries and international financial institutions need to make resources available to help Governments support and invest in their people, leaving no one behind.

Developing countries that face debt default must have access to effective debt relief to keep their economies afloat and their people thriving. Financial institutions must find the flexibility and understanding to get resources where they are needed most. The Food and Agriculture Organization's (FAO) proposal for a Food Import Financing Facility could help the most exposed countries meet their immediate needs.

Today's discussions are an **opportunity for concrete steps to stabilize global food markets and tackle the volatility of commodity prices.** We need strong political and private sector leadership for a coordinated multilateral response. We cannot accept mass hunger and starvation in the twenty-first century. Thank you.

### **World Bank Approves \$2.3 Billion Program to Address Escalating Food Insecurity in Eastern and Southern Africa**

WASHINGTON, June 21, 2022 — The World Bank Group approved a \$2.3 billion program to help countries in Eastern and Southern Africa increase the resilience of the region's food systems and ability to tackle growing food insecurity.

Food system shocks brought on by extreme weather, pest and disease outbreaks, political and market instability, and conflict are becoming more frequent and severe, putting more people at risk of food insecurity. The war in Ukraine is further exacerbating these effects by disrupting the global food, fuel, and fertilizer markets. As a result, an estimated 66.4 million people in the region are projected to experience food stress or a food crisis, emergency, or famine by July 2022...

### **Arab Coordination Group (ACG) Institutions Launch Food Security Action with Initial US\$10 Billion Package**

Vienna, Austria, 20 June 20, 2022 - The Arab Coordination Group (ACG) is taking action in response to the global food supply crisis. As a first step, the institutions constituting the group are providing an initial US\$10 billion for immediate relief and long-term support. According to the latest estimates by the United Nations, about 49 million people worldwide are at risk of falling into famine conditions in the months ahead...

### **OAS Presents Report on Food and Nutrition Insecurity in the Americas**

June 24, 2022

The Organization of American States (OAS) presents the report "Confronting Food Insecurity in the Americas: Good Practices and Lessons Learned during the Covid-19 Pandemic," which systematizes information from 16 countries on policies and programs to ensure food security in the region and identifies priority lines of action on this issue.

Food insecurity is on the rise in several countries around the world, reversing years of progress and jeopardizing the ability to achieve the Sustainable Development Goals by 2030, specifically the goal to "End hunger, achieve food security and improved nutrition and promote sustainable agriculture." The

combination of the onset of the COVID-19 pandemic with declining incomes and disruptions in food supply networks and distribution chains have led to a significant increase in chronic and acute hunger.

In Latin America and the Caribbean in 2020, 41% of people were moderately or severely food insecure, and 14% experienced extreme food insecurity, defined as having no food and going a day or more without eating, according to data from the Food and Agriculture Organization of the United Nations (FAO). The number of people lacking physical or economic access to a quantity and quality of food necessary for health and development increased to 267 million people in 2020, an increase of 60 million people from the previous year. Food insecurity disproportionately affects groups that are already in a situation of greater vulnerability, such as women, indigenous and Afro-descendant peoples, people with disabilities, the elderly, people in a situation of human mobility, among others...

### **OECD - Support to agriculture has risen in response to global crises, while reforms to combat climate change and market distortions remain essential**

Public support for agriculture has reached record levels as governments enacted measures to shield both consumers and producers from the COVID-19 pandemic and other crises, according to a new report from the OECD. Only a small share of this support has been directed at longer-term efforts to combat climate change and other food systems challenges.

## **Internal Displacement**

### **Secretary-General's video message for the launch of the Action Agenda on Internal Displacement**

24 June 2022

Our world is facing a crisis of internal displacement.

Record high numbers of people around the world have been displaced within their countries by tragedies such as conflict, disasters and the climate crisis. Many have been uprooted for years... even decades... and often multiple times. Others have been forced to flee more recently. In just three months, the war in Ukraine drove 13 million people out of their homes and communities, nearly two-thirds of whom remain in Ukraine.

All of us have a duty to help find lasting solutions to the plight of internally displaced persons.

**Today I am launching an Action Agenda on Internal Displacement. Building on the recommendations of the High-Level Panel on Internal Displacement, the Action Agenda has three key objectives:**

**:: First, to help internally displaced persons find durable solutions;  
:: Second, to better prevent future displacement crises; and  
:: Third, to ensure stronger protection and assistance for those currently facing displacement.**

Let me be clear: the duty to end displacement lies first and foremost with governments. However, we all have a responsibility to act. **The plight of internally displaced persons is more than a humanitarian issue. It takes an integrated approach – combining development, peacebuilding, human rights, climate action and disaster risk reduction efforts.**

The Action Agenda sets out clear commitments for the United Nations system. I urge Member States, civil society and International Financial Institutions to do their part to help drive change. Together, we can ease human suffering and deliver a better future for internally displaced persons around the world.

### **Taking forward the UN Secretary-General's Action Agenda on Internal Displacement Joint Statement by the Principals of DCO, IOM, OCHA, UNDP and UNHCR**

24 Jun 2022

Today, the UN Secretary-General António Guterres [launched his Action Agenda on Internal Displacement](#). With over 59 million people currently internally displaced around the world – the highest number ever recorded – there has never been a more critical moment to address this global crisis.

**As the Heads of five UN Agencies and Entities, we come together today to express our shared commitment to taking this Action Agenda forward.** We recognize that it is only with strong cooperation, common purpose, and joined up efforts that we will be able to help internally displaced persons (IDPs) find an end to their displacement, better prevent future displacement crises from emerging, and ensure that those currently facing displacement receive effective protection and assistance.

Importantly, we recognize that while humanitarian action continues to serve a vital purpose, achieving real change on internal displacement will require greater collaboration with, and engagement from, actors across the UN system and beyond – most notably development, peace, and climate experts. **The current internal displacement crisis will not be sustainably resolved through humanitarian assistance alone, but rather by working with national and local authorities to create the conditions for safe and lasting solutions.**

**In developing the Action Agenda, the Secretary-General asked our five organizations to serve as a Steering Group on Solutions to Internal Displacement.** The Steering Group has been meeting regularly since the start of 2022, and we look forward to welcoming the newly appointed Special Adviser on Solutions to Internal Displacement Robert Piper as the group's Chair.

Looking to the future, the Steering Group will work with the Special Adviser to support implementation of the Action Agenda at all levels. **This begins with each of our five organizations leading by example, both by stepping up our own engagement and by embodying the collaborative spirit called for in the Action Agenda.** We will work closely with one another, and with other UN

Agencies and Entities, to ensure complementarity and coherence in our efforts and will support UN Resident Coordinators as the UN's lead on solutions at country-level.

As noted above, we will also seek to strengthen our partnerships with national and local authorities on internal displacement, including to redouble efforts to help IDPs sustainably reintegrate into society – whether they choose to return to their areas of origin, settle locally, or move to another part of the country. Protection and respect for the rights of IDPs and local communities will remain at the heart of this work and will guide all our engagements.

**We will also work closely with other NGOs, civil society, and displaced communities themselves, recognizing that for our efforts to succeed, they must be engaged as true partners in the search for solutions. Further, we will seek to bring in new partners, including the private sector and development finance actors.**

As the Action Agenda says, there is a long road ahead of us, but together it is possible to achieve real change. Our five organizations stand ready to take this important work forward and will be sharing more information over the coming months on concrete steps to deliver on this Agenda.

## **Humanitarian Action**

### **[Red Cross and Red Crescent leaders commit to accelerate efforts to tackle rising humanitarian challenges](#)**

Geneva, 23 June 2022 - The Council of delegates of the International Red Cross and Red Crescent Movement concluded today in Geneva with commitments from Red Cross and Red Crescent leaders and youth representatives from around the world, to **work together and scale-up efforts to take urgent action on a range of critical humanitarian issues.**

Representatives of 192 National Red Cross and Red Crescent Societies, the International Federation of Red Cross and Red Crescent Societies (IFRC) and the International Committee of the Red Cross (ICRC) **passed a series of resolutions to address a range of humanitarian challenges**, including;

- the growing existential threats posed by the climate crisis;
- the escalating migration crisis;
- the devastating impacts of war in cities and
- the need to continue efforts to work towards the elimination of nuclear weapons.

**"Urban warfare has a devastating humanitarian impact**, including the appallingly high number of civilian deaths, the physical and mental suffering, the destruction of homes and critical civilian infrastructure, the disruption to essential services and the widespread displacement of people. We have seen that sad reality playing out in Libya, Syria, Ukraine and elsewhere. The Red Cross and Red Crescent must mobilise all its influence and resources to meet the challenges that lie ahead," said ICRC

President Peter Maurer. 'To be clear: the consequences of urban conflicts are not inevitable. They are the result of the behaviour of the parties fighting in these environments and we call for international humanitarian law to be upheld as an urgent priority'.

**IFRC President Francesco Rocca said: "How we work to tackle and mitigate against the impacts of climate change will define our work, not just for the next few years, but for decades to come.**

"All over the world, our volunteers and staff are working with people in their communities to help them adapt to the climate crisis and, frankly, they are demonstrating greater readiness, eagerness, and leadership than the majority of our global political leaders. We need action from them, not more words. And now.

**"The same goes for the international migrant crisis.** The Red Cross Red Crescent Movement speaks of leaving no person behind, of solidarity, and humanity. But, all over the world, **we see world leaders failing to take the plight of migrants seriously enough and too easily prepared to neglect the human rights of those fleeing conflict, hunger, persecution, and, of course, those parts of the world where climate change has already done untold damage to their communities."**

***Francesco Rocca, IFRC President, was re-elected to serve a second four-year term in office at the IFRC's General Assembly on 19 June.***

### **[GSK announces £1 billion R&D investment over ten years to get ahead of infectious diseases in lower-income countries](#)**

## Novartis renews commitment to neglected tropical disease and malaria elimination, investing USD 250 million over five years to research and develop new treatments

- *Novartis endorses the Kigali Declaration on neglected tropical diseases, pledging USD 250 million to advance R&D of new treatments against NTDs and malaria over five years*
- *Commitment includes USD 100 million to advance R&D for Chagas disease, leishmaniasis, dengue and cryptosporidiosis, and USD 150 million for next-generation antimalarials and a new formulation for babies under 5kg with malaria*
- *Around the world, 1.7 billion people suffer from NTDs<sup>1</sup>, and there are 241 million cases of malaria<sup>2</sup>*

Basel, June 23, 2022 — Novartis endorses the Kigali Declaration on neglected tropical diseases (NTDs) and announces a five-year financial commitment of USD 250 million to the fight against NTDs and malaria in conjunction with the Kigali Summit on Malaria and NTDs alongside the 26th Commonwealth Heads of Government (CHOGM) meeting. This summit comes at a pivotal time for world leaders to reaffirm commitments to end neglected tropical diseases and malaria through the adoption of the Kigali Declaration. The declaration aims to mobilize political will and secure commitments to achieve the SDG3 target on NTDs and to deliver the targets set out in the World Health Organization's Neglected Tropical Disease Roadmap (2021-2030).

"Over the past decade, great progress has been made against NTDs, but there is still a lot more work to be done. Novartis will continue progressing our longstanding commitment to helping realize a world free of NTDs," said Vas Narasimhan, CEO of Novartis. "Today, by endorsing the Kigali Declaration and pledging to invest USD 250 million, we aim to accelerate progress toward elimination of these diseases, which continue to cause suffering and stigma for millions of people around the globe."...

#### The global impact of disproportionate vaccination coverage on COVID-19 mortality

Over the course of the first year of COVID-19 vaccination, between Dec 8, 2020, and Dec 8, 2021, 8·33 billion doses were administered among 4·36 billion people globally.<sup>1</sup> In their study in The Lancet Infectious Diseases, by fitting a mathematical model to excess mortality, Oliver J Watson and colleagues<sup>2</sup> estimated that in 185 countries and territories 31·4 million COVID-19-related deaths would have occurred during this timeframe in the absence of COVID-19 vaccination. **They estimated that 19·8 million deaths were averted by COVID-19 vaccination.**

**Consequently, the number of lives saved by COVID-19 vaccination markedly exceeded the death toll that has occurred.** Nonetheless, even more lives could have been saved by improving the equitability of vaccination coverage worldwide. **Specifically, an estimated 156 900 additional deaths would have been averted if the COVID-19 Vaccines Global Access (COVAX) Facility's vaccination target of 20% (for each Advance Market Commitment country) had been attained, and an estimated 599 300 additional deaths would have been averted if WHO's 2021 COVID-19 vaccination target of 40% (for each country) had been attained.**<sup>2</sup>



Meeting these targets, particularly in low-income countries, is challenged by myriad obstacles that require international support to overcome.

The primary barrier is the lack of access to vaccines due to a combination of restricted supply and funding in resource-constrained settings. Several high-income countries secured advanced purchasing agreements with vaccine manufacturers.<sup>3, 4</sup> In the case of the USA, the number of vaccine doses purchased even before production was enough to fully vaccinate its entire population three times over.<sup>4</sup> By contrast, low-income countries were unable to pay the premium prices negotiated by high-income countries, delaying the delivery of vaccines.<sup>3, 4</sup> In Burundi, for example, vaccine rollout was initiated 10 months later than in the USA.<sup>1</sup>

**The inequitable distribution of vaccines has prolonged the pandemic, and exacerbated the probability and frequency of the emergence of variants of concern.** Additionally, many of these novel variants evade host immunity, thereby eroding vaccine efficacy, as well as increasing transmissibility. Given the rapid global dissemination of these variants, the worldwide burden of morbidity and mortality due to COVID-19 is thereby affected. Provision of vaccine doses from high-income to lower-income countries is therefore not only moral but also pragmatic. The G7 countries have failed to meet their 2021 commitments for donation of vaccines, with the delivery of respective commitments to low-income countries and middle-income countries ranging from 31% by Japan to 8% by Canada.<sup>3</sup> Concerningly, contentious negotiations between political parties in the US Senate have resulted in the exclusion of financing for international COVID-19 vaccination, imperiling global vaccination aid programmes.<sup>5</sup>

Beyond the donation of vaccines to low-income countries, vaccine distribution infrastructure is fundamental to achieving vaccination coverage targets. For instance, more than 1·3 million donated doses were returned by the Democratic Republic of the Congo's Government and more than 114 000 doses expired because of an inability to maintain cold-chain storage and administration of vaccines.<sup>6</sup> Consequently, vaccination coverage of only 0·07% was achieved in the Democratic Republic of the Congo by December, 2021. The model created by Watson and colleagues<sup>2</sup> estimates that if the WHO vaccination target had been met, 32 070 additional lives could have been saved in the Democratic Republic of the Congo (country estimates are provided in the appendix of the Article).

**Vaccine hesitancy is an increasingly pervasive challenge across the world.** Within Nigeria, for example, vaccine misinformation has been widespread,<sup>7</sup> leading to vaccination coverage of only 1·82%. Watson and colleagues<sup>2</sup> estimate that if the WHO-targeted coverage of 40% had been achieved in Nigeria, 96 420 additional deaths could have been averted. Vaccine misinformation has also affected high-income countries, such as the USA, where public health responses to COVID-19 have become politically polarised.<sup>8</sup> Transparency during evidence-based vaccine approval processes is fundamental to trust. If vaccine refusal remains entrenched, mandates might become necessary to protect individuals, reduce SARS-CoV-2 transmission, and mitigate the emergence of more virulent variants.

**Vaccination programmes have also been disrupted by violent conflict.** For example, aid agencies have been unable to distribute COVID-19 vaccines, among other vaccines, in Houthi-controlled regions of Yemen.<sup>9</sup> Similarly, there has been cessation of vaccination in areas of Ukraine targeted by the Russian invasion.<sup>10</sup> Watson and colleagues<sup>2</sup> estimate that if the WHO targeted coverage of 40% had been achieved, 14 230 additional lives could have been saved in Yemen and 19 300 additional lives could have been saved in Ukraine.

**The saving of more than 19 million lives by the unprecedented rapidity of development and roll-out of COVID-19 vaccines is an extraordinary global health feat. Nonetheless, millions**

**of additional lives could have been saved by more equitable distribution of vaccines.** The most effective approaches to promote vaccination coverage worldwide are multifaceted, requiring improvements in vaccine supply, cold-chain operations, and public confidence. High coverage in an individual country not only benefits that country but contributes to a worldwide reduction in SARS-CoV-2 transmission and emergence of novel variants. An enduring collective response is both pragmatic and ethically imperative.

#### **Global impact of the first year of COVID-19 vaccination: a mathematical modelling study**

#### *Summary*

#### *Background*

The first COVID-19 vaccine outside a clinical trial setting was administered on Dec 8, 2020. To ensure global vaccine equity, vaccine targets were set by the COVID-19 Vaccines Global Access (COVAX) Facility and WHO. However, due to vaccine shortfalls, these targets were not achieved by the end of 2021. We aimed to quantify the global impact of the first year of COVID-19 vaccination programmes.

#### *Methods*

A mathematical model of COVID-19 transmission and vaccination was separately fit to reported COVID-19 mortality and all-cause excess mortality in 185 countries and territories. The impact of COVID-19 vaccination programmes was determined by estimating the additional lives lost if no vaccines had been distributed. We also estimated the additional deaths that would have been averted had the vaccination coverage targets of 20% set by COVAX and 40% set by WHO been achieved by the end of 2021.

#### *Findings*

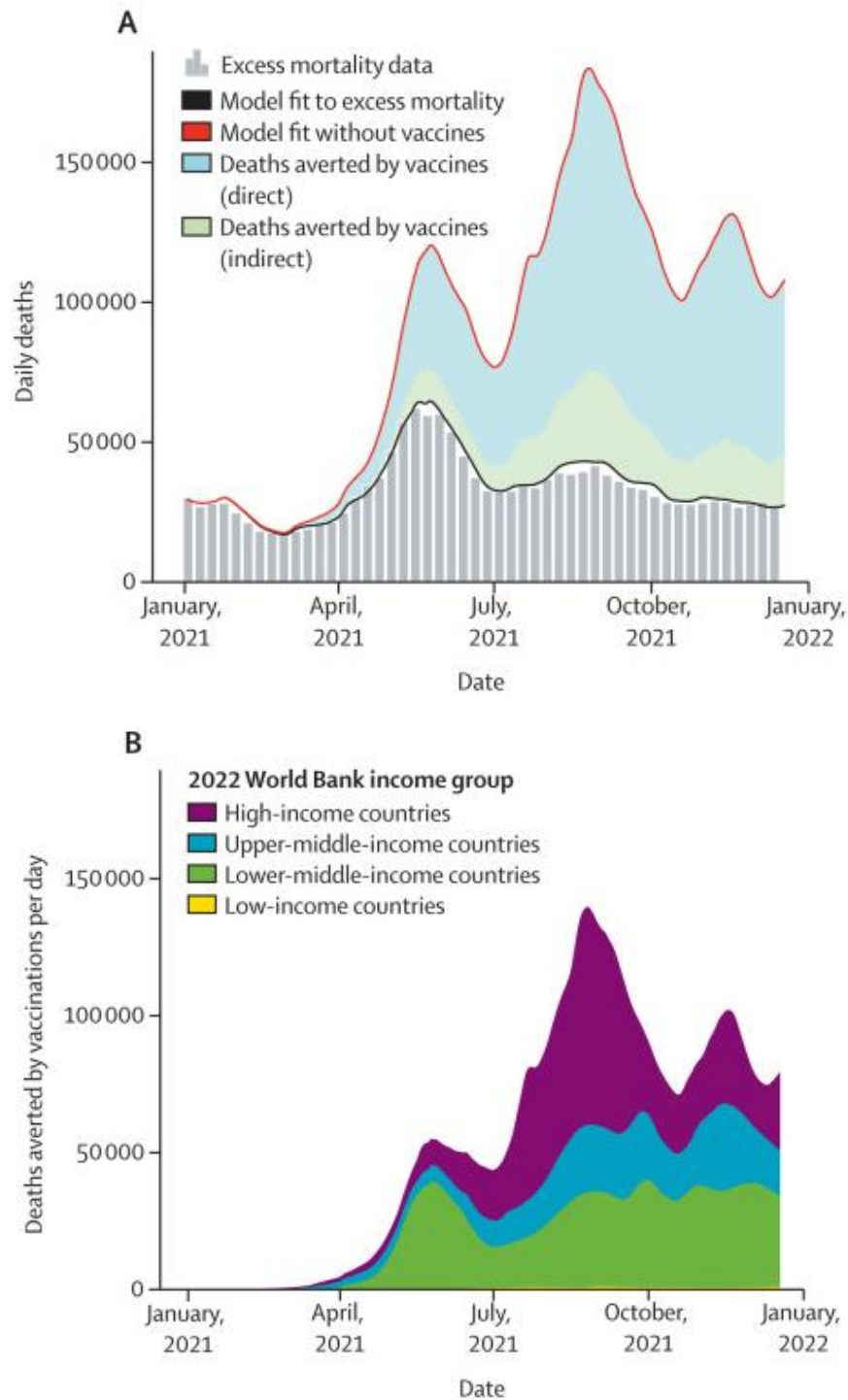
Based on official reported COVID-19 deaths, we estimated that vaccinations prevented 14·4 million (95% credible interval [CrI] 13·7–15·9) deaths from COVID-19 in 185 countries and territories between Dec 8, 2020, and Dec 8, 2021. This estimate rose to 19·8 million (95% CrI 19·1–20·4) deaths from COVID-19 averted when we used excess deaths as an estimate of the true extent of the pandemic, representing a global reduction of 63% in total deaths (19·8 million of 31·4 million) during the first year of COVID-19 vaccination. In COVAX Advance Market Commitment countries, we estimated that 41% of excess mortality (7·4 million [95% CrI 6·8–7·7] of 17·9 million deaths) was averted. In low-income countries, we estimated that an additional 45% (95% CrI 42–49) of deaths could have been averted had the 20% vaccination coverage target set by COVAX been met by each country, and that an additional 111% (105–118) of deaths could have been averted had the 40% target set by WHO been met by each country by the end of 2021.

#### ***Interpretation***

**COVID-19 vaccination has substantially altered the course of the pandemic, saving tens of millions of lives globally. However, inadequate access to vaccines in low-income countries has limited the impact in these settings, reinforcing the need for global vaccine equity and coverage.**

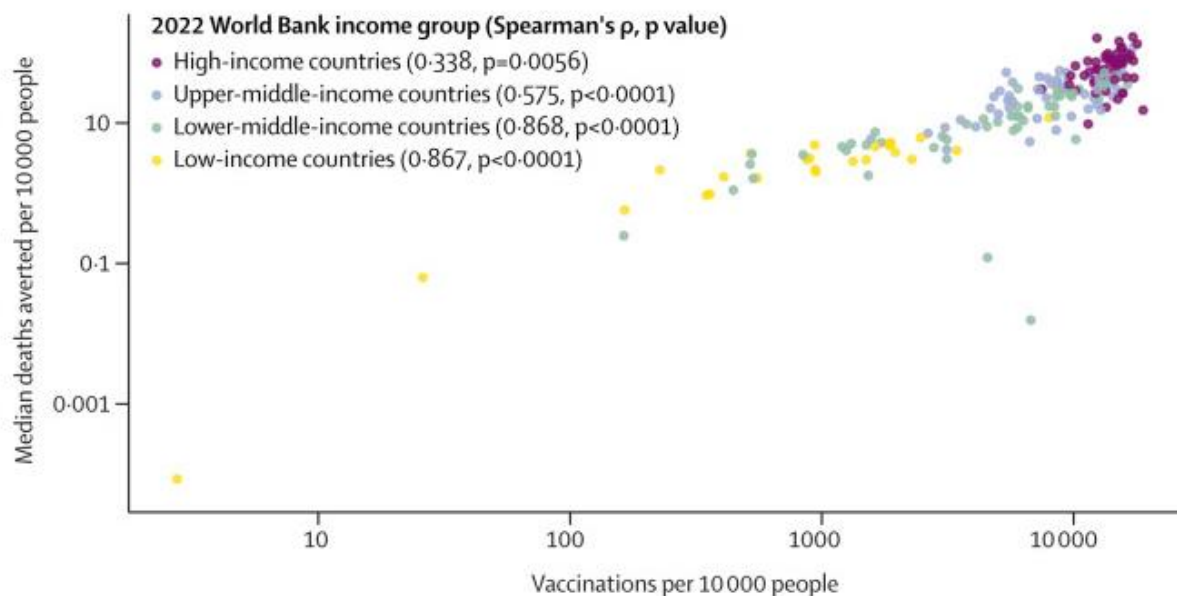

### **...Discussion [Excerpt]**

More broadly, our estimates should be considered in light of the considerable uncertainty inherent in estimating vaccine impact. Uncertainty in the true death toll of the pandemic, the circulating variants of concern and their immunological phenotypes, and the vaccines themselves administered in many countries vastly complicate efforts to derive accurate estimates of the impact of COVID-19 vaccines.

However, the results of this analysis still provide a comprehensive and thorough assessment of the impact of COVID-19 vaccination, revealing the substantial impact that vaccines have had and the millions of lives that are likely to have been saved during the first year of vaccination. Despite this, more lives could have been saved if vaccines had been distributed more rapidly to many parts of the world and if vaccine uptake could have been strengthened worldwide. Reaching vaccination coverage targets and improving vaccine coverage globally is dependent on multiple factors and not solely dependent on improving vaccine donations.<sup>30</sup>

Vaccine intellectual property needs to be shared more quickly in the future, with more open technology and knowledge transfer surrounding vaccine production and allocation. Vaccine distribution and delivery infrastructure also needs to be scaled up worldwide and misinformation combatted to improve vaccine demand. Improvements must be made in all these areas to reach current vaccine targets and help ensure that vaccines are more equitably distributed in the future.

## Weekly epidemiological update on COVID-19 – 22 June 2022

### Overview

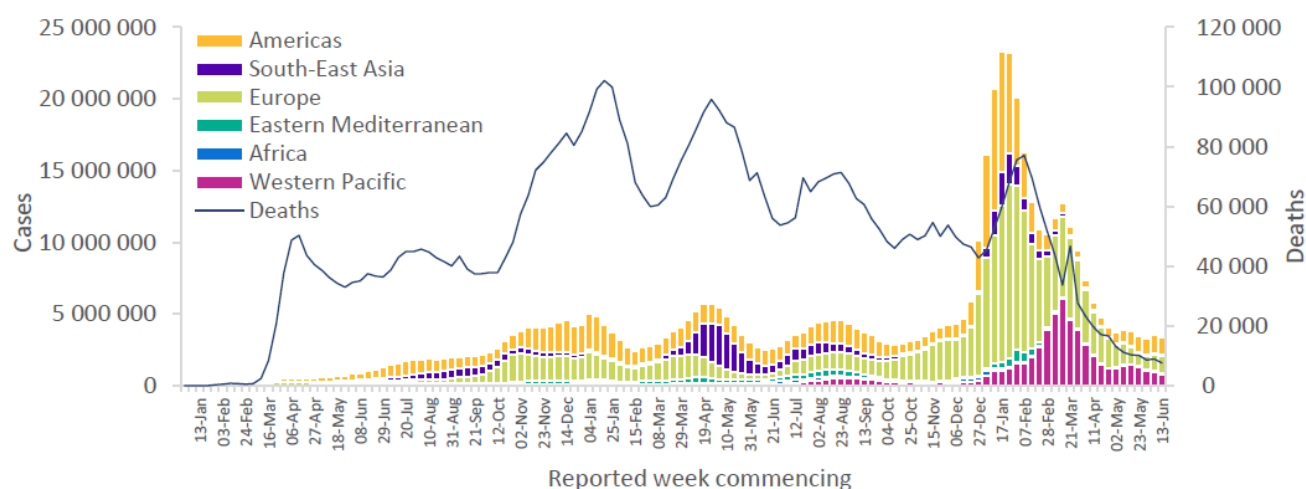
Globally, the number of new weekly cases has continued to decline since the peak in January 2022.

During the week of 13 until 19 June 2022, over 3.3 million cases were reported, a 4% decrease as compared to the previous week. The number of new weekly deaths declined by 16% as compared to the previous week, with over 7500 fatalities reported.

As of 19 June 2022, over 536 million confirmed cases and over 6.3 million deaths have been reported globally.

In this edition, we provide an update on the circulating SARS-CoV-2 variants of concern (VOCs), including their geographic spread and prevalence. We also provide a summary of current evidence on the Omicron variant.

**Statement of the Thirty-second Polio IHR Emergency Committee**

24 June 2022

The thirty-second meeting of the Emergency Committee under the International Health Regulations (2005) (IHR) on the international spread of poliovirus was convened by the WHO Director-General on 15 June 2022 with committee members and advisers attending via video conference, supported by the WHO Secretariat. The Emergency Committee reviewed the data on wild poliovirus (WPV1) and circulating vaccine derived polioviruses (cVDPV) in the context of global eradication of WPV and cessation of outbreaks of cVDPV2 by end of 2023. Technical updates were received about the situation in the following countries and territories: Afghanistan, Democratic Republic of the Congo, Israel, Malawi, the occupied Palestinian territory and Pakistan, and written updates were provided by Eritrea and Yemen...

...Conclusion

**Although heartened by the apparent progress, the Committee unanimously agreed that the risk of international spread of poliovirus remains a Public Health Emergency of International Concern (PHEIC)** and recommended the extension of Temporary Recommendations for a further three months. The Committee recognizes the concerns regarding the lengthy duration of the polio PHEIC and the importance of exploring alternative IHR measures in the future but concluded that there are still significant risks as exemplified by the importation of virus into Malawi and Mozambique...

**...Based on the current situation regarding WPV1 and cVDPV, and the reports provided by affected countries, the Director-General accepted the Committee's assessment and on 20 June 2022 determined that the situation relating to poliovirus continues to constitute a PHEIC, with respect to WPV1 and cVDPV...**

The Organization of American States (OAS) presents the report "Confronting Food Insecurity in the Americas: Good Practices and Lessons Learned during the Covid-19 Pandemic," which systematizes information from 16 countries on policies and programs to ensure food security in the region and identifies priority lines of action on this issue.

Food insecurity is on the rise in several countries around the world, reversing years of progress and jeopardizing the ability to achieve the Sustainable Development Goals by 2030, specifically the goal to "End hunger, achieve food security and improved nutrition and promote sustainable agriculture." The combination of the onset of the COVID-19 pandemic with declining incomes and disruptions in food supply networks and distribution chains have led to a significant increase in chronic and acute hunger.

In Latin America and the Caribbean in 2020, 41% of people were moderately or severely food insecure, and 14% experienced extreme food insecurity, defined as having no food and going a day or more without eating, according to data from the Food and Agriculture Organization of the United Nations (FAO). The number of people lacking physical or economic access to a quantity and quality of

food necessary for health and development increased to 267 million people in 2020, an increase of 60 million people from the previous year. Food insecurity disproportionately affects groups that are already in a situation of greater vulnerability, such as women, indigenous and Afro-descendant peoples, people with disabilities, the elderly, people in a situation of human mobility, among others...

**Bill & Melinda Gates Foundation Announces New Commitments in Support of African Leadership Driving to End Malaria and Neglected Tropical Diseases**

KIGALI and SEATTLE (June 23, 2022) – Melinda French Gates, co-chair of the Bill & Melinda Gates Foundation, today announced a US\$140 million commitment over four years in support of new initiatives and research directed by African institutions and leaders that accelerate progress toward ending malaria and neglected tropical diseases (NTDs) and contribute to the continent's COVID-19 recovery. French Gates made the announcement at the Kigali Summit on Malaria and Neglected Tropical Diseases on the sidelines of the 26th Commonwealth Heads of Government Meeting, alongside African heads of state and ministers and global dignitaries.

French Gates highlighted the remarkable progress Africans and their partners have made against preventable infectious diseases. "Over the past two decades, it has been inspiring to see the way leaders have come together to combat malaria and neglected tropical diseases," said French Gates, who spoke at the Kigali Summit. "African government officials, health workers, advocates, and scientists have contributed to significant reductions in death and other impacts these diseases have on communities. Tremendous leadership and collaboration with multilateral organizations, donor countries, and pharmaceutical companies are saving lives and helping people live to their fullest potential."

However, the rate of progress has slowed, prompting French Gates to call for renewed support to fight malaria and NTDs. She urged donors, the private sector, and affected country governments to increase investments to push back against these diseases and other health threats and to continue the development of vital innovations. This includes meeting the US\$18 billion target for the Global Fund to Fight AIDS, Tuberculosis and Malaria, which will hold its seventh replenishment conference later this year, and committing to the Kigali Declaration on NTDs, which was signed by global leaders at the Kigali Summit...

### **The Overturning of Roe v. Wade is an Assault on Women and Democracy Globally**

NEW YORK—The U.S. Supreme Court's decision today to overturn Roe v. Wade—the 1973 landmark case protecting the right to abortion—is an assault on women's rights, human rights, and democracy that will have a damaging impact around the world.

The decision reverses nearly 50 years of precedent in the United States, explicitly ending federal Constitutional protections for abortion, diminishing the rights of women, and threatening their access to reproductive care. With the significant hurdles already confronting those seeking to access reproductive care in the U.S., this decision will not only exponentially increase those who are impacted, but will hurt communities systemically failed by health systems the most—especially communities of color and poor women.

This is particularly concerning given the role the United States has played in championing human rights globally. Roe v. Wade inspired movements and laws in countries such as Tunisia and Cape Verde, and activists across the globe have expressed alarm at the prospect of other countries emulating the Supreme Court's decision. This ruling may also signal a return to U.S. obstructionism on sexual and reproductive health and rights globally, and a renewed effort to withdraw U.S. funding for reproductive health care.

"The majority's decision will not only wreak untold harm on women and families in the U.S., it could have reverberating damage around the world, rolling back hard-won advances in other nations and emboldening anti-choice movements," said Laleh Ispahani, co-director of Open Society-U.S.

Twenty-four countries still prohibit abortion, including Malta, Honduras, Senegal, and the Philippines. More than 50 countries have severe restrictions in place. And in countries such as Poland, rollbacks of basic rights, including restrictions on abortion access, have happened alongside a rise in authoritarian leadership.

But there are signs of hope, too. Over the past decade, African countries such as Benin have reversed or relaxed colonial-era abortion laws, while Latin American states such as Argentina, Colombia, and Mexico have advanced towards decriminalization...

Open Society has been proud to invest in grassroots and national reproductive rights organizations who are fighting back at this moment, both in the United States and globally. Today, those groups are facing an unprecedented challenge to their efforts in the communities they serve. Now more than ever, we must stand with them to reject further attempts to deny and take away long-established human rights.

### **An avoidable hunger crisis still looms for millions of children**

*The "Keep Kids Fed Act" passed, but more is needed to be done.*

Since early 2020, child nutrition waivers provided in response to the pandemic have made all students eligible for school meals at no cost and provided additional funding and flexibility to school meal programs. The waivers were set to expire June 30, which would have been premature: 23 million people in the United States are currently facing food insecurity and school meal programs are still struggling mightily with rising costs, staff shortages, and supply chain issues. Fortunately, Congress passed legislation last week ensuring that children could continue to receive meals at no cost through summer and extended some waivers through next school year. This bill averts the most dire short-term consequences but is far from perfect: it is imperative that the waivers be extended through next school year. As leaders of two nonprofit organizations committed to healthy school meals as integral to children's learning and overall wellbeing, Richard Besser and Nancy Brown, CEO of the AHA, explain why this bill must be a first step not be a final one.

#### *Summary*

#### *Motivation*

The Sustainable Development Goals (SDGs) call for transformative development rooted in international norms, such as human rights, rule of law, and gender equality. Often, however, nation-states do not implement these norms to the extent to which they are envisaged. Against this backdrop, regions have the potential to fill this implementation vacuum.

#### *Purpose*

Without a normative dimension, transformative development risks reproducing traditional economic development. In this special issue we focus on norm implementation in different world regions through the lens of normative coherence for development.

#### *Methods and approach*

The articles in this special issue all use qualitative methods, such as text analysis and in-depth interviews. Given the different regional contexts, each article has its own approach to normative coherence for development depending on the regional normative framework.

#### *Findings*

This special issue indicates that regions are an important interlocutor between the global, national, and sub-national level and, as such, are crucial for implementing the sustainable development agenda. The

articles show, however, that to date normative coherence for development has not been achieved due to overriding priorities and technical approaches to policy coherence for development.

#### *Policy implications*

With this special issue we aim to draw more attention to the topic of normative coherence for development and show that policies need to be adjusted in order to reflect the normative dimension of sustainable development.

### **Brazil: New Decree Creates Comprehensive Protection Program for Children and Adolescents**

On May 18, 2022, Brazilian President Jair Bolsonaro issued [Decree No. 11,074](#), which amended [Decree No. 9,579](#) of November 22, 2018, and created the Comprehensive Protection Program for Children and Adolescents – Protect Brazil and its management committee (comitê gestor).

Decree No. 9,579 consolidated normative acts published by the federal executive branch that provide for infants, children, adolescents, and apprentices and that relate to the National Council for the Rights of Children and Adolescents, the National Fund for Children and Adolescents, and federal programs for children and adolescents.

Decree No. 11,074 added articles 125-A to 125-R to Decree No. 9,579. Article 125-A defines Protect Brazil as a permanent intersectoral, multidisciplinary program instituted as a national strategy for the integral protection of children and adolescents. The program is to be coordinated by the Ministry of Women, Family and Human Rights' National Secretariat for the Rights of Children and Adolescents. (Decree No. 11,074, art. 125-B.) Its purpose is to promote and implement actions for the integral and healthy development of children and adolescents. (Art. 125-C.)...

A stable, well-functioning and integrated national medicines regulatory system is a core component of health systems resilient against infectious disease outbreaks. ### *Abstract*

Power distribution across the global health landscape has undergone a fundamental shift over the past three decades. What was once a system comprised largely of bilateral and multilateral institutional

arrangements between nation-states evolved into a varied landscape where these traditional actors were joined by a vast assemblage of private firms, philanthropies, non-governmental organizations and public-private partnerships. Financial resources are an explicit power source within global health that direct how, where and to whom health interventions are delivered, which health issues are (de)prioritized, how and by whom evidence to support policies and interventions is developed and how we account for progress. Financial resource allocations are not isolated decisions but rather outputs of negotiation processes and dynamics between actors who derive power from a multiplicity of sources. The aims of this paper are to examine the changes in the global health actor landscape and the shifts in power using data on disbursements of development assistance for health (DAH). A typology of actors was developed from previous literature and refined through an empirical analysis of DAH. The emergent network structure of DAH flows between global health actors and positionality of actors within the network were analysed between 1990 and 2015. The results reflect the dramatic shift in the numbers of actors, relationships between actors, and funding dispersal over this time period. Through a combination of the massive influx of new funding sources and a decrease in public spending, the majority control of financial resources in the DAH network receded from public entities to a vast array of civil society organizations and public-private partnerships. The most prominent of these was the Bill and Melinda Gates Foundation and the Global Fund for AIDS, TB and malaria, which rose to the third and fourth most central positions within the DAH network by 2015.

## **Public Health Virtue Ethicss**

Kathryn MacKay

*Abstract*

This paper proposes that public health is the sort of institution that has a role in producing structures of virtue in society. This proposal builds upon work that describes how virtues are structured by the practices of institutions, at the collective or whole-of-society level. This work seeks to fill a gap in public health ethics when it comes to virtues. Mainstay moral theories tend to incorporate some role for virtues, but within public health ethics this role has not been fully articulated. Two recent papers have proposed ways in which the virtues might be incorporated: working from a structural account, Rozier suggests that public health could work to instil virtues, like temperance, in the public in order to



achieve its health-related goals; Nihlén Fahlquist suggests that compassion is among three virtues that practitioners of public health should cultivate in order to do their work well. In the end, both accounts recommend incorporating virtues at the level of individuals, among the public and among practitioners. I propose a third kind of role for virtue in public health that focuses on structures. Public health activities take place at the population level, and a public health virtue ethics must also be suitably population-focussed.
