Secretary-General Appeals to Russian Federation: Allow International Committee of Red Cross Access to All Prisoners of War

The following statement was issued today by the Spokesman for UN Secretary-General António Guterres:

The Secretary-General reiterates his appeal to the Russian Federation that the International Committee of the Red Cross be granted full access to all prisoners of war, in accordance with international humanitarian law, including the Third Geneva Convention.

With 143 Votes in Favour, 5 Against, General Assembly Adopts Resolution Condemning Russian Federation's Annexation of Four Eastern Ukraine Regions

Continuing its emergency special session, the **General Assembly today condemned the Russian Federation's attempted illegal annexation of the Donetsk, Kherson, Luhansk and Zaporizhzhia regions of Ukraine, and demanded it immediately withdraw all its military forces from Ukraine territory.**

By the terms of the text, titled "***Territorial integrity of Ukraine: defending the principles of the Charter of the United Nations***"— adopted by a recorded vote of 143 in favour to 5 against (Belarus, Democratic People's Republic of Korea, Nicaragua, Russian Federation, Syria) with 35 abstentions — **the Assembly demanded that the Russian Federation immediately reverse its decisions of 21 February and 29 September related to the status of the four abovementioned regions.**

These acts are a violation of the territorial integrity and sovereignty of Ukraine and inconsistent with the principles of the United Nations Charter, the Assembly declared. It called on all States, international organizations and United Nations agencies not to recognize any alteration by the Russian Federation of the status of the four regions of Ukraine.

[The Assembly's eleventh emergency special session resumed on 11 October after the Security Council on 30 September failed to adopt a resolution intended to condemn the Russian Federation referendums that preceded Moscow's proclamation of its annexation of Luhansk, Donetsk, Kherson and Zaporizhzhia. (See Press Release [SC/15046](#) for details.) The draft Council resolution also would have declared that the referendums taken from 23 to 27 September in parts of those regions are neither valid nor form the basis for any alteration of the status of these regions of Ukraine, including any purported annexation by the Russian Federation.]

In the discussion today, **many Member States deplored the Russian Federation's aggression towards its neighbour and its attempted annexation of Ukrainian land as blatant disregard for the bedrock principles on which the Organization was founded.** The Czech Republic's representative said the Russian Federation's organizing of "fake voting amidst the war" is yet more proof of the intimidation and violations Ukrainian citizens are facing.

Some speakers were more neutral in their approach, while a handful sided with the Russian Federation. Among them was the Democratic People's Republic of Korea, whose delegate said that the people of Luhansk, Donetsk, Kherson and Zaporizhzhia voted to be a part of the Russian Federation. He also added that illegals acts of aggression against former Yugoslavia, as well as Afghanistan, Iraq and Libya, by the United States and other Western countries, have yet to be addressed by the Security Council...

Debt Relief – Developing Economies

50 percent of world's poorest need debt relief now to avert major systemic development crisis, warns UN Development Programme

Debt restructuring cannot wait until interest rates drop or a global recession kick in
October 11, 2022

New York —Fifty-four developing economies accounting for more than half of the world's poorest people need urgent debt relief as a result of cascading global crises. The risks of inaction are dire - if these countries do not get access to effective debt restructuring, poverty will rise and desperately needed investments in climate adaptation and mitigation will not happen - particularly since countries affected are among the most climate-vulnerable in the world, according to a new paper published today by the United Nations Development Programme (UNDP).

The paper - ['Avoiding 'Too Little Too Late' on International Debt Relief'](#) - highlights the ripple effects of government responses to the recent economic crisis and warns of the potential impacts. Against this bleak backdrop, the paper lays out a number of policy actions for debt restructuring that could help stop the debt crisis in its tracks.

Market conditions are shifting rapidly as a synchronized fiscal and monetary contraction and low growth are fuelling volatility around the globe: 19 developing economies are now paying more than 10 percentage points over US Treasury bonds to borrow money on capital markets, effectively shutting them out of the market. Holders of many developing economy bonds are seeing them trade at deep discounts of between 40 to 60 cents on the dollar...

The paper proposes a way forward for the Common Framework on debt restructuring, focusing on key areas: debt sustainability analysis, official creditor coordination, private creditor participation, and the use of state-contingent debt clauses that target future economic and fiscal resilience. UNDP proposes that the Common Framework shifts focus to comprehensive restructurings that will allow countries a faster return to growth, financial markets, and development progress...

Effective debt restructuring is only one vital element of ensuring that developing economies have the finances they need to make progress on sustainable development. New sources of funding are urgently needed for developing countries to undertake investments in climate adaptation and mitigation, the report concludes.

Development Capital – MDB Challenge Fund

Global Philanthropies Create New Multilateral Development Banks Challenge Fund To Increase Investment in Developing Countries

10.12.22

New fund will help to expand capacity of development banks around the world to scale up lending in low- and middle-income countries in line with the new G20 Capital Adequacy Review Commission recommendations

WASHINGTON, DC | October 12, 2022 — With the 2022 Annual Meetings of the International Monetary Fund (IMF) and the World Bank Group underway, **The Bill & Melinda Gates Foundation, Open Society Foundations, and The Rockefeller Foundation announce they are collaborating on a new grant fund aimed at unlocking more financing by multilateral development banks (MDBs) to low- and middle-income countries.** The group is making an initial commitment of up to \$5.25 million. By aligning its assistance around the recommendations made by the G20 Independent Review of MDBs' Capital Adequacy Frameworks report released in July, the goal of the MDB Challenge Fund is to help accelerate financing for the United Nation's Sustainable Development Goals (SDGs) and Paris Climate Agreement...

The G20 report contains a series of recommendations that have the potential to unlock tens of billions of dollars in new development finance with little to no cost to shareholders and while safeguarding the financial integrity of the MDBs. The announcement of the new Fund comes on the heels of U.S. Treasury Secretary Janet Yellen remarks about the changes needed in incentives, operating models, and uses of banks' financial resources to enable evolution of these institutions. Barbados Prime Minister Mia Mottley made similar remarks at the UN General Assembly last month, showing convergence on the need for the MDBs to do more.

"Multilateral Development Banks play a critical role in the global development finance system. They finance demands to address critical priorities like reducing child mortality, building climate resilient agriculture, and advancing gender equality that continue to exceed lending envelopes. We are confident that the MDB Challenge Fund will surface new ideas and thinking on how MDBs can more efficiently use their resources without compromising their financial integrity," said Kalpana Kochhar, director of development policy and finance at The Bill & Melinda Gates Foundation.

In addition, the G20 Capital Adequacy Frameworks report reinforced findings by organizations like the Center for Global Development, which released an analysis showing that MDB capital adequacy policies are significantly more conservative than their charters permit, with statutory headroom on average four times more than prudential limits indicate. Its calculations, which were based largely on equity to loan ratios, suggest that just the World Bank, Asian Development Bank, and African Development Bank, together, could potentially support over \$280 billion in additional lending annually...

When the Fund releases its first Request for Proposals later this year, it will **solicit proposals to support a range of activities, including but not limited to:**

- **Technical assistance to address potential barriers** to leveraging shareholders' capital contributions and maximizing financing as determined by MDBs' capital adequacy frameworks. This could include innovative solutions around risk transfer by the MDBs, such as the increased use of securitization.
- **Operational funding to finance components or pilot stages of reform initiatives** that can facilitate proof of concept for subsequent scaling.
- **Policy analysis to help assess and tailor policy changes** within MDBs that enable institutionalizing and scaling innovative solutions.

Catastrophic hunger levels recorded for the first time in Haiti

Almost half the population are currently facing acute hunger

PORT-AU-PRINCE: **An unrelenting series of crises has trapped vulnerable Haitians in a cycle of growing desperation, without access to food, fuel, markets, jobs and public services, bringing the country to a standstill**, warn the Food and Agriculture Organization of the United Nations (FAO) and the United Nations World Food Programme (WFP).

Hunger has reached Catastrophic levels, or the highest level, 5 on the Integrated Food Security Phase Classification (IPC), in Cité Soleil, an urban neighborhood in Port-au-Prince, Haiti.

According to the latest IPC analysis, a record 4.7 million people are currently facing acute hunger (IPC 3 and above), including 1.8 million people in Emergency phase (IPC 4) and, for the first time ever in Haiti, 19,000 people are in Catastrophe phase (IPC 5).

Cité Soleil has seen a worrisome rise in food insecurity over three years. Currently, 65 percent of its population, especially the poorest and most vulnerable, are in high levels of food insecurity with 5 percent of them in urgent need of humanitarian assistance. **Increased violence in Cité Soleil, with armed groups vying for control of the area has meant that residents have lost access to their work, markets and health and nutrition services. Many have been forced to flee or hide in their homes.**

Food security has also continued to deteriorate in rural areas, with several going from Crisis (IPC 3) to Emergency phase (IPC 4). Harvest losses due to below average rainfall and the 2021 earthquake that devastated parts of the Grand'Anse, Nippes and Sud departments are among the shocks that worsened conditions.

"WFP stands with the people of Haiti - serving the vulnerable and helping the poorest. We are here to ensure schoolchildren get a nutritious meal each day, families meet their basic food needs and communities are empowered," said Jean-Martin Bauer, WFP Country Director in Haiti. "This is a time of tumult in Haiti. But there is a way forward. We all need to be steadfast and focus on delivering urgent humanitarian assistance and supporting long-term development."...

Women and girls among those most impacted by Haiti's multiple crises

30,000 pregnant women at risk in Haiti as three-quarters of hospitals are unable to provide services.

PORT-AU-PRINCE / NEW YORK, 13 October 2022 – The health system has been brought to its knees in Haiti following the gang blockade of the country's principal fuel terminal in the capital Port-au-Prince, which began last month. **Around three-quarters of major hospitals across the country, which rely on diesel generators for electricity, report being unable to provide regular services.** Fuel shortages also mean there are now only three ambulances functioning in Port-au-Prince – with close to none running across the rest of the country.

Vulnerable populations, including pregnant women and girls, are the most impacted by restricted access to health services. UNFPA, the United Nations sexual and reproductive health agency, estimates that **close to 30,000 pregnant women are at risk of being unable to access essential healthcare, and almost 10,000 could experience life-threatening – if not fatal – obstetric complications without skilled medical assistance. Around 7,000 survivors of sexual violence could be left without medical and psychosocial support by the end of the year.**

UNFPA has collaborated with hospitals, health authorities and partners to install solar power supplies at 25 facilities across Haiti, which have improved cold-chain storage and enabled maternity services to continue. Solar power, however, is insufficient to keep hospitals fully functioning.

"Despite the extremely challenging security situation and fuel shortages, UNFPA and our partners are operating mobile clinics frequently in internally displaced persons sites around Port-au-Prince," said Saïdou Kaboré, UNFPA Representative in Haiti. "Our trained community workers are doing all they can to ensure that women and girls, especially pregnant women and survivors of violence, can access services and support that are critical to their health and survival."

As Haiti grapples with a complex humanitarian crisis, there has been a resurgence of cholera, a disease which causes dangerous levels of dehydration. The outbreak comes at a time when many Haitians lack access to basic services, including drinking water, sanitation and hygiene, and threatens the well-being of vulnerable populations, particularly women and girls. To date, the disease has claimed 18 lives, with more than 260 suspected cases, although the numbers could be higher...

Scientific Cooperation

ISC and WHO sign new agreement furthering mutual scientific cooperation for global health and sustainable development

14 October 2022, Geneva – The International Science Council (ISC) and the World Health Organization (WHO) have today signed a Memorandum of Understanding (MoU) **to ensure mutual scientific cooperation aimed at promoting and achieving healthier lives and wellbeing for all.**

The new agreement will facilitate and consolidate collaboration efforts between the two organizations considering their common goals relating to research, development and innovation in global health, and in the interest of better responding to and solving health issues of global concern. The agreement aims

to enhance the contribution of science to global health and sustainable development, to facilitate mobilization of scientific expertise and to strengthen science-policy interfaces relevant to health...

With the ISC's unique global membership representing both the natural and social sciences, and the WHO's authority within the United Nations system to direct and coordinate, **this new agreement will strengthen the contribution of the international scientific community to the advancement of health research, development and innovation.** The MoU will also promote dialogues on how to tackle health issues of global relevance by bringing to bear integrated knowledge across all sciences.

To this end, both organizations have agreed to work together on:

- **Advancing global health research and sustainable development**, including in the areas of foresight, horizon scanning, knowledge sharing and shaping of the global research agenda.
- **Advancing evidence-informed decision-making** for health policy and programmes.
- **Strengthening trust in science** for better uptake of health advice through communicating public health guidelines, collaborating on the creation and use of digital content, and addressing mis- and dis-information.

While the WHO and the ISC have already collaborated recently on work related to the coronavirus pandemic, notably on the ISC's policy report Unprecedented & Unfinished: COVID-19 and Implications for National and Global Policy, this new agreement now enables both organizations to focus on their shared strategic and operational priorities and to use their comparative strengths and advantages to maximize impact. Combining and connecting the scientific and policy expertise of both organizations will be key to ensuring evidence-based decision-making in the broad area of health and to strengthening trust in science at the global scale.

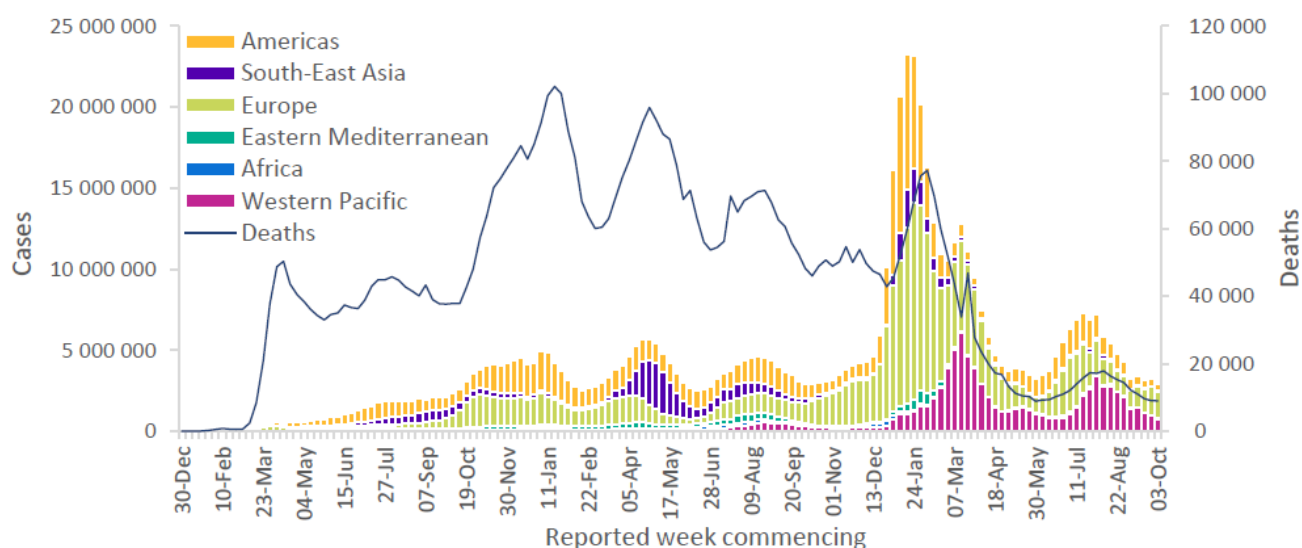
Weekly epidemiological update on COVID-19 – 12 October 2022

Overview

Globally, the number of new weekly cases decreased by 10% during the week of 3 to 9 October 2022, as compared to the previous week, with over 2.8 million new cases reported. The number of new weekly deaths remained stable (-1%), as compared to the previous week, with about 9000 fatalities reported.

As of 9 October 2022, 618 million confirmed cases and 6.5 million deaths have been reported globally.

WHO Director-General's opening remarks at the 13th meeting of the IHR Emergency Committee on COVID-19 pandemic – 13 October 2022

Professor Houssin, Members and Advisors of the Emergency Committee, dear colleagues and friends,

We have never been in a better position to end COVID-19 as a global health emergency. The number of weekly reported deaths is near the lowest since the pandemic began. And two-thirds of the world's population is vaccinated, including 75% of health workers and older people.

But our work is not yet finished. There are still wide disparities in vaccination rates. While almost two-thirds of the world's population has completed a primary course of vaccination, three-quarters of people in low-income countries are yet to receive a single dose.

Most countries no longer have measures in place to limit the spread of the virus; And most countries have reduced surveillance drastically, while testing and sequencing rates are also much lower. This is blinding us to the evolution of the virus and the impact of current and future variants.

Several countries in Europe are now reporting an increase in COVID-19 cases, hospitalizations and deaths. This is to be expected, as the weather cools in the northern hemisphere and people spend

more time together inside. Given the current situation, we expect continued transmission of the virus, and we expect reported cases of COVID-19 to increase.

But even if cases increase, deaths don't have to. We have the vaccines, therapeutics and know-how to save lives. As the pandemic evolves, so must the response.

WHO's 2022 Strategic Preparedness, Readiness and Response Plan outlines the key measures that all countries need in place to reduce and control infections and save lives. We are concerned that most countries are not using all the tools at their disposal. It is important that countries maintain and further strengthen their surveillance, testing and sequencing capacities, so that they can quickly identify and trace the virus. At the moment, most countries are not doing this.

Countries also need to ensure access to diagnostics, antivirals and treatment for all, especially those most at-risk. But again, there are still unacceptable gaps in access, putting far too many at risk of severe disease and death.

My colleagues will provide technical updates on the current epidemiological situation, virus evolution, future scenarios, and the use of life saving tools. My thanks once again to you, Professor Houssin, for your leadership. And my thanks to each of the committee members and advisors for sharing your expertise, and for your dedication and commitment. As always, the International Health Regulations will guide your deliberations. I wish you a productive discussion, and I look forward to your recommendations. I thank you.

With New Commitment, Gates Foundation Joins Call to Help End Polio

BERLIN (October 16, 2022) – Today at the World Health Summit, the Bill & Melinda Gates Foundation **announced it will commit \$1.2 billion to support efforts to end all forms of polio globally.** The announcement was made ahead of a key pledging moment that will be co-hosted by Germany and the Global Polio Eradication Initiative (GPEI).

The new financial commitment will support implementation of the GPEI’s Polio Eradication Strategy 2022-2026, which aims to end wild poliovirus in the last two endemic countries—Pakistan and Afghanistan—and stop outbreaks of new variants of the virus. **The foundation has contributed nearly \$5 billion to GPEI.**

“Polio eradication is within reach. But as far as we have come, the disease remains a threat. Working together, the world can end this disease,” said Bill Gates, co-chair of the Bill & Melinda Gates Foundation. “I want to thank Germany for co-hosting this week’s events and its longstanding support for polio eradication, and I urge other donors to support the eradication strategy to ensure no one is paralyzed by polio again.”

On October 18, Germany will co-host the GPEI pledging moment at the World Health Summit, where global partners, donors, and country leaders will make further commitments toward the **GPEI Strategy 2022-2026, which requires \$4.8 billion in funding.** If fully funded, GPEI will reach 370 million children each year with polio vaccines and other essential health services. GPEI’s efforts include deepening relationships with communities, supporting governments in responding to outbreaks, and helping advance the rollout of a next-generation polio vaccine...

WMA General Assembly

10.10.2022

Delegates from 57 national medical associations around the world attended the annual General Assembly of the WMA from 5 to 8 October. Among the issues discussed were:

Ukraine

Delegates reaffirmed their support for physician colleagues in Ukraine and condemned the Russian

army's bombing of Ukrainian civilians and hospitals, infringing medical neutrality in conflict zones. They called for an end to hostilities and urged all parties to ensure that access to medical care is guaranteed to all victims, civil or military, without distinction. They also called on the international community and governments to come to the aid of all those displaced by the conflict.

Iran

The meeting expressed its deep concern at reports of violence against protesters in Iran, where many people are reported to have died, many more are said to have been detained and medical vehicles have been abused by Iranian authorities to bring protesters to detention. Delegates urged the Iranian authorities to fully adhere to its human rights obligations, including the right to peaceful demonstration, to respect the autonomy of physicians and in particular their ethical duty to provide care to anyone on the basis of medical need alone, and to ensure that healthcare equipment and facilities are used for health care purposes only.

Ethical Use of Social Media

New guidelines were agreed, stating that physicians should avoid any inappropriate use of social media networks, such as frivolous, insensitive attitudes or light-hearted opinions on medical matters. Delegates urged national medical associations to produce guidelines to combat misinformation, disinformation, and the promotion of pseudoscience and pseudo-therapy, all of which could result in negative health outcomes for patients and communities.

The Use of Telehealth

The Assembly issued a warning to patients and physicians to be discerning in their use of digital health and to be careful of the potential risks. It approved new guidelines for physicians, saying that the largely unregulated growth in the number and variety of digital health services could have patient safety and ethical implications. The guidelines make it clear that 'face to face consultation should be the gold standard where a physical examination is required to establish a diagnosis, or where there is a wish on the part of the physician or patient to communicate in person'.

New President

Dr. Osahon Enabulele, former President of the Nigerian Medical Association, was installed as the 73rd President of the WMA for 2022-23.

Dr. Lujain Alqodmani, a leading public health doctor from Kuwait, was elected unopposed as President elect of the WMA. She is the first Arab to be elected President and will take up her post at the WMA's General Assembly in Kigali, Rwanda in October 2023.

Dr. Tohru Kakuta (Japan) was elected unopposed as Vice-Chair of Council.

Dr. Jacques de Haller, President of the Swiss Association of General Practitioners and a former President of the Standing Committee of European Doctors, was elected Chair of the Associate Members.

Other Policies

Other policies adopted by the Assembly include guidance on discrimination against the elderly, physicians treating their relatives, assisted reproductive technologies, prison conditions and tuberculosis, and chronic diseases.

Health Care Waste

Most health care generated waste is not hazardous, but it is voluminous. Health care organizations have obligations to manage waste in ways that minimize environmental impact and express their status as good citizens of their global, domestic, and regional communities. Resource-rich countries generate on average more than double the amount of hazardous waste per bed per day than resource-poor countries, and waste processing is concentrated in minoritized communities nearly everywhere. Segregating waste and reducing overall volume are key to curbing primary and secondary emissions that contaminate air and water. Decarbonization and moving the health care sector to net-zero emissions are key expressions of sincerity about motivating health equity.

Summary

Background

Refugee research ethics overlaps with and has drawn from ethics in humanitarian relief, anthropology and medical research. Ethics procedures and ethical practice need to be adapted to refugee settings to prevent unintentional harms and provide benefit to potential research participants who are highly vulnerable.

Methods

Non-systematic review of published literature on ethics and ethical practice related specifically to conducting research among refugees.

Discussion

Researchers conducting studies with refugees may find that compliance with procedural ethics is straightforward but, in practice, encounter myriad issues of relational (or "micro") ethics. These include how to obtain fully informed and genuinely voluntary consent, ensure confidentiality and participant anonymity, avoid unintentional harms, and fulfil the "dual imperative" of conducting methodologically rigorous research that provides reciprocal benefit to participants. Underlying all these issues is the asymmetric power relationship between researchers and refugees. Professionalism and reflexivity in the researcher's practice, establishing a researcher-participant relationship and ensuring meaningful participation in the research process are essential. It is the joint responsibility of all stakeholders in the research process to scrutinize every aspect of a research project to be conducted with refugees, thereby preventing sub-optimal or inadvertently unethical practices, but the individual researcher is ultimately responsible for ensuring that refugees derive benefit from the research to which they have contributed.

Perspective

Good ethical practice and methodological quality are mutually reinforcing goals. Although much progress has been made in improving ethical guidance for research among refugees, further development to define and guide best practice is needed.

Can We Automate Scientific Reviewing?

Abstract

The rapid development of science and technology has been accompanied by an exponential growth in peer-reviewed scientific publications. At the same time, the review of each paper is a laborious process that must be carried out by subject matter experts. Thus, providing high-quality reviews of this growing number of papers is a significant challenge. In this work, we ask the question “can we automate scientific reviewing? ”, discussing the possibility of using natural language processing (NLP) models to generate peer reviews for scientific papers. Because it is non-trivial to define what a “good” review is in the first place, we first discuss possible evaluation metrics that could be used to judge success in this task. We then focus on the machine learning domain and collect a dataset of papers in the domain, annotate them with different aspects of content covered in each review, and train targeted summarization models that take in papers as input and generate reviews as output. Comprehensive experimental results on the test set show that while system-generated reviews are comprehensive, touching upon more aspects of the paper than human-written reviews, the generated texts are less constructive and less factual than human-written reviews for all aspects except the explanation of the core ideas of the papers, which are largely factually correct. Given these results, we pose eight challenges in the pursuit of a good review generation system together with potential solutions, which, hopefully, will inspire more future research in this direction.

Research funders, professional associations, and scientific journals have increasingly endorsed positions and established policies that recognize data as a public good ([1](#)). In the health research context, the promise of data sharing is to accelerate health research across borders and improve patient care ([2](#)). But this raises ethical concerns for research participants, researchers, and marginalized communities, such as questions about data ownership, risk of reidentification (for example, genomic datasets), data security, and appropriate consent processes ([1](#)). Data sharing also raises distinctive ethical challenges for community-engaged research (CEnR), a term encompassing diverse research collaborations with communities, from community consultation to community-based participatory research. We discuss key rationales and goals of data sharing in health research and of CEnR and highlight three areas of potential tension between these two movements: incentives and

benefit sharing; group harm and power structures; and researcher engagement and responsibility sharing...
