COP27 Science Day Reiterates Importance of Data and Evidence for Delivering Implementation

10 November 2022

Sharm El-Sheikh, Egypt, 10 November 2022 – COP27's second thematic day focused on the importance of scientific developments and research to solve the catastrophic long-term problems that the world is facing as a result of climate change. **The various sessions concluded that scientists need to do more to make their data available and understandable to help policy makers fight climate change.**

Science Day comprised of panel discussions and events to bring forward the outcomes of the reports and their recommendations, and further enhance engagement of the climate community, practitioners,

and different stakeholders to discuss and engage on the linkages and findings related to climate change.

Commenting on Science Day, COP27 President H.E. Sameh Shoukry said, “**Science plays a key role in informing the climate process, providing critical evidence and numbers to build the case for action and the urgency of implementation.** We hope that all the participants in our thematic day on science leave with a stronger desire for finding science-based solutions and plan for implementation that leaves no one behind.”...

Data Sharing Principles – Pathogen Genomic Data

WHO guiding principles for pathogen genome data sharing

Overview

WHO encourages the sharing of pathogen genome data to protect global public health. Sharing of pathogen genome data is critical for preventing, detecting, and responding to epidemics and pandemics at national and international levels, and is in the interest of all Member States. The regular collection and sharing of such data are also important for monitoring and responding to endemic diseases and for tracking antimicrobial resistance to inform policy decisions...

Foreword [Excerpts]

One of the defining features of the COVID-19 pandemic is the lack of solidarity and sharing that has made the global response to the most severe health crisis in a century fractured and uncoordinated.

The world needs timely, high quality and geographically representative sharing of pathogen genome data in as close to real time as possible. When pathogen genome data is shared nationally and internationally, it helps to prevent, detect, and respond to epidemics and pandemics. Regular collection and sharing of pathogen genome data is also crucial for endemic diseases, especially for pathogens that are resistant to antimicrobials and require regularly updated policies. Genomic surveillance is critical for early warning of new epidemics, to monitor the evolution of infectious disease agents, and develop diagnostics, medicines and vaccines. This technology has been crucial in our response to the COVID-19 pandemic, from identifying a novel coronavirus to developing the first diagnostic tests and vaccines, to tracking and identifying new variants.

Capacities for pathogen genomics around the world are advancing rapidly. The speed, scale and affordability of sequencing are all increasing at astonishing rates. While these advances are welcome, inequities in access to new technologies leave blind spots in global surveillance that put us all at risk. A commitment to equity and support for capacity development must therefore be the overriding principle of the international system for sharing of pathogen data.

Even when countries have the technology and capacity to perform high quality genomic sequencing, the lack of global standards or rules for sharing genomic data can disincentivize them from sharing those data, out of concern for the potentially negative effects of reporting the emergence of a new and dangerous pathogen on trade and tourism. During the COVID-19 pandemic, some countries that shared high quality data on new variants were punished with travel restrictions, instead of being applauded for their act of solidarity...

Global pathogen genome data sharing practice should prioritize developing and sustaining trust among providers, platforms, and users of the data. Establishing who controls data sharing and where data are stored is important for achieving trust. Where all parties have confidence in the global system of pathogen genome data sharing, consider it fair,⁴ and support the underpinning principles, data sharing will be enhanced. Conversely, without such trust, it is unlikely that quality data will be submitted rapidly before publication.

11. Transparency

Terms and conditions of databases in the global system of pathogen genome data sharing should be publicly available. Governance procedures, for example, in the constitution of boards and committees and their terms of reference, should be publicly available. The governance structure should strive to ensure efficient and effective administration of the data sharing platforms while aligning the functioning of platforms with the principles outlined here.⁵

12. Consistency with applicable law and ethical regulations

Pathogen genome data sharing platforms should be established and operated in a manner consistent with applicable national and international laws, regulations, rules, and standards, and ethical regulations, norms, and standards.

13. Compliance and enforcement

Mechanisms to ensure compliance with principles are needed to make them credible. Data sharing platforms whose terms and conditions provide specific protections to data submitters, should include mechanisms and resources to ensure compliance. Where data sharing mechanisms permit, there may also be a need to raise awareness of instances and sanctions for breaches of the rules of data access as a means of supporting trustworthiness.

Data solidarity: a blueprint for governing health futures

We live in an era of inequalities, many of which are being increased by digital technologies. Moreover, as noted by the *Lancet* and *Financial Times* Commission, “**business models based on data extraction, concentrations of power, and viral spread of misinformation and disinformation represent defining features of the current phase of digital transformations**”.¹ At the root of these problems lie corporate practices but also public policies that allow data processors to accrue profits at the cost of people and communities. Individuals harmed by data use often have no access to remedies, either because they cannot prove who and what caused the harm, or because no law was broken.²

Against this backdrop, regulatory frameworks that seek to prevent harm mostly by strengthening the control that individuals have over their data are not enough. Although individual control is important, it cannot address the vast power asymmetries between data processors and data subjects. Neither does it respond to the fact that in the digital era, harm—just as benefits—can affect wider groups of people than only the primary data subjects from whom the data comes.

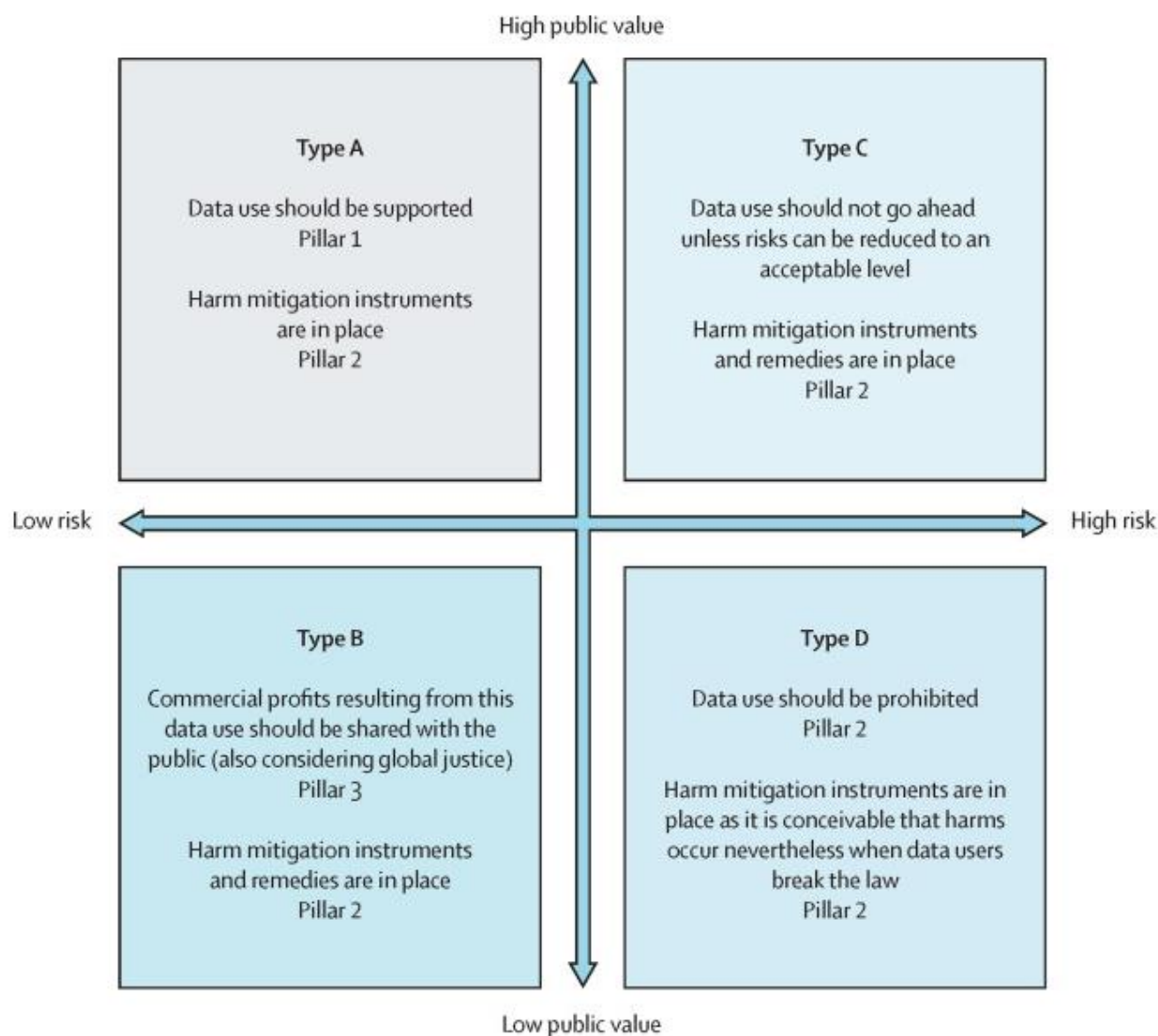


Figure Four types of data use

Solidarity-based data governance—by strengthening collective control and ownership of data—helps to ensure that the benefits and costs of digital practices are borne collectively and fairly. Next to preventing harm, data solidarity foregrounds the public value that specific instances of data use create. Data use creates public value when it benefits people and communities without posing grave risks ([figure](#)). Data use that creates little or no public value but poses substantial risks should be prohibited, with fines severe enough to deter even powerful corporations from breaking the law, and effective enforcement. Data use that poses no grave risks and is likely to benefit the public substantially, in contrast, should receive more public support ([figure](#)).

In this manner, data solidarity complements and helps to realise justice. **It seeks to ensure that people are protected from harm, and proposes ways of owning, overseeing, and governing data beyond the individual-focused model.**^{3, 4} **It consists of three main pillars: facilitating good data use (pillar 1); preventing and mitigating harm (pillar 2); and returning profits to the public domain (pillar 3).**

Data use that would create considerable public value—often in non-profit health research—can be very difficult or even impossible to carry out because regulation is unduly onerous, or due to financial, technological, or practical barriers. Data solidarity requires that such data uses receive more public support by removing red tape or by providing financial and practical assistance. Examples for how this could be done exist.^{5, 6}

Concerning data use that poses grave risks to individuals or communities, in contrast, data solidarity requires making use of the full force of the law to prohibit such harmful practices. For large corporate actors, the costs of breaking the law must be increased, such as by multiplying fines for repeat offenders and by improving cross-border cooperation in law enforcement. At the same time, some risks will remain, also in the case of beneficial data uses. When people are harmed by data use, they need remedies that are easily accessible and effective. One way to reach this goal is the creation of harm mitigation bodies at regional, national, or supranational level that would complement existing legal remedies.²

Where commercial profits accrue from data use, some of these profits need to come back to the people and communities that enabled them in the first place. The European Commission proposed corporate taxation specific to the digital economy⁷ to be accompanied by a future global minimum corporate tax.⁸

Corporate taxation for digital businesses could also help to reduce inequities between countries where digital businesses operate and where they pay taxes.⁹ An additional way of giving the people and communities more collective control over the profits from data use are data commons, in which data and other digital resources are governed collaboratively, guided by the values of fairness, equality, justice, and sustainability.¹⁰

The benefits from digital data and technologies are considerable, but they are distributed unequally. At the same time, people and communities that bear the costs of data use are often left behind. Societies have a collective responsibility to ensure that digital practices help to improve the lives of all people, and that harms are prevented more effectively. Data solidarity provides a blueprint of how to make this happen.

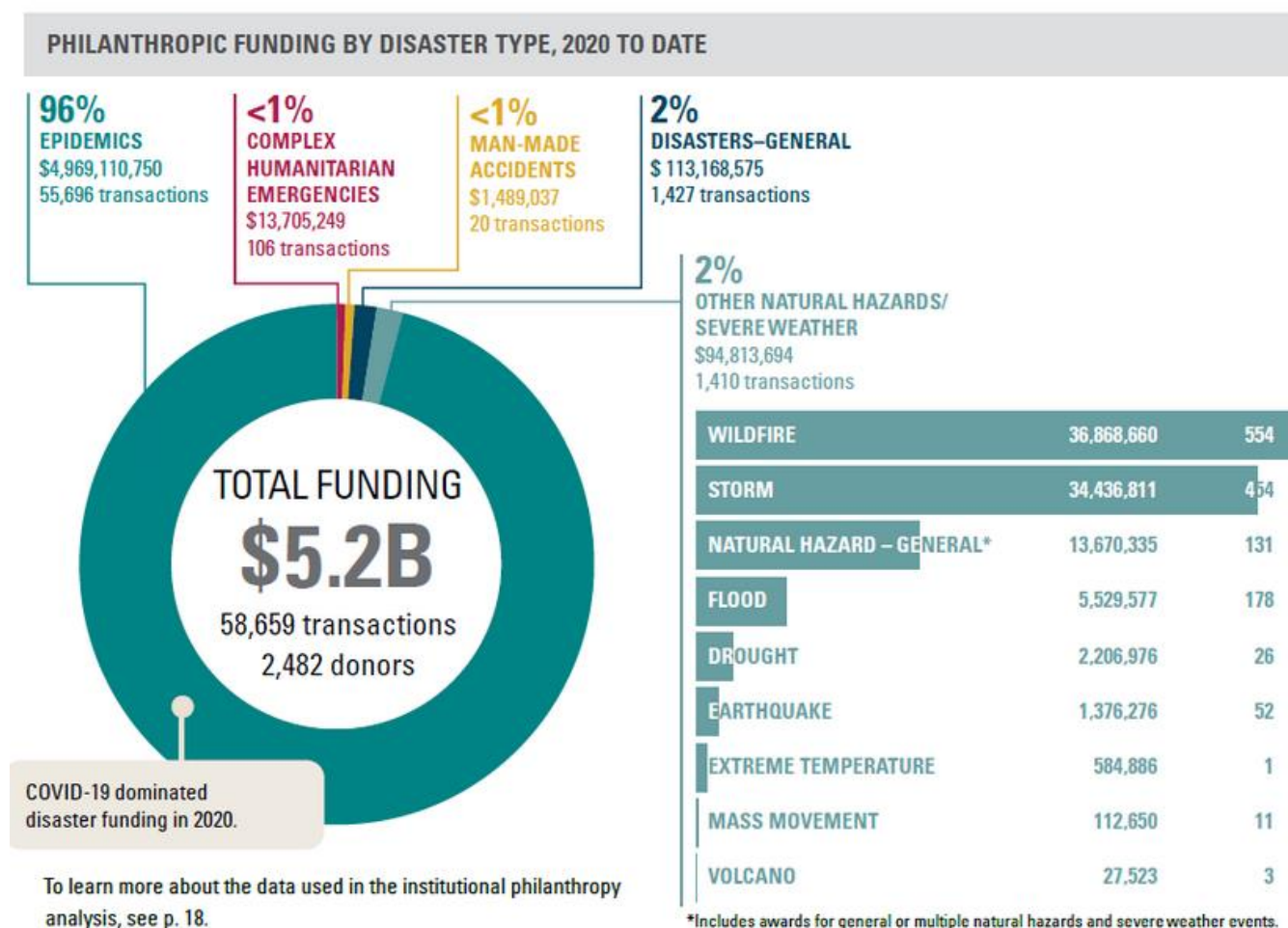
Disasters – Philanthropy

New State of Disaster Philanthropy report finds Covid-19 giving shattered records, but only a fraction went to climate-related and humanitarian crises in 2020

2022 report from Candid and Human Rights Funders Network shows that there is room for growth

This year's ***Measuring the State of Disaster Philanthropy 2022: Data to Drive Decisions*** report underscores philanthropy's vital role in ensuring that disaster survivors and their communities have access to immediate relief and resources to rebuild and thrive.

...Key findings



As expected, COVID-19 overshadowed other disasters among donors. Of the \$5.2 billion in disaster giving by institutional philanthropy, 96% went toward COVID-19, while the rest was in response to the most active Atlantic hurricane season on record; destructive earthquakes in Puerto Rico; devastating wildfires in the Amazon, Australia, and the U.S.; flooding across Asia; the humanitarian crisis in Yemen; and other disasters.

Other key findings include:

- When comparing the year-to-year giving of 222 U.S. foundations, disaster-related funding in 2020 was nearly 19 times more than in 2019 (at \$2.1 billion and \$110.7 million, respectively). The enormous increase in funding in 2020 was due to the COVID-19 pandemic.

- In 2020, \$5.2 billion of funding to date came from foundations and public charities. Of this amount, 96% went toward COVID-19, while the remainder supported wildfires, storms, and general disaster efforts.
- Candid's analysis of corporate public announcements found \$3.6 billion in disaster-related funding from corporate giving programs.
- The Organisation for Economic Co-operation and Development's Development Assistance Committee (DAC) distributed \$36.4 billion for disasters and humanitarian crises in 2020. Non-DAC government donors and multilateral organizations contributed an additional \$3.1 billion.
- The Federal Emergency Management Agency (FEMA) distributed \$57.6 billion for U.S. disasters in 2020, a \$54 billion increase from 2019. The U.S. Department of Housing and Urban Development (HUD) allocated \$9 billion in recovery efforts in 2020, an \$8 billion increase from 2019. In 2020, the U.S. Economic Development Administration (EDA) invested approximately \$1.2 billion in 988 projects, an \$851.8 million increase from 2019.

Summary box

- The COVID-19 pandemic illuminates the need to move away from the current social contract, which focuses on the nation-state's responsibility for protecting the health of its own population, including by providing essential medicines and health technologies.
- We argue for embracing a global social contract, which is a governance concept that lays the foundation for how states should act as members of the international community, as regulators of the private pharmaceutical industry and as guarantors of public goods benefiting people worldwide.
- A global social contract should be based on a set of four principles: collective state stewardship of the pharmaceutical and health technology; equity and the protection of health as a human right; an effective global polity; and governmental transparency and democratic accountability.
- This foundation can serve as a basis for a future pandemic treaty and as a model to address the much broader global crisis of inequitable access to medicines and health technologies for infectious and non-communicable diseases.

Conclusions

The COVID-19 pandemic has starkly highlighted the failings of our current social contract and the lack of a global health governance system to ensure timely and equitable access to medicines and health technologies for all. A global social contract is needed to align individual state interests and incentives for the pharmaceutical industry with the global goal of protecting public health and health security. A pandemic treaty could both be shaped by this need and help create the conditions for an effective global social contract for access to medicines and health technologies.

The challenges for children's rights in international child protection: Opportunities for transformation

Highlights

:: Tensions affecting children's rights & international child protection pose challenges for protection actors and children's rights in practice.

:: It is argued that the real issue in this field is not children's rights per se but the way that they are (or are not) interpreted &/or operationalised.

:: There are 4 main challenges: politics, how child rights are interpreted, child (non) participation, & categorization.

:: Varying interpretations of rights at local levels, child participation, & actors' roles must be further explored.

Abstract

Children's rights highlight the priority of child protection internationally and require us to think about how protection is defined and conceptualised, whether protection efforts are working, and how we are carrying them out. Many scholars have noted the apparent conflict between the idea of children's rights as universal and the particular realities of local contexts, understandings, and experiences. Some argue that the failures of child protection are due to the structure of the children's rights framework itself. However, we contend that the issues lie in traditional child protection systems and frameworks, and how children's rights are (or are not) understood and operationalised by child protection actors. Relying on a narrative literature review, this conceptual paper presents several examples in support of this view, and argues that more work needs to be done to contextualize and secure the rights of children in need of protection. We explore the complex interplay between local and global interpretations of rights and recommend that dialogue among actors with different perspectives and socio-cultural experiences of children's rights will produce richer understandings and practices of them. This dialogue can support the transformation of the current international child protection system to support the ability of children, their families and caregivers to realise children's rights and support their thriving.

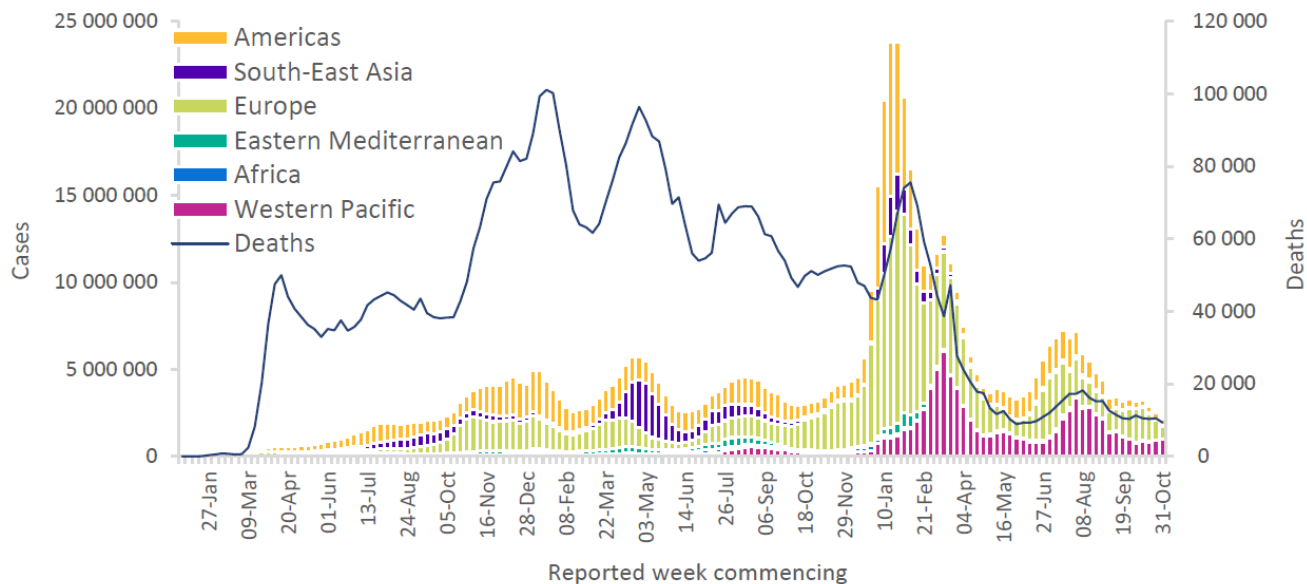
Weekly epidemiological update on COVID-19 - 9 November 2022

Overview

Globally, the number of new weekly cases decreased by 15% during the week of 31 October to 6 November 2022, as compared to the previous week, with over 2.1 million new cases reported. The number of new weekly deaths decreased by 10%, as compared to the previous week, with about 9400 fatalities reported. As of 6 November 2022, 629 million confirmed cases and 6.5 million deaths have

been reported globally.

On 2 November 2022, at the invitation of the Global Development Network (GDN), a worldwide network of research and policy institutes related to the contemporary development challenges, the Secretary General of the World Customs Organization (WCO), Dr. Kunio Mikuriya, spoke on Customs research agenda at the 2022 Global Development Conference: Tax Policy for Sustainable Development, held from 2 to 4 November at Clermont-Ferrand, France.

At the opening session, Dr. Mikuriya mentioned three areas of Customs research: digital transformation, border management in fragile and conflict-affected situations (fragile borders) and environmental issues. He announced that in terms of digital transformation, the WCO has developed a Data Strategy to assist Customs at becoming trusted government advisers. Customs can provide data for government agencies, including tax authorities, and business, for evidence-based decision-making.

Secretary General Mikuriya called upon researchers to join the Customs Data Innovation Hub to create proof of concepts, together with Customs and the private sector. He highlighted the role of Customs in fragile borders areas, particularly in protecting trade and taxation in fragile and conflict-

affected situations. He explained the importance of Customs presence in fragile areas to collect revenue, thus ensuring a lifeline for borderlands while defending the legitimacy of states against insurgents. Finally, he invited researchers to reflect on how to tackle the problem of lack of data and traceability on recycled goods in order to promote circular economy.

Dr. Mikuriya had a series of discussions with international organizations and academic institutions specialized in taxation about the role and relevance of Customs in sustainable development. They expressed their interest in collaborating with the WCO in the area of research by providing data and statistics.

An honest answer to the question, How much will it cost? is what most people seeking price transparency in health care tend to be after. Yet, what health care costs you or your family, or even being given an opportunity to assess whether you can afford services, is not how price transparency in

health care is defined by even the most dedicated, knowledgeable advocates. A 2014 report from a landmark task force of the Healthcare Financial Management Association, for example, states that what all patients deserve from health care price transparency is “accurate price estimates from a reliable source.” If this is the best definition of price transparency that a well-intentioned, well-informed task force suggests the American public can expect, one might reasonably suspect that, without dramatic reforms to financial structures of US health care, an honest answer to the question, How much will it cost? might not even be possible in many cases. Summary box

- The COVID-19 pandemic illuminates the need to move away from the current social contract, which focuses on the nation-state's responsibility for protecting the health of its own population, including by providing essential medicines and health technologies.
- We argue for embracing a global social contract, which is a governance concept that lays the foundation for how states should act as members of the international community, as regulators of the private pharmaceutical industry and as guarantors of public goods benefiting people worldwide.
- A global social contract should be based on a set of four principles: collective state stewardship of the pharmaceutical and health technology; equity and the protection of health as a human right; an effective global polity; and governmental transparency and democratic accountability.
- This foundation can serve as a basis for a future pandemic treaty and as a model to address the much broader global crisis of inequitable access to medicines and health technologies for infectious and non-communicable diseases.

Abstract

In recent years, there has been a surge of high-profile publications on applications of artificial intelligence (AI) systems for medical diagnosis and prognosis. While AI provides various opportunities for medical practice, there is an emerging consensus that the existing studies show considerable deficits and are unable to establish the clinical benefit of AI systems. Hence, the view that the clinical benefit of AI systems needs to be studied in clinical trials—particularly randomised controlled trials (RCTs)—is gaining ground. However, an issue that has been overlooked so far in the debate is that, compared with drug RCTs, AI RCTs require methodological adjustments, which entail ethical challenges. This paper sets out to develop a systematic account of the ethics of AI RCTs by focusing on the moral principles of clinical equipoise, informed consent and fairness. This way, the objective is to animate further debate on the (research) ethics of medical AI.

Decision making in global health: is everyone on board?

The Lancet Global Health

... All organisations involved in global health (including for-profit organisations) should have boards that are representative of the groups they serve, they should be publicly listed so they can be scrutinised, and these organisations should publish strategies on how they are addressing and aiming to resolve questions of board diversity, with time-bound targets. A representative board is unlikely to instantly realign an organisation's aims to perfectly concur with those of the disadvantaged but, providing these are not token appointments, would still be a valuable step.

Before and during the COVID-19 pandemic, NGOs such as the Gates Foundation filled a void created by the deficit of preparedness and initiative shown by many national governments. As nations, such as the UK, continue to cut international aid budgets and turn their increasingly myopic gaze inward, the importance of such NGOs will only grow in all facets of global health, not just the COVID-19 pandemic. This increased importance will have to come with increased scrutiny, as NGOs impact greater and greater numbers of people. And if an organisation truly aims to aid a traditionally underserved community, members of that community should be involved in the decision-making process at the very top.

Summary

COVID-19 has exacerbated endemic health inequalities resulting in a syndemic pandemic of higher mortality and morbidity rates among the most socially disadvantaged. We did a scoping review to identify and synthesise published evidence on geographical inequalities in COVID-19 mortality rates globally. We included peer-reviewed studies, from any country, written in English that showed any area-level (eg, neighbourhood, town, city, municipality, or region) inequalities in mortality by socioeconomic deprivation (ie, measured via indices of multiple deprivation: the percentage of people living in poverty or proxy factors including the Gini coefficient, employment rates, or housing tenure). 95 papers from five WHO global regions were included in the final synthesis. A large majority of the studies (n=86) found that COVID-19 mortality rates were higher in areas of socioeconomic disadvantage than in affluent areas. The subsequent discussion reflects on how the unequal nature of the pandemic has resulted from a syndemic of COVID-19 and endemic inequalities in chronic disease burden.

Conclusion

This Review has found extensive evidence of inequalities in COVID-19 mortality rates by area-level deprivation across the world. The pandemic has been an unequal experience with high mortality rates

in the most deprived places and communities. These inequalities can be understood as a syndemic, arising from endemic inequalities in the social determinants of health. Reducing these inequalities—and those that might arise from future pandemics—requires long-term action to reduce inequalities in health and wealth. Future research and data collection should focus on improving surveillance systems by, for example, integrating measures of inequalities into the WHO Mortality Database.

Abstract

The extraordinary success of mRNA vaccines against coronavirus disease 2019 (COVID-19) has renewed interest in mRNA as a means of delivering therapeutic proteins. Early clinical trials of mRNA therapeutics include studies of paracrine vascular endothelial growth factor (VEGF) mRNA for heart failure and of CRISPR–Cas9 mRNA for a congenital liver-specific storage disease. However, a series of challenges remains to be addressed before mRNA can be established as a general therapeutic modality with broad relevance to both rare and common diseases. An array of new technologies is being developed to surmount these challenges, including approaches to optimize mRNA cargos, lipid carriers with inherent tissue tropism and in vivo percutaneous delivery systems. Abstract

Rheumatoid arthritis (RA) is a highly heritable complex disease with unknown etiology. Multi-ancestry genetic research of RA promises to improve power to detect genetic signals, fine-mapping resolution and performances of polygenic risk scores (PRS). Here, we present a large-scale genome-wide association study (GWAS) of RA, which includes 276,020 samples from five ancestral groups. We conducted a multi-ancestry meta-analysis and identified 124 loci ($P < 5 \times 10^{-8}$), of which 34 are novel. Candidate genes at the novel loci suggest essential roles of the immune system (for example, TNIP2 and TNFRSF11A) and joint tissues (for example, WISP1) in RA etiology. Multi-ancestry fine-mapping identified putatively causal variants with biological insights (for example, LEF1). Moreover, PRS based on multi-ancestry GWAS outperformed PRS based on single-ancestry GWAS and had comparable performance between populations of European and East Asian ancestries. Our study provides several insights into the etiology of RA and improves the genetic predictability of RA.

Abstract

The past 2 Myr have seen both unprecedented environmental instability and the evolution of the human capacity for complex culture. This, along with the observation that cultural evolution occurs faster than genetic evolution, has led to the suggestion that culture is an adaptation to an unstable environment. We test this hypothesis by examining the ability of human social learning to respond to environmental changes. We do this by inserting human participants (n = 4800) into evolutionary simulations with a changing environment while varying the social information available to individuals across five conditions. We find that human social learning shows some signs of adaptation to environmental instability, including critical social learning, the adoption of up-and-coming traits and, unexpectedly, contrariness. However, these are insufficient to avoid significant fitness declines when the environment changes, and many individuals are highly conformist, which exacerbates the fitness effects of environmental change. We conclude that human social learning reflects a compromise between the competing needs for flexibility to accommodate environmental change and fidelity to accurately transmit valuable cultural information.

Abstract

COVID-19 is an infectious disease that has widened the gap between victims and non-victims in society. Understanding how individuals support and assist COVID-19 sufferers in a pandemic crisis is critical. Thus, this study aims to qualitatively evaluate the prosocial intention and types of prosocial behavior toward COVID-19 victims by low socioeconomic individuals from India and Indonesia's collectivistic societies. We conducted semi-structured and in-depth interviews during the lockdown from March to May 2020, via phone and in-person, using a purposive selection of respondents (total n = 50). The data were analyzed using the qualitative synthesis method. Five themes were discovered: 1) too scared to help, 2) love to help but scared: moral dilemma, 3) informing authority who knows how to handle, 4) caring, sharing, and supporting, but with a distance, and 5) helping at one's personal health risk. This study highlights that prosocial intentions range from minor acts of kindness to self-harm and out-of-bounds acts of kindness for COVID-19 victims.

Abstract

Children's rights highlight the priority of child protection internationally and require us to think about how protection is defined and conceptualised, whether protection efforts are working, and how we are carrying them out. Many scholars have noted the apparent conflict between the idea of children's rights as universal and the particular realities of local contexts, understandings, and experiences. Some argue that the failures of child protection are due to the structure of the children's rights framework itself. However, we contend that the issues lie in traditional child protection systems and frameworks, and how children's rights are (or are not) understood and operationalised by child protection actors. Relying on a narrative literature review, this conceptual paper presents several examples in support of this view, and argues that more work needs to be done to contextualize and secure the rights of children in need of protection. We explore the complex interplay between local and global interpretations of rights and recommend that dialogue among actors with different perspectives and socio-cultural experiences of children's rights will produce richer understandings and practices of them. This dialogue can support the transformation of the current international child protection system to support the ability of children, their families and caregivers to realise children's rights and support their thriving.
