#### **ISC Statement on Afghanistan**

2 January 2023

Paris, France

The International Science Council is deeply saddened by the recent decision of the authorities in Afghanistan to ban women from participating in university-level education. This measure, the latest in a series of negative actions affecting the ability of Afghani women and girls to participate in education, is at odds with both the Sustainable Development Goals and the Universal Declaration of Human Rights, which entrench the basic moral requirement for equity and the entitlement to education.

Education is critical to the social, cultural and economic progress of any country and to the wellbeing of its citizens. As societies have empowered and included women and girls in their education and science systems, so too have those countries achieved better social, health and economic outcomes. The decision to exclude Afghani women from university-level education will impede the social, cultural and economic development of Afghanistan.

Knowledge derived from scientific research is fundamental to human progress and creativity. Education allows the benefits of knowledge to be universally shared. More generally, education helps ensure that the application of science contributes productively to all societies.

The International Science Council is fully committed to promoting equitable access to education and participation in science in all societies irrespective of their political structure. It urges the authorities to reverse their decision on excluding women from university education. The Council stands ready to support Afghani women and girls in meeting their aspirations through education and engagement with science and invites the Afghan authorities to meet with us to further this goal.

# <u>UNODC global report on trafficking in persons: crises shift trafficking patterns and hinder victim identification</u>

24/01/2023

Fewer victims of trafficking in persons are being identified even as the COVID-19 pandemic and other crises are increasing vulnerabilities to exploitation, according to the latest <u>Global Report on Trafficking in Persons</u> launched today by UNODC.

The number of victims detected globally fell by 11 per cent in 2020 from the previous year, driven by fewer detections in low- and medium-income countries. The pandemic, in addition to reducing opportunities for traffickers to operate, may have weakened law enforcement capacities to detect victims.

"This latest report shows how the pandemic has increased vulnerabilities to trafficking in persons, further undercutting capacities to rescue victims and bring criminals to justice," said UNODC Executive Director Ghada Waly. "We cannot allow crises to compound exploitation. The UN and the donor community need to support national authorities, most of all in developing countries, to respond to trafficking threats, and to identify and protect victims especially in states of emergency."

The seventh UNODC Global Report on Trafficking in Persons covers 141 countries and provides an overview of patterns and flows of trafficking in persons at global, regional and national levels, based on trafficking cases detected between 2017 and 2021. The findings are further informed by analysis of 800 court case summaries and accompanied by detailed suggestions to policy makers to help formulate effective responses...

#### **\$2** trillion in public assets but little transparency

The first ever ranking of the transparency of development finance institutions (DFIs) highlights a **startling lack of public disclosure**.

The inaugural edition of the DFI Transparency Index examines the transparency of 30 DFI operations, with combined assets of \$2 trillion. The report reveals that:

- Across the board DFIs are insufficiently transparent. This is especially the case for non-sovereign (private sector) operations.
- Critically, **DFIs** are not providing evidence of impact, data regarding mobilisation, or proof of accountability to communities. The lack of disclosure around results and mobilisation limits the ability of stakeholders to ensure that DFIs are investing in the most impactful ways and mobilising private finance efficiently.
- For many DFIs, even basic information about their investments is not publicly available.
- But progress is being made. Many of the DFIs included in the Index have committed time and resources to improving the transparency of their operations, using Publish What You Fund's DFI Transparency Tool.
- The International Finance Corporation (IFC) was ranked as the most transparent non-sovereign (private sector) DFI in the assessment, scoring 54.4 out of 100. The rest of the top five positions in the non-sovereign assessment were filled by the African Development Bank (AfDB), Asian Development Bank (AsDB), European Bank for Reconstruction and Development (EBRD), and IDB Invest.
- The AsDB was ranked as the most transparent DFI in the analysis of sovereign (public sector) operations, scoring 75.9 out of 100. The rest of the top five positions in the sovereign assessment were filled by AfDB, the Inter-American Development Bank (IDB), EBRD and the Asian Infrastructure Investment Bank (AIIB).
- The US International Development Finance Corporation (DFC) was the top ranking bilateral DFI...

Paul James, who researched and authored the report, said: "Multilateral and bilateral development banks are operating in the face of mounting and urgent global crises – from health to debt, food to climate. \$2.4 trillion needs to be mobilised each year for climate finance alone, according to recent estimates. So it's crucial that the investments of our financial institutions have the desired impact, and are effective in mobilising greater investments. The lack of transparency that the Index found on these issues is concerning. But we're hopeful that DFIs will take on the actions we have highlighted and work with us to improve their transparency."...

**The Index report makes five main recommendations** for DFIs to improve their transparency, including:

- Report impact data
- Publish disaggregated mobilisation data
- Improve transparency around assurance of disclosure to project affected people
- Disclose high risk financial intermediary sub-investments
- Increase standardisation of data

### Community consensus on core open science practices to monitor in biomedicine

#### **Abstract**

The state of open science needs to be monitored to track changes over time and identify areas to create interventions to drive improvements. In order to monitor open science practices, they first need to be well defined and operationalized. **To reach consensus on what open science practices to monitor at biomedical research institutions, we conducted a modified 3-round Delphi study**. Participants were research administrators, researchers, specialists in dedicated open science roles, and librarians. In rounds 1 and 2, participants completed an online survey evaluating a set of potential open science practices, and for round 3, we hosted two half-day virtual meetings to discuss and vote on items that had not reached consensus. **Ultimately, participants reached consensus on 19 open science practices**. This core set of open science practices will form the foundation for institutional dashboards and may also be of value for the development of policy, education, and interventions.

## Box 1. Summary of key points

- Funders and other stakeholders in the international research ecosystem are increasingly introducing mandates and guidelines to encourage open science practices.
- Research institutions cannot currently monitor compliance with open science practices without engaging in time-consuming manual processes that many lack the expertise to undertake.
- We conducted an international Delphi study to agree which open science practices would be valuable for research institutions to monitor, with a view to creating an automated dashboard to support monitoring.
- We report 19 open science practices that reached consensus for institutional monitoring in an open science dashboard and describe how we intend to implement these.
- The open science practices identified may be of broader value for developing policy, education, and interventions.

#### **Conclusions**

This Consensus View aimed to establish a core set of open science practices to monitor at biomedical institutions. The core set of practices was developed to inform items to track in a proposed automated open science dashboard, which could be deployed by institutions and report aggregated institutional-level information on performance for each practice included. The value of a consensus list of open science practices may be of broad value when developing policy, education, and interventions to improve open science in biomedicine.

Through consulting with 80 stakeholders from 20 institutions, consensus was reached on the value of tracking 19 practices in the proposed dashboard. By taking the approach of consulting the community and building consensus on the practices to include in the dashboard, we intend to develop a dashboard that best meets the needs of the community. By bringing the community together prior to developing the tool, we have also had the opportunity to brainstorm and discuss implementation strategies. We now have a roadmap to guide how to obtain community feedback on a prototype of the dashboard and a plan to pilot implementation at 3 institutions. This pilot and implementation exercise will position us to better understand barriers and enablers to adoption and use of the proposed open science dashboard [28].

#### **Abstract**

Julian Simon argued that more people were associated with more prosperity: human talents were the "ultimate resource" and the force behind rising living standards. The last 30 years have been consistent with that view. But, globally, we are making fewer workers—and, more importantly, fewer potential innovators. In rich countries, human capital is growing considerably more slowly than in the past. Meanwhile innovation per researcher appears to be dropping as the population of researchers ages, while it takes longer to get to the knowledge frontier and more collaboration to expand it. Combined with the fact we are increasingly intolerant of risk and increasingly desirous of innovations in sectors where it is particularly hard to increase productivity, it is little surprise that productivity growth is indeed declining. To extend our two-century era of comparatively rapid progress, we need radically reduced discrimination in the global opportunity to innovate.

## NIH launches intramural bioengineering center to foster technology collaboration across the agency

*NIH-wide resource will champion diversity, equity, inclusion and accessibility.*January 25, 2023 —

The National Institute of Biomedical Imaging and Bioengineering (NIBIB) has established the Center for Biomedical Engineering Technology Acceleration (BETA Center), a new intramural research program to solve a range of medicine's most pressing problems. The BETA Center will serve the wider NIH intramural research program as a biotechnology resource and catalyst for NIH research discoveries.

The center will incorporate a focused engineering approach to accelerate the development, validation and dissemination of cutting-edge technologies. Areas of emphasis will include biomedical imaging, biosensing, engineered and synthetic biology, nanomaterials and biomaterials, artificial intelligence, modeling, computation and informatics. A unique feature of the center will be its ability to rapidly assemble expert teams for purpose-driven technology development to address urgent national and global health needs.

"The BETA Center will be a catalyst for innovation and collaboration," said NIBIB Director Bruce J. Tromberg, Ph.D. "Engineering and technology development are central to everything that NIH does. New tech drives new biomedical discoveries, and new discoveries are transformed into cutting-edge methods, devices and knowledge that can be widely disseminated."

**Globally, nearly 1.9 million new cases and over 12 000 deaths were reported in the week of 16 to 22 January 2023.** In the last 28 days (26 December 2022 to 22 January 2023), over 11 million cases and over 55 000 new deaths were reported globally – a decrease of 25% and an increase of 13%, respectively, compared to the previous 28 days. As of 22 January 2023, over 664 million confirmed cases and over 6.7 million deaths have been reported globally...

• The support comes at a time when Sierra Leone and health partners are working to strengthen the health care delivery system and improve child health care services.

Bearing the weight of a traumatic history, medical research is often seen as invasive and harmful by subaltern communities. ## <u>Tools such as ChatGPT threaten transparent science; here are our ground rules for their</u> use

As researchers dive into the brave new world of advanced AI chatbots, publishers need to acknowledge their legitimate uses and lay down clear guidelines to avoid abuse.

... But the release of the AI chatbot ChatGPT in November has brought the capabilities of such tools, known as large language models (LLMs), to a mass audience. Its developers, OpenAI in San Francisco, California, have made the chatbot free to use and easily accessible for people who don't have technical expertise. Millions are using it, and the result has been an explosion of fun and sometimes frightening writing experiments that have turbocharged the growing excitement and consternation about these tools....

That's why it is high time researchers and publishers laid down ground rules about using LLMs ethically. Nature, along with all Springer Nature journals, has formulated the following two principles, which have been added to our existing guide to authors (see go.nature.com/3j1jxsw). As Nature's news team has reported, other scientific publishers are likely to adopt a similar stance.

First, no LLM tool will be accepted as a credited author on a research paper. That is because any attribution of authorship carries with it accountability for the work, and AI tools cannot take such responsibility.

Second, researchers using LLM tools should document this use in the methods or acknowledgements sections. If a paper does not include these sections, the introduction or another appropriate section can be used to document the use of the LLM...

Discriminatory attitudes against unvaccinated people during the pandemic

Vaccinated people express discriminatory attitudes towards unvaccinated individuals across cultures. Alexander Bor, Frederik Jørgensen, Michael Bang Petersen

Abstract

During the COVID-19 pandemic, sizeable groups of unvaccinated people persist even in countries with high vaccine access 1. As a consequence, vaccination became a controversial subject of debate and even protest2. Here we assess whether people express discriminatory attitudes in the form of negative affectivity, stereotypes and exclusionary attitudes in family and political settings across groups defined by COVID-19 vaccination status. We quantify discriminatory attitudes between vaccinated and unvaccinated citizens in 21 countries, covering a diverse set of cultures across the world. Across three conjoined experimental studies (n = 15,233), we demonstrate that vaccinated people express discriminatory attitudes towards unvaccinated individuals at a level as high as discriminatory attitudes that are commonly aimed at immigrant and minority populations 3,4,—5. By contrast, there is an absence of evidence that unvaccinated individuals display discriminatory attitudes towards vaccinated people, except for the presence of negative affectivity in Germany and the USA. We find evidence in support of discriminatory attitudes against unvaccinated individuals in all countries except for Hungary and Romania, and find that discriminatory attitudes are more strongly expressed in cultures with stronger cooperative norms. Previous research on the psychology of cooperation has shown that individuals react negatively against perceived 'free-riders'6,7, including in the domain of vaccinations 8,9. Consistent with this, we find that contributors to the public good of epidemic control (that is, vaccinated individuals) react with discriminatory attitudes towards perceived free-riders (that is, unvaccinated individuals). National leaders and vaccinated members of the public appealed to moral obligations to increase COVID-19 vaccine uptake 10,11, but our findings suggest that discriminatory attitudes—including support for the removal of fundamental rights—simultaneously emerged.

# REVISED - A network of empirical ethics teams embedded in research programmes across multiple sites: opportunities and challenges in contributing to COVID-19 research and responses [version 2; peer review: 1 approved with reservations]

**Abstract** 

Covid-19 continues to teach the global community important lessons about preparedness for research and effective action to respond to emerging health threats. We share the COVID-19 experiences of a pre-existing cross-site ethics network-the Global Health Bioethics Network-which brings together researchers and practitioners from Africa, Europe, and Southeast Asia. We describe the network and its members and activities, and the work-related opportunities and challenges we faced over a one-year period during the pandemic. We highlight the value of having strong and long-term empirical ethics networks embedded across diverse research institutions to be able to: 1) identify and share relevant ethics challenges and research questions and ways of 'doing research'; 2) work with key stakeholders to identify appropriate ways to contribute to the emerging health issue response – e.g., through ethics oversight, community engagement, and advisory roles at different levels; and 3) learn from each other and from diverse contexts to advocate for positive change at multiple levels. It is our view that being embedded and long term offers opportunities in terms of deep institutional and contextual knowledge, existing relationships and access to a wide range of stakeholders. Being networked offers opportunities to draw upon a wide range of expertise and perspectives, and to bring together internal and external insights (i.e.drawing on different positionalities). Long term funding means that the people and resources are in place and ready to respond in a timely way. However, many tensions and challenges remain, including difficulties in negotiating power and politics in the roles that researchers and research institutions can and should play in an emergency, and the position of empirical ethics within research programmes. We discuss some of these tensions and challenges and consider the implications for our own and similar networks in future.

#### **REVISED - An overview of innovations in the external peer review of journal manuscripts.**

**Abstract** 

Background: There are currently numerous innovations in peer review and quality assurance in scholarly publishing. The Research on Research Institute conducted a programme of co-produced projects investigating these innovations. This literature review was part of one such project 'Experiments in peer review' which created an inventory and framework of peer review innovations. The aim of this literature review was to aid the development of the inventory by identifying innovations in the external peer review of journal manuscripts reported in the scholarly literature and by providing a summary of the different approaches. This did not include interventions in editorial processes. Methods: This review of reviews is based on data identified from Web of Science and Scopus limited from 2010 to 2021. A total of 291 records were screened, with six review articles chosen for the focus of the literature review. Items were selected that described approaches to innovating peer review or illustrated examples.

Results: The overview of innovations are drawn from six review articles. The innovations are divided into three high-level categories: approaches to peer review, reviewer focussed initiatives and technology to support peer review with sub-categories of results presented in tabular form and summarised. A summary of all innovations found is also presented.

Conclusions: From a simple synthesis of the review authors' conclusions, three key messages are presented: observations on current practice; authors' views on the implications of innovations in peer review; and calls for action in peer review research and practice.
