## Afghanistan: UN experts say 20 years of progress for women and girls' rights erased since Taliban takeover

GENEVA (8 March 2023) – UN experts\* today said the situation of women and girls' rights in Afghanistan has reverted to that of the pre-2002 era when the Taliban last controlled the country, effectively erasing progress on women's rights in the intervening 20 years. They issue the following statement:

"In 2002, after years of being denied their rights under the previous Taliban regime, Afghan women celebrated International Women's Day full of hope. The day was observed in Afghanistan and at UN Headquarters with the theme 'Afghan women today: Realities and Opportunities' and commitments were made to support our Afghan sisters rebuild their lives and be full partners in the post-conflict reconstruction of the country. On that day the international community said that the plight of Afghan women had been "an affront to all standards of dignity, equality and humanity." It stressed that world support for reasserting their rights should go beyond expressions of solidarity.

Despite challenges, Afghan women and girls made steady advances towards fulfilling their human rights. However, the situation has significantly regressed to the pre-2002 period, and women are denied their fundamental rights and freedoms including the rights to education, to work, to the highest attainable standard of physical and mental health, freedom of movement and freedom from fear and want and from discrimination.

Now, over two decades later, girls in Afghanistan have been banned from secondary school and women from tertiary education. Women and girls have been banned from entering amusement parks, public baths, gyms and sports clubs for four months. Women have been banned from working in NGO offices. Since the takeover of Afghanistan by the Taliban in August 2021, women have been wholly excluded from public office and the judiciary. Today, Afghanistan's women and girls are required to adhere to a strict dress code and are not permitted to travel more than 75 km without a mahram. They are compelled to stay at home.

All over the country, women report feeling invisible, isolated, suffocated, living in prison like conditions. Many are unable to have their basic needs met without access to employment or aid, including access to medical healthcare and psychological support in particular for victims of violence, including sexual violence. It's a sobering reminder of how swiftly and aggressively women's and girls' rights can be taken away.

In two weeks, a new school year will start in Afghanistan. If the restrictions are indeed temporary, as the Taliban claim, they have an opportunity to prove it by lifting the ban on girls and women attending

secondary and tertiary education institutions and allowing them to resume their studies at the start of this school year.

We call on the de facto authorities to end the harmful annihilation of women rights and lift restrictions imposed on women, including on their working with NGOs.

We further call on the de facto authorities to fulfil their obligations under the international human rights treaties, including CEDAW, to which Afghanistan is a State party.

## The international community must continue to provide robust support to Afghan women and;

- 1. Reaffirm their commitment by taking concrete actions to support and realise the rights of women and girls in Afghanistan, in particular their right to education and employment.
- 2. Prioritise women and girls rights in all their engagements with the de facto authorities and demand the immediate reversal of edicts and policies that assault women's and girls' rights.
- 3. Take proactive measures to support Afghan women to engage in decision making processes in Afghanistan and about Afghanistan.
- 4. Increase support to Afghan women so that they can resume employment, access aid and healthcare (including reproductive healthcare), and have an adequate standard of living." ENDS

#### Freedom in the World 2023: Marking 50 Years in the Struggle for Democracy

\*\*Key Findings\*\*

**Global freedom declined for the 17th consecutive year.** Moscow's war of aggression led to devastating human rights atrocities in Ukraine. New coups and other attempts to undermine representative government destabilized Burkina Faso, Tunisia, Peru, and Brazil. Previous years' coups and ongoing repression continued to diminish basic liberties in Guinea and constrain those in Turkey, Myanmar, and Thailand, among others. Two countries suffered downgrades in their overall freedom status: Peru moved from Free to Partly Free, and Burkina Faso moved from Partly Free to Not Free.

**The struggle for democracy may be approaching a turning point.** The gap between the number of countries that registered overall improvements in political rights and civil liberties and those that registered overall declines for 2022 was the narrowest it has ever been through 17 years of global

deterioration. Thirty-four countries made improvements, and the tally of countries with declines, at 35, was the smallest recorded since the negative pattern began. The gains were driven by more competitive elections as well as a rollback of pandemic-related restrictions that had disproportionately affected freedom of assembly and freedom of movement. Two countries, Colombia and Lesotho, earned upgrades in their overall freedom status, moving from Partly Free to Free.

While authoritarians remain extremely dangerous, they are not unbeatable. The year's events showed that autocrats are far from infallible, and their errors provide openings for democratic forces. The effects of corruption and a focus on political control at the expense of competence exposed the limits of the authoritarian models offered by Beijing, Moscow, Caracas, or Tehran. Meanwhile, democratic alliances demonstrated solidarity and vigor.

**Infringement on freedom of expression has long been a key driver of global democratic decline.** Over the last 17 years, the number of countries and territories that receive a score of 0 out of 4 on the report's media freedom indicator has ballooned from 14 to 33, as journalists face persistent attacks from autocrats and their supporters while receiving inadequate protection from intimidation and violence even in some democracies. The past year brought more of the same, with media freedom coming under pressure in at least 157 countries and territories during 2022. Scores for a related indicator pertaining to freedom of personal expression have also declined over the years amid greater invasions of privacy, harassment and intimidation, and incentives to self-censor both online and offline.

**The fight for freedom persists across decades.** When Freedom House issued the first edition of its global survey in 1973, 44 of 148 countries were rated Free. Today, 84 of 195 countries are Free. Over the past 50 years, consolidated democracies have not only emerged from deeply repressive environments but also proven to be remarkably resilient in the face of new challenges. Although democratization has slowed and encountered setbacks, ordinary people around the world, including in Iran, China, and Cuba, continue to defend their rights against authoritarian encroachment.

Global Freedom Declines for 17th Consecutive Year, but May Be Approaching a Turning Point — Freedom House

March 9, 2023

... "The struggle for freedom endures across generations," said Michael J. Abramowitz, president of Freedom House. "For 50 years, Freedom in the World has tracked the health of political rights and civil liberties around the globe. This latest edition documents a continuation of troubling trends, but it also gives some reason to hope that the freedom recession of the past 17 years may be turning a corner. There is nothing inevitable about authoritarian expansion. While authoritarian regimes remain extremely dangerous, they are not unbeatable. The year's events showed that missteps by autocrats provide openings for democratic forces. And over the course of five decades, people from every region of the world have repeatedly challenged oppression and demanded freedom, even in the face of daunting odds and at great personal risk."

The report finds that one of the biggest drivers of democratic decline over the last 17 years has been a trend of attacks on freedom of expression... "Freedom of expression is under attack around the globe," said Yana Gorokhovskaia, the report's coauthor and Freedom House's research director for strategy and design. "Denying press freedom and the freedom of personal expression cuts citizens off from accurate information and from one another, strengthening authoritarian control.

Democracies must fiercely guard these rights at home and vigorously work to defend them abroad, in part by supporting public-interest media and journalists who have been forced into exile. They should also strictly regulate the use of surveillance tools and protect robust encryption technology, which is vital for the safety of activists, journalists, and ordinary users everywhere."

The report identifies a number of steps that democratic governments can take to protect and expand political rights and civil liberties. The recommendations include:

- Help Ukraine win. Democratic governments must maintain unwavering support for Ukraine and
  its people, whose cause is crucial to the future of freedom. This should include providing the
  weapons and technical and security assistance necessary to help ensure Ukrainian success on the
  battlefield.
- Stop enabling authoritarians. Democracies must address corruption and kleptocracy head on by closing the many financial loopholes that allow authoritarian rulers to hide or launder stolen assets in democratic settings.
- Be clear and unapologetic about the virtues of democracy and tireless in efforts to uphold and defend it. Democratic states should make the protection of freedom and democracy a fundamental component of all international policy efforts—including in foreign, security, and economic affairs—and every diplomatic engagement. Human rights concerns should be raised in meetings with foreign counterparts at all levels.
- **Dramatically ramp up support for human rights defenders and for countries and regions at critical junctures.** Democratic governments should help human rights defenders and civil society groups remain active in their home countries whenever possible, and provide technical assistance and training. When democracy advocates come under threat, their foreign partners should provide medical, legal, and psychosocial support as needed.

#### **Human Genome Editing**

#### **Third International Summit on Human Genome Editing**

The Third International Summit on Human Genome Editing took place on 6-8 March 2023 at the Francis Crick Institute, London UK.

Building on previous events held in Washington, DC (2015) and Hong Kong (2018), the London meeting continued the global dialogue on somatic and germline human genome editing. Major themes for discussion included developments in clinical trials and genome editing tools such as CRISPR/Cas9, as well as social, ethical and accessibility considerations these scientific developments entail.

The three-day Summit was organised by the Royal Society, the UK Academy of Medical Sciences, the US National Academies of Sciences and Medicine and The World Academy of Sciences. The <u>Summit's Organising Committee</u>, chaired by Professor Robin Lovell-Badge FMedSci FRS, <u>released a statement</u> [full text below] based on the Summit discussions.

### <u>Statement from the Organising Committee of the Third International Summit on Human</u> Genome Editing

Issued 08 March 2023

The Third International Summit on Human Genome Editing, convened by the UK Royal Society, UK Academy of Medical Sciences, US National Academies of Sciences and Medicine, and The World Academy of Sciences, was held to discuss progress, promise, and challenges in research, regulation, and equitable development of human genome editing technologies and therapies.

After listening to three days of thoughtful and inclusive discussion, the members of the Organising Committee offer the following conclusions:

- :: Remarkable progress has been made in somatic human genome editing, demonstrating it can cure once incurable diseases. To realise its full therapeutic potential, research is needed to expand the range of diseases it can treat, and to better understand risks and unintended effects. The extremely high costs of current somatic gene therapies are unsustainable. A global commitment to affordable, equitable access to these treatments is urgently needed.
- **::** Heritable human genome editing remains unacceptable at this time. Public discussions and policy debates continue and are important for resolving whether this technology should be used. Governance frameworks and ethical principles for the responsible use of heritable human genome editing are not in place. Necessary safety and efficacy standards have not been met.
- :: Governance mechanisms for human genome editing need to protect ongoing, legitimate research, while preventing clinics or individuals from offering unproven interventions in the guise of therapies or ways to avoid disease.

#### Somatic human genome editing<sup>1</sup>

Numerous clinical trials using somatic human genome editing are in progress or soon to be initiated, with preliminary but encouraging results that point to future therapies. The dramatic improvement following CRISPR-based research interventions for sickle cell disease offers hope for patients. Many techniques, including base, prime, and epigenetic editing, may also prove to be useful interventions for a broad range of both genetic and acquired diseases and disorders. However, as with other gene therapies, extended long-term follow-up is essential to fully understand the consequences of an edit and to identify any unanticipated effects, should they occur.

Improved techniques have enhanced the efficiency, precision, and accuracy of the editing process, yet effective delivery and editing remains difficult for many tissues of the body. Further research to diversify and increase the efficiency, specificity, and safety of editing-delivery systems is essential for improving potential treatment options and promoting equitable access.

#### **Equitable access for somatic human genome editing**

As interventions based on somatic genome editing become more widespread, a commitment to equitable, financially sustainable, and accessible treatments becomes more urgent. In many cases, costs and infrastructure needs of current gene therapy treatments are not manageable for either patients or healthcare systems. Correcting this will require appropriate planning from the earliest stages of the research and development for each potential application. Ensuring research includes more genetically diverse populations and expanding the range of those who conceive and conduct the research, play a vital role in achieving equitable outcomes.

With sickle cell disease (as well as other genetic diseases), a large percentage of patients live in underserved countries and communities or in settings without adequate infrastructure. Moving from exvivo to "one and done" in-vivo somatic human genome editing can partially address this problem. But knowledge transfer between nations, improved clinics and research facilities, and strong oversight are also needed to establish sustainable access to safe interventions for research participants and patients.

Health care systems and the global health community should prepare to provide patients with costeffective, affordable, proven therapies. Therapies based on somatic genome editing that could help meet these needs should be a priority for research investment.

### Human germline genome editing for research (not for reproduction)<sup>2</sup>

Basic research using genome editing in human embryos has continued, with the aim of either understanding aspects of early human development or exploring how the methods might be used to correct gene variants leading to genetic disorders. There has also been significant progress in basic research on deriving functional gametes from stem cells. Basic research in this field should continue.

#### Heritable human genome editing

Preclinical evidence for the safety and efficacy of heritable human genome editing has not been established, nor has societal discussion and policy debate been concluded. (In some cases, preimplantation genetic testing is among the alternatives.) Heritable human genome editing should not be used unless, at a minimum, it meets reasonable standards for safety and efficacy, is legally sanctioned, and has been developed and tested under a system of rigorous oversight that is subject to responsible governance. At this time, these conditions have not been met.

### Ongoing international collaboration and discussions

The Organising Committee calls for on-going dialogue and continued international collaboration on innovative approaches to governance and regulation of human genome editing technologies, the state of the science, and innovation in the treatment of genetic diseases.

- 1. Somatic human genome editing refers to the editing of somatic cells, which are non-reproductive cells, and changes made in these cells affect only the person who receives the genome editing.
- 2. In this statement, germline human genome editing refers to the editing of human embryos or gametes in a research setting, with no plans for those embryos or gametes to be used for human reproduction. Heritable human genome editing refers to the editing of human embryos or gametes to be used for human reproduction.

G-7 Science Academies Call for Actions to Improve Climate Change Decision-Making, Protect Ocean Biodiversity, and Support Well-Being of Older People

Statement | March 7, 2023

WASHINGTON — **Today the science academies of the G-7 countries issued three joint statements** to their respective governments to inform discussions during the G-7 summit to be held in Hiroshima, Japan, in May, as well as ongoing policymaking. The statements, which were drawn up by the academies under the aegis of the Science Council of Japan, call for strategies to address systemic risks and improve decision-making related to climate change; restore and recover ocean biodiversity; and deliver better health and well-being for aging populations.

Joint statements:

# :: Addressing systemic risks in a changing climate: Science and technology in support of cross-sectoral decision-making [PDF]

The academies expressed grave concern about three global challenges: the increasing number of climate-related disasters; the COVID-19 pandemic and its global socioeconomic impacts; and the Russian invasion of Ukraine and its exacerbation of climate and health impacts. These three challenges highlight the need for action to reach climate targets, the statement says. It recommends multiple steps, such as increasing support for the improvement of models to project anthropogenic climate change's impact on economies; establishing cross-sectoral frameworks at the local, national, regional, and global levels to link cutting-edge science with on-site decision-making and action; and enhancing technical cooperation and financial support, especially for the most vulnerable countries with a large resource deficit, in order to pursue shared objectives and take concerted actions.

#### :: Restoration and recovery of the ocean and its biodiversity [PDF]

To restore and recover the ocean and its biodiversity, it is imperative that the G-7 governments take sustained, coordinated action, the statement says. For example, to shift towards sustainable fishing practices, governments should take measures to end illegal, unreported, and unregulated fishing; control large-scale commercial trawling and deep-sea trawling; and prevent overfishing. Governments should also adopt a comprehensive, ecosystem-based approach to the management of the coastal marine environment, including the effects of agricultural runoff and other land-based pollutants, and establish clear governance structures.

## :: <u>Delivering better health and well-being of older people through wisdom sharing and innovation</u> [PDF]

The global population aged 65 and over is expected to increase from 10% currently to 16% by 2050, and the population aged over 80 is expected to triple in the next 30 years. The statement urges action to improve understanding of the complexity of aging biology and the diversity of aging trajectories in order to deliver sustainable solutions to the challenges of global population aging. It also urges the building of a new social support system that promotes successful lives and social participation by older people through a wide range of community-based programs and advanced technologies. Nations should also improve the socioeconomic status and well-being of formal and informal caregivers.

The U.S. National Academies of Sciences, Engineering, and Medicine are private, nonprofit institutions that provide independent, objective analysis and advice to the nation to solve complex problems and inform public policy decisions related to science, engineering, and medicine. They operate under an 1863 congressional charter to the National Academy of Sciences, signed by President Lincoln.



#### Weekly epidemiological update on COVID-19 - 8 March 2023

Overview

Globally, nearly 4.5 million new cases and 32 000 deaths were reported in the last 28 days (6 February to 5 March 2023), a decrease of 58% and 65%, respectively, compared to the previous 28 days. As of 5 March 2023, over 759 million confirmed cases and over 6.8 million deaths have been reported globally.

OCHA and its humanitarian partners continue the response to earthquake-affected areas across Syria, where at least 8.8 million people have been affected.

Since the beginning of the emergency response, humanitarian partners have reached more than 185,000 people across Syria with supplies. More than 280,000 people have received protection services, including awareness sessions on gender-based violence and child protection.

In north-west Syria, as of 10 March, 702 trucks loaded with aid provided by seven UN agencies have so far crossed from Türkiye since the earthquakes using the three available border crossings. A month after the quake, this represents double the number of trucks crossing per day compared to last year. In addition, as of 10 March, the UN has so far completed 24 cross-border missions to north-west Syria since the first interagency visit to Idleb on 14 February...

Security Council Emphasizes That Punitive Restrictions on Women's Rights, Escalating Hunger, Insecurity Taking Devastating Toll in Afghanistan

Afghanistan under the Taliban remains the most repressive country in the world for women's rights, the senior United Nations official in Afghanistan told the Security Council today, spotlighting numerous restrictions imposed on women's right to travel, study, and work freely, including for non-governmental organizations, making the response to the world's largest humanitarian crisis even more challenging.

The World Health Organization (WHO) received allegations of misconduct against the Regional Director for the Western Pacific during the latter half of 2021 and in 2022.

In line with the Organization's policy of zero tolerance for abusive conduct, the allegations were investigated and subsequently reviewed in accordance with the normal procedures applicable to all WHO staff members. This included the right of the Regional Director to receive all relevant evidence

and respond to the allegations in line with due process. These procedures resulted in findings of misconduct.

After careful consideration of the findings, and following consultation with the Regional Committee for the Western Pacific and the Executive Board, the Regional Director's appointment has been terminated.

## <u>Understanding the role of narratives in humanitarian policy change</u>

06 March 2023

Key messages

- Narratives and frames have greater influence on policy change than facts and figures. They have a critical role to play in leveraging political will for transforming the humanitarian system.
- Humanitarian organisations have greater power to shape narratives than they are willing to admit.
- The constant need to raise funds has given rise to a master frame of exceptionalism. Dominant narratives represent crises as exceptional events that require humanitarian aid as a self-contained solution. The label 'humanitarian' is used both to forge a collective identity and to exclude other actors.
- This frame has Western roots and is increasingly contested by donors, affected governments, national and local aid groups, and international activists who are excluded from it. It helps fuel narratives used to delay transformations towards a more people-centred and locally led model, in particular assertions that the system needs money more than reform.
- New shared frames and narratives should underpin the relationship between donor governments and the public, aid agencies and aid recipients. They should focus on the independence and agency of affected countries and people, equity, partnership and progress.

<u>Temperature-Stable TB Vaccine Safe, Prompts Immune Response in NIH-Supported Study</u>

A clinical trial testing a freeze-dried, temperature-stable experimental tuberculosis (TB) vaccine in healthy adults found that it was safe and stimulated both antibodies and responses from the cellular arm of the immune system. The Phase 1 trial was supported by the National Institute of Allergy and Infectious Diseases (NIAID), part of the National Institutes of Health. A non-temperature stable form of the candidate previously had been tested in several clinical trials. However, this was the first clinical trial of any subunit TB vaccine candidate in a temperature-stable (thermostable) form. Results are published in *Nature Communications*.

## Protecting Bristol Bay: A victory 20 years in the making

On January 30, 2023, after a hard-won fight that stretched across nearly two decades, the Environmental Protection Agency (EPA) issued its 404(c) clean water act veto – effectively ending the threat of the potentially devastating effects of the Pebble Mine on Bristol Bay in southwest Alaska. The impact of GAVI on children's health outcomes is larger in countries with lower per capita income. Our findings underscore the relevance of health interventions in improving children's health outcomes in developing economies.

Health misinformation, most visibly following the COVID-19 infodemic, is an urgent threat that hinders the success of public health policies. It likely contributed, and will continue to contribute, to avoidable deaths. Policymakers around the world are being pushed to tackle this problem. Legislative acts have been rolled out or announced in many countries and at the European Union level. The goal of this paper is not to review particular legislative initiatives, or to assess the impact and efficacy of measures implemented by digital intermediaries, but to reflect on the high constitutional and ethical stakes involved in tackling health misinformation through speech regulation. Our findings suggest that solutions focused on regulating speech are likely to encounter significant constraints, as policymakers grasp with the limitations imposed by freedom of expression and ethical considerations. Solutions focused on empowering individuals – such as media literacy initiatives, fact-checking or credibility labels – are one way to avoid such hurdles.

The Lancet Global Health

Global health as a knowledge system remains marred by (neo)colonialism, which instils and maintains worrisome asymmetries of power. Moreover, global health solutions all too often fall foul of over<u>medicalisation</u>: the tendency to focus exclusively on biomedical solutions to control individual risk factors without tackling deep-rooted social determinants of health through political and social actions. The co-existence of colonialism and overmedicalisation has enabled <u>parachute</u> (or helicopter) research and a persistent gap between knowledge and practice, as the real-world usability of the evidence produced is seldom the primary focus in this research paradigm.

There is no simple, immediate solution for these threats to global health, but taking a more pragmatic approach seems a good place to start. A pragmatic approach could contribute to shrinking the knowledge–practice gap and maximising real-world implications through a multidimensional effort that centres on local needs and participation.

Being pragmatic in global health primarily means adopting a <u>consequentialist perspective</u>—ie, oriented by the practical consequences of interventions...

# Supporting healthcare access for refugees and migrants

The Lancet Infectious Diseases

... For a host country, managing a large influx of refugees and migrants is a complex task that requires strong political commitment, well-established policies, and structures in place. If giving incoming populations a home, protection, and opportunities for an income is essential, access to healthcare for displaced populations is equally a key human right. The release on Jan 25, 2023, of the WHO Refugee and Migrant Health Toolkit was aimed at helping individual countries to access all available guidelines and tools to develop policies to integrate migrants and refugees in their health system. Such integration is essential for the achievement of the goals of the Global action plan on promoting the health of refugees and migrants, 2019–2023, that mandates provision of healthcare to anyone independently from nationality...

The reality remains that countries denying universal healthcare to their own citizens are unlikely to be open to implementing access to care for refugees and migrants. Without a strong political will and commitment, any guideline or tool to develop, promote, and support access to healthcare for migrants and refugees will be useless. But without equity in health access, we will never have resilient health systems and healthy populations.

As a key partner of Ministry of Health (MOH) Ethiopia, The Clinton Health Access Initiative (CHAI) had been implementing the Child Survival Project (CSP) since October 2015. Strengthening DTC was one of its focuses to improve overall supply chain management (SCM). The objective of this study are to review the evolution of DTCs in Ethiopia from their early years to current practice and identify the major driving and hindering factors for their functionality.

A descriptive mixed study design was employed. The study made use of qualitative data supplemented with quantitative data, generated from both primary and secondary sources through key informant interviews and desk review methods.

DTCs were introduced in Ethiopia in the early 1980s. The mandate of DTCs has been given to four different government organizations during that time. As a result, due to a lack of coordination among these organizations, its implementation was lagging. Recently, the government and its partners have

given attention to DTCs. More than 5847 professionals underwent DTC training from 2016 onwards. DTC establishment in health facilities improved from 85% to 98% between 2015 and 2019 during baseline and end-line assessments carried out by CHAI/CSP. Similarly, DTC functionality in HFs improved from 20% to 63%. The CHAI/CSP regular supervision data analysis revealed that DTC establishment improved from 83% to 100% of HFs, while its functionality improved from 5% to 72% between 2016 and 2019, respectively. A chi-square test of independence examining the relationship between facility and pharmacy head training on DTCs and functionality of DTC in the same facility revealed a significant association between the two variables at p < 0.0001.

Conclusions: Providing consistent capacity building and availing strong monitoring and evaluation system improves functionality of DTCs. Moreover, national coordinating bodies for DTCs and similar structures at Regional Health Bureaus and woreda health offices should be established.

# **Introducing a Framework for Open and Reproducible Research Training (FORRT)**

**Abstract** 

Dramatic changes to the transparency, rigor, reproducibility and replicability of research practices have occurred in the last decade. Despite considerable progress towards the adoption of open science practices by researchers in many disciplines, developing pedagogy to train students in open and reproducible scholarship has received much less attention. Engaging students with the multiple dimensions of open scholarship is crucial to embedding sustainable change: it enables the future generation of researchers to practice open scholarship themselves, fosters lasting engagement with research, and allows them to better understand findings in light of epistemic uncertainty. Teaching students about open scholarship also helps it become a public good, thereby reducing knowledge inequities in academia and beyond. We address the lack of an infrastructure for open scholarship education by introducing the Framework for Open and Reproducible Research Training (FORRT). FORRT is a community-driven infrastructure for educators that advances research transparency, reproducibility, rigor, and ethics through pedagogical reform. FORRT encompasses multiple initiatives and tools to provide educators with guidance and resources to easily embed open and reproducible practices into research training. In addition to fostering a wider ecosystem for resource-sharing and discussion, FORRT has developed a wide range of initiatives, including a seven-part roadmap to the open scholarship literature, a curated database of open scholarship materials and pedagogies for customizable adoption by teachers, and a self-assessment tool to help educators evaluate the integration of open scholarship tenets in their own teaching and mentoring. FORRT actively works towards principled teaching and mentoring, an underappreciated dimension of the scientific endeavour.

Background: The promise of biobanking and genetic research (BGR) in the context of translational research towards improving public health and personalised medicine has been recognised in India. Worldwide experience has shown that incorporating stakeholders' expectations and values into the governance of BGR is essential to address ethical aspects of BGR. This paper draws on engagement with various stakeholders in the South Indian city of Bengaluru to understand how incorporating people's values and beliefs can inform policy making decisions and strengthen BGR governance within India.

Methods: We adopted a qualitative research approach and conducted six focus group discussions with civil society members and seven in-depth interviews with key informants in BGR, identified through a targeted web search and snowballing methods, until data saturation was reached. Data were thematically analysed to identify emergent patterns.

Results: Specific themes relating to the ethics and governance of BGR emerged. Fears and uncertainty about future sample and data use, possibilities of discrimination and exploitation in the use of findings and the lack of comprehensive data protection policies in India along with expectations of enhanced contributor agency, control in future use of samples and data, benefit sharing, enhanced utility of samples, sustained BGR and public good, reflected tensions between different stakeholders' values and beliefs. Fair governance processes through an independent governance committee for biobanks and a system of ongoing engagement with stakeholders emerged as best practice towards building trust and respecting diversity of views and values.

Conclusions: Ensuring public trust in BGR requires listening to stakeholders' voices, being open to counter narratives, and a commitment to long term engagement embedded in principles of participatory democracy. This is central to a 'people-centred governance framework' involving a negotiated middle ground and an equilibrium of governance which promotes social justice by being inclusive, transparent, equitable, and trustworthy.
