International Laws Protecting Civilians in Armed Conflict Not Being Upheld, Secretary-General Warns Security Council, Urging Deadly Cycle Be Broken

The world is failing to live up to its commitments to protect civilians in armed conflict, United Nations Secretary-General António Guterres warned the Security Council today, urging greater respect for international humanitarian law through action and accountability, as speakers, during a day-long open debate, outlined priority action areas for ensuring civilians' survival, security and dignity.

"We must never lose sight of the meaning and purpose of international humanitarian law. It is the difference between life and death, between restraint and anarchy, between losing ourselves in horror and retaining our humanity," Secretary-General Guterres stressed, briefing the 15-nation organ on his report on the protection of civilians in armed conflict (document [S/2023/345](#)). Since war is devastating lives around the world, he urged States to intensify their conflict prevention efforts, preserve peace and find political solutions to war.

Where war continues, all must comply with international humanitarian law, States must investigate alleged war crimes and prosecute perpetrators and the Council must urge countries to respect the rules of war, he said. **As a whole, the international community must break the deadly cycle of armed conflict and hunger** by addressing underlying causes, strengthening vulnerable countries' economies, honouring commitments to support nations on the frontlines of the climate crisis and increasing contributions to humanitarian operations. "Civilians have suffered the deadly effects of armed conflict for too long," he emphasized, asserting: "It is time we live up to our promise to protect them."

Mirjana Spoljaric Egger, President of the International Committee of the Red Cross (ICRC), pointed out that development and peace become unachievable when conflicts are characterized by widespread destruction and international humanitarian law violations. In that regard, all parties engaged in urban warfare must prioritize civilian protection, avoid the use of heavy explosive weapons in populated areas and ensure essential services. States and other actors must also reduce the risk of food insecurity and invest in practical solutions to mitigate the effects of climate change in conflict-affected regions.

Enabling neutral and impartial humanitarian access is critical, she continued. With misinformation and disinformation hindering humanitarian operations, fuelling dangerous divisions and undermining communities' acceptance of humanitarian missions, all States must take the necessary measures to prevent and mitigate their harmful effects on the safety and rights of civilians. **However, until**

international humanitarian law is upheld for all genders, there is no chance for enduring stability or security, she underscored...

Noting Civilians Have Suffered Deadly Effects of Armed Conflict for Too Long, Secretary-General Tells Security Council We Must 'Promise to Protect Them'

Following are excerpts from UN Secretary-General António Guterres' remarks to the Security Council's open debate on "Protection of civilians in armed conflict", in New York today:

...Less than six weeks have passed since war erupted in Sudan. In that time: Hundreds of civilians have been killed — including members of the United Nations family; 250,000 people have fled the country; hospitals have been occupied and attacked; the price of goods is reported to have quadrupled in parts of the country; and aid warehouses have been looted on a massive scale.

Terrible as this picture is, it is far from unique. My report on the protection of civilians in armed conflict in 2022 shows that war is devastating lives around the world.

Explosive weapons continue to wreak havoc, especially in the cities: Last year, 94 per cent of their victims in populated areas were civilians. Those able to flee the fighting did so in record numbers: The total number forced from their homes due to conflict, violence, human rights violations and persecution reached 100 million refugees.

Health facilities and schools were devastated, and their workers injured, kidnapped and killed. At least 2000 schools were destroyed in three regions of Ethiopia alone.

Humanitarians also faced regular threats. Their work was hampered by violence, bureaucracy and politics, and obstructed by overly broad sanctions and counter-terrorism measures...

Last year, more than 117 million people faced acute hunger primarily because of war and insecurity. This is an outrage...

There has been action over the past year to alleviate the impact of conflict on civilians: Some parties to conflicts have taken steps to protect children, allow humanitarians to gain access to those in need, and more...

Last November, States adopted a political declaration to protect civilians by restricting or refraining from the use of explosive weapons in populated areas. I urge all states to join and turn the declaration into meaningful action. And in December, the Security Council adopted resolution 2664 (2022), which aims to prevent United Nations sanctions from harming civilians and obstructing humanitarian action. I urge all States to implement it and to exclude humanitarian and medical activities from their own counter-terrorism and sanctions measures.

These modest steps are welcome. But **the terrible truth is that the world is failing to live up to its commitments to protect civilians; commitments enshrined in international humanitarian law.** The Geneva Conventions of 1949 and their Additional Protocols are the cornerstone of that legal framework.

And I pay tribute to the work of the International Committee of the Red Cross (ICRC), the guardian of those treaties: You meet danger and brutality with bravery, compassion and humanity, and you will always have my full support. ICRC's role is unique. It has a mandate to respond, and that mandate must be respected: by every Government, every armed group and every fighter.

We must never lose sight of the meaning and purpose of international humanitarian law: It is the difference between life and death; between restraint and anarchy; between losing ourselves in horror and retaining our humanity.

But law overlooked is law undermined. We need action and accountability to ensure it is respected. That depends on political will. Peace is the best form of protection. We must intensify our efforts to prevent conflict, protect civilians, preserve peace and find political solutions to war.

In the coming weeks, I will issue a policy brief on *A New Agenda for Peace* in preparation for next year's Summit of the Future. This will offer a holistic approach for Member States to consider, tuned to the times, to address peace and security in a changing world.

Where war continues, all countries must comply with international humanitarian law and members of this Council have a particular responsibility. Governments should incorporate international humanitarian law into national laws and military rules and training.

Humanitarians must be assured safe access. Attacks against them must cease. And their work must be facilitated, including by removing deadly bureaucratic barriers. It is unconscionable that vital aid languishes in ports and warehouses while people die.

The Security Council has a special role to play in urging States to respect the rules of war. Governments with influence over warring parties should engage in political dialogue and train forces on protecting civilians. And countries that export weapons should refuse to do business with any party that fails to comply with international humanitarian law.

Those who commit war crimes must be held to account. States must investigate alleged war crimes, prosecute perpetrators and enhance other States' capacity to do so...

Civilians have suffered the deadly effects of armed conflict for too long. It is time we live up to our promise to protect them.

[UN Rights Chief issues call to protect and expand civic space](#)

GENEVA (26 May 2023) – We all want to help shape our futures, our communities, and our countries, but it is not possible when we do not have space to speak up and debate different viewpoints safely, noted UN High Commissioner for Human Rights Volker Türk today as he made a clarion call to protect and expand civic space. Civic space is the environment that enables each and everyone to play a role in political, economic, and social life, at all levels, from local to global.

"Civic space is a human rights issue, it is a peace issue, it is a development issue. It is key for sustainable and resilient societies, yet it is under increasing pressure from undue restrictions and repressive laws. From threats and attacks on journalists and human rights defenders, online bullying and harassment, crackdowns on peaceful assembly, to internet shutdowns," said the High Commissioner.

"States must step up efforts to protect and expand civic space as the precondition for people to be able to sustainably enjoy all other entitlements enshrined in the Universal Declaration of Human Rights, from access to health care and clean water and quality education to social protection and labour rights."

Pressure on civil space continues despite the inspiring commitment of civil society groups, among them human rights defenders, journalists, trade unionists, environmental groups, climate justice advocates, LGBTIQ rights defenders and the feminist movement, youth and anti-racism activists, and migrants' rights defenders, to addressing the world's most pressing crises, from growing inequalities to the triple planetary crisis of climate change, pollution, and biodiversity loss.

"Civil society is a key enabler of trust between governments and the populations they serve and is often the bridge between the two. For governments to reduce barriers to public participation, they must protect this space, for the benefit of all – both online and offline," said Türk.

"As crucial decisions about our lives are increasingly made online, with private companies playing an outsized role, having an open, safe digital public square has never been more important," said the High Commissioner. "Yet we see states struggling, and often failing, to protect online civic space and those who use it, swinging between a laissez-faire approach that has allowed violence and dangerous hate speech to go unchecked, and overbroad regulations used as a cudgel against those exercising their free speech rights, including journalists and human rights defenders," he added...

The platform ensures that information is gathered quickly, safely, and securely. OTPLink streamlines the traditional manual review process by allowing the Office to handle larger information volumes utilising Artificial Intelligence (AI) and Machine Learning (ML) to

offer greater insights into the information received, significantly reducing the time required to review and act on it. The platform maintains compliance with international evidence handling standards by using **a digital chain of custody trail that collects and preserves information**. This preserves the integrity of the evidence and creates a dependable and tamper-proof record of the collection and handling process.

It is my hope that the launch of **OTPLink will further empower all of our stakeholders, whether affected communities, civil society, or national authorities, allowing you to share information more easily and securely with my Office**, and strengthening the basis for our common work to deliver justice for Rome Statute crimes...

Global Oxygen Alliance Launched to Boost Access to Lifesaving Oxygen

24 May 2023

GENEVA – Oxygen, a lifesaving medicine to treat acute respiratory illnesses like COVID-19 and pneumonia, is essential for surgery, trauma, emergency and critical care, and treating older persons, pregnant women and newborns. Medical oxygen is also proving to be a critical tool in pandemic preparedness as the world braces itself for potential future outbreaks of respiratory diseases.

The COVID-19 pandemic...exacerbated chronic shortages of medical oxygen in low- and middle-income countries, leading to many preventable deaths and straining the already fragile health systems. Even before COVID-19 swept across the world, 9 in 10 hospitals in low- and middle-income countries were unable to provide oxygen therapy, resulting in as many as 800,000 preventable deaths each year.

Against this backdrop, the Oxygen Emergency Taskforce of the Access to COVID-19 Tools Accelerator (ACT-Accelerator) was launched in February 2021 to coordinate the response of multilateral agencies and mobilize grant financing to help low- and middle-income countries deal with acute oxygen shortages.

...a new Global Oxygen Alliance (GO2AL) is launched by global health partners to continue the essential work of the ACT-A Oxygen Emergency Taskforce, which raised more than US\$1 billion to boost access to medical oxygen, including financing to expand production, lower the price of oxygen and provide technical support to governments. Taskforce achievements include negotiating ground-breaking agreements with the world's two largest medical oxygen suppliers, drawing up plans to increase regional production of oxygen in low- and middle-income countries, and helping more than 100 countries to upgrade their treatment facilities.

GO2AL is designed to provide sustained support for low- and middle-income countries to fill yawning gaps in the availability and supply of medical oxygen. A core objective of GO2AL is to support countries with technical cooperation, financial solutions, capacity building, and demand-generation, to ensure that investments in oxygen systems made during the COVID-19 crisis are sustained. GO2AL will also engage in political advocacy and give a voice to those making oxygen systems work on the ground and those who need it.

"The case for scaling up oxygen therapy is overwhelming," said Unitaids' Executive Director Philippe Duneton. "More than 1 million people die each year from hypoxemia, or low blood oxygen, caused by

conditions other than COVID-19, such as pneumonia, the leading cause of death among children under 5. This is unacceptable and cannot go on.”...

Cholera – OCV

Global vaccine alliance outlines path to sustainable cholera vaccine supply

- Global oral cholera vaccine (OCV) supply could enable large-scale preventive vaccination by 2026 – but urgent action is needed to achieve this goal.
- In an alarming trend, approximately 10 million more vaccines needed for outbreak response through 2021 and 2022 than the entire previous decade combined.

Geneva, 22 May 2023 – **Gavi, the Vaccine Alliance today published a [roadmap](#)* outlining critical actions needed to ensure supply of oral cholera vaccine (OCV) is able to meet growing demand from countries.** Released against a backdrop of a recent wave of cholera outbreaks around the world, the roadmap forecasts the short-, mid- and long-term outlook for global cholera vaccine supply.

Developed in consultation with a range of key Alliance partners, including WHO, UNICEF, the Global Taskforce for Cholera Control (GTFCC), and the Bill and Melinda Gates Foundation (BMGF), it describes how these organizations, manufacturers and countries can work together towards ensuring global OCV supply can support largescale preventive vaccination by 2026...

...Forecasting the future of OCV supply

... The availability of oral cholera vaccines has risen sharply in the last decade, from around 4 million doses available globally in 2012 to 35 million doses in 2022, thanks to targeted investments from Gavi, BMGF and partners in the funding and establishment of the global OCV stockpile, as well as support for increasing manufacturer capacity.

In the short-term, the roadmap forecasts that global supply will increase by the end of 2025, due to investments by EuBiologics, Gavi and BMGF in the development of vaccines that can be produced in higher volumes, and the expected entry of a new manufacturer. **However, if the current trend in outbreaks continues, supply for preventive vaccination will likely continue to be limited during this period, and will need to be allocated transparently and equitably.**

By 2026, the roadmap forecasts that supply will start to meet demand for preventive vaccination, thanks to investments in increased capacity and additional manufacturers entering the market. This will enable large-scale preventive OCV campaigns in cholera-endemic countries. The pattern of cholera disease and outbreaks in the longer term, as well as ongoing vaccine needs, will likely depend on the success of cholera control measures, including investments in water, sanitation, and hygiene infrastructure, as well as preventive vaccination...

Africa's largest polio vaccination drive since 2020 targets 21 million children

Brazzaville, 26 May 2023 – Africa's largest polio vaccination campaign since 2020 kicks off today in three West and Central African countries, in a combined effort by national health authorities to immunise a total 21 million children under the age of five.

The exercise, which will begin in Cameroon, Chad and Niger before being extended to the Central African Republic next week, comes in response to 19 detections of type-2 polioviruses in the countries; 2 in Niger, 10 in Chad, 4 in Central Africa Republic and 3 in Cameroon.

The multi-country initiative is supported by the World Health Organization (WHO), through the Global Polio Eradication Initiative (GPEI), and comprises synchronized vaccinations and joint plans in border communities to halt polio transmission.

"This is a crucial undertaking to close vaccination gaps in the wake of the COVID-19 pandemic and will provide millions of children with vital protection from the risk of irreversible polio paralysis," said Dr Matshidiso Moeti, WHO Regional Director for Africa. "Synchronizing the campaign will ensure that a large cohort of children across the four countries receive the vaccine at the same time to enhance polio immunity in a broad geographic area."...

Weekly epidemiological update on COVID-19 - 25 May 2023

Overview

Globally, nearly 2.3 million new cases and nearly 15 000 deaths were reported in the last 28 days (24 April to 21 May 2023), a decrease of 21% and 17%, respectively, compared to the previous 28 days (27 March to 23 April 2023). The situation is mixed at the regional level, with increases in reported cases seen in the WHO African and Western Pacific Regions and increases in deaths in the African, the Americas, South-East Asia, and Western Pacific Regions. As of 21 May 2023, over 766 million confirmed cases and over 6.9 million deaths have been reported globally.

Abstract

Member states of the World Health Organization (WHO) are undertaking ambitious governance reforms to prevent, prepare for, and respond to pandemics by concurrently negotiating both a new international legal instrument (henceforth called “the Pandemic Treaty”) and amendments to the International Health Regulations (IHR). We therefore find ourselves at a critical juncture in global health governance, with the opportunity to strengthen pandemic prevention, preparedness, and response through international law. One issue being given considerable prominence in each of these negotiations is how compliance by member states with their obligations can best be achieved. We argue that any efforts to ensure compliance with these instruments should be seen as part of broader efforts to ensure effective and equitable implementation, as opposed to being overly focused on formal compliance mechanisms and the possibility of punitive action in response to noncompliance.
