# New and emerging technologies need urgent oversight and robust transparency: UN experts

GENEVA (2 June 2023) – UN experts\* today called for greater transparency, oversight, and regulation to address the negative impacts of new and emerging digital tools and online spaces on human rights.

"New and emerging technologies, including artificial intelligence-based biometric surveillance systems, are <u>increasingly being used</u> in sensitive contexts, without the **knowledge or consent of individuals,"** the experts said ahead of the RightsCon summit in Costa Rica from 5 to 8 June 2023.

"Urgent and strict <u>regulatory red lines</u> are needed for technologies that claim to perform emotion or gender recognition," they said.

The experts expressed concern about the proliferation of invasive spyware and a growing array of targeted surveillance technologies used to unlawfully target human rights defenders, activists, journalists, and civil society in all regions.

"We condemn the alarming use of spyware and surveillance technologies in violation of human rights and the broader chilling effect of such unlawful measures on the legitimate work of human rights defenders and on civic space worldwide, often under the guise of national security and counter-terrorism measures," they said.

The experts stressed the need to ensure that these systems do not further expose people and communities to human rights violations, including through the expansion and abuse of invasive surveillance practices that infringe on the right to privacy, facilitate the commission of gross human rights violations, including enforced disappearances, and discrimination. They expressed concern about respect for freedoms of expression, thought, <u>peaceful protest</u>, and for access to essential economic, social and cultural rights, and humanitarian services.

"Specific technologies and applications should be avoided altogether where the regulation of human rights complaints is not possible," the experts said.

The experts noted that so-called "generative AI" systems can enable the cheap and rapid mass production of synthetic content that spreads disinformation or promotes and amplifies incitement to hatred, discrimination or violence on the basis of race, sex, gender and other characteristics. The experts also expressed concern that their development is driven by a small group of powerful actors, including businesses and investors, without adequate requirements for

conducting human rights due diligence or consultation with affected individuals and communities. Additionally, content moderation is often performed by individuals in situations of labour exploitation.

"Regulation is urgently needed to ensure transparency, alert people when they encounter synthetic media, and inform the public about the training data and models used," the experts said.

The experts <u>reiterated their calls for caution</u> about the radical impact of digital technologies in the context of humanitarian crises, from large-scale data collection – including the collection of highly sensitive biometric data – to the use of advanced targeted surveillance technologies. "We urge restraint in the use of such measures until the broader human rights implications are fully understood and robust data protection safeguards are in place," they said.

They underlined the need to ensure technical solutions – including strong end-to-end encryption and unfettered access to virtual private networks – and secure and protect digital communications. The experts reminded States and businesses of their respective duties and responsibilities, including human rights due diligence requirements when it comes to the development, use, vetting and procuring of digital technologies.

"Both industry and States must be held accountable, including for their economic, social, environmental, and human rights impacts," they said. "The next generation of technologies must not reproduce or reinforce systems of exclusion, discrimination and patterns of oppression."

<u>Deportation of Ukrainian children by Russia: joint statement</u> 1 June 2023

A joint statement by diplomatic missions in Ukraine on International Day for Protection of Children about forced deportation of Ukrainian children by Russia. [Editor's text bolding]

Today, on International Day for the Protection of Children in Ukraine and across the region, we, the Embassies associated with this statement, call on the Russian Federation to return Ukraine's children to Ukraine. We are appalled by Russia's large-scale forced transfer and deportation of children to Russia or Russian-controlled territory within Ukraine and note in this regard the arrest warrants issued by the International Criminal Court.

The Ukrainian government has identified over 19,000 children unlawfully deported or otherwise separated from their parents or guardians. This number continues to grow with recent transfers from the Zaporizhzhia region. Russia has seized children from their schools, and their homes – including those living in institutions, while others have been separated from their families during Russia's so-called 'filtration' process. Very few have been returned. This trauma will affect these children and their families for the rest of their lives.

While the Russian Federation claims these are "evacuations", we note that **the UN Commission of Inquiry concluded that none of the cases examined were justified by safety or medical reasons, nor did they satisfy the requirements set forth by international humanitarian law.** The obstacles Russia puts in place to prevent Ukrainian children from reuniting with their families and caregivers undermine Russia's narrative. Direct relatives or legal guardians must undertake a dangerous and costly journey to collect their children. During this journey, they face a high risk of arrest and interrogation – as do those who help them. In some cases, parents arrive in Russia only to learn authorities have hidden their child in a foster home.

Unlawfully deported children face **abusive indoctrination processes designed to systematically undermine and erase their Ukrainian identity**, through "re-education" programmes as part of intense militarised schooling practices. Ukrainian children are confronted by Russian disinformation, while their access to alternative voices and education in Ukrainian is denied. Their new environments are linguistically and culturally entirely Russian. This practice **violates or abuses a multitude of children's rights under international human rights law and international humanitarian law, including their rights to family, to identity and to education**. Children in temporarily Russian-controlled areas of Ukraine are also exposed to this indoctrination, as the Russian Federation imposes its curriculum on local schools, in which children meet Russian soldiers and learn how to use weapons. Parents face threats they will lose custody of their child if they refuse to enrol them.

We remind the Russian Federation of its obligations under international law to end its illegal war of aggression and to ensure the lives of all children are protected. We call on Russia to ensure respect for children's cultural identity and cease the forcible transfer of children to the Russian Federation, and its efforts to indoctrinate Ukrainian children and force them to become Russian. Finally, in cooperation with the Ukrainian authorities, we call on the Russian Federation to return Ukraine's children where they belong: Ukraine.

The international community stands with Ukraine in protecting its future generations. We will hold the Russian Federation to account for its illegal and barbaric actions in Ukraine.

# <u>Parliamentary report on religion and belief - Working towards more peaceful and inclusive</u> societies

Overview

Religion and belief play a significant role in our States and societies. Over 100 States refer to God in their constitutional or similar instruments, and religion and belief are often present in different branches of government or are interwoven into a State's self-understanding. The right to freedom of religion or belief is enshrined in the 1948 Universal Declaration of Human Rights.

At the IPU, we believe in the central role of parliaments in guaranteeing the rule of law and justice and also in contributing to more inclusive societies. Our strategy encourages parliaments to view themselves as part of broader ecosystems with which they must engage for the promotion of peace, democracy and sustainable development for all.

The present report explores the institutional engagement of parliaments with different aspects of religion and belief. It reviews and assesses parliamentary mechanisms and activities and also highlights how parliaments promote inclusion and engage with religion and belief in a way that reflects different needs, values and parliamentary cultures.

#### Outlook

This report is intended as a contribution to dialogue and learning between political, religious and

**other spheres about issues of common concern**. Part 1 of the report focuses on showcasing examples of different ways that religion and belief are institutionally present in the life and work

of parliaments.

The present report hopes to encourage parliaments to engage in self-reflection, especially to assess whether the mechanisms they have in place to engage with religion and belief are inclusive, transparent and representative. Another related issue that merits more in-depth exploration is the role of parliaments in promoting freedom of religion or belief and in countering expressions of intolerance against people on the basis of their religion or belief.

The conversation will be continued at the Parliamentary Conference on Interfaith Dialogue (Marrakesh, June 2023), which will bring together political and religious leaders along with representatives of faith-based and civil society organizations and subject matter experts to explore avenues for joint action to promote the rule of law, peace and inclusion in our societies.

Part 2 of the report will subsequently combine takeaways from the Parliamentary Conference on Interfaith Dialogue with insights of individual parliamentarians into how their work engages with religion and belief.

# New IPU report explores the place of religion and belief in parliament 08/06/2023

For the first time, the IPU has published a report which examines how parliaments around the world engage with issues of religion and belief. The IPU <u>Parliamentary report on religion and belief</u> explores how religion and belief are institutionalized in parliaments; for example, through legislation, representation, parliamentary committees and mechanisms for consultation with faith-based organizations or the general public

The report draws on multiple sources, including an IPU survey with responses from 53 national parliaments and dozens of interviews with parliamentarians, parliamentary staff and experts. Overall, the IPU findings reveal a rich diversity of parliamentary cultures with regard to religion and belief.

The report notes that over 100 countries refer to God in their constitutions or other fundamental laws. Religion and belief are often present in different branches of government or are interwoven into a State's self-understanding. And, according to a 2012 study, some 84% of people around the world are religious, a proportion which is growing. As a result, there is scope for parliaments and parliamentarians to engage meaningfully with religion and belief, which can influence the identity, values and decision-making of the people they represent.

The report identifies various ways in which religion and belief influence legislation. **Some countries** have one set of laws which apply to all members of society, regardless of religion or belief. Others allow for different religions or beliefs to exercise their own laws in certain areas. Exceptions are often made in areas of personal or family law, including marriage, divorce, adoption, inheritance and succession...

# <u>Joint Statement by the Leaders of the Global Fund, UNAIDS and PEPFAR on Uganda's Anti-Homosexuality Act 2023</u>

29 May 2023

Geneva | Washington, D.C. -- The Global Fund to Fight AIDS, Tuberculosis and Malaria (the Global Fund), the Joint United Nations Programme on HIV/AIDS (UNAIDS), and the U.S. President's Emergency Plan for AIDS Relief (PEPFAR) are deeply concerned about the harmful impact of the Ugandan Anti-Homosexuality Act 2023 on the health of its citizens and its impact on the AIDS response that has been so successful up to now.

Uganda's Leadership Towards Ending the AIDS Pandemic as a Public Health Threat

Uganda and President Yoweri Museveni have been leaders in the fight to end AIDS. Progress has been made thanks to the implementation of large-scale prevention, diagnosis, treatment and care programs, all provided on the principle of access to health care for all who need it, without stigma or discrimination. This approach has saved lives. The strong health systems built to support the AIDS response serve the entire population of Uganda. This was evident as community health workers and health systems developed for the AIDS response played a key role in tackling COVID-19 and other disease threats. Maintaining this is vital: Failures in the HIV public health response will have system-wide impacts that could negatively affect everyone.

#### Success Is Possible

We know that we will be able to overcome this public health threat when we ensure that 95% of people living with HIV know their status, 95% of them are on treatment, and 95% of those on treatment have achieved viral suppression. Uganda can reach that. By 2021, 89% of people living with HIV in Uganda knew their status, more than 92% of people who knew their HIV status were receiving antiretroviral therapy, and 95% of those on treatment were virally suppressed. Uganda is well on track to achieve the UNAIDS HIV treatment targets if progress can be maintained.

#### Discrimination Threatens Progress in the AIDS Response

Uganda's progress on its HIV response is now in grave jeopardy. The Anti-Homosexuality Act 2023 will obstruct health education and the outreach that can help end AIDS as a public health threat. The stigma and discrimination associated with the passage of the Act has already led to reduced access to prevention as well as treatment services. Trust, confidentiality, and stigma-free engagement are essential for anyone seeking health care. LGBTQI+ people in Uganda increasingly fear for their safety and security, and increasing numbers of people are being discouraged from seeking vital health services for fear of attack, punishment and further marginalization.

Uganda has repeatedly demonstrated leadership and commitment to ending AIDS – and has achieved great success – by leaving no one behind. **Together as one, we call for the Act to be reconsidered so that Uganda may continue on its path to ensure equitable access to health services and end AIDS as a public health threat by 2030.**

### Weekly epidemiological update on COVID-19 - 8 June 2023

**Overview** 

Globally, over 1.7 million new cases and over 10 000 deaths were reported in the last 28 days (8 May to 4 June 2023), a decrease of 38% and 47%, respectively, compared to the previous 28 days (10 April to 7 May 2023). During this 28-day reporting period, 144 of 243 (59%) countries and territories reported at least one case. The situation at the regional level shows decreases in cases and deaths in all six WHO regions. As of 4 June 2023, over 767 million confirmed cases and over 6.9 million deaths have been reported globally.

- The war in Ukraine has further escalated in 2023, with hostilities ravaging communities in the east and south and taking a heavy toll on civilians living close to the front line.
- Mine contamination is also creating tremendous challenges for civilians trying, for example, to get back to their farms, and humanitarians striving to deliver assistance.
- Despite tremendous challenges, humanitarian organizations in Ukraine continue to reach more people every month. By the end of April, 5.4 million had received aid.
- This was possible thanks to the efforts of hundreds of aid organizations, local groups and volunteers who play a vital role in getting assistance for those who need it the most.
- Insecurity and access challenges continued, however, to hamper assistance in areas under Russian military control. Funding also remained low, adding to the challenges.

# <u>Statement from the OAS General Secretariat on the Exercise of Political Rights by Persons Elected by the People</u>

June 1, 2023

Within the framework of the Secretary General's visit to Colombia, the General Secretariat of the Organization of American States (OAS) highlights that in line with current international regulations, embodied in international human rights treaties, and especially in the American Convention on Human Rights, as well as the jurisprudence of the Inter-American Court of Human Rights, it follows that the constitutional mandates of elected authorities can only be interrupted based on the sentences of criminal judges.

The jurisprudence of the Inter-American Court of Human Rights (CorteIDH) reflects what is established in Article 23 of the Convention, which establishes parameters for the exercise of political rights.

The jurisprudence of the Inter-American Court also affirms that the materialization of political rights strengthens the rule of law in the Hemisphere.

Accordingly, it is essential that all those State bodies that are not criminal judges, including

administrative control bodies, refrain from carrying out acts that go against this principle, which constitutes the essence of the function of democracy and of the rule of law.

#### Real-World Data and Real-World Evidence in Regulatory Decision Making

Background

There is increasing interest in the use of Real-World data (RWD) to support regulatory decision making across the product life cycle. Key sources of RWD are electronic health records, claims data, prescription data, and patient registries. Real-world evidence (RWE) is the clinical evidence about the usage and potential benefits or risks of a medical product derived from an analysis of RWD. For decades, such evidence has been well accepted for satisfying post-approval safety monitoring requirements but has not been used commonly to demonstrate drug effectiveness, which is a relatively new concept.

As applications are increasing, it is proposed that CIOMS develop a consensus report and recommendations for the use of RWD and RWE in regulatory decision-making related to biopharmaceutical products. This report will cover three key areas:

- :: Articulate the different RWD/RWE requirements depending on the intent of use e.g. Regulatory, Payers, and Public Health;
- :: Propose harmonized practices and guidance for using RWD and RWE for regulatory purposes (given that there are no existing consensus guidelines);
- :: Articulate point of view (POV) on key ethical issues relevant to RWD and RWE and a provisional set of standards to address those issues (the high-level POV may lead to a separate/satellite group of ethicists to deal with it). Full Concept Note (31 March 2020)

**Abstract** 

Global health requires evidence-based approaches to improve health and decrease inequalities. In a roundtable discussion between health practitioners, funders, academics and policy-makers, we recognised key areas for improvement to deliver better-informed, sustainable and equitable global health practices. These focus on considering information-sharing mechanisms and developing evidence-based frameworks that take an adaptive function-based approach, grounded in the ability to perform and respond to prioritised needs. Increasing social engagement as well as sector and participant diversity in whole-of-society decision-making, and collaborating with and optimising on hyperlocal and global regional entities, will improve prioritisation of global health capabilities. Since the skills required to navigate drivers of pandemics, and the challenges in prioritising, capacity building and response do not sit squarely in the health sector, it is essential to integrate expertise from a broad range of fields to maximise on available knowledge during decision-making and system development. Here, we review the current assessment tools and provide seven discussion points for how improvements to implementation of evidence-based prioritisation can improve global health.

**ABSTRACT**

#### What's the ideal World Health Organization (WHO)?

**Abstract** 

The World Health Organization (WHO) is tasked with the 'attainment by all peoples of the highest possible level of health', yet, it is widely struggling to meet this mandate, and COVID-19 has revealed significant limitations of the organisation. Despite clear guidance provided by the institution as to how best to respond to the pathogen, many governments departed from WHO's guidance in their response efforts. Is this a new crisis for WHO? Does WHO need to restore its legitimacy in the eyes of the global community? As renewed calls for changes to WHO emerge, in this perspective we lay out the obstacles WHO face to become the WHO 'we' need. The assumption is that UN member states need an empowered and well-funded organisation. Yet, many years of discussion of reform of WHO have failed to lead to meaningful change, and glaring challenges remain in its financing, governance and politics, which are considered in turn. The reality may be that we have the WHO that UN member states need one that can provide guidance and advice, but also take criticism for health governance failures when states want to avoid blame or responsibility. Since 2018, this Lancet Commission has sought to understand how to maximise synergies between the global health agendas of universal health coverage, health security, and health promotion, and what drives dis-synergies. Conclusion

The COVID-19 pandemic necessitated the allocation of multiple scarce medical resources, and forced clarification on the ethics of such allocation. The lessons learned clarify that the ethical framework to guide allocation entails five substantive values—minimising harms, mitigating disadvantage (ensuring equity), equal moral concern (not identical treatment), reciprocity, and instrumental value. The pandemic also helped to clarify the establishment of priority tiers that primarily emphasise instrumental value, minimising harm, and mitigating disadvantage. Finally, the pandemic showed that implementation requires careful attention to ensure disadvantaged groups are not further disadvantaged. This aim necessitates carefully delineating eligible groups, avoiding seemingly open access methods that prioritise the wealthy with capabilities and skills to access resources, and applying active—not passive—distribution methods, since passivity favours the privileged. Learning these lessons

on the ethical allocation of scarce medical resources from COVID-19 should facilitate the rapid distribution of other scarce medical interventions in the next health emergency.

Polygenic risk scores (PRS) have improved in predictive performance supporting their use in clinical practice. Reduced predictive performance of PRS in diverse populations can exacerbate existing health disparities. The NHGRI-funded eMERGE Network is returning a PRS-based genome-informed risk assessment to 25,000 diverse adults and children. We assessed PRS performance, medical actionability, and potential clinical utility for 23 conditions. Standardized metrics were considered in the selection process with additional consideration given to strength of evidence in African and Hispanic populations. Ten conditions were selected with a range of high-risk thresholds: atrial fibrillation, breast cancer, chronic kidney disease, coronary heart disease, hypercholesterolemia, prostate cancer, asthma, type 1 diabetes, obesity, and type 2 diabetes. We developed a pipeline for clinical PRS implementation, used genetic ancestry to calibrate PRS mean and variance, created a framework for regulatory compliance, and developed a PRS clinical report. eMERGE's experience informs the infrastructure needed to implement PRS-based implementation in diverse clinical settings.

Many diseases with significant health burden and healthcare costs have been neglected in biomedical research, partly due to a lack of data. Here, we systematically harmonized >12 million primary care and hospitalisation health records from ~440,000 UK Biobank participants into 1445 collated disease terms for genetic analyses. This included ~200 diseases with >10,000 cases that are predominantly managed in primary care, like skin and non-serious infectious diseases. We quantify the heritability for these common diseases, identify novel loci with extreme effect sizes, and highlight novel roles of poorly characterised genes, e.g. PNLIPRP3 as a sebaceous gland cell-specific gene for rosacea. We characterise the substantial regional pleiotropy with more than 300 independent genomic regions associated with multiple, often seemingly unrelated diseases and use these insights to generate a pangenome disease network of shared disease loci to prioritise potential pathways contributing to multiple diseases and onset of multimorbidity. We demonstrate the value of primary care data to improve and quide genetic approaches for drug selection, repurposing, and adverse event prediction, e.g., IGFR1 as a putative multi-disease target for, among others, gout and atrial fibrillation, through network augmentation and integration of molecular quantitative trait loci. We make all results publicly available via an interactive webserver (https://www.omicscience.org/apps/phecodes). Our results provide new insights for diseases across diverse clinical specialties and provide a resource for drug discovery and mechanistic understanding.

**Abstract** 

Health-related research with human participants is governed by research ethics regulations in most jurisdictions. Globally, the 2016 International Ethical Guidelines for Health-related Research Involving Humans, published by the Council for International Organizations of Medical Sciences (CIOMS), are especially influential and widely held as an international standard. The CIOMS guidelines support the inclusion of people with psychosocial disabilities in research and offer clear guidance to promote their recruitment, including by outlining provisions for substitute decision-making. The CIOMS guidelines sit alongside the United Nations' Convention on the Rights of Persons with Disabilities (CRPD). Adopted in 2006 and ratified in 2008, the CRPD offers a robust framework for recognizing the rights of persons with disabilities, including individuals with psychosocial disabilities. Though the CRPD does not explicitly reference research inclusion, its core principles—especially pertaining to the right to universal legal capacity—have clear implications for research ethics governance, specifically with respect to the use of substitute decision-making for research participation. In this paper, we review the extent to which existing research ethics regulations across selected jurisdictions concord with each of these two frameworks, offering first a broad analysis of regulations across 26 African countries, and then exploring two country-specific case studies from Malaysia and Peru. We find that, while many countries' research ethics regulations align with key aspects of the CIOMS guidelines, core principles of the CRPD are absent. Given the shortcomings of existing regulations, we analyse a key point of tension between CIOMS and the CRPD—the right to participate in research—and offer a proposal for revised regulations that aims to bridge this tension and meet the standards of both frameworks.
