#### The UN can no longer protect human rights by itself

Authoritarianism is on the march, and crucial entitlements are being rolled back Mark Malloch-Brown, President of the Open Society Foundations, former UN deputy secretary-general Financial Times, 27 December 2023

In 1948, 75 years ago this month, the UN General Assembly adopted the Universal Declaration of Human Rights, a historic act of international co-operation and a powerful assertion of our common humanity...

Today, however, human rights around the world are not in good fettle. Authoritarianism is on the march. Crucial individual rights are being rolled back, from the right to a girl's education in Afghanistan to a woman's right to choose in the US. Free speech is under attack on campuses. And as armed conflicts become more numerous and more deadly to civilians, old norms are giving way to a new age of impunity.

The UN — the cradle of the UDHR — still has a role to play. Its Human Rights Council is a deeply flawed but important monitor. Its peacekeepers help to prevent atrocities. And its voice is still raised, as we saw most recently on December 6 when secretary-general António Guterres invoked Article 99 of the UN charter to urge the Security Council to push for a new humanitarian ceasefire in the Israel-Palestine conflict.

But current events also expose an important truth: the UN is not enough. Often it finds itself on the back foot as the geopolitical tensions of a fragmenting international order stymie common action. Despite the service of the "blue helmets", its peacekeeping missions have a much smaller footprint today than they did in the late 1990s and 2000s. The UN's moral force remains, but is impaired...

The answer is not to dismiss the UN's role in the protection of human rights, but to acknowledge that in future it must be buttressed by new strategies and methods, rooted in the art of the possible, that go beyond it. Pragmatic approaches should govern these...

While a number of brave NGOs work to defend human rights globally, we also need a new generation of bottom-up initiatives led by local campaigners that draw on the demands of their communities rather than external finger-wagging...

It takes local knowledge and sensitivity. International allies must see themselves not as preachers imposing human rights from afar, but as enablers supporting the platforms on which local actors can enact change as they see fit....

#### **International Court of Justice**

### Press release No. 2023/77

29 December 2023

The Republic of **South Africa institutes proceedings against the State of Israel** and requests the Court to indicate provisional measures.

[Excerpts]

...According to the Application, "acts and omissions by Israel . . . are genocidal in character, as they are committed with the requisite specific intent . . . to destroy Palestinians in Gaza as a part of the broader Palestinian national, racial and ethnical group" and that "the conduct of Israel — through its State organs, State agents, and other persons and entities acting on its instructions or under its direction, control or influence — in relation to Palestinians in Gaza, is in violation of its obligations under the Genocide Convention".

The Applicant further states that "Israel, since 7 October 2023 in particular, has failed to prevent genocide and has failed to prosecute the direct and public incitement to genocide" and that "Israel has engaged in, is engaging in and risks further engaging in genocidal acts against the Palestinian people in Gaza".

South Africa seeks to found the Court's jurisdiction on Article 36, paragraph 1, of the Statute of the Court and on Article IX of the Genocide Convention, to which both South Africa and Israel are parties. The Application also contains a Request for the indication of provisional measures, pursuant to Article 41 of the Statute of the Court and Articles 73, 74 and 75 of the Rules of Court. The Applicant requests the Court to indicate provisional measures in order to "protect against further, severe and irreparable harm to the rights of the Palestinian people under the Genocide Convention" and "to ensure Israel's compliance with its obligations under the Genocide Convention not to engage in genocide, and to prevent and to punish genocide"...

#### **UN relief chief: The war in Gaza must end**

5 January 2024

Statement by Martin Griffiths, Under-Secretary-General for Humanitarian Affairs and Emergency Relief Coordinator

Three months since the horrific 7 October attacks, Gaza has become a place of death and despair. Tens of thousands of people, mostly women and children, have been killed or injured. Families are sleeping in the open as temperatures plummet. Areas where civilians were told to relocate for their safety have come under bombardment. Medical facilities are under relentless attack. The few hospitals that are partially functional are overwhelmed with trauma cases, critically short of all supplies, and inundated by desperate people seeking safety.

A public health disaster is unfolding. Infectious diseases are spreading in overcrowded shelters as sewers spill over. Some 180 Palestinian women are giving birth daily amidst this chaos. People are facing the highest levels of food insecurity ever recorded. Famine is around the corner.

For children in particular, the past 12 weeks have been traumatic: No food. No water. No school. Nothing but the terrifying sounds of war, day in and day out.

Gaza has simply become uninhabitable. Its people are witnessing daily threats to their very existence – while the world watches on.

The humanitarian community has been left with the impossible mission of supporting more than 2 million people, even as its own staff are being killed and displaced, as communication blackouts continue, as roads are damaged and convoys are shot at, and as commercial supplies vital to survival are almost non-existent. Meanwhile, rocket attacks on Israel continue, more than 120 people are still held hostage in Gaza, tensions in the West Bank are boiling, and the specter of further regional spillover of the war is looming dangerously close.

Hope has never been more elusive. Gaza has shown us the worst of humanity, as well as moments of great heroism. We have seen how violence cannot resolve differences, but only inflame passions and build new generations of danger and insecurity.

We continue to demand an immediate end to the war, not just for the people of Gaza and its threatened neighbors, but for the generations to come who will never forget these 90 days of hell and of assaults on the most basic precepts of humanity.

It is time for the parties to meet all their obligations under international law, including to protect civilians and meet their essential needs, and to release all hostages immediately. It is time for the international community to use all its influence to make this happen. This war should never have started. But it's long past time for it to end.

<u>Flash report on the human rights situation in the West Bank including East Jerusalem, 7 October - 20 November 2023</u>

Country reports - Palestine

GENEVA (28 December 2023) – A UN <u>report</u> released today details the rapidly deteriorating human rights situation in the occupied West Bank, including East Jerusalem, after 7 October 2023, and calls on Israel to end unlawful killings and settler violence against the Palestinian population.

The report calls for an immediate end to the use of military weapons and means during law enforcement operations, an end to arbitrary detention and ill-treatment of Palestinians, and the lifting of discriminatory movement restrictions.

The UN Human Rights Office has verified the deaths of 300 Palestinians from 7 October to 27 December 2023 - including 79 children - in the occupied West Bank, including East Jerusalem, since the attacks by Hamas and other Palestinian armed groups in southern Israel. Of these, Israeli Security Forces killed at least 291 Palestinians, settlers killed eight, and one Palestinian was killed either by Israeli Security Forces or settlers. Prior to 7 October, 200 Palestinians had already been killed in the area in 2023 - the highest number in a ten-month-period since the UN began keeping records in 2005...

## **Gaza – Cultural, Archaeological Heritage**

#### **ICOMOS Press Release on the Situation in Gaza and Israel**

International Council on Monuments and Sites Written on 21 December 2023.

Following ICOMOS' <u>appeal on 17 October</u>, and in the face of the increasingly distressing developments over the last months, **ICOMOS again expresses its sadness and horror at the unacceptable and unconscionable price being paid by civilians, in particular children, and at the destruction of cultural, archaeological and living heritage, since the present round of this conflict began over two months ago.** 

Cultural heritage not only plays a central role in the history of this ongoing conflict but also serves as a source of social cohesion and humanitarian values, and gives people a sense of place, belonging and identity.

The heritage of Gaza, with its over 3000-year history as a strategic crossroads of civilisations, whose traces – religious buildings, historic buildings, museums, archaeological sites, traditional neighbourhoods – can be found throughout the Strip but especially in and around the densely urbanised Gaza City in the northern part, has suffered irreversible damages – and every further day of fighting puts it at greater risk.

Among others, reports are available on the destruction of the 7th century Great Omari Mosque and airstrikes within the compound of the 5th century Church of St. Porphyrius. Furthermore, mass population displacement and destruction of homes and neighbourhoods will have an incalculable impact on the living culture and intangible heritage of the Palestinians.

ICOMOS again calls on all parties to do all in their power to protect cultural heritage and to respect to the letter and the spirit their obligations under international law, both treaty and customary – and in particular the 1954 Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict and its two protocols, the 1972 World Heritage Convention and the 2003 Convention for the Safeguarding of the Intangible Cultural Heritage. ICOMOS reminds and stresses that the intentional targeting of cultural and religious sites (that are not legitimate military objectives and have no imperative military necessity), as other civilian objects, is prohibited specifically, under any circumstances, in international humanitarian law and is considered a war crime.

ICOMOS is in constant contact with its colleagues in both Israel and Palestine. Our International Scientific Committee on Risk Preparedness (ICORP) and its Crisis Monitoring and Response Working Group are tracking developments, gathering information on impacts to cultural heritage and preparing strategic response and recovery activities.

ICOMOS welcomes the UN General Assembly <u>resolution A/ES-10/L.27</u> adopted on 12 December 2023, demanding an immediate humanitarian ceasefire, the immediate and unconditional release of all hostages, as well as ensuring humanitarian access to Gaza. ICOMOS urges all parties involved to work toward a sustainable cessation of hostilities.

**ICOMOS offers its scientific and technical assistance** and cooperation to all those working to protect the heritage in the region and towards paths which embrace dialogue, mutual respect and

dignity for the people and their **shared cultural heritage** – **as an indispensable element to rebuilding peace**. As always, our thoughts remain foremost with our colleagues in both ICOMOS Israel and ICOMOS Palestine, and their families.

Protecting the Environment in Armed Conflict

In the context of the historical development of international humanitarian law (IHL), the specific protection of the environment is relatively recent. Still, in the almost fifty years since the first treaty rules emerged explicitly protecting the environment during armed conflict, modern understandings of the relationships among ecological and human health, on one hand, and the multi-layered and diverse threats that armed conflicts pose to the environment, on the other hand, have significantly advanced.

This issue of the International Review of the Red Cross delves into the many ways that conflict can adversely impact the environment. The articles within it develop thoughtful analysis regarding how the existing international legal framework protects the environment during armed conflict.

Armed conflicts can have a devastating impact on the environment, and the environmental consequences of conflict in turn threaten people's health and livelihoods. International humanitarian law (IHL) contains a range of obligations that set legal limits on the damage that warring parties can inflict on the environment.

The "State Expert Meeting on International Humanitarian Law: Protecting the Environment in Armed Conflicts", organized by Switzerland and the International Committee of the Red Cross (ICRC) for States party to the Geneva Conventions, was held in early 2023. The meeting brought together nearly 400 experts from ministries of defence, the environment and foreign affairs from over 120 countries to share national experiences, challenges and good practices related to the protection of the environment in armed conflicts.

In addition, expert resource persons from the UN Environment Program, the UN International Law Commission and the International Union for Conservation of Nature supported the exchanges. The meeting's purpose was to progress on the national implementation of international humanitarian law relating to the protection of the natural environment in armed conflicts. The Chair's Summary prepared by Switzerland and the ICRC reviews the contents of the meeting, including the good practices shared, and can be drawn upon to enhance environmental protection in war...

<u>Situation Report: Greater Horn of Africa Food Insecurity and Health - Grade 3 Emergency — 1 September - 31 October 2023</u>

Overview

- Countries in the Horn are experiencing increased rainfall resulting in flooding and river overflows influenced by El-Niño and a positive Indian Ocean Dipole. This has resulted in the displacement of hundreds of thousands of people, cutting off road networks, damaging infrastructure and affecting human health.
- 49.3 million people in the region are food insecure (IPC3+) experiencing crisis levels of acute
- Food insecurity and above; 8.2 million people are in IPC phase 4 and 43,000 in IPC phase 5 (South Sudan).

- More than 11.1 million children under the age of five are suffering from acute malnutrition, of which 2.7 million will require treatment for severe acute malnutrition in 2023.
- Over 19.4 million people have been displaced due to conflict, drought, and flooding. Out of these 14.5 million are internally displaced, while 4.5 million are refugees and asylum seekers (as of 30 September 2023). Out of the total number of IDPs, 10.1 million were displaced due to conflict and 4.4 million due to natural disaster.
- Admission trends for severe acute malnutrition (SAM) have shown a decrease in the majority of
  countries in the region which can likely be attributed to improved pasture, but also to a reduction of
  outreach activities (funding shortages) and flooding affecting the access to health services.
- Between January and October 2023, compared to the same period in 2022, there were over 43% (155,480) more SAM admissions in Somalia, and 38% (28,705) more in Kenya, 9% (over 19,000) more in South Sudan, and 11% (461) more admissions in Djibouti.
- The region is battling with multiple outbreaks of diseases including cholera in four countries, measles and malaria in all seven countries, and dengue fever in Ethiopia, Djibouti, Sudan and Somalia. In Sudan, a cholera outbreak was declared on 26th September 2023 in Gedaref state, and in South Kordofan and Khartoum state on 7th October 2023.
- WHO continues to provide support on leadership and coordination, surveillance and health information, outbreak prevention and control, essential nutrition actions and health services.

## **Dengue - Global situation**

21 December 2023 Global Overview Current situation

The global incidence of dengue has markedly increased over the past two decades, posing a substantial public health challenge. From 2000 to 2019, the World Health Organization (WHO) documented a ten-fold surge in reported cases worldwide increasing from 500 000 to 5.2 million. The year 2019 marked an unprecedented peak, with reported instances spreading across 129 countries.

After a slight decline of cases between the year 2020-2022 due to the COVID-19 pandemic and lower reporting rate, in 2023, an upsurge in dengue cases have been observed globally, characterized by a significant increase in the number, scale, and simultaneous occurrence of multiple outbreaks, spreading into regions previously unaffected by dengue.

Dengue transmission is cyclic and large outbreaks every 3-4 years can be expected. During the COVID-19 pandemic we saw moderate transmission of dengue in some regions and low transmission in others leading to an accumulation of people without immunity to certain dengue virus serotypes. However, the data on the circulating dengue serotypes is limited.

Since the beginning of 2023, ongoing transmission, combined with an unexpected spike in dengue cases have resulted in close to a historic high of over five million cases and more than 5000 dengue-related deaths reported in over 80 countries/territories and five WHO regions: Africa, Americas, South-East Asia, Western Pacific and Eastern Mediterranean Regions globally (Figure 1). Close to 80% of these cases, or 4.1 million, have been reported in the Region of the Americas. Dengue is the most widespread arbovirus and causes the highest number of arboviral disease cases in the Region of the Americas, with cyclic epidemics recurring every 3 to 5 years. In

addition, clusters of autochthonous dengue have been reported in the WHO European Region. However, these numbers are likely an underestimate of the true burden as most of the primary infections are asymptomatic and dengue reporting is not mandatory in many countries.

Several factors are associated with the increasing risk of spread of the dengue epidemic including, the changing distribution of the vectors (chiefly Aedes aegypti and Aedes albopictus), especially in previously dengue naïve countries; the consequences of El Nino phenomena in 2023 and climate change leading to increasing temperatures and high rainfall, humidity among others; fragile health systems in the midst of COVID-19 pandemic, political and financial instabilities in countries facing complex humanitarian crises and high population movements. These factors also challenge the response to the epidemic and the risk of further spread to other countries. Weakness in the surveillance systems in many affected countries may have led to delayed reporting and response and missed identification of symptoms, contributing to increased severe dengue outcomes.

WHO has assessed the risk to be high globally considering the increasing risk of transmission and the upsurge of cases and deaths.

# <u>Unitaid awards US\$24 million in funding to address intellectual property-related barriers to health technologies</u>

With new grants issued to three organizations, Unitaid will continue to support work on the use of TRIPS flexibilities – internationally agreed legal mechanisms allowing countries to overcome or reduce the potential negative impact of patents in response to specific public health needs – to enable equitable access to critical health products in low- and middle-income countries (LMICs). This work aims to ensure the products are affordable and available to everyone in LMICs who needs them.

Before the COVID-19 pandemic began, a World Health Organization publication estimated that as many as <u>two billion people</u> lacked access to essential medicines. Then the pandemic overloaded health systems and set back progress on diseases such as HIV, tuberculosis (TB), malaria, and hepatitis C, among others. It also laid bare profound disparities in the way that health research is conducted and how access to innovation is determined.

Without intervention, inequitable access will only widen, and populations that are already vulnerable and marginalized will face increasing risk of disease, poverty, reduced quality of life and even death.

Working in partnership with the <u>International Treatment Preparedness Coalition</u> (ITPC), <u>Third World Network</u> (TWN), and <u>Wemos</u>, Unitaid will contribute to equitable access to health products of public health importance by improving affordability, building capacity and improving supply of key tools for HIV, TB, hepatitis C, cervical cancer, and public health emergencies, in complementarity with other access strategies such as voluntary licenses.

**Abstract** 

Non-pharmaceutical measures such as preventive quarantines, remote working, school and workplace closures, lockdowns, etc. have shown effectiveness from an epidemic control perspective; however, they have also significant negative consequences on social life and relationships, work routines and community engagement. In particular, complex ideas, work and school collaborations, innovative discoveries and resilient norms formation and maintenance, which often require face-to-face interactions of two or more parties to be developed and synergically coordinated, are particularly affected. In this study, we propose an alternative hybrid solution that balances the slowdown of epidemic diffusion with the preservation of face-to-face interactions, that we test simulating a disease and a knowledge spreading simultaneously on a network of contacts. Our approach involves a two-step partitioning of the population. First, we tune the level of node clustering, creating 'social bubbles' with increased contacts within each bubble and fewer outside, while maintaining the average number of contacts in each network. Second, we tune the level of temporal clustering by pairing, for a certain time interval, nodes from specific social bubbles. Our results demonstrate that a hybrid approach can achieve better trade-offs between epidemic control and complex knowledge diffusion. The versatility of our model enables tuning and refining clustering levels to optimally achieve the desired trade-off, based on the potentially changing characteristics of a disease or knowledge diffusion process.

### A blueprint for elimination of cervical cancer

...Disadvantaged girls and women, especially those in LMICs and marginalised groups, are still disproportionately affected by cervical cancer. Although HPV vaccines have been available for almost two decades, access to the vaccines has not been equal and coverage of two doses has been low, in part due to vaccine hesitancy. Progress on screening and treatment is lagging. Many countries do not offer cervical cancer screening, and most countries with official recommendations for cervical cancer screening begin to screen women at age 30 years, repeating every 5 years, with the potential for delayed detection of early, treatable stages of cervical cancer. Tedros said that access to surgery, radiotherapy, chemotherapy, and palliative care needs to be better in most countries.

There is hope that the situation will improve. Recommendations supporting single-dose strategies for HPV immunisation make incorporating HPV vaccines into routine immunisation programmes a more realistic option for many countries and mean that many more girls can be protected. Nigeria, for instance, is aiming to reach 7·7 million girls with a single dose of HPV vaccine after introducing the vaccine into its immunisation programme in October, 2023. Production of HPV vaccines in LMICs—perhaps leveraging new vaccine manufacturing capacity in these countries in the wake of the COVID-19 pandemic—should ensure more equitable access to the vaccines. The Serum Institute of India, for example, is producing the country's first domestic HPV vaccine, Cervavax, after its approval on the basis of immunological data. This pathway to licensure, made possible by the established efficacy of existing vaccines, is less costly and time-consuming than the traditional route of demonstrating efficacy against disease in large trials and could expedite approval of other HPV vaccines in development...

... Respiratory illnesses have re-emerged in unpredictable patterns after the pandemic, whereas COVID-19 cases seem to have reached a plateau in the USA. Scientists are unsure whether COVID-19 will become a winter virus since there appears to be no clear pattern yet, but capacities that were increased during COVID-19 need to be sustained for other infectious diseases. Population-level immunity following vaccination and infection wanes over time, and vaccine hesitancy remains a large problem that requires a targeted reponse. # A synthesis of evidence for policy from behavioural science during COVID-19

**Abstract** 

Scientific evidence regularly guides policy decisions 1, with behavioural science increasingly part of this process2. In April 2020, an influential paper3 proposed 19 policy recommendations ('claims') detailing how evidence from behavioural science could contribute to efforts to reduce impacts and end the COVID-19 pandemic. Here we assess 747 pandemic-related research articles that empirically investigated those claims. We report the scale of evidence and whether evidence supports them to indicate applicability for policymaking. Two independent teams, involving 72 reviewers, found evidence for 18 of 19 claims, with both teams finding evidence supporting 16 (89%) of those 18 claims. The strongest evidence supported claims that anticipated culture, polarization and misinformation would be associated with policy effectiveness. Claims suggesting trusted leaders and positive social norms increased adherence to behavioural interventions also had strong empirical support, as did appealing to social consensus or bipartisan agreement. Targeted language in messaging yielded mixed effects and there were no effects for highlighting individual benefits or protecting others. No available evidence existed to assess any distinct differences in effects between using the terms 'physical distancing' and 'social distancing'. Analysis of 463 papers containing data showed generally large samples; 418 involved human participants with a mean of 16,848 (median of 1,699). That statistical power underscored improved suitability of behavioural science research for informing policy decisions. Furthermore, by implementing a standardized approach to evidence selection and synthesis, we amplify broader implications for advancing scientific evidence in policy formulation and prioritization.

Moral foundations theory (MFT) holds that moral judgements are driven by modular and ideologically variable moral foundations but where and how these foundations are represented in the brain and shaped by political beliefs remains an open question. Using a moral vignette judgement task (n = 64), we probed the neural (dis)unity of moral foundations. Univariate analyses revealed that moral judgement of moral foundations, versus conventional norms, reliably recruits core areas implicated in theory of mind. Yet, multivariate pattern analysis demonstrated that each moral foundation elicits dissociable neural representations distributed throughout the cortex. As predicted by MFT, individuals' liberal or conservative orientation modulated neural responses to moral foundations. Our results confirm that each moral foundation recruits domain-general mechanisms of social cognition but also has a dissociable neural signature malleable by sociomoral experience. We discuss these findings in view of unified versus dissociable accounts of morality and their neurological support for MFT.

Rare diseases have a significant impact on patients, families, the health system, and society. Measuring the socioeconomic burden is crucial to valuing interventions for rare diseases. Healthcare system costs are significant, but so are costs to other government sectors, patients, families, and society. To understand the breadth of costs captured in rare disease studies, we examined the cost categories and elements of socioeconomic burden captured in published studies.

**Conclusions** 

Contrary to cost-of-illness analyses, most of the included economic evaluations did not account for the hidden burden of rare diseases, that is, costs borne by patients, families, and societies. Including these types of costs in future studies would provide a more comprehensive picture of the burden of disease,

providing empirical data to inform how we value and make decisions regarding rare disease interventions, health policy, and resource allocation.

**Abstract** 

Background: As well as suffering a high burden of pneumococcal disease people living with HIV (PLHIV) may contribute to community transmission in sub-Saharan African (sSA) settings. Pneumococcal vaccination is not currently offered to PLHIV in sSA but may prevent disease and reduce transmission. More evidence of vaccine effectiveness against carriage in PLHIV is needed. An Experimental Human Pneumococcal Carriage model (EHPC) has been safely and acceptably used in healthy adults in Malawi to evaluate pneumococcal vaccines against carriage and to identify immune correlates of protection from carriage. This study will establish the same model in PLHIV and will be the first controlled human infection model (CHIM) in this key population.

**Ethics, equity, climate change, and infectious disease research: a scoping** review [version 1; peer review: awaiting peer review]

**Abstract** 

Objectives

This scoping review aimed to summarise ethical issues related to climate-sensitive infectious diseases identified in the scientific literature.

Methods

We conducted a scoping review of PubMed to assess the level of engagement by scientists in the ethical and broader equity issues intersecting with climate-sensitive infectious diseases. Articles were included if they covered at least two out of three subjects – infectious disease, climate change, and ethics; and were published in English since 1995.

Results

The majority of scientific work in this field has focused on the relationship between climate change and vector-borne diseases (e.g., malaria and dengue fever) or water-borne diseases (e.g., cholera). Many studies identify the role of climate change in exacerbating inequities caused by the convergence of social and environmental determinants of health and show that the world's most vulnerable populations are disproportionately impacted. However, few studies included explicitly normative ethical analysis of these trends, and there was limited discussion of the ethical responsibilities arising in infectious disease research including in relationships between researchers and communities.

Conclusions

This review provides a foundation for renewed and ethically-informed research on climate-sensitive diseases in low-and middle-income countries. It also highlights critical knowledge gaps and reveals where more work is needed to understand and respond to the ethical implications of these relationships and thereby inform more ethically conscious infectious disease research.
