## **Global Rights Crises Deepen as World Leaders Shy Away**

Principled Diplomacy Critical to Uphold Human Rights Framework Human Rights Watch January 11, 2024 Read the World Report

(New York) – **Global leaders have failed to take strong stands to protect human rights during 2023,** a year of some of the worst crises and challenges in recent memory, with deadly consequences, Human Rights Watch said today in its <u>World Report 2024</u>. Governments should stop engaging in transactional diplomacy and do their utmost to uphold universal human rights principles.

Renewed armed conflict between the Israeli government and Hamas caused tremendous suffering, as did conflicts in Ukraine, Myanmar, Ethiopia, and the Sahel. The year 2023 was the hottest since global records began in 1880 and the onslaught of wildfires, drought, and storms wreaked havoc on communities from Bangladesh to Libya to Canada. Economic inequality rose around the world, as did anger about the policy decisions that have left so many people struggling to survive.

"The international system that we rely on to protect human rights is under threat as world leaders look the other way when universal principles of human rights are violated," said <u>Tirana Hassan</u>, executive director at Human Rights Watch. "Every time a country overlooks these universal and globally accepted principles, someone pays a price, and that price is sometimes peoples' lives."

In the 740-page World Report 2024, its 34th edition, Human Rights Watch reviews human rights practices in more than 100 countries. In her <u>introductory essay</u>, Executive Director Tirana Hassan says that 2023 was a consequential year not only for human rights suppression and wartime atrocities but also for selective government outrage and transactional diplomacy that carried profound costs for the rights of those not in on the deal. But she says there were also signs of hope, showing the possibility of a different path, and calls on governments to consistently uphold their human rights obligations.

Governments' double standards in applying the human rights framework not only put countless lives at risk, but they chip away at trust in the institutions responsible for enforcing and protecting rights, Human Rights Watch said. When governments are vocal in condemning the Israeli government's war crimes against civilians in Gaza but silent when it comes to Chinese government crimes against humanity in Xinjiang, or demand international prosecution for Russian war crimes in Ukraine while undermining accountability for US abuses in Afghanistan, they weaken the belief in the universality of human rights and the legitimacy of the laws designed to protect them.

Governments have found it easier to disregard human rights issues in the international arena in part because their violations of human rights at home have gone unchallenged by the international community, Human Rights Watch said.

The human rights and humanitarian crises have led many to question the effectiveness of the human rights framework, when abusive governments are able to benefit from the lukewarm endorsement of a rights approach by more democratic and rights-respecting governments, Human Rights Watch said...

Global Economy Set for Weakest Half-Decade Performance in 30 Years- World Bank Reforms to boost investment and strengthen fiscal policy could help turn the tide

WASHINGTON, Jan. 9, 2024— As the world nears the midpoint of what was intended to be a transformative decade for development, the global economy is set to rack up a sorry record by the end of 2024 — the slowest half-decade of GDP growth in 30 years, according to the World Bank's latest Global Economic Prospects report.

By one measure, the global economy is in a better place than it was a year ago: the risk of a global recession has receded, largely because of the strength of the U.S. economy. **But mounting geopolitical tensions could create fresh near-term hazards for the world economy.**Meanwhile, the medium-term outlook has darkened for many developing economies amid slowing growth in most major economies, sluggish global trade, and the tightest financial conditions in decades. Global trade growth in 2024 is expected to be only half the average in the decade before the pandemic. Meanwhile, borrowing costs for developing economies—especially those with poor credit ratings—are likely to remain steep with global interest rates stuck at four-decade highs in inflation-adjusted terms.

Global growth is projected to slow for the third year in a row—from 2.6% last year to 2.4% in 2024, almost three-quarters of a percentage point below the average of the 2010s. Developing economies are projected to grow just 3.9%, more than one percentage point below the average of the previous decade. After a disappointing performance last year, low-income countries should grow 5.5%, weaker than previously expected. By the end of 2024, people in about one out of every four developing countries and about 40% of low-income countries will still be poorer than they were on the eve of the COVID pandemic in 2019. In advanced economies, meanwhile, growth is set to slow to 1.2% this year from 1.5% in 2023.

"Without a major course correction, the 2020s will go down as a decade of wasted opportunity," said Indermit Gill, the World Bank Group's Chief Economist and Senior Vice President. "Near-term growth will remain weak, leaving many developing countries—especially the poorest—stuck in a trap: with paralyzing levels of debt and tenuous access to food for nearly one out of every three people. That would obstruct progress on many global priorities. Opportunities still exist to turn the tide. This report offers a clear way forward: it spells out the transformation that can be achieved if governments act now to accelerate investment and strengthen fiscal policy frameworks."

<u>To tackle climate change and achieve other key global development goals by 2030,</u>
<u>developing countries will need to deliver a formidable increase in investment</u> —about \$2.4
<u>trillion per year</u>. Without a comprehensive policy package, prospects for such an increase are not

bright. Per capita investment growth in developing economies between 2023 and 2024 is expected to average only 3.7%, just over half the rate of the previous two decades.

The report offers the first global analysis of what it will take to generate a sustained investment boom, drawing from the experience of 35 advanced economies and 69 developing economies over the past 70 years.

It finds that **developing economies often reap an economic windfall when they accelerate per capita investment growth to at least 4% and sustain it for six years or more**: the pace of convergence with advanced-economy income levels speeds up, the poverty rate declines more swiftly, and productivity growth quadruples. Other benefits also materialize during these booms: among other things, inflation falls, fiscal and external positions improve, and people's access to the internet expands rapidly...

THE HAGUE, 12 January 2024. The public hearings on the request for the indication of provisional measures submitted by South Africa in the case concerning Application of the Convention on the Prevention and Punishment of the Crime of Genocide in the Gaza Strip (South Africa v. Israel) concluded today...The Court will now begin its deliberation. **The Court's decision will be delivered at a public sitting, the date of which will be announced in due course.** 

## Requests of the Parties

At the end of the hearings, the Agent of South Africa and the Co-Agent of Israel made the following requests to the Court:

#### For South Africa:

"South Africa, as a State party to the Convention on the Prevention and Punishment of the Crime of Genocide, respectfully requests the Court, as a matter of extreme urgency, pending the Court's determination of this case on the merits, to indicate the following provisional measures in relation to the Palestinian people as a group protected by the Genocide Convention. These measures are directly linked to the rights that form the subject matter of South Africa's dispute with Israel:

- (1) The State of Israel shall immediately suspend its military operations in and against Gaza;
- (2) The State of Israel shall ensure that any military or irregular armed units which may be directed, supported or influenced by it, as well as any organisations and persons which may be subject to its control, direction or influence, take no steps in furtherance of the military operations referred to point (1) above;
- (3) The Republic of South Africa and the State of Israel shall each, in accordance with their obligations under the Convention on the Prevention and Punishment of the Crime of Genocide, in relation to the Palestinian people, take all reasonable measures within their power to prevent genocide;
- (4) The State of Israel shall, in accordance with its obligations under the Convention on the Prevention and Punishment of the Crime of Genocide, in relation to the Palestinian people as a group protected by the Convention on the Prevention and Punishment of the Crime of Genocide, desist from the commission of any and all acts within the scope of Article II of the Convention, in particular:
- (a) killing members of the group;
- (b) causing serious bodily or mental harm to the members of the group;

- (c) deliberately inflicting on the group conditions of life calculated to bring about its physical destruction in whole or in part; and
- (d) imposing measures intended to prevent births within the group;
- (5) The State of Israel shall, pursuant to point (4) (c) above, in relation to Palestinians, desist from, and take all measures within its power including the rescinding of relevant orders, of restrictions and/or of prohibitions to prevent:
- (a) the expulsion and forced displacement from their homes;
- (b) the deprivation of:
  - (i) access to adequate food and water;
  - (ii) access to humanitarian assistance, including access to adequate fuel, shelter, clothes, hygiene and sanitation;
  - (iii) medical supplies and assistance; and
- (c) the destruction of Palestinian life in Gaza;
- (6) The State of Israel shall, in relation to Palestinians, ensure that its military, as well as any irregular armed units or individuals which may be directed, supported or otherwise influenced by it and any organizations and persons which may be subject to its control, direction or influence, do not commit any acts described in (4) and (5) above, or engage in direct and public incitement to commit genocide, conspiracy to commit genocide, attempt to commit genocide, or complicity in genocide, and insofar as they do engage therein, that steps are taken towards their punishment pursuant to Articles I, II, III and IV of the Convention on the Prevention and Punishment of the Crime of Genocide;
- (7) The State of Israel shall take effective measures to prevent the destruction and ensure the preservation of evidence related to allegations of acts within the scope of Article II of the Convention on the Prevention and Punishment of the Crime of Genocide; to that end, the State of Israel shall not act to deny or otherwise restrict access by fact-finding missions, international mandates and other bodies to Gaza to assist in ensuring the preservation and retention of said evidence;
- (8) The State of Israel shall submit a report to the Court on all measures taken to give effect to this Order within one week, as from the date of this Order, and thereafter at such regular intervals as the Court shall order, until a final decision on the case is rendered by the Court, and that such reports shall be published by the Court;
- (9) The State of Israel shall refrain from any action and shall ensure that no action is taken which might aggravate or extend the dispute before the Court or make it more difficult to resolve."

#### For Israel:

"In accordance with Article 60, paragraph 2, of the Rules of Court, for the reasons given during the hearing of 12 January, 2024 and any other reasons the Court might deem appropriate, the State of Israel hereby requests the Court to:

(1) Reject the request for the indication of provisional measures submitted by South Africa; and

(2)	Remove	the	case	from	the	General	List.

# <u>UN human rights experts welcome start of ICJ genocide hearings in The Hague, reiterate call for ceasefire</u>

GENEVA (11 January 2024) – UN human rights experts\* today welcomed the start of hearings before the International Court of Justice ("ICJ") of a case brought by South Africa concerning allegations that

Israel is committing acts of genocide against the Palestinian people. The experts emphasized that any decision the Court reaches on provisional measures must be respected and implemented by the parties to the dispute, as required by the ICJ Statute...

"ICJ decisions are final, binding, and not subject to appeal. Adherence to any order the Court may make by the parties involved is imperative for protecting the rights of Palestinians and reinforcing the primacy of international law," the experts said.

"We commend South Africa for bringing this case to the ICJ at a time when the rights of Palestinians in Gaza are being violated with impunity. We call on all States to cooperate with the Court as it interprets the Genocide Convention and to respect the role of the ICJ as an independent court of law."

The experts also welcomed the statements of support by many States for South Africa's action in bringing the case to the Court, as well as the principled stand taken by individuals and organizations worldwide that have expressed support for the submission of the case by South Africa...

"South Africa's case has broader implications for all States – not only those that have ratified the Convention – as all are obligated both to refrain from committing genocide, and to prevent and punish it wherever it occurs. All States must act together to prevent, halt, and punish genocide," the experts said.

"The ICJ has in the past made clear that obligations under the Genocide Convention are of an erga omnes nature, meaning that any and all countries have a stake in preventing genocide wherever it is at risk of occurring. This plainly means that uninvolved countries have standing to bring a case like South Africa's to the ICJ," the experts explained...

Recalling the alarming magnitude and intensity of the bombardments, the experts also reiterated their demand, issued in December 2023 along with other Special Procedure mandate holders, for an immediate ceasefire and a halt to displacement, domicide, and attacks on health infrastructure.

The experts further **called for immediate action to ensure the unimpeded delivery of desperately needed humanitarian aid** to people in Gaza, especially for the sick or injured, persons with disabilities, older persons, pregnant women, and children.

## <u>Multi-country outbreak of cholera, External situation report #10 - 11 January 2024</u> *Overview*

Preliminary data from Member States indicate that the number of cholera cases reported in 2023 as of 15 December has surpassed that of 2022, with over 667 000 cases and 4000 deaths. These figures must be interpreted with caution given the varying surveillance systems and capacity across countries, which means that 2023 data are not directly comparable to reports from previous years.

Since the publication of the last situation report on the multi-country outbreak of cholera on 7 December 2023 (which included data up to 15 November), and as of 15 December 2023, one new country (Togo) has reported an outbreak of cholera or acute watery diarrhoea (AWD). In total, at least 30 countries have reported cases since 1 January 2023.

Nearly a year has passed since WHO classified the global resurgence of cholera as a grade 3 emergency, the highest internal level for a health emergency requiring a comprehensive response at the three levels of the organization. WHO is currently reviewing its response to cholera globally to identify key lessons and make evidence-based adjustments where needed to better coordinate activities in the coming months.

Based on the large number of outbreaks and their geographic expansion, alongside the shortage of vaccines and other resources, WHO continues to assess the risk at global level as very high.

#### Is this a violation? Learning and understanding norm violations in online communities

Abstract

Using norms to guide and coordinate interactions has gained tremendous attention in the multi-agent community. However, new challenges arise as the interest moves towards dynamic socio-technical systems, where human and software agents interact, and interactions are required to adapt to human's changing needs. For instance, different agents (human or software) might not have the same understanding of what it means to violate a norm (e.g., what characterizes hate speech), or their understanding of a norm might change over time (e.g., what constitutes an acceptable response time). The challenge is to address these issues by learning the meaning of a norm violation from limited

interaction data. For this, we use batch and incremental learning to train an ensemble of classifiers. Ensemble learning and data-sampling handle the imbalanced class distribution of the interaction stream. At the same time, the training approaches use different strategies to ensure that the ensemble models reflect the latest community view on the meaning of norm violation. Batch learning uses weight assignment, while incremental learning continuously updates the ensemble models as community members interact. Here, we extend our previous work by creating a different balance strategy for online learning and integrating interpretability to understand norm violations. Additionally, we evaluate the proposed approaches in the context of Wikipedia article edits, where interactions revolve around editing articles, and the norm in question is prohibiting vandalism. Lastly, we conduct ablation studies to compare the ensemble's performance against a single model approach and to examine the behavior of two data sampling techniques. Results indicate that the different machine learning frameworks can learn the meaning of a norm violation in a setting with data imbalance and concept drift, although with significant differences.

## **Article Israel: Systematic Continuous Consumption of Terrorist Publications Criminalized**

On November 8, 2023, the Knesset (Israel's parliament) adopted the <u>Combating Terrorism Law</u> (<u>Amendment No. 9 and Temporary Order</u>), 5784-2023. The amendment law amends the <u>Combating Terrorism Law</u>, 5776-2016, as amended, with effect for two years from its date of publication, November 12, 2023.

The amendment law imposes one year of imprisonment on a person who systematically and continuously consumes publications of a specified terrorist organization in circumstances indicating their identification with the terrorist organization. (Combating Terrorism Law § 24(c1)(1).)

To constitute an offense, the publication must directly call for perpetrating an act of terrorism, or express praise, sympathy, or encouragement for, or document the commission of such an act. ( $\S$  24(c1)(2).) Publications "made at random, in good faith or for a legitimate purpose, including for the purpose of making information available to the public, preventing [perpetration of] terrorism offenses or research" are excluded from those that may trigger prosecution. ( $\S$  24(c1)(3).)...

While some civil rights organizations <u>criticize the law</u>, arguing that it may lead to "punishing people not based on their actions," the amendment bill's explanatory note states:

The temporary order is intended to provide, for a limited period ... another tool in the struggle against terrorism, with an emphasis on individual attacks, which are characterized by perpetrators of acts of terrorism who do not belong to terrorist organizations but whose motivation to perform the acts stems from intensive consumption of terrorist publications of terrorist organizations with certain characteristics. This need is intensified in light of the current security situation and concern that it could be exploited by those terrorist organizations. Intensive viewing of terrorist publications of certain organizations may create a process of indoctrination, a kind of self-"brainwashing," which may bring the desire and motive to commit an act of terrorism to a very high level of maturity, with the final trigger that will bring the consumer of terrorist content to commit an act of terrorism being a random factor that may not be anticipated or prevented in advance. **Abstract** 

A clean, healthy and sustainable environment is both a human right itself and necessary for the full enjoyment of a broad range of children's rights. Conversely, environmental degradation, including the consequences of the climate crisis, adversely affects the enjoyment of these rights, in particular for children in disadvantaged situations or children living in regions that are highly exposed to climate change. The exercise by children of their rights to freedom of expression, peaceful assembly and association, to information and education, to participate and be heard and to effective remedies can result in more rights-compliant, and therefore more ambitious and effective, environmental policies. In this way, children's rights and environmental protection form a virtuous circle. The present general comment is focused on children's rights and the environment, with a particular emphasis on climate change. Its aims are to: (a) emphasize the urgent need to address the adverse effects of environmental degradation, with a special focus on climate change, on the enjoyment of children's rights; (b) promote a holistic understanding of children's rights as they apply to environmental protection; and (c) clarify the obligations of States party to the UN Convention on the Rights of the Child (the Convention) and provide authoritative guidance on legislative, administrative and other appropriate measures to address environmental harm, with a special focus on climate change.

**Abstract** 

Under Article 24 of the Convention on the Rights of the Child (crc), children have the right to the highest attainable standard of health. One component of this right that has received little attention is the connection between children's health and their participation in health-related research. This represents a missed opportunity in the full realisation of the right to health. This paper accordingly argues that Article 24 should obligate or incentivise State Parties to create more research opportunities for children in implementing this right. It explores the links between paediatric research and children's health, highlighting the impacts of the lack of research on the paucity or absence of many treatment and prevention options for childhood diseases. It also considers the application of other rights which may be implicated in paediatric research. While paediatric health-related research is imperative, it must occur within a framework which respects all children's rights.

## The future of the global clinical trial ecosystem: a vision from the first WHO Global Clinical Trials Forum

The first WHO Global Clinical Trials Forum  $\underline{1}$  held at WHO, Geneva, Switzerland, on Nov 20–21, 2023, brought together a diverse community to advance sustainable global clinical trial infrastructure. To secure the improvements needed to "strengthen clinical trials", as mandated by the World Health Assembly in May, 2022,  $\underline{2}$  the Forum agreed a unified vision of "always on, always busy", whereby sustained national and global clinical trial capacity during and between crises ensures clinical research and trials are integrated and sustained in all health systems so that trials can help improve health outcomes for all, all the time.

#### Moving cholera vaccines ahead of the epidemic curve

The ongoing multi-country cholera outbreaks deserve greater attention and higher prioritisation globally.  $\underline{1}$  Since the early 1800s, there have been seven characterised global outbreaks of cholera. The seventh and current pandemic has been causing considerable illness effects since the early 1960s.  $\underline{2}$  Most recently, floods, droughts, natural disasters, and conflicts have displaced millions of people who have restricted access to clean water and live in settings with poor sewage management and increasing disease risk, further increasing the devasting effect of cholera around the globe.  $\underline{3}$  Currently, 1 billion people are at risk of contracting cholera and, concerningly, 28 countries with outbreaks in 2023, and 24 countries with active outbreaks were recorded by WHO by Sept 10, 2023 alone.  $\underline{4}$  In addition, recent outbreaks have had a high case fatality rate.  $\underline{5}$  The average cholera case fatality rate reported globally in 2021 was 1.9% (2.9% in Africa), a significant increase above the accepted target rate (<1%) and the highest recorded in over a decade.  $\underline{1}$ ,  $\underline{5}$ 

Preliminary data suggest a similar trend for 2022 and 2023.  $\underline{1}$  Cholera is an old adversary that is both preventable and treatable.  $\underline{5}$  Despite widespread calls for strengthened pandemic preparedness and response, the global public health community are failing to apply lessons learned from COVID-19 to old challenges such as cholera. ## Significance

Human mobility shapes the global sustainability landscape: mobile lifestyles and multicultural settings affect how places develop. The confrontation between different ways of thinking about and practicing sustainability can reconfigure socioeconomic patterns in highly diverse cities. Yet, this research shows that sustainability and migration are currently isolated from one another in policy thinking and action. Migration is thought of as external to sustainability concerns and migrants are left out of national and urban sustainability planning. However, research itself may help stimulate new, more integrative and inclusive conversations among actors who have an interest and an influence at the migration—sustainability nexus.

#### Abstract

Sustainability and migration are typically treated as discrete policy spheres in international, national, and local fora, separated in governance structures and institutions. This results in policy incoherence that hinders just transitions toward more sustainable societies cognizant of mobile realities. This explorative effort identifies the (dis)connections between policy domains using data collected on how the sustainability-migration nexus is governed in four countries with a special emphasis on urban areas: Belgium, the Netherlands, Sweden, and the United States. Results of 73 interviews show that migration and sustainability actors find it challenging to see how they could be working together and that migrants are rarely conceived of as sustainability actors and/or targeted populations of sustainability policy. Despite the cross-sectoral nature of sustainability, it appears that migration and sustainability are sequestered into silos that hinder collaborative actions. Lamenting the existence of silos is not enough to encourage new lines of thinking or practice in how sustainability is governed; therefore, we examine the evidence to ascertain current barriers blocking synergetic governance and the opportunities for change perceived by respondents via three critical elements of transformations toward sustainability: structural, systemic, and enabling conditions. We argue that for sustainability transitions to happen, a wider set of societal actors needs to be included from policy intention to action, but that this transformation may require more than policy integration via horizontal coordination. It demands reflexivity and pluralistic pathways that close vertical gaps between national and municipal levels and diminish structural inequalities as they intersect with migration type and status.

In this open letter, members of the Global Forum for Research Ethics and Integrity [GFREI] – an open, independent collaborative involving 80+ individuals in 30+ countries – report on and extend arguments made during a workshop conducted at the Oxford Global Health and Bioethics International Conference (June 26–27, 2023). Based on our experience, we posit that engagement of public consultation opportunities is a matter of transnational civic responsibility; that such engagement can add substantive value to public discourse and the realization of public good; that engaging voices and views from all global regions, and respecting and integrating diverse contributions from varying experience, expertise and forms of knowledge significantly strengthens public consultation responses; and that sustaining and extending GFREI's independent global voice, and building its diversity and the range of disciplines represented, is worthy of robust support from the global community. Finally, we call on the ethics/bioethics community to engage these calls as an important strategy in advancing the ethical soundness of the laws, regulations, policies, guidelines presented for public consultation.

<u>Strategies for evaluation of a multi-phased complex arts-and-health</u> project [version 1; peer review: awaiting peer review]

**Abstract** 

Background: Different approaches and frameworks are available for those evaluating arts-and-health projects. We share our experience in devising, implementing and reflecting on the evaluation strategy of a complex arts-and-health project rooted in a deep participatory phase and culminating in an immersive nationally touring exhibition.

Methods: The evaluation focused on different stakeholders (i.e. workshop participants, clinicians involved in the participatory phase, public audiences, the project team itself) using different

approaches (i.e. group reflections, email feedback, 1:1 interviews, feedback cards with creative invitations, online journals).

Results: Rich and nuanced observations indicate that a mix of methodologies can produce knowledge about team dynamics, participants' experiences and audiences' responses. This strategy, designed at the onset of the project and carried out collaboratively by the interdisciplinary core project team, was responsive to the evolution of the project, resulting in a well-defined, transparent but also reactive evaluation plan to maximise the capture of stakeholder feedback.

Conclusion: A clear, collaborative evaluation plan should be devised at the onset of arts-and-health participatory projects.
