# A "moment of truth" for climate action says UN Secretary-General

05 June 2024

Now is the "moment of truth" for climate action, said UN Secretary-General António Guterres as he laid out a sweeping blueprint for cuts in emissions, strengthening resilience, reforming financial flows and tackling the fossil fuel industry.

Mr. Guterres cited a <u>new WMO report predicting even more record temperatures in the next five years</u>, and on new data from the EU's Copernicus Climate Change Service that the past 12 months were the hottest eve, with temperatures more than 1.6 °C above the pre-industrial era.

"We are playing Russian roulette with our planet," said Mr Guterres. "We need an exit ramp off the highway to climate hell. And the good news is that we have control of the wheel. The battle to limit temperature rise to 1.5 degrees will be won or lost in the 2020s – under the watch of leaders today."

"We have what we need to save ourselves. Our forests, our wetlands, and our oceans absorb carbon from the atmosphere. They are vital to keeping 1.5 alive, or pulling us back if we do overshoot that limit. We must protect them...and we have the technologies we need to slash emissions. Renewables are booming as costs plummet and governments realize the benefits of cleaner air, good jobs, energy security, and increased access to power," he said.

**Every fraction of a degree of global heating counts, he said**. "The difference between 1.5 and two degrees could be the difference between extinction and survival for some small island states and coastal communities. The difference between minimizing climate chaos or crossing dangerous tipping points. 1.5 degrees is not a target. It is not a goal. It is a physical limit."

"Scientists have alerted us that temperatures rising higher would likely mean: The collapse of the Greenland Ice Sheet and the West Antarctic Ice Sheet with catastrophic sea level rise; Destruction of tropical coral reef systems and the livelihoods of 300 million people; Collapse of the Labrador Sea Current that would further disrupt weather patterns in Europe; And widespread permafrost melt that would release devastating levels of methane, one of the most potent heat-trapping gasses," said Mr Guterres.

# He set out a five-point plan of action:

**Huge cuts in emissions. Led by the huge emitters.** The G20 countries produce eighty percent of global emissions – they have the responsibility, and the capacity, to be out in front. Advanced G20 economies should go furthest, fastest, he said.

**Early warnings should protect every person on Earth by 2027** through the <u>Early Warnings for All</u> action plan, which is championed by WMO.

For every dollar needed to adapt to extreme weather, only about five cents is available. As a first step, all developed countries must honour their commitment to double adaptation finance to at least \$40 billion a year by 2025, he said.

**Finance.** The global financial system must be part of the climate solution. Eye-watering debt repayments are drying up funds for climate action. Extortion-level capital costs are putting renewables virtually out of reach for most developing and emerging economies, he said.

Fossil fuels must be phased out by ending financial subsidies, disinvestment, curtailing advertizing and ending misinformation. Fossil fuel companies must use the massive profits to lead the energy transition.

"Now is the time to mobilise, now is the time to act, now is the time to deliver. This is our moment of truth," said Mr Guterres.

# 1 in 4 children globally live in severe child food poverty due to inequity, conflict, and climate crises – UNICEF

Children experiencing this level of food poverty are up to 50 per cent more likely to suffer from lifethreatening malnutrition, new analysis finds

NEW YORK, 6 June 2024 – Around 181 million children worldwide under 5 years of age – or 1 in 4 – are experiencing severe child food poverty, making them up to **50 per cent more likely to experience wasting, a life-threatening form of malnutrition,** a new UNICEF report reveals today.

For the first time, <u>Child Food Poverty: Nutrition Deprivation in Early Childhood</u> analyses the impacts and causes of dietary deprivation among the world's youngest people in nearly **100 countries**, and across income groups. It warns that millions of children under the age of five are unable to access and consume a nutritious and diverse diet to sustain optimal growth and development in early childhood and beyond.

Children who consume, at most, two of eight defined food groups are considered to be in severe child food poverty. Four out of five children in this situation are fed only breastmilk/milk and/or a starchy staple, such as rice, maize or wheat. Less than 10 per cent of these children are fed fruits and vegetables. And less than 5 per cent are fed nutrient-dense foods such as eggs, fish, poultry, or meat.

"Children living in severe food poverty are children living on the brink. Right now, that is the reality for millions of young children, and this can have an irreversible negative impact on their survival, growth and brain development," said UNICEF Executive Director Catherine Russell. "Children who consume just two food groups per day, for example rice and some milk, are up to 50 per cent more likely to experience severe forms of malnutrition."

The report warns that while countries are still recovering from the socio-economic impacts of the COVID-19 pandemic, the effects of growing inequities, conflicts, and the climate crisis have pushed food prices and the cost of living to record high levels.

Of the 181 million children living in severe food poverty, **65 per cent reside in just 20 countries.** Around 64 million affected children are in South Asia, and 59 million are in Sub-Saharan Africa...

# **Biological Poverty Line for Infants—Evidence and Implications**

This Viewpoint discusses whether protective and promotive interventions in brain development would benefit from identification of a "biological poverty line" during pregnancy and early childhood, above which the brain is informed and enhanced by experience in positive ways, and below which adverse experiences may influence the brain in ways that do not support long-term health trajectories.

Abstract

Decades of behavioral and educational research have clearly demonstrated the powerful detrimental effects of exposure to poverty on child development. Building on this, a burgeoning body of literature has also demonstrated adverse effects on brain development. Together such findings suggest that exposure to poverty very early in life alters the structure and function of the developing brain. This may be one mechanism by which poverty negatively affects developmental outcomes, often with lifelong consequences.<sup>1</sup>

Biological mechanisms underlying the effects of experience (eg, exposure to poverty) on brain development have been elucidated; these **mechanisms include impacts on gene expression** (epigenetic) and modification of stress systems, as well as influences on inflammatory and gut microbiome systems that directly communicate with the brain. Data suggest that the negative effects of these exposures may be uniquely powerful during periods of highest neuroplasticity (ie, when the brain is most shaped by experience) during fetal and infant brain development.

Such findings underscore the importance of further investigation of the impact of poverty on development in pregnancy and early childhood to guide protective and promotive interventions during this period.

# **Global Food Security – Aquaculture**

FAO Report: Global fisheries and aquaculture production reaches a new record high
Aquaculture surpasses capture fisheries in aquatic animal production for the first time, The State of
World Fisheries and Aquaculture 2024 says

Rome/San Jose, Costa Rica – World fisheries and aquaculture production has hit a new high, with aquaculture production of aquatic animals surpassing capture fisheries for the first time,

according to a new report from the Food and Agriculture Organization of the United Nations (FAO) released today.

The 2024 edition of The State of World Fisheries and Aquaculture (SOFIA) said global fisheries and aquaculture production in 2022 surged to 223.2 million tonnes, a 4.4 percent increase from the year 2020. Production comprised 185.4 million tonnes of aquatic animals and 37.8 million tonnes of algae.

"FAO welcomes the significant achievements thus far, but further transformative and adaptive actions are needed to strengthen the efficiency, inclusiveness, resilience and sustainability of aquatic food systems and consolidate their role in addressing food insecurity, poverty alleviation and sustainable governance," said FAO Director-General QU Dongyu. "That's why FAO advocates <u>Blue Transformation</u>, to meet the overall requirements of better production, better nutrition, a better environment and a better life, leaving no one behind."...

Aquaculture growth indicates its capacity to further contribute to meeting the rising global demand for aquatic foods, but future expansion and intensification must prioritise sustainability and benefit regions and communities most in need.

At present, a small number of countries dominate aquaculture. Ten of them — China, Indonesia, India, Viet Nam, Bangladesh, the Philippines, Republic of Korea, Norway, Egypt, and Chile — produced over 89.8 percent of the total. But many low-income countries in Africa and Asia are not using their full potential. Targeted policies, technology transfer, capacity building and responsible investment are crucial to boost sustainable aquaculture where it is most needed, especially in Africa...

# **UN experts urge all States to recognise State of Palestine**

GENEVA (3 June 2024) -

All States must follow the example of 146 United Nations Member States and recognise the State of Palestine and use all political and diplomatic resources at their disposal to bring about an immediate ceasefire in Gaza, UN experts\* said today.

"This recognition is an important acknowledgement of the rights of the Palestinian people and their struggles and suffering towards freedom and independence," the experts said. They insisted that Palestine must be able to enjoy full self-determination, including the ability to exist, determine their destiny and develop freely as a people with safety and security.

"This is a pre-condition for lasting peace in Palestine and the entire Middle East — beginning with the immediate declaration of a ceasefire in Gaza and no further military incursions into Rafah," the experts said.

The State of Palestine, formally declared by the Palestine Liberation Organization (PLO) on 15 November 1988, claims sovereignty over the remaining parts of historic Palestine that Israel occupied in 1967: the West Bank, including East Jerusalem, and the Gaza Strip.

As of 28 May 2024, the State of Palestine was recognised by the vast majority of Member States of the United Nations. **The experts welcomed the latest recognitions of the occupied Palestinian** 

**territory as a State by Norway, Ireland and Spain**, which comes after the General Assembly overwhelmingly voted - with 143 votes in favour to nine votes against - to <u>back</u> Palestine's bid to become a full member of the United Nations on 10 May 2024.

"Even though the prospect of lasting peace and an end to occupation has remained elusive since the Oslo Accords more than 30 years ago, a political solution should not be considered foregone," the experts said. "A two-State solution remains the only internationally agreed path to peace and security for both Palestine and Israel and a way out of generational cycles of violence and resentment."

The UN experts said the move by the Prosecutor of the International Criminal Court (ICC) to seek arrest warrants against the Israeli Prime Minister, Minister of Defense and top Hamas leaders on suspicions of war crimes and crimes against humanity was a promise of accountability and an end to impunity in the occupied Palestinian territory.

"The International Court of Justice (ICJ) in its most recent <u>ruling on provisional measures</u>, ordering Israel to stop its military operations in Rafah, immediately reopen the Rafah crossing to allow life-saving humanitarian aid into the Gaza strip and grant unimpeded access for UN human rights mechanisms, complements the work of the ICC in ensuring full justice in Palestine and preventing any further bloodshed in Gaza," the experts said.

"States must refrain from threats and attacks against the ICC and the ICJ," they said. "These courts must operate without foreign interference and threats, to uphold the promise of global justice and individual accountability for all victims of the conflict."

#### **IHSA's Humanitarian Blog Posts Selection**

This week's selection continues to put some of the most urgent crises around the world in focus. Four posts explore uncomfortable truths about the realities in Gaza. One particularly sharp point raised is the inability of the International Court of Justice to protect civilians in conflict, or indeed to uphold and enforce its own decisions. It is not just the ICJ that struggles with this, the other 'Hague Court', the International Criminal Court seems equally impotent in the face of the conflicts of the last two or three years. The International Criminal Court has so far publicly indicted 54 people, most recently including the Israeli Prime Minister and Defence Minister, and two leaders of Hamas; but it is exceptionally unlikely that many will ever be tried by the court. There is an ongoing refusal to recognize the jurisdiction of the court by large countries including the USA, China, India and Russia and particularly pertinently in this case, Israel. Without bulk buy-in from countries around the world, the ICC and ICJ risk being seen as toothless in the face of ongoing and overwhelming violence.

Other blogs in the selection argue to redefine humanitarian action, and academics call for an end to scholasticide. Philippe Lazzarini renews calls for the protection of UNRWA and UN institutions. Not too far away, Sudanese civilians are in "Hell on Earth" in El Fasher, where fighting has intensified and local mutual aid groups are paying the price. Meanwhile, as the conflict in Myanmar rapidly deteriorates, Rohingyas are caught in the middle, facing the threat of another genocide.

In other parts of the world, the UK's Safety of Rwanda Act may be in breach of the principle of non-refoulement, and one post explores the concept of community philanthropy in the Philippines and its contributions to community-driven aid. As the humanitarian system grapples with doing no harm, another argues that the existing system has already caused harm to forcibly displaced LGBTQIA+ persons. In the midst of these and other humanitarian challenges, one post asks whether or not the humanitarian protection system is already failing

In recent years, many medicines regulatory agencies have expressed increased willingness to consider real-world evidence (RWE), that derives from the review and/or analysis of real-world data (RWD), to support claims of efficacy or effectiveness as well as of safety. This increased willingness is changing the regulatory environment in which RWE is generated and used. This consensus report aims to describe the potential use of RWE for decision making; RWD and data sources; key scientific considerations in the generation of RWE; and ethical and governance issues in using RWD.

The intended audience for this report includes medicinal product regulators, healthcare payers, health care and medicinal products industries, researchers, bioethicists, patients and health care professionals. This report was developed to inform discussions about the use of RWD and RWE for regulatory and health care decision making, including decisions to make a product available for use (authorisation), to cover the costs of its use (reimbursement), and to use a product for a particular patient (clinical use).

This report reflects the opinions of the Council for International Organizations of Medical Sciences (CIOMS) Working Group XIII on Real-world data and real-world evidence in regulatory decision making, and it was finalised after considering comments received during a public consultation.

## Bridging the Gaps in Our Efforts to Combat Human Trafficking

This Special Issue (SI) seeks to collect the most current knowledge on gaps in the research realm or intervention development. For example, until recently, the primary focus of intervention and prevention efforts has focused on the supply side of the equation. There needs to be more quality research on the demand side of the equation. Similarly, there are ongoing issues of reliable data (i.e., measurement) and how best to collect it; the issue of under-counting and possible system failure issues; navigating the existing "system" and its barriers; the challenges of prosecutions and convictions; and "siloing" of NGOs, among a host of other themes and issues.

The SI's focus is broad, and we do not want to prejudice the process by assuming that all the (primary) challenges are adequately understood and addressed in our efforts to combat human trafficking. Instead, as acknowledged by experts in the field, we invited a group of experienced researchers and practitioners to contribute to this collective effort. More importantly, we sought voices from the global south for inclusion in this volume, e.g., India, Cambodia, and South Africa.

To assure adequate coverage and balance against the traditional preference for academic-type research papers, we included two broad types of articles in this volume: shorter articles (around 2,500 words) from several front-line organizations and services that speak directly (from their experience) to the challenges of meeting their objectives and mandates and full-length empirically based articles to point out or address some of the gaps in "human trafficking" (HT) research.

<u>Comparative ethical evaluation of epigenome editing and genome editing in medicine: first steps and future directions</u>

Targeted modifications of the human epigenome, epigenome editing (EE), are around the corner. For EE, techniques similar to genome editing (GE) techniques are used. While in GE the genetic information is changed by directly modifying DNA, intervening in the epigenome requires modifying the configuration of DNA, for example, how it is folded. This does not come with alterations in the base sequence ('genetic code'). To date, there is almost no ethical debate about EE, whereas the discussions about GE are voluminous. Our article introduces EE into bioethics by translating knowledge from science to ethics and by comparing the risks of EE with those of GE. We, first (I), make the case that a broader ethical debate on EE is due, provide scientific background on EE, compile potential use-cases and recap previous debates. We then (II) compare EE and GE and suggest that the severity of risks of novel gene technologies depends on three factors: (i) the choice of an ex vivo versus an in vivo editing approach, (ii) the time of intervention and intervention windows and (iii) the targeted diseases. Moreover, we show why germline EE is not effective and reject the position of strong epigenetic

determinism. We conclude that EE is not always ethically preferable to GE in terms of risks, and end with suggestions for next steps in the current ethical debate on EE by briefly introducing ethical challenges of new areas of preventive applications of EE (III).

#### **H5N1: international failures and uncomfortable truths**

If you ask an infectious diseases specialist whether we should start worrying about influenza A H5N1, they will probably tell you that we should always be worrying about it. An influenza pandemic has long topped the list of global threats to health, and avian influenza poses a particularly serious concern. H5N1 has infected over 800 people since its identification in 1996, with a mortality rate exceeding 50%. Since 2020, it has become endemic in bird populations, triggering an unparalleled animal pandemic, affecting at least 26 mammal species. There is nothing new in influenza strains evolving, shifting their epidemiological habits, and causing infections in people, although human-to-human transmission of H5N1 is rare. Nonetheless, although developments over the past 3 months may or may not signal the start of a global pandemic, they are at the very least a pressing and unwelcome reminder of the caprices of zoonotic influenza and our continued collective complacency about it.

An unprecedented outbreak of highly pathogenic avian influenza A(H5N1), the first documented infection in dairy cows, was reported on March 25, 2024 in Texas, Kansas, and New Mexico, raising the potential of cow-to-human transmission. Three confirmed human cases in the USA, all farm workers, have been reported so far, with the third person presenting with respiratory symptoms. Genetic analysis shows that the virus lacks changes that would make it better adapted to transmit between people and the risk to human health remains low, but it did detect adaptation to mammalian hosts. Despite calls for increased surveillance, the US response has been slow, with many cases likely going undetected. There has been resistance from the farming industry around testing and prevention, driven by a lack of awareness or understanding around changing practice and fear of trade restrictions and product loss. The US Department of Agriculture (USDA) and the US Centers for Disease Control and Prevention are incentivising dairy producers to supply personal protective equipment and offer laundering services for employees, but the USDA has been accused of being slow in sharing crucial virus sequence data, complicating our understanding of the outbreak. In Canada, early warning

systems have been implemented to screen for H5N1 in milk. The UK says it has intensified its response to the US outbreak, but according to a report last month, it is not yet testing cows for the virus.

Action to curb this outbreak is needed urgently, including improving testing, surveillance, and reporting of infected animals and food products; vaccinating animal populations; transparent information sharing; developing and stockpiling human vaccine; and promoting protective measures among farm workers. All countries should build capacities to test, detect, and report infections, cases, and deaths above expected levels and share this information. Countries in need of external assistance to bolster their capacity should receive support.

The need for a robust and coordinated response to highly pathogenic avian influenza A(H5N1), as described in a Comment by Kojima and colleagues, serves to highlight the scale of the failure of countries to secure an international agreement on the pandemic accord. The 77th World Health Assembly, which closed on June 1, was meant to see a finalised draft of an international instrument on pandemic prevention, preparedness, and response. As The Lancet has noted, negotiations have been mired in disagreement and draft provisions have been unjust and inequitable (although changes to the International Health Regulations have been agreed). The process is not over yet—discussions continue with the hope of securing an agreement by May, 2025. Until then, the continued absence of a meaningful and effective accord undermines the ability to respond appropriately to international health threats, such as H5N1. Despite COVID-19, most countries are not prepared for a new pandemic.

Beyond the proximal drivers of outbreaks and potential interventions though, there is a need to confront an uncomfortable truth that the US H5N1 outbreak once again raises. Spillover of zoonoses into human populations stems ultimately from our ways of life and how they shape the human—animal interface. Our diets, our intensive farming practices, our livelihoods, our behaviours, and our cultures. Our exploitation of the natural world and our destruction of the environment. These issues are tractable through interdisciplinary education, intersectoral collaboration, adequate funding, and integrated policies. The concept of One Health, although often acknowledged, is rarely prioritised and operationalised. The result is a missed opportunity to not just respond to pandemic threats, but to prevent them altogether.

Controlled human infection models (CHIMs) for TB may be used to accelerate vaccine development by ensuring only the most promising vaccine candidates are selected for phase 3 trials, but it is not currently possible to give participants Mycobacterium tuberculosis as a challenge agent.

This study aims to replicate and refine an established BCG CHIM at the Liverpool School of Tropical Medicine. Participants will receive an intradermal injection with licensed BCG vaccine (Statens Serum Institut strain). In phase A, participants will undergo punch biopsy two weeks after administration, paired with minimally invasive methods of skin sampling (skin swab, microbiopsy, skin scrape). BCG detection by classical culture and molecular methods will be compared between these techniques and gold standard punch biopsy. Techniques meeting our pre-defined sensitivity and specificity criteria will be applied in Phase B to longitudinally assess intradermal BCG growth two, seven and fourteen days after administration. We will also measure compartmental immune responses in skin, blood and respiratory mucosa in Phase B.

This feasibility study will transfer and refine an existing and safe model of BCG controlled human infection. Longitudinal BCG quantification has the potential to increase model sensitivity to detect vaccine and therapeutic responses. If successful, we aim to transfer the model to Malawi in future studies, a setting with endemic TB disease, to accelerate development of vaccines and therapeutics relevant for underserved populations who stand to benefit the most.
