Forced Displacement

[UNHCR warns against apathy and inaction amid spike in forced displacement](#)

Overall numbers rise to 120 million by May 2024; conflicts from Sudan to Gaza and Myanmar are creating new displacement and urgently require resolution.

GENEVA – **Forced displacement surged to historic new levels across the globe last year** and this, according to the 2024 flagship Global Trends Report from UNHCR, the UN Refugee Agency.

The rise in overall forced displacement – to 120 million by May 2024 – was the 12th consecutive annual increase and reflects both new and mutating conflicts and a failure to resolve long-standing crises. The figure would make the global displaced population equivalent to the 12th largest country in the world, around the size of Japan's.

A key factor driving the figures higher has been the devastating conflict in Sudan: at the end of 2023, 10.8 million Sudanese remained uprooted. In the Democratic Republic of the Congo and Myanmar, millions were internally displaced last year by vicious fighting. UNRWA estimates that by the end of last year, up to 1.7 million people (75 per cent of the population) had been displaced in the Gaza Strip by the catastrophic violence, most of whom were Palestine refugees. Syria remains the world's largest displacement crisis, with 13.8 million forcibly displaced in and outside the country.

"Behind these stark and rising numbers lie countless human tragedies. That suffering must galvanize the international community to act urgently to tackle the root causes of forced displacement," said Filippo Grandi, the UN High Commissioner for Refugees. "It is high time for warring parties to respect the basic laws of war and international law. The fact is that without better cooperation and concerted efforts to address conflict, human rights violations and the climate crisis, displacement figures will keep rising, bringing fresh misery and costly humanitarian responses."

The largest increase in displacement figures came from people fleeing conflict who remain in their own country, rising to 68.3 million people according to the Internal Displacement Monitoring Centre – up almost 50 per cent over five years.

The number of refugees, and others in need of international protection, climbed to 43.4 million when including those under UNHCR and UNRWA's mandates. The vast majority of refugees are hosted in countries neighbouring their own, with 75 per cent residing in low- and middle-income countries that together produce less than 20 per cent of the world's income.

The report showed that worldwide, more than 5 million internally displaced people and 1 million refugees returned home in 2023. These figures show some progress towards longer-term solutions. Positively, resettlement arrivals increased to almost 160,000 in 2023.

"Refugees – and the communities hosting them – need solidarity and a helping hand. They can and do contribute to societies when they are included," Grandi added. "Equally, last year millions of people returned home, representing an important glimmer of hope. Solutions are out there – we've seen countries like Kenya lead the way in refugee inclusion – but it takes real commitment."

The report also offered new analysis on the climate crisis and how it increasingly and disproportionately affects forcibly displaced people.



Peace

[UN symposium ends with new pact on disarmament, demobilization and reintegration](#)

GENEVA – A climate of growing global insecurity risks grave and lasting consequences for humanity unless there is **collective international action to address challenges posed by wars**, said delegates at the end of the week-long UN Disarmament, Demobilization and Reintegration (known as DDR) Symposium in Geneva.

Conflicts affect 2 billion people worldwide, civilian deaths were up 72% in 2023, and 40% of post-war countries return to civil war within a decade. Peace cannot take hold unless former members of armed forces and groups have opportunities to return to civilian life and rejoin families and communities.

Under the theme of "DDR's Role in Conflict Prevention and Sustaining Peace", over 80 practitioners, experts and national directors from some of the world's most complex crises met 3-7 June.

Delegates were looking to come up with practical contributions to the Secretary-General's New Agenda for Peace which is a key part of the Summit for the Future in September, led by Member States. Key outcomes of the symposium included the need for coalition building around investment, national and regional leadership, and diplomatic support for DDR in all contexts.

The importance of women in disarmament, demobilization and reintegration processes was another key concern of delegates. Out of 18 peace agreements in 2022, provisions for women and girls were only included in six. The implementation of the Women, Peace and Security (WPS) agenda on DDR has lagged, with decrease in gender responsive actions as well as reporting capacity.

The United Nations Development Programme (UNDP) and the United Nations Department of Peace Operations (DPO) co-hosted the event, with the support of the Swiss government. Experts included those from Chad, Colombia, the Democratic Republic of Congo, Ethiopia, Haiti, Libya, the Philippines and Ukraine, among others. Strategic partners also participated from Germany, Sweden, the European Union, the World Bank, and representatives from the Integrated Disarmament, Demobilization and Reintegration Training Group (IDDRTG) and the United Nations Inter-Agency Working Group (IAWG) on Disarmament, Demobilization and Reintegration (DDR).

"Addressing the needs of former combatants, both men and women, at a war's end is a key constituent part to sustainable peace. A key part of this approach must be to ensure that those who have lived through and participated in conflict are not left behind," said UNDP Administrator Achim Steiner in a message to participants.

Jean-Pierre Lacroix, Under-Secretary-General for Peace Operations, said DDR was integral to peace efforts: "From treating prevention as a political priority, to centering national ownership in any DDR process, to working with robust regional frameworks and organizations, to finding new innovative ways to finance peace, and to ensuring young people have a say in their future and patriarchal power structures are dismantled."...



Education Services – Non-State Actors

[New UNESCO report explores regulation of non-state actors in education](#)

*The landscape of education is evolving, with **non-state actors playing a significant role in the provision of educational services worldwide**. The UNESCO Global Education Monitoring Report 2021/2 on 'Non-state actors in education: Who chooses? Who loses?', found that more than 350 million children and youth worldwide are educated in the non-state sector and 'governments financially support non-state schools in 171 out of 204 countries'.*

In response, UNESCO and the Global Schools Forum (GSF) embarked on a collaborative research project to delve into the complex world of regulating non-state education based on key informant interviews with government officials and non-state education operators in **five diverse low- and middle-income countries: Colombia, Nepal, Nigeria, Pakistan, and Uganda**.

Building on the [GEM Report 2021/22](#), the recently published joint report '[Regulating non-state actors in education: Findings from a collaborative research project](#)' sheds light on how regulatory systems operate and the implications for shaping regulatory frameworks that uphold the principles of quality education, non-discrimination, and inclusion.

The report emphasizes that States hold the primary responsibility for overseeing their education systems, requiring not just adequate education budget allocation but also robust regulatory mechanisms. However, the effectiveness of regulations varies among States due to disparities in capacity and resources, prompting a need for strengthening government's regulatory capacity of non-state actors.

Quality learning rooted in human rights principles

Highlighting the importance of clear, quality education standards rooted in human rights principles, the report underscores regulations' role in fostering equal opportunities for disadvantaged students in non-state schools. In addition, according to interviewees, current regulations, often focused on registration and infrastructure, need a broader scope considering local contexts, education quality, and teacher challenges. This echoes the findings of the GEM Report 2021/22, which noted, based on an analysis of 211 education systems, that "regulations are least likely to focus on quality or equity."

The report advocates for education pluralism in national systems, emphasizing the balance between prescription and autonomy to uphold educational freedom and minority rights. It calls for participatory approaches involving collaboration between government, non-state actors, communities, parents, and children in shaping regulations.

Acknowledging challenges in compliance, such as inconsistent implementation and political dynamics, the report calls for clear, unambiguous, and transparent regulations.

Beyond enforcement, regulations are viewed as opportunities to support schools in their journey toward improvement, ensuring students' and teachers' interests are central to the debate...



World Bank – Climate Change Loss and Damage

[Board Approves World Bank’s Role as Host and Trustee for the Fund for Responding to Loss and Damage](#)

Historic Fund will assist developing countries hit by adverse effects of climate change.

WASHINGTON, June 10, 2024—The World Bank’s Board of Executive Directors today approved the World Bank’s role as interim secretariat host and trustee of a **fund for responding to loss and damage caused by climate change**.

In a historic decision at COP28, an agreement was reached by 198 countries to move forward with a fund to provide financial support to vulnerable countries hardest hit by climate impact. Since COP28, the World Bank has worked with urgency to operationalize the Fund as a World Bank hosted financial intermediary fund (FIF) for an interim period of four years. **Today’s decision represents a major milestone on the path towards operationalizing the Fund, in collaboration with the Board of the Fund for Responding to Loss and Damage.**

The World Bank welcomes the Board’s decision and the role of the new Fund in providing both **much needed support and hope to poor and vulnerable people and communities in countries hardest hit by climate impacts**.

Additional Information: The Fund Board is independent from the World Bank and has its own governance structure. It will determine key priorities, including financing decisions, eligibility criteria, and risk management policies. The Fund is expected to be operationalized over the coming months. As Trustee, the World Bank will not play any role in fundraising, making funding allocation decisions or in the identification, preparation, appraisal, implementation or monitoring of projects financed by the Fund. Implementing entities and direct access recipients will remain solely accountable for the end use of funds, including with respect to fiduciary, environmental and social aspects, vis-à-vis the Board of the Fund.



Digital Remittances

[Digital remittances reduce poverty and drive rural transformation by connecting millions of ‘unbanked’ women and men, new IFAD-authored G20 report reveals](#)

Rome, 14 June 2024 – In celebration of the International Day of Family Remittances (IDFR) on 16 June, the G20’s Global Partnership for Financial Inclusion (GPII) has today unveiled a new report that provides **evidence of the transformative impact of digital remittances, as a driver of financial inclusion and poverty reduction worldwide**. Despite persistent gender gaps, the hard-earned money sent back home by migrant workers remains a vital lifeline for over 800 million people, particularly for women and vulnerable populations.

Authored by the UN's International Fund for Agricultural Development (IFAD) with contributions from the World Bank, the GPFi report "[Promoting Financial Inclusion through Digitalization of Remittances](#)", showcases significant strides in digitalizing remittance distribution channels.

"Digitalization reduces transfer costs, speeds up transactions, and enhances security and tracking of payments. It also broadens access to financial services like savings, credit, and insurance, especially when accompanied by proper consumer protection and financial education policies. These benefits promote financial inclusion and build financial resilience for remittance families," says Magda Bianco, co-chair of the G20 Global Partnership for Financial Inclusion (GPFi) and head of the Consumer Protection and Anti-Money Laundering Directorate at the Bank of Italy.

"The digitalization of remittances is spearheading change, especially in rural and underserved areas. It **is connecting millions of unbanked people to basic financial services that make a real difference in improving their lives,**" said Pedro de Vasconcelos, Manager of IFAD's Financing Facility for Remittances.

Beyond addressing immediate needs such as food security, health assistance, education, housing, and sanitation, one-quarter of remittance flows are saved, invested, or used to start businesses. Around US\$75 billion annually goes towards rural development.

Gender empowerment through digital remittances

The G20 report emphasizes how digital remittances provide women with greater control and privacy over their funds. "Digital remittances allow women to access funds directly and securely, empowering them to make financial decisions that benefit their families and communities. Women are more likely to allocate these funds towards household consumption, thereby contributing to poverty alleviation," said de Vasconcelos..



SDGs – State of Evidence

[State of the evidence on SDGs: Five key takeaways and reflections](#)

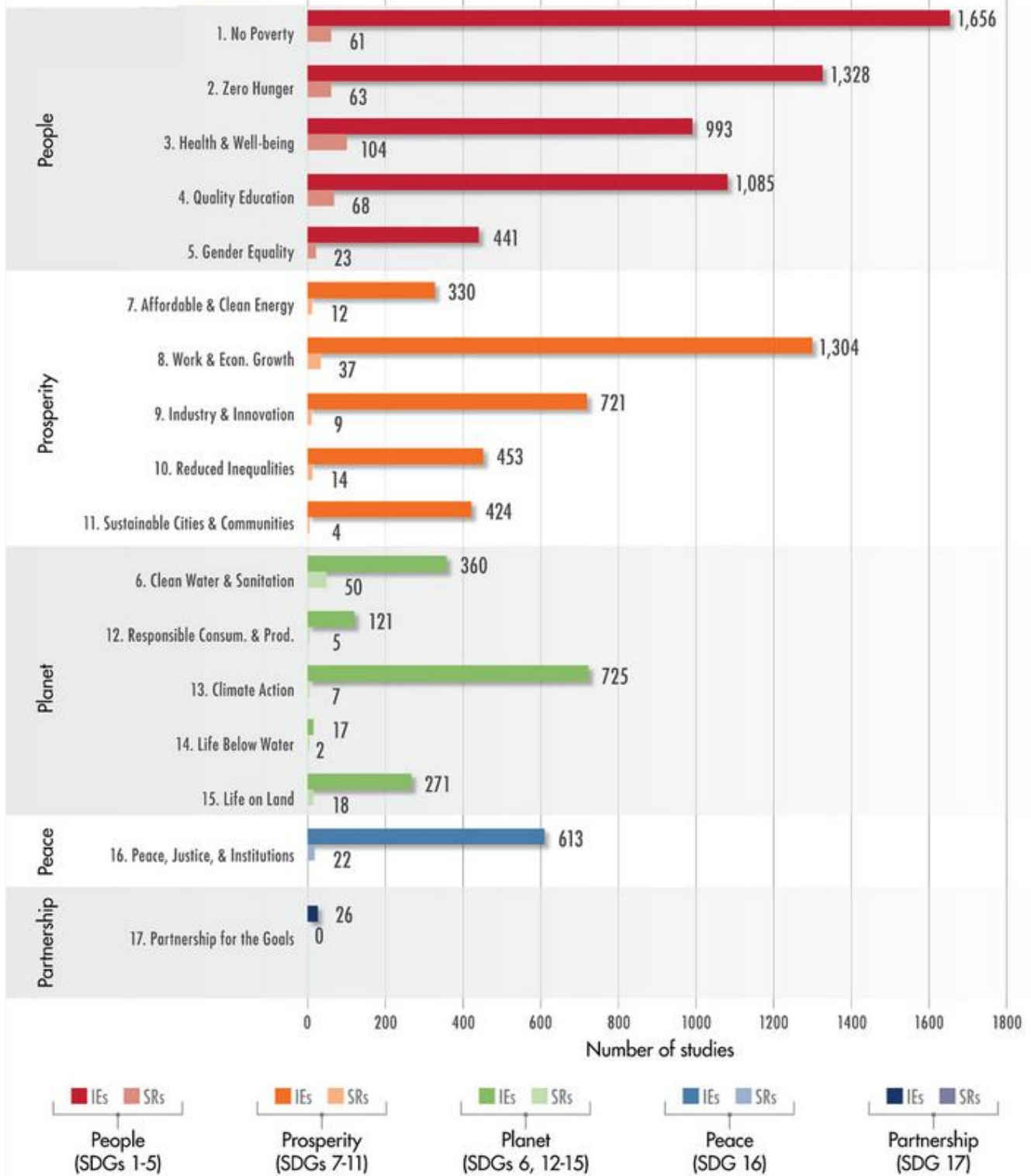

As we crossed the halfway point of the [2030 Agenda for Sustainable Development](#), we examined the state of the evidence for all 17 Sustainable Development Goals (SDGs). Joining forces with DEval* – and with funding from the German Federal Ministry for Economic Cooperation and Development (BMZ) – we did a deep dive into the effectiveness evidence in our [Development Evidence Portal \(DEP\)](#) to unpack the trends and themes across SDGs.

Our report contains a series of dashboards summarizing the state of the evidence for each of the 17 SDGs between 1990 and 2022, and in this blog, we present five key takeaways about what this means for the sustainable development agenda.

1. The thematic distribution of evidence is very lopsided—plenty of evidence for some SDGs and very little for others.

Large discrepancies in evidence bases across the SDGs

The availability of evidence across SDGs varies significantly. Whereas SDGs 1 (No Poverty), 2 (Zero Hunger), 4 (Quality Education), and 8 (Decent Work & Economic Growth) have abundant evidence with over 1,000 impact evaluations (IEs) each, SDGs 14 (Life Below Water) and 17 (Partnerships to Achieve the Goals) each have less than 30 IEs

In terms of evidence on the five thematic categories – the “5 Ps” comprising People, Prosperity, Planet, Peace, and Partnerships – we find the “People” group (SDGs 1-5) is the most represented, with SDG 1 being evaluated in more than 1,500 IEs. Evidence for “Planet” (SDGs 6 and 12–15) and “Prosperity” (SDGs 7–11) thematic categories has grown rapidly since 2016 with particularly stark growth over the last three years in China. The “Peace” and “Partnership” groups remain under-evaluated.

In general, the DEP data does not allow us to say much about why some topics are studied more than others. But it is likely that some thematic categories – such as “People” – may be broader in terms of the scope of different interventions included. Some areas may be less represented in the evidence because they’re more difficult to evaluate – for example, because they are not easily amenable to randomization. The data available in the DEP can provide the basis for more detailed mapping and analysis.

Takeaway: When it comes to addressing imbalances, the wider evaluation community will need to up its game in terms of coordination and innovation. Making use of existing evidence more systematically, avoiding duplication of effort, and focusing scarce resources on critical gaps will require more transparency of planned, ongoing, and completed activities. Less expensive and invasive methods such as geospatial impact evaluation, as well as theory-based qualitative approaches to impact assessment such as process tracing, may help to close remaining gaps...

Gaza

[Israeli authorities, Palestinian armed groups are responsible for war crimes, other grave violations of international law, UN Inquiry finds](#)

GENEVA (12 June 2024) – Israeli authorities are responsible for war crimes and crimes against humanity committed during the military operations and attacks in Gaza since 7 October 2023, the UN Independent International Commission of Inquiry on the Occupied Palestinian Territory, including East Jerusalem, and Israel, said in a new [report](#) today. The Commission also found that Palestinian armed groups are responsible for war crimes committed in Israel.

The Commission’s report – the UN’s first in-depth investigation of the events that took place on and since 7 October 2023 – is based on interviews with victims and witnesses conducted remotely and during a mission to Türkiye and Egypt, thousands of open-source items verified through advanced forensic analysis, hundreds of submissions, satellite imagery and forensic medical reports. Israel obstructed the Commission’s investigations and prevented its access to Israel and the Occupied Palestinian Territory.

“It is imperative that all those who have committed crimes be held accountable,” said Navi Pillay, Chair of the Commission. “The only way to stop the recurring cycles of violence, including aggression and retribution by both sides, is to ensure strict adherence to international law.”

"Israel must immediately stop its military operations and attacks in Gaza, including the assault on Rafah, which has cost the lives of hundreds of civilians and again displaced hundreds of thousands of people to unsafe locations without basic services and humanitarian assistance," Pillay said. " Hamas and Palestinian armed groups must immediately cease rocket attacks and release all hostages. The taking of hostages constitutes a war crime."

In relation to Israeli military operations and attacks in Gaza, the Commission found that Israeli authorities are responsible for the war crimes of starvation as a method of warfare, murder or wilful killing, intentionally directing attacks against civilians and civilian objects, forcible transfer, sexual violence, torture and inhuman or cruel treatment, arbitrary detention and outrages upon personal dignity.

The Commission found that the crimes against humanity of extermination, gender persecution targeting Palestinian men and boys, murder, forcible transfer, and torture and inhuman and cruel treatment were also committed.

The immense numbers of civilian casualties in Gaza and widespread destruction of civilian objects and infrastructure were the inevitable result of a strategy undertaken with intent to cause maximum damage, disregarding the principles of distinction, proportionality and adequate precautions. The intentional use of heavy weapons with large destructive capacity in densely populated areas constitutes an intentional and direct attack on the civilian population.

The report found that statements made by Israeli officials – including those reflecting the policy of inflicting widespread destruction and killing large numbers of civilians – amounted to incitement and may constitute other serious international crimes. Direct and public incitement to genocide is a crime under international law whenever perpetrated, even by persons with no direct authority for the conduct of the hostilities. Incitement to discrimination, hostility or violence is a serious violation of international human rights law and may amount to an international crime.

Although Israel issued hundreds of evacuation orders to people in north Gaza and other locations, the Commission found that they were at times insufficient, unclear and conflicting, and did not provide adequate time for safe evacuations. Furthermore, the evacuation routes and the areas designated as safe were consistently attacked by Israeli forces. All of this, the Commission determined, amounted to forcible transfer.

The Commission determined that Israel's imposed a "total siege" which amounts to collective punishment against the civilian population. Israeli authorities have weaponized the siege and used the provision of life-sustaining necessities, including by severing water, food, electricity, fuel and humanitarian assistance, for strategic and political gains. The siege has disproportionately impacted pregnant women and persons with disabilities, with serious harm inflicted on children leading to preventable child deaths from starvation including newborns.

The report found that specific forms of sexual and gender-based violence constitute part of Israeli Security Forces' operating procedures. It made the finding due to the frequency, prevalence and severity of the violations, which include public stripping and nudity intended to humiliate the community at large and accentuate the subordination of an occupied people.

In the West Bank, the Commission found that Israeli forces committed acts of sexual violence, torture and inhuman or cruel treatment and outrages upon personal dignity, all of which are war crimes. Furthermore, the Commission found that the government of Israel and Israeli forces permitted,

fostered and instigated a campaign of settler violence against Palestinian communities in the West Bank.

In relation to the attack of 7 October in Israel, the report found that the military wing of Hamas and six other Palestinian armed groups, are responsible for the war crimes of intentionally directing attacks against civilians, murder or wilful killing, torture, inhuman or cruel treatment, destroying or seizing the property of an adversary, outrages upon personal dignity, and taking hostages, including children. The indiscriminate firing of thousands of projectiles towards Israeli towns and cities resulting in death and injury of civilians are also violations of international humanitarian and human rights law. Members of Palestinian armed groups, in some instances aided by Palestinians in civilian clothing, deliberately killed, injured, tortured, took hostages, including children, and committed sexual and gender-based violence against civilians and against members of the Israeli Security Forces, some of whom were hors de combat and should not have been targeted.

The Commission identified patterns indicative of sexual violence and concluded that these were not isolated incidents but perpetrated in similar ways in several locations primarily against Israeli women. In its recommendations, the report calls on the Government of Israel to immediately implement a ceasefire, end the siege of Gaza, ensure the delivery of humanitarian aid and cease the targeting of civilians and civilian infrastructure. The Commission calls on Israel to comply fully with its legal obligations set forth in the International Court of Justice orders on provisional measures issued on 26 January 2024, 28 March 2024 and 24 May 2024 and, in particular, allow the Commission access to Gaza to conduct investigations. It also recommended that all State Parties to the Rome Statute cooperate fully with the International Criminal Court.

The report calls on the Government of the State of Palestine and the de-facto authorities in Gaza to immediately cease all rocket attacks on Israel, unconditionally release all hostages, and thoroughly and impartially investigate violations and prosecute those responsible for crimes, including those committed on and since 7 October by members of Palestinian non-State armed groups in Israel.

Background: The [UN Human Rights Council](#) mandated the Commission on 27 May 2021 to "investigate, in the Occupied Palestinian Territory, including East Jerusalem, and in Israel, all alleged violations of international humanitarian law and all alleged violations and abuses of international human rights law leading up to and since 13 April 2021." [Resolution A/HRC/RES/S-30/1](#) further requested the commission of inquiry to "investigate all underlying root causes of recurrent tensions, instability and protraction of conflict, including systematic discrimination and repression based on national, ethnic, racial or religious identity." The Commission of Inquiry was mandated to report to the

Human Rights Council and the General Assembly annually commencing from June 2022 and September 2022, respectively.

Bridging the Gaps in Our Efforts to Combat Human Trafficking

This Special Issue (SI) seeks to collect the most current knowledge on gaps in the research realm or intervention development. For example, until recently, the primary focus of intervention and prevention efforts has focused on the supply side of the equation. There needs to be more quality research on the demand side of the equation. Similarly, there are ongoing issues of reliable data (i.e., measurement) and how best to collect it; the issue of under-counting and possible system failure issues; navigating the existing "system" and its barriers; the challenges of prosecutions and convictions; and "siloiing" of NGOs, among a host of other themes and issues.

The SI's focus is broad, and we do not want to prejudice the process by assuming that all the (primary) challenges are adequately understood and addressed in our efforts to combat human trafficking. Instead, as acknowledged by experts in the field, we invited a group of experienced researchers and practitioners to contribute to this collective effort. More importantly, we sought voices from the global south for inclusion in this volume, e.g., India, Cambodia, and South Africa.

To assure adequate coverage and balance against the traditional preference for academic-type research papers, we included two broad types of articles in this volume: shorter articles (around 2,500 words) from several front-line organizations and services that speak directly (from their experience) to the challenges of meeting their objectives and mandates and full-length empirically based articles to point out or address some of the gaps in "human trafficking" (HT) research.

Abstract

The modern canon of open science consists of five “schools of thought” that justify unfettered access to the fruits of scientific research: i) public engagement, ii) democratic right of access, iii) efficiency of knowledge gain, iv) shared technology, and v) better assessment of impact. Here, we introduce a sixth school: due process. Due process under the law includes a right to “discovery” by a defendant of potentially exculpatory evidence held by the prosecution. When such evidence is scientific, due process becomes a Constitutional mandate for open science. To illustrate the significance of this new school, we present a case study from forensics, which centers on a federally funded investigation that reports summary statistics indicating that identification decisions made by forensic firearms examiners are highly accurate. Because of growing concern about validity of forensic methods, the larger scientific community called for public release of the complete analyzable dataset for independent audit and verification. Those in possession of the data opposed release for three years while summary statistics were used by prosecutors to gain admissibility of evidence in criminal trials. Those statistics paint an incomplete picture and hint at flaws in experimental design and analysis. Under the circumstances, withholding the underlying data in a criminal proceeding violates due process. Following the successful open-science model of drug validity testing through “clinical trials,” which place strict requirements on experimental design and timing of data release, we argue for registered and open “forensic trials” to ensure transparency and accountability.

Abstract

After decades of fits and starts, the ambition to protect 30% of land and sea by 2030 (30x30) ([1](#)) is gaining some momentum, but only modest progress has been made. One reason is that signing on to

protect 30x30 will be much more costly for some nations than others; many nations facing low costs of conserving have already protected, while other nations foresee enormous costs and are reluctant to sign on. Focusing on the context of marine habitats contained by nation's exclusive economic zones (EEZs), we propose an alternative approach to meeting these ambitious conservation targets in a way that lowers the costs to all nations: allowing nations to trade their conservation obligations with other nations. Some nations would voluntarily end up conserving more than 30% of their waters and others would end up conserving less, all within well-defined and ecologically informed constraints that ensure protection across marine habitats.
