## <u>UNHCR celebrates historic Olympics with largest refugee team and first medal</u>

Press releases 10 August 2024

GENEVA/PARIS - As the 2024 Paris Olympic Games come to a close, UNHCR, the UN Refugee Agency, paid tribute to the Refugee Olympic Team for the historic achievements of the past two weeks. This year's Olympic Games marked a significant triumph for refugees worldwide, featuring **the largest-ever refugee team and the first-ever medal for a Refugee Olympic Team athlete.** 

With **37 athletes competing in 12 different sports,** this was the largest refugee team since the International Olympic Committee (IOC) created the first refugee team at the 2016 summer Olympics in Rio de Janeiro. **These athletes, representing 120 million displaced people globally**, showcased their talents, strength and determination on the world stage, bringing attention to the plight and potential of refugees...

The warm welcome given to the refugee athletes by the sport-loving public, whether in the sport venues, the fan zones around Paris or the loud cheering as the team made its way along the river Seine during the Opening Ceremony, showed the widespread support they received, regardless of individual results.

"Sport is a powerful tool that protects and helps heal. These refugee athletes have overcome immense challenges, but their success is a reminder to the world of what can be achieved when refugees are given a helping hand to pursue their dreams," said Deputy High Commissioner for Refugees, Kelly T. Clements. "As the Olympic flame is extinguished here in Paris, the legacy of the Refugee Olympic Team will continue to inspire us all."...

Attention will now turn to the Refugee Paralympic Team, comprising eight athletes and one quide runner, which will hope for more medals when the Paralympic Games begin on 28 August.

# <u>Sports bodies must pushback against the Taliban's ban on women participating in sports, say UN experts</u>

GENEVA – UN experts\* today called for decisive action from national and international sports bodies against the Taliban's ban on women and girls in Afghanistan participating in all sports.

"For nearly three years, the Taliban has barred women and girls in Afghanistan from participating in all sports, an unacceptable abrogation of their rights, which no other country imposes," the experts said. "This ban is part of the Taliban's institutionalised system of sex and gender discrimination and oppression, which may amount to crimes against humanity," the experts said.

Despite the ban, during the Olympics and Paralympics in Paris, Afghan women athletes who are living in exile are competing as part of the Afghanistan team and the refugee team, due to positive intervention of the International Olympic Committee (IOC).

The Olympic Afghanistan team which does not bear the symbols of the current de facto authorities, comprises three women and three men. **However, the Taliban does not recognise the women team members.** 

"It is essential that inspiring and talented Afghan women athletes are seen at the pinnacle of sports in Paris, as well as in other competitions, especially when they are being eviscerated from public life in their home country. Their participation stands against the Taliban's systematic oppression and exclusion of women and girls," they said.

In a letter to the IOC, the UN experts called for increased support and resources for Afghan women athletes from the entire Olympic movement, which also includes International Sports Federations and National Olympic Committees. They reminded sports bodies of their human rights responsibilities under the United Nations Guiding Principles on Business and Human Rights, the Universal Declaration on Human Rights, and their commitments under the Olympic Charter. They also expressed concern that some members of the Olympic Movement appear unable or unwilling to uphold their own organisational obligations regarding the right to equal and non-discriminatory participation of women and girls.

"The appalling deprivation of the rights and dignity of Afghan women and girls, including through their exclusion from sport in Afghanistan, must end," the experts said. "Culture should not be used as a pretext to violate human rights, including cultural rights such as the right to participate in sports."

"International sports bodies have a responsibility to challenge the Taliban's oppressive policies and support female Afghan athletes wherever they are. They must refrain from any actions that could be interpreted as complicity with these discriminatory and illegal policies," the experts said. "IOC Support for a gender-balanced Afghanistan team at the Paris Olympics is a welcome start but they must do more

**Protecting the rights of Indigenous Peoples in voluntary isolation and initial contact** 

08 Aug 2024 | DESA

Around 200 groups of Indigenous Peoples currently live in voluntary isolation and initial contact. They reside in remote forests, rich in natural resources, in Bolivia, Brazil, Colombia, Ecuador, India, Indonesia, Papua New Guinea, Peru and Venezuela. They choose to live detached from the rest of the world, and their mobility patterns allow them to engage in gathering and hunting, thereby preserving their cultures and languages. These peoples have a strict dependency on their ecological environment. Any changes to their natural habitat can harm both the survival of individual members and the group as a whole.

Despite their right to autonomy, as enshrined in the <u>UN Declaration on the Rights of Indigenous Peoples</u>, Indigenous Peoples in voluntary isolation and initial contact face unique challenges often overlooked by the surrounding world. Developments for agriculture, mining, tourism and natural resources in their territories result in the deforestation of swathes of Indigenous Peoples' forests, disrupting their way of life and destroying the natural environment that they have protected for generations.

For Indigenous Peoples living in voluntary isolation and initial contact, one of the most serious threats from external contact is exposure to diseases. Due to their isolation, they do not have the immunological defenses to combat relatively common diseases. Forced contact with the outside world can lead to devastating consequences and can destroy entire societies.

This International Day of the World's Indigenous Peoples on 9 August 2024 focuses on 'Protecting the Rights of Indigenous Peoples in Voluntary Isolation and Initial Contact.' Indigenous Peoples in voluntary isolation and initial contact are the best protectors of the forest.

Where their collective rights to lands and territories are protected, the forests thrive, alongside their societies. Not only is their survival crucial to the protection of our planet, but it is also essential to the preservation of cultural and linguistic diversity. In today's hyper-connected world, the existence of Indigenous Peoples in voluntary isolation and initial contact is a testament to the rich and complex tapestry of humanity. It would be a huge loss to our world if they were to cease to exist.

# **Equator Prize 2024 honors 11 Indigenous Peoples and local communities putting nature at the heart of climate action**

New York – The United Nations Development Programme (UNDP) and its partners are pleased to announce the winners of the **Equator Prize 2024. Celebrating its 15th cycle**, this year's Equator Prize honors eleven Indigenous Peoples and local communities from eight countries spanning Asia, Africa, and Latin America and the Caribbean. They were chosen from a competitive pool of more than 600 nominations from 102 countries.

Under the theme of 'Nature for Climate Action,' the 2024 winners exemplify the transformative potential of Indigenous and locally-led nature-based solutions in combating the climate crisis. They champion initiatives that not only protect, conserve, and restore ecosystems but also integrate nature into planning frameworks, preserve cultural heritage, enhance resilience to the impacts of climate change, and promote a fair, inclusive, and circular green economy...

Aligned with the theme of this year's International Day of the World's Indigenous Peoples, 'Protecting the Rights of Indigenous Peoples in Voluntary Isolation and Initial Contact,' one of this year's Brazilian winners stands out for its dedication to defend the rights, traditional knowledge, and territories of sixteen Indigenous communities, including many in voluntary isolation – one of the largest regions globally to host such communities.

Among the 2024 recipients are a diverse array of projects, including an Indigenous community innovating in scientific tourism for biodiversity conservation and cultural heritage preservation; a community-led organization promoting peace through sustainable coffee production; a fintech enterprise leveraging technology to offer affordable climate finance to Indigenous small-scale farmers; a youth-founded NGO advocating for wetland protection and restoration through environmental education and the mobilization of environmental activists; a community-led nature reserve ensuring the sustainable coexistence of human habitation, agriculture, and wildlife; and a locally-driven organization supporting the sustainable livelihoods of rural communities through sustainable seed resource management.

Together, these winners from Brazil, Bangladesh, Colombia, Iran, Kenya, Morocco, Senegal, and Zambia become part of a prestigious network of 285 innovative locally-led initiatives from 94 countries that have been honored as Equator Prize winners since 2002...

## **United Nations: Member States finalize a new cybercrime convention**

09/08/2024 - New York

After three years of work, the committee established by the UN General Assembly to negotiate a new convention on cybercrime agreed today on a draft convention text. The draft convention is expected to be adopted by the General Assembly later this year, thus becoming the first global legally binding instrument on cybercrime.

This achievement represents the culmination of a five-year effort by UN Member States, with the input of civil society, academic institutions and the private sector. UNODC served as the substantive secretariat for the negotiations.

"The finalization of this Convention is a landmark step as the first multilateral anti-crime treaty in over 20 years and the first UN Convention against Cybercrime at a time when threats in cyberspace are growing rapidly," said UNODC Executive Director Ghada Waly...

As noted in the draft convention, technology has created opportunities for a greater scale, speed, and scope of crimes, from terrorism to drug trafficking to trafficking in persons, migrant smuggling, firearms trafficking, and more.

The draft convention provides tools that will enhance international cooperation, law enforcement efforts, technical assistance, and capacity-building relating to cybercrime.

# <u>Project launched to tackle key ethical questions regarding the future of neural organoid</u> research

The Nuffield Council on Bioethics (NCOB) has opened a <u>call for evidence</u>, seeking expert opinion on the three key areas where we believe further ethical guidance is needed in research using neural organoids.

Since publishing our <u>neural organoids policy briefing note</u>, we have held a horizon scanning workshop on the <u>ethical implications of engineering biology</u>, which has deepened our understanding of the ethical, policy and regulatory challenges faced by researchers working directly with neural organoids and the decision-makers seeking to regulate and govern the field.

These insights, alongside further engagement with key stakeholders have helped us to decide where to focus our attention, and what our evidence gathering programme should look like. As such, this new call for evidence, open from now until **18 September 2024**, will help us to assess:

- How regulation and governance of neural organoids can be proportionate and future proofed.
- What an informed consent process, able to account for fast-paced developments and an unpredictable direction of research, could look like.
- What current and possible future characteristics of neural organoids could have implications for their moral and legal significance, and so may warrant special ethical consideration.

# Standards in Medical-Legal Partnerships

Complex demands of patients' socially, culturally, and politically situated health needs have given rise to what have become known as medical-legal partnerships (MLPs). An MLP is a model of US-based health and legal service provision that generally looks to offer combined, single-site interprofessional responses to patients whose health status and access to health services can be compromised by their need for legal help. Patients who are immigrants, were recently incarcerated, or lack reliable and safe shelter or employment, for example, can experience health vulnerabilities that call for legal expertise, perhaps in the form of advice; aid in petitioning a court or program; referral; representation in administrative proceedings; or advocacy. ### Positive Impacts of Adolescent Involvement in Health Research: An Umbrella Review

#### **Abstract**

Despite an increased recognition of the right of adolescents to be involved in decisions that affect them, young people continue to be under-involved in health research. One of the reasons is a lack of awareness among researchers on the current evidence base around the benefits of involving adolescents. To address this, we conducted an umbrella review to synthesize the evidence on the positive impacts of adolescent involvement in health research. This umbrella review was preregistered with PROSPERO (CRD42021287467). We searched 11 databases, Google Scholar, PROSPERO, reference lists, 10 journals, websites of 472 organizations, and sought input from experts. Ultimately, we included 99 review articles. We found that adolescent involvement has many positive impacts on young people, including increased knowledge and skills; personal development; financial benefits; career and academic growth; enhanced relationships; and valuing their experience. The positive impacts of adolescent involvement on the research itself include increased relevance of the study to adolescents, improved recruitment, development of more adolescent-friendly materials, enhanced data collection and analysis, and more effective dissemination. Researchers also benefited from adolescents' involvement through increased knowledge, skills, and a shift in their attitudes. The evidence supporting the positive impacts of adolescent involvement in research is substantial but limited by a lack of rigorous evaluation, inconsistent reporting, and unclear evaluation methods.

#### Pathology in the era of generative AI

Precise and swift pathology is a major pillar in the detection, diagnosis, and treatment of a broad range of conditions, such as cancer, infectious diseases, and autoimmune disorders. It is an essential approach to preventive medicine, effective treatment planning, and identifying new diagnostic markers of diseases. Computational pathology, which involves computer-based methods to analyse and interpret pathological image data, has seen substantial evolution due to advancements in artificial intelligence (AI)-assisted methods, widespread adoption of digital pathology slides, and increased availability of pathology image datasets. As we see groundbreaking applications of large language models (LLM) and generative AI, what is the effect of these technologies on digital pathology?

In this issue of The Lancet Digital Health, <u>Omar and colleagues</u> discuss the potential of LLMs like OpenAI's ChatGPT-4 in the field of medical research, particularly digital pathology, highlighting the need for domain-specific AI tools, given the limited precision of generalist LLMs in this area. Omar and colleagues also present the <u>Digital Pathology Assistant</u>, a toolkit for computational pathology aiming to simplify the processing and analysis of pathology imaging data using the PathML library, capable of handling large-scale pathology imaging datasets.

Building on these advancements, Lu and colleagues described the <u>PathChat</u>, a new multimodal generative AI, that combines three key components: the vision encoder, the multimodal projector module and the LLM, representing a major leap forward in human pathology. PathChat outperforms

other tools based on the commercially available state-of-the-art LLMs, providing high-quality answers to diagnostic questions from diverse tissue origins and disease models related to pathology. Importantly, the code used to train PathChat is publicly accessible for non-commercial academic purposes.

<u>Li and colleagues</u> further validate the practical applications of these technologies by examining the Cpath TIL-score biomarker, which is based on the density of tumour infiltrating lymphocytes (TIL), to evaluate its association with recurrence risk and the benefit of adjuvant treatment in whole slide images of ductal carcinoma in situ (DCIS) from a large randomised controlled trial cohort. The study found that high TIL density in patients with DCIS significantly increases the risk of ipsilateral breast events (IBE) and invasive IBE, but also indicates a greater benefit from radiotherapy, highlighting its prognostic and predictive value.

Although the potential of AI in digital pathology is substantial, it is essential to address its numerous limitations and ethical considerations. Challenges such as the interpretability of AI models and integration of these models into current workflows need careful navigation. Moreover, the quality and generalisability of AI tools might be compromised by biases inherent in the datasets used for their training. Under-representation of minority demographic groups is a real concern. Hence, evaluating how varying demographic compositions in training and testing cohorts impact the performance of AI models is crucial, yet often overlooked.

The potential of such AI tools is particularly relevant when considering health inequity concerns related to access to care, especially in low-income and middle-income countries (LMICs) where a notable increase in cancer cases is estimated to result in nearly <u>75% of all cancer fatalities</u> by 2030. Hence, it is crucial to prioritise strategies that promote the development and implementation of <u>digital pathology in LMICs</u>. Potential strategies include provision of open pathology datasets, development of open-source models, establishment of public-private partnerships, and strategic and long-term funding research projects. These projects should focus on implementation science initiatives, the development of innovative technologies, collaborative research efforts led by local researchers and clinicians to adapt these technologies to local contexts.

Background A paradigmatic clash exists between biomedical and Indigenous research frameworks. Problematically, when ill-fit biomedical research frameworks are applied Indigenous peoples can experience exclusion from biomedical studies and consequent potential health benefits. To overcome these issues, community based participatory research methodologies are often recommended. However, these can prove difficult to apply in tertiary healthcare research where prospective Indigenous peoples and families participating in research will come from unforeseen and numerous Indigenous communities. Adding further complexity, there appears a dearth of information for achieving incorporation of decolonising and Indigenous research frameworks into this type of prospective research.

Methods We sought to reflect on and describe inclusion of an Indigenous Research Paradigm into the establishment of a prospective multi-site tertiary healthcare study on improving diagnosis and treatment of acute rheumatic fever. To generate reflection, the First Nations' Yarning method was employed allowing qualitative findings to be generated via Indigenous epistemology and ontology. Findings Four main areas were identified as requiring significant change to align with an Indigenous Research Paradigm: stakeholder engagement, project design, consent processes, and multi-site approach. Multi-layered Indigenous leadership was recognised as a crucial component of the transformation and of the project's success more broadly.

Interpretation With extensive local First Nations involvement and a First Nations-led research team, a multi-site institution-based biomedical research project can be successfully adapted to be more in keeping with an Indigenous Research Paradigm.
