Overview

The Summit is a high-level event, bringing world leaders together to forge a new international consensus on how we deliver a better present and safeguard the future.

Effective global cooperation is increasingly critical to our survival but difficult to achieve in an atmosphere of mistrust, using outdated structures that no longer reflect today's political and economic realities.

This once-in-a-generation opportunity serves as a moment to mend eroded trust and demonstrate that international cooperation can effectively achieve agreed goals and tackle emerging threats and opportunities.

Why the Summit matters

The world is not on track to meet the goals we have already set for ourselves. Nor are we effectively rising to new challenges or opportunities.

The speed and complexity of developments have outpaced our systems for cooperating and coping. The benefits and opportunities of progress are spread unevenly, with the majority of people left behind. The risks and threats are also unevenly felt, disproportionately impacting the most vulnerable.

Extreme poverty and hunger are on the march. Global emissions are at their highest levels in human history, as are levels of human displacement. Threats such as climate, conflict, food security, weapons of mass destruction, pandemics and health crises, and the risks associated with new technologies, are growing.

Multilateral governance, designed in simpler, slower times, is not adequate to today's complex, interconnected, rapidly changing world.

The Summit is an opportunity to put ourselves on a better path.

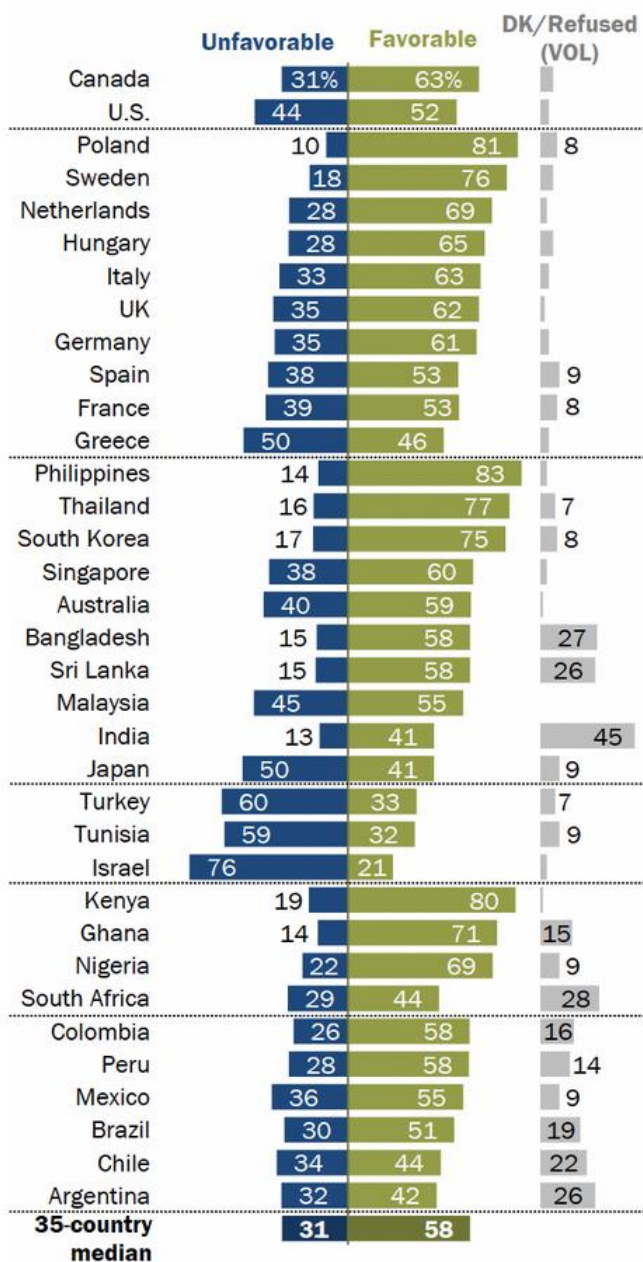
Most people in 35 countries see the UN favorably, but views have dipped in some places

As the 79th United Nations General Assembly opens on Sept. 10, people around the world generally see the UN in a positive light. A median of 58% across 35 countries have a favorable view of the organization, while 31% have a negative view, according to a Pew Research Center survey conducted this spring.

Sudan: Starvation crisis reaches historic proportions

Joint statement from the heads of the Norwegian Refugee Council, the Danish Refugee Council, and Mercy Corps.

03. September 2024

"As the heads of humanitarian organisations operating in Sudan, **we urgently call on the international community to address the immense hunger crisis within the country.**

"We cannot be clearer: Sudan is experiencing a starvation crisis of historic proportions. And yet, the silence is deafening. People are dying of hunger, every day, and yet the focus remains on semantic debates and legal definitions.

"Every opportunity to head-off the worst of this situation has been missed, and now the people of Sudan face a crisis unmatched in decades. As the peak of the lean season approaches, widespread death and suffering is advancing across the country. Children are starving to death.

"More than 25 million people – more than half the population – are suffering acute food insecurity. Many families have for months been reduced to one meal a day and have been forced to eat leaves or insects. The people of Sudan have shown immense resilience and strength over the past 17 months: they now have nowhere left to turn.

"International attention and action have amounted to too little, too late. **Currently the Humanitarian Response Plan is only 41 per cent funded, with much of this funding arriving too late to prevent deaths from starvation.** Pressure must be applied to ensure that humanitarian aid can flow in and reach those who will otherwise pay with their lives.

"Our teams in Sudan have spoken of the huge loss of life resulting from the extreme violence that has swept the country, and now tell us that famine will likely eclipse that death toll. The conflict significantly impacted food production, destroying agriculture and livestock sectors.

"Staff also witness the weaponisation of food on a mass scale, in areas held by both sides of the conflict. In June alone, about 1.78 million people have had no access to critical humanitarian assistance due to logistics constraints, arbitrary denials, and bureaucratic obstruction. Even where aid is getting through, it is in such scarce supply that meagre individual rations are being divided between groups of people. In some places, ten-person households have received 2kg of millet to last an entire month – this is not enough even for three days. Such is the situation for many in "fortunate" areas where some aid is getting through.

"The level of suffering endured by the Sudanese people in recent months is impossible to express with words alone. Their endurance and resilience will be in vain if we continue to look the other way. The indifference must end."

Sudan: UN Fact-Finding Mission outlines extensive human rights violations, international crimes, urges protection of civilians

Human Rights Council - Independent International Fact-Finding Mission for the Sudan

GENEVA – **Sudan’s warring parties have committed an appalling range of harrowing human rights violations and international crimes, including many which may amount to war crimes and crimes against humanity**, the UN’s Independent International Fact-Finding Mission for the Sudan said in its first report today.

Both the Sudanese Armed Forces (SAF) and the Rapid Support Forces (RSF), as well as their respective allies, were found to be responsible for **patterns of large-scale violations, including indiscriminate and direct attacks carried out through airstrikes and shelling against civilians, schools, hospitals, communication networks and vital water and electricity supplies.**

The warring parties also targeted civilians – as well as those assisting survivors or documenting violations – through rape and other forms of sexual violence, arbitrary arrest and detention, as well as torture and ill-treatment. These violations may amount to war crimes related to violence to life and person and committing outrages upon personal dignity, the report found.

“The gravity of these findings underscores the urgent and immediate action to protect civilians,” said Mohamed Chande Othman, Chair of the Fact-Finding Mission.

“Given the failure of the warring parties to spare civilians, it is imperative that an independent and impartial force with a mandate to safeguard civilians be deployed without delay,” Othman said. “The protection of the civilian population is paramount, and all parties must comply with their obligations under international law and immediately and unconditionally cease all attacks on the civilian population.”

The report also found reasonable grounds to believe that RSF and its allied militias committed the additional war crimes of rape, sexual slavery, and pillage, as well as ordering the displacement of the civilian population and the recruitment of children below 15 in hostilities. Horrific assaults carried by the RSF and its allies against non-Arab communities – in particular the Masalit in and around El Geneina, West Darfur – included killings, torture, rape and other forms of sexual violence, destruction of property and pillage.

There are also reasonable grounds to believe that acts committed by the RSF and its allied militias amount to numerous crimes against humanity, including murder, torture, enslavement, rape, sexual slavery, other sexual violence of comparable gravity, persecution on the basis of ethnic and gender targeting, and forcible displacement.

The conflict, which has spread to 14 of the 18 states in Sudan, has killed and wounded tens of thousands of civilians, displaced nearly 8 million people and forced two million more to flee to

neighboring countries. The warring parties have exacerbated the crisis by obstructing humanitarian access, the report said...

The report – mandated by the Human Rights Council when it established the Fact-Finding Mission in October 2023 – was drawn from investigations conducted between January and August 2024. These included visits to Chad, Kenya, and Uganda, first-hand testimony from 182 survivors, family members and eyewitnesses, extensive consultations with experts and civil society members, and the corroboration and analysis of additional information provided to the Mission.

The report recommended expanding the existing arms embargo in Darfur pursuant to Security Council Resolution 1556 (2004) and subsequent resolutions, to all Sudan to stem the supply of weapons, ammunition, and other logistical or financial support to the warring parties and prevent further escalation. Those supplying arms, the report warned, may be complicit in grave violations of human rights and humanitarian law.

Sudanese authorities should cooperate fully with the International Criminal Court (ICC), and surrender all indicted persons, including former President Al Bashir, the report said. The ICC's jurisdiction stemming from Security Council resolution 1593 (2005) concerning the situation in Darfur should also be expanded to cover the entire territory of Sudan...

The report also called for the establishment of a separate international judicial mechanism working in tandem and complementary to the ICC...

Domestic violence in sub-Saharan Africa will triple by 2060 due to extreme heat epidemic and stalling development, new UNFPA research finds

New York, 5 September 2024 – Tens of millions of women and girls in sub-Saharan Africa will experience catastrophic levels of intimate partner violence because the world is failing to make progress on the climate crisis, according to new projections by UNFPA, the UN sexual and reproductive health agency.

The [report](#) - *Climate Change Impacts and Intimate Partner Violence in Sub-Saharan Africa* - by UNFPA, the International Institute for Applied Systems Analysis (IIASA), and the University of Vienna shows **that rising global temperatures are leading to increasing rates of intimate partner violence.** In the worst-case scenario where emissions rise, temperatures warm by more than 4°C by the end of the century, and socioeconomic development stalls, the **number of people experiencing intimate partner violence in sub-Saharan Africa will almost triple from 48 million in 2015 to 140 million in 2060.**

The impacts of human-induced climate change are intensifying, marked by global rising temperatures and extreme weather events. Studies show that extreme temperatures and heat waves can drive up aggression and intimate partner violence. **The collapse of agriculture, water scarcity and housing insecurity is a further trigger — leading to increased conflict and risk of women and girls suffering physical and emotional abuse.** Natural disasters linked to warming temperatures trigger forced displacement, which is associated with higher levels of intimate partner violence.

In parts of sub-Saharan Africa, which is on the frontlines of the climate crisis, more than half of women and girls reported experiencing intimate partner violence in the previous 12 months.

"Extreme heat threatens the safety and well-being of the most vulnerable women and girls all across Africa," said UNFPA Executive Director Dr. Natalia Kanem. "Heat stress can put the health of pregnant women and their babies at risk, increasing the chance of preterm birth and stillbirth," she added. "The climate crisis has also led to shocking levels of violence in the home – an impact often overlooked by policymakers."

...LLMs also present challenges, e.g. variability in results, returning of irrelevant or inaccurate responses (so-called hallucinations), and potential data security risks. The purpose of the guiding principles is to build understanding of the capabilities and limitations of these applications among staff at regulatory agencies across the EU so that they can harness the potential of LLMs effectively and avoid pitfalls and risks.

The guiding principles cover various aspects of using LLMs, from ensuring safe input of data, to applying critical thinking and cross-checking outputs, to knowing whom to consult when concerns arise. Responsible use of LLMs requires familiarity with the tools. The importance of continuous learning is emphasised to keep pace with the fast-changing field.

Additionally, the principles encourage regulatory agencies to make efforts to support their staff in using LLMs. This includes defining governance on the use of LLMs, specifying permitted use cases, providing training and monitoring risks.

The guiding principles are one of the deliverables of the multiannual AI workplan to 2028 by EMA and the Heads of Medicines Agencies (HMA). This workplan guides EMA and the EMRN in their use of AI, maximising the benefits while managing the risks, and facilitating information sharing. The guiding principles are a living document that will be regularly updated, and EMA will introduce it to the network in a webinar on 13 September 2024...

Ebola: a study in Guinea reveals persistent immunity five years after vaccination

Epidemics of Ebola virus disease occur periodically in several sub-Saharan African countries. Two vaccines have already received WHO prequalification[1] against the Ebolavirus Zaire species. However, information on the long-term immune response to these vaccines is still insufficient. We need to consolidate our knowledge on this subject to continue developing the safest and most effective vaccination strategies possible, for both adults and children. In a new study conducted in Guinea, scientists from VRI, Inserm and Université Paris-Est Créteil (U955 Institut Mondor de recherche biomédicale)[2] have taken a further step in this direction. They have shown that the cellular immune response induced by three different vaccine strategies is maintained for up to five years after vaccination. These results, which support current vaccine strategies against Ebola, are published in *Nature Communications*.

Nonhuman animals have long been and continue to be routinely used in biomedical and behavioral research to promote human health. When SARS-CoV2 infections triggered a race to develop and scale global access to vaccines in 2019, two key innovations happened to the supply chain of nonhuman animals created, raised, and used for science: (1) experiments and trials regarded as essential were prioritized and (2) governments and researchers shortened vaccine production timelines. Clinical and public health urgency concentrated and acutely focused demand for live mammals—especially ferrets, guinea pigs, hamsters, mice, nonhuman primates, pigs, and rats—in ways that also intensified demand for efficient protocol designs and streamlined methods of human vaccine research and development. Reasonable people can still disagree about when, why, and how nonhuman animals should be sacrificed for human health, but we now know that human health endeavors, specifically vaccine development, flourish even when we sanction fewer nonhuman animals' cultivation and deaths for science. The Double-Edged Sword of Extremely High Prices for Gene Therapies in Sickle Cell Disease

This Viewpoint discusses the high cost of new gene therapies for sickle cell disease, the challenges these costs pose for health care access, and new policy approaches to ensure fair reimbursement for payers and manufacturers without further increasing health care costs or barriers to access for underserved populations.

Abstract

With the recent US Food and Drug Administration and European Medicines Agency approvals of gene therapy for sickle cell disease, exagamglogene autotemcel (exa-cel) (Casgevy, Vertex Pharmaceuticals and CRISPR Therapeutics), the transformational gene-editing technology CRISPR-Cas9 was officially converted into an approved therapeutic modality just 11 years after it was discovered.¹ This treatment, along with lovotibeglogene autotemcel (lovo-cel) (Lyfgenia, bluebird bio), a lentiviral vector therapy, offer new avenues for treating—and perhaps even offering functional cures for—sickle cell disease, a debilitating congenital disease that disproportionately affects Black patients and other patients facing health disparities.

Genotype prediction from RNA sequencing (RNA-seq) data has become widespread, but there is a lack of clarity in current policy and inconsistency in data handling. To address this we call for a framework consisting of registered access for RNA-seq data, controlled access for genotypes, a code of conduct and enhanced downstream protections.
