### <u>High Commissioner Türk: Education is the engine of the human rights system</u>

Statements and speeches 11 December 2025

Delivered by UN High Commissioner for Human Rights Volker Türk Video message to the UN Human Rights-Council of Europe Forum: "Unleashing Human Rights: A forum to further universal human rights education for, with and by young people"

Dear educators, young people, and human rights advocates,

...Today is **Human Rights Day, marking the 77**<sup>th</sup> **anniversary of the Universal Declaration of Human Rights** – a landmark in efforts to steer humanity on to a more peaceful, stable, and prosperous path.

The visionary authors of the Declaration went further than laying the foundations of the human rights system. They equipped it with an engine: human rights education. By embedding human rights education into the text, they ensured that each generation would power and renew this system. They recognized that education – not arms – is our most sustainable investment in peace and security.

As conflicts intensify, inequalities widen, and divisions deepen, we need to learn from history and remember what unites us: the fundamental principles of freedom and dignity for all. Today, when our collective progress is under strain, we need more human rights – not less.

Globally, millions of young people recognize this and are calling for change. Many feel a conflicting mix of responsibility for our shared future and a sense of powerlessness to influence it. Human rights education can give them the confidence and capacity to become agents of change – in their schools, workplaces, on social media.

**Human rights education is not an ideology; it is about building the consensus that every society needs to survive.** Every young person – whether a future economist, a factory worker, or an IT developer – needs to learn about their rights and how their decisions, how their work affect the rights of others.

Across all continents, my Office works with Governments, educational institutions, and youth organizations to develop human rights curricula, to amplify the voices of children and young people, and to promote our shared values of respect, equality, and solidarity. Understanding these values, which are at the heart of human rights, defines our ability to tackle today's challenges.

### Through human rights education,

- **we can inspire leaders** who govern through justice and accountability.
- we can nurture citizens who cherish differences and care for others.
- we can encourage business models that are grounded in respect for people and planet.
- and we can cultivate a digital space that supports meaningful connection and serves the public

good.

To the educators, young leaders, and activists in and beyond this room: thank you for advancing a brighter future for all. I wish you fruitful discussions.

### <u>UN experts call for safeguarding Special Procedures system as 'indispensable pillar' for human rights protection</u>

### **Special Procedures of the Human Rights Council**

The special procedures of the Human Rights Council are independent human rights experts with mandates to report and advise on human rights from a thematic or country-specific perspective. They are unpaid and their tenure is limited to a maximum of six years. As of November 2025, there are 46 thematic and 13 country mandates.

With the support of the Office of the United Nations High Commissioner for Human Rights (OHCHR), special procedures:

- :: Undertake country visits
- :: Act on individual cases of reported violations and concerns of a broader nature by sending <u>communications</u> to States and others
- :: Contribute to the development of international human rights standards, and
- :: Engage in advocacy, raise public awareness, and provide advice for technical cooperation.

GENEVA – Amid rising authoritarianism, deepening polarisation, growing intolerance, and mounting pressures on the multilateral system, Human Rights Day offers a vital moment to reaffirm our shared commitment to universal human rights, UN experts\* said today.

They issued a <u>joint statement</u> renewing their unwavering dedication to the Universal Declaration of Human Rights and emphasising the urgent need for a strong, independent, and properly resourced human rights system — one capable of safeguarding dignity, justice, and equality for all.

"Standing firmly by the promise of the Universal Declaration of Human Rights, even as the multilateral order and the global human rights ecosystem face an unprecedented and existential threat, we recommit to upholding our independence as a human rights mechanism and responding to the calls and expectations of victims, survivors and all those in need.

We will continue to call for the full implementation of human rights standards and provide dedicated technical advice, grounding our work in the principles of international human rights law. We endeavour to keep promoting positive change in people's lives by discharging our prevention and protection mandates. We will remain steadfast in our advocacy for stronger protection of human rights, the rule of law and democratic processes around the world. We will continue to proclaim inconvenient truths.

Over the decades, UN leaders have repeatedly affirmed the system's significance and power. In 2006, Secretary-General Kofi Annan hailed Special Procedures as the "crown jewel" of the international human rights system. His successor, Secretary-General Ban Ki-moon, described Special Procedures experts as the Council's indispensable "eyes and ears," essential for exposing violations and insisted that they must be allowed to work unhindered. Former High Commissioner for Human Rights Louise Arbour famously characterised Special Procedures as the UN's frontline human rights defenders — the system's early warning and protection mechanism in action.

This mechanism has grown into a dynamic system, with committed independent experts working pro bono on a vast range of thematic and country situations. Special Procedures mandate holders have carried out their duties with courage, impartiality and unwavering dedication — often at great personal cost — at a time when many human rights voices are being intimidated into silence. Their impact has reverberated despite severely limited capacity and resources.

As the United Nations and the Human Rights Council undergo critical moments of reform and reflection, we emphasise that these processes must create more, not fewer spaces for dialogue. Human rights protection is indispensable for peace, security and sustainable development.

We call on Member States to resist all attempts to dilute or sideline the Human Rights Council's Special Procedures system. States and all relevant actors must act now to protect and reinforce Special Procedures as an indispensable pillar through which human rights concerns are heard. As independent voices, we are able to defend all human rights, everywhere, even in the face of personal attacks, threats and sanctions.

On Human Rights Day, we pledge to victims across the world that we will remain your voices and your advocates – even when it seems that the world has turned away."

### Statement of ICC President Judge Tomoko Akane on the Occasion of Human Rights Day

Statement 10 December 2025

Today, the International Criminal Court (ICC) joins the international community in marking <u>Human Rights Day</u>, a moment to reflect on the universal commitment made in 1948 to uphold the dignity and equality of all people.

This year's theme, "<u>Human Rights, Our Everyday Essentials</u>," highlights the **fundamental truth that human rights are not theoretical concepts**. They are the conditions that allow individuals and societies to live in safety, to participate freely, and to pursue their aspirations. They are the foundations of peaceful and resilient communities.

At the ICC, we are reminded each day of the consequences when these essentials are denied. The crimes within the Court's jurisdiction — genocide, crimes against humanity, war crimes and the crimes of aggression — represent the gravest violations of human rights and the international rule of law. Through its judicial mandate, the Court seeks to uphold accountability for these crimes, and in doing so, to prevent future violations.

Human rights require a shared and sustained commitment. **States, institutions, and individuals all play a role in ensuring that these rights are respected in practice**. The work of the ICC is one part of this collective effort: to provide a forum where victims' voices can be heard and where the law is applied impartially and independently.

On this Human Rights Day, we reaffirm that justice and human rights are closely linked. A rules-based international order, grounded in accountability, remains essential for safeguarding the rights and security of present and future generations. Together, we must uphold the commitments that form the basis of our shared humanity.

Restoring institutional confidence in backsliding democracies: Evidence from Mexico Significance

The rise of democratic backsliders, leaders and ministers who win elections fairly but then undermine democratic institutions, is a major challenge to 21st-century democracies. Backsliding leaders criticize coequal branches of government and public agencies, perhaps reducing public confidence in democratic institutions. Is their rhetoric effective? And can it be rebutted?

We explore these questions in Mexico. A Mexican president's diatribes reduced institutional confidence. But rebuttals attributed to actors outside the partisan fray restored it. Supporters of the backsliding leader, whom we might have expected to be immune to rebuttals, were moved by these rebuttals to view the institution as more effective and honest. **Our research demonstrates that well-attributed rebuttals can counter backsliders' democracy-degrading rhetoric.** 

#### **Abstract**

**Declining confidence in public institutions afflicts many democracies,** a trend apparently exacerbated by backsliding leaders. These are leaders who gradually undermine the institutions that sustain democratic competition and accountability. Does the rhetoric of backsliders undermine the public's confidence in the institutions under attack and can rebuttals of presidential diatribes restore this confidence? We explore the impact of backsliding leaders' anti-institutional rhetoric in the context of Mexico. With text-as-data analyses, we demonstrate the harshness of President Andrés Manuel López Obrador's (2018–2024) anti-institutional diatribes against the agency that oversees national elections.

With survey experiments, we demonstrate that these diatribes can indeed undermine public confidence. Yet our research also uncovers the potential for rebuttals to restore confidence.

Counternarratives offered by organizations viewed as above the fray of Mexican politics restored public confidence—surprisingly, even among the president's supporters. Our findings suggest strategies for breaking out of the cage of intense partisanship and countering democracy-degrading rhetoric. Though presidential haranguing of democratic institutions can have a powerful effect, there remains room for public confidence to be restored by more positive accounts.

#### **Discussion and Conclusion**

...Stepping back, democratic erosion has taken place in a surprisingly large and diverse set of countries. Even when a leader who has undermined democratic institutions exits office, as the Mexican president did in late 2024, adverse effects of backsliding are not immediately undone. In the United States, persistent loss of confidence in election integrity among large segments of the electorate is a phenomenon that the country is likely to struggle with for years to come.

Our study says that it is not a waste of time to offer voters alternative viewpoints and corrective information. In line with recent work on democratic backsliding, we find that presidential discourse can indeed reduce public confidence in critical democratic institutions, in ways that facilitate the expansion of executive power (3, 5, 19). But we also find that public confidence may be rebuilt, even among those who are most under the sway of presidential rhetoric.

In practice, the kinds of rebuttals that succeed in counteracting presidential rhetoric may be hard to disseminate at scale. International, nonpartisan experts have a much smaller megaphone than the president; simply gaining the attention of voters is no easy task. Here, domestic experts with larger or more regular audiences could help. But, as our results show, this may undermine the rebuttal if they are perceived as partisan or biased. Reaching voters with such rebuttals requires sustained attention and thoughtful investment.

Improving access to high-quality scientific information can fill information voids that exist for topics of interest to people, reducing the likelihood of exposure to and uptake of misinformation about science. 
30,000 live animals seized in global operation against wildlife and forestry crime

134 participating countries make record seizures of protected plants, animals and timber World Customs Organization – WCO 11 December 2025

BRUSSELS, Belgium — A global operation against the illegal trafficking of wild fauna and flora has led to

the seizure of nearly 30,000 live animals and the identification of 1,100 suspects. From 15 September – 15 October, law enforcement agencies comprising Customs, police, border security and forestry and wildlife authorities from 134 countries made a total of 4,640 seizures during Operation Thunder 2025.

This record number of seizures included tens of thousands of protected animals and plants and tens of thousands of cubic metres of illegally logged timber, as well as more than 30 tonnes of species classified as endangered under the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES).



Coordinated by the World Customs Organization (WCO) and INTERPOL, the operation sought to intercept and seize illegally traded wildlife and forestry commodities across the global supply chain and identify, disrupt, investigate and dismantle criminal networks involved in these types of environmental crime...

INTERPOL Secretary General, Valdecy Urquiza, said: "Operation Thunder once again exposes the sophistication and scale of the criminal networks driving the illegal wildlife and forestry trade - networks that increasingly intersect with all crime areas, from drug trafficking to human exploitation. These syndicates target vulnerable species, undermine the rule of law and endanger communities worldwide. Recognizing these deeply interconnected crime threats, INTERPOL is committed to strengthening global policing responses, dismantling the entire ecosystem of illicit activity and protecting our planet's shared natural and human heritage."...

### <u>International Standards Proliferate, Reshaping Global Economy: Too Many Developing</u> <u>Countries Are Left Behind, Report Finds</u>

WASHINGTON, Dec. 11, 2025— A proliferating set of international standards—covering everything from food labeling to the specifications of 5G cellular networks—is steadily reshaping the global economic order, delivering hefty benefits to the wealthy nations and large multinational companies that set them while leaving many developing countries on the sidelines, according to a new World Bank report.

**Today, standards are foundational economic infrastructure, as vital to prosperity as roads or ports, according to the** <u>World Development Report 2025: Standards for Development</u>, which provides the first comprehensive analysis of the landscape of global standards. By making the transportation of goods seamless, the standardization of the shipping container boosted global trade to a greater extent than all of the trade agreements of the last 60 years, the report notes.

Since the turn of the century, however, standards have also become weapons in trade wars: non-tariff measures such pesticide specifications or labeling requirements, for example, now affect 90 percent of global trade, up from just 15% in the late 1990s.

"Standards are both central and unsung today," said Indermit Gill, Chief Economist of the World Bank Group and Senior Vice President for Development Economics. "When they're set right, they go unnoticed: the ship sails through the canal, the building withstands an earthquake, a kilogram weighs the same in Kenya as in Canada, and no one gives the gains that come a second thought. The standardized shipping container might well have catalyzed more trade in manufactured goods than all the trade deals put together. Digital standards could do the same for the services trade.

When countries are active in adapting, aligning, and authoring standards, they are a powerful tool for growth and poverty reduction. This report is the first assessment of the role of standards in economic development--and a call to developing nations to make them a core component of their development strategies."

"The World Bank's decision to dedicate the 2025 World Development Report to standards sends a powerful signal: international standards are no longer invisible infrastructure—they are critical enablers of sustainable, inclusive development," said Sergio Mujica, Secretary-General of the International Organization for Standardization (ISO), the world's largest standard-setting body, which surveyed 173 national standards bodies in support of the data-gathering work for the report. "Unlocking the full development potential of standards means ensuring all countries can participate in their creation and implement them. This report is a timely call to action to strengthen global participation and cooperation in standardization."

The global appetite for standards has surged. More than half of the 20,000 standards issued over the last seven decades by ISO have been created since 2000, the report notes. In 2024 alone, key global standard-setting bodies issued more than 7,000 standards. Not enough developing countries are at the table when standards are written—because they often lack the resources and expertise needed to participate. On average, they sit on less than one-third of the technical committees that determine global standards at ISO, and even fewer in other bodies. Supporting broader, more strategic participation is key to ensuring that standards are globally relevant and reflect diverse development needs and contexts.

Turning standards into a springboard for development requires a deliberate strategy. The report proposes an adapt-align-author framework for countries at different stages of development.

This Position Paper focuses on the key human rights risks of developing and using relevant AI systems

to counter terrorism. It addresses how the design, development and use of AI engages international human rights law, how human rights must inform decisions relating to the operation of AI systems, and the responsibilities of public authorities and private actors.

### 10 December 2025 | Seasonal influenza - Global situation

Situation at a glance

... Seasonal influenza activity has increased globally in recent months, with an increased proportion of seasonal influenza A(H3N2) viruses being detected. This rise coincides with the onset of winter in the northern hemisphere and an increase in acute respiratory infections caused by influenza and other respiratory viruses typically observed at this time of year. Although global activity remains within expected seasonal ranges, early increases and higher activity than typical at this time of year have been observed in some regions. Seasonal influenza viruses, including A(H3N2) viruses, continually evolve over time.

Since August 2025, there has been a rapid increase of A(H3N2) J.2.4.1 alias K subclade viruses detected from several countries based on available genetic sequence data. These subclade K viruses have several changes from related A(H3N2) viruses. Current epidemiological data do not indicate an increase in disease severity, although this subclade marks a notable evolution in influenza A(H3N2) viruses. Early estimates suggest that the influenza vaccine continues to provide protection against hospital attendance in both children and adults, even though its effectiveness against clinical disease during the current season remains uncertain.

Vaccines remain essential, especially for people at high risk of influenza complications and their care givers. Even if there are some genetic differences between the circulating influenza viruses and the strains included in the vaccines, the seasonal influenza vaccine may still provide protection against drifted viruses and the other virus strains included in the vaccine. Vaccination is still expected to protect against severe illness and remains one of the most effective public health measures. WHO continues to monitor global influenza activity and influenza viruses, supports countries in surveillance capacity and updates guidance as needed.

leadership February 23, 2025, by 5 p.m. EST.

### 30,000 live animals seized in global operation against wildlife and forestry crime

134 participating countries make record seizures of protected plants, animals and timber 11 December 2025

BRUSSELS, Belgium — A global operation against the illegal trafficking of wild fauna and flora has led to the seizure of nearly 30,000 live animals and the identification of 1,100 suspects.

From 15 September – 15 October, law enforcement agencies comprising Customs, police, border security and forestry and wildlife authorities from 134 countries made a total of 4,640 seizures during Operation Thunder 2025. This record number of seizures included tens of thousands of protected animals and plants and tens of thousands of cubic metres of illegally logged timber, as well as more than 30 tonnes of species classified as endangered under the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES).

Coordinated by the World Customs Organization (WCO) and INTERPOL, the operation sought to intercept and seize illegally traded wildlife and forestry commodities across the global supply chain and identify, disrupt, investigate and dismantle criminal networks involved in these types of environmental crime...

Across the globe, many governments are considering or have already introduced legislative bans on social media use for children under a certain age. As of 10 December 2025, Australia began enforcing a world-first social media ban restricting children under 16 from using platforms such as Instagram and TikTok. While the urgent and genuine concern to protect children from technology-facilitated child sexual abuse and exploitation often drives these proposals, these bans do not provide a perfect solution.

As an organisation committed to ending the sexual exploitation of children, ECPAT International supports efforts to improve children's safety in digital spaces. However, we are concerned that legislative bans risk misdiagnosing the problem, excluding children from critical connection and support spaces, and shifting responsibility away from the actors best placed to drive systemic change: governments and technology companies.

Instead of hastily implementing age-based bans as a one-size-fits-all solution, we urge policymakers to invest in rights-based and evidence-led solutions that address the complexity of the digital ecosystem...

This week's selection looks into a common thread across ongoing crises: **the systematic erosion of protection for displaced and conflict-affected populations.** 

In Gaza, a ceasefire "pause" masks ongoing atrocities, while testimonies highlight torture,

mass detention, and the mirrored grief shared with Sudanese civilians enduring parallel horrors. In Bangladesh, severe funding cuts leave Rohingya infants acutely malnourished, exposing the consequences of donor fatigue in protracted crises.

Sudanese movements across the Egypt border illustrate how **displacement routes have become treacherous survival corridors shaped by extortion, violence, and policy neglect.** India's new border regime with Myanmar further reveals how **securitisation overrides refugee rights in violation of international law.** Across Syria and other long-term displacement settings, refugees continue returning to destroyed homes amid land disputes and insecurity, underscoring the **gap between "voluntary return" narratives and lived realities.** 

Collectively, the pieces call for **reaffirming IHL obligations**, **prioritising personal safety**, **and ensuring states facilitate—not obstruct—life-saving humanitarian relief**.

Search for Life Should Be Top Science Priority for First Human Landing on Mars, Says New Report

WASHINGTON — A <u>new report</u> from the National Academies of Sciences, Engineering, and Medicine identifies the highest priority science objectives for the first human mission to Mars, and says searching for evidence of existing or past life on Mars should be the top priority. Improving our understanding of the effects of Mars' environment on humans, plants, and animals; water cycles; geologic records; and dust storms are also among the 11 science priorities named in the report.

The report presents four possible campaigns for human exploration of Mars, each encompassing a sequence of three missions linked to specific science objectives. For each campaign, the report describes which science objectives could be met, the likely roles of crew members, and the campaign's strengths and weaknesses for meeting scientific goals...

At some point along life's trajectory, growing becomes aging. Gerotherapeutics—biologically-based approaches to health that target processes of aging—seem poised to respond. This theme issue investigates ethical valences of what gerotherapeutics suggest about our socially, culturally, and historically entrenched patterns of pathologizing and medicalizing aging. Advancement in our understanding of physiological mechanisms of aging has prompted some to reconceive lifespans as health spans. Geroscience also suggests the need to critically evaluate whether and to what extent we should think of anti-aging ventures as legitimate enterprises of health care. Normative roles played by aging in our personal and relational narratives, in our expectations about how duration and quality of life

Through paleogenomics, the study of ancient DNA (aDNA), scientists have been able to construct chronologies of human evolution, detailing interactions between *Homo sapiens*, other species, and past environments. Paleogenomics differs from modern genomics in that aDNA is typically extracted from skeletal remains and other finite organic sources, often destroying irreplaceable samples. Once destroyed, recovery of additional endogenous aDNA is not possible, and re-analysis is limited to the reprocessing of raw data sequence.

# Collaborative science in genomics: The value of data sharing and thoughtful stewardship

Large-scale data sharing is indispensable for advancing human genetics and genomics (HGG) research and medicine. The willingness of study participants and researchers to share data has been the foundation of rapid advancements of the HGG field for decades. If the potential benefits of HGG research are to be fully realized, maintaining a broad data-sharing ethos and policy environment is vital. ASHG reasserts the HGG community's commitment to responsible data stewardship and emphasizes the role of researchers in working alongside other interested parties to create a secure research enterprise without imposing undue restrictions on researchers' ability to collaborate, share data, and advance knowledge while also protecting the will and privacy of participants.

International humanitarian law (IHL) represents a balancing of priorities that have often been seen

as being in tension: military necessity, on the one hand, and considerations of humanity, on the other.

Inherent in this balancing act is the idea that military necessity and humanitarian imperatives are equally valid priorities that can be accommodated under the same legal framework to achieve related goals, allowing the military to fight effectively while avoiding needless suffering and destruction.

Accordingly, the negotiation of IHL treaties involves diplomats, representatives of the humanitarian community, and the armed forces working together to find common ground. By working together, the armed forces and the humanitarian community have crafted a body of law that effectively balances oft- competing priorities and optimizes military necessity and humanitarian considerations. While many analyze military decision-making from outside the ranks of States' armed forces, ultimately, the ones applying IHL during real-life battlefield situations are the decision-makers inside these structures. Yet, for various reasons, they express themselves less publicly on matters of IHL in academic journals, including the Review. With the articles selected for this issue, the Review has created a space to put the spotlight on States' armed forces so as to hear from them— and about them first-hand, from a contemporary perspective. Through this, the Review sincerely hopes that military lawyers and operators will more often find their way to our journal's pages in the future, so as to share their experiences with its readers around the world on topics of interest to both the humanitarian and military communities.

**Informed Consent: We Can Do Better to Defend Privacy**

We need to rethink our approach to defend privacy on the internet. Currently, policymakers focus heavily on the idea of informed consent as a means to defend privacy. For instance, in many countries the law requires firms to obtain an individual's consent before they use data about her; with such informed consent requirements, the law aims to empower people to make privacy choices in their best interests. But behavioural studies cast doubt on this approach's effectiveness, as people tend to click OK to almost any request they see on their screens. To improve privacy protection, this article argues for a combined approach of protecting and empowering the individual. This article discusses practical problems with informed consent as a means to protect privacy, and illustrates the problems with current data privacy rules regarding behavioural targeting. First, the privacy problems of behavioural targeting, and the central role of informed consent in privacy law are discussed. Following that, practical problems with informed consent are highlighted. Then, the article argues that policymakers should give more attention to rules that protect, rather than empower, people.

Systematic reviews require time and resources to conduct that might not be available in a rapidly developing context such as during new and (re-) emerging infectious disease outbreaks. As part of the Pandemic-PACT program at the Pandemic Sciences Institute at the University of Oxford we have, in collaboration with Cochrane Response and Cochrane South Africa, developed a "living" Rapid Research Needs Appraisal (RRNA) methodology. The aim is to develop a protocol for rapidly and robustly identify key evidence gaps across pre-defined research domains to inform research prioritisation and coordination in preparedness time and during outbreaks. The RRNA utilises modified systematic review

methods, a global relay of reviewers, and systematic review software. The objective is to strengthen capability for carrying out RRNAs, and establish a baseline evidence platform for priority infectious diseases that can be readily updated as new evidence emerges, utilising an adaptable "living" RRNA protocol. This data will be of relevance to funders, researchers, clinical and public health stakeholders involved in management of infectious diseases of epidemic and pandemic potential.

# WMA - Declaration of Taipei Revision Launched [Ongoing]

The World Medical Association (WMA) invites you to attend its first Open Expert Meeting on the Revision of the WMA Declaration of Taipei (DoT), which will take place 4-6 December 2025, in Taipei, Taiwan.

...The <u>Declaration of Taipei</u> tries to achieve a balance between the rights of individuals giving their tissue or data for research and other purposes based on confidentiality and privacy rules while at the same time recognising that health data has become a very powerful tool for increasing knowledge.

In analysing the scenarios that already exist for the use (and misuse) of health data and biobanks, we came to the conclusion that the major risk scenarios may not result from science, but from the commercial, administrative or political use of such data. Limiting our guidelines to research only would have left us blind to the imminent risk of abuse from outside the field of medicine: commercialization, cost-cutting and potential political abuse.

Therefore, in contrast to the Declaration of Helsinki, this policy aims to address any use of health databases and biobanks excluding individual treatment and is not restricted to research. As physicians are the primary custodians of confidential health information, they feel an obligation towards their patients and other persons who entrust them with their data and specimens...

In April 2025, the WMA appointed a workgroup to initiate the revision process of this document. To encourage as much global participation in the revision process as possible, the WMA is collaborating with its members to host a series of regional meetings...
