## **Trafficking**

### **125,000 Trafficking Victims Worldwide, 30,000 Children: IOM Chief Calls for Global Action**

Marrakesh/Geneva, 12 February 2026 – The International Organization for Migration (IOM) urged governments at the **Sixth Global Conference on the Elimination of Child Labour in Marrakesh to place migration and trafficking in persons at the centre of efforts to end child labour**, calling for stronger data, research, and cross-border cooperation to better protect children on the move.

According to the latest available IOM data, **more than 125,000 victims of trafficking have been officially identified worldwide, although the true number is believed to be significantly higher** due to widespread underreporting and gaps in detection. Of those identified, close to 30,000 are children – meaning nearly 1 in 4 detected victims globally is a child.

“Millions of children on the move face heightened risks of exploitation and trafficking, yet they remain too often invisible in global policies and protection systems” said IOM Director General Amy Pope in her video message. “We must act now – across borders and across sectors – to close these alarming protection gaps and ensure that every child, everywhere, is safe.”...

During the event, **IOM underscored the importance of stronger data and research to identify risks, inform prevention efforts, and guide targeted responses.**

Recent evidence, including **a joint IOM–Harvard study analyzing two decades of child trafficking data, highlights the complex links between child labour, migration, and trafficking in persons**. The findings point to the need for closer alignment between child protection, migration, and anti-trafficking systems, as well as more coordinated action among policymakers, researchers, and practitioners.

IOM reaffirmed its commitment to working with governments, UN partners, civil society, and youth networks to ensure that efforts to eliminate child labour include children on the move and are guided by stronger evidence, including in the lead-up to the International Migration Review Forum...

**IOM additionally presented WakaWell, a youth-designed platform that supports young people across Africa in making safe and informed migration decisions.** IOM’s participation in the conference was supported through the Cooperation on Migration and Partnerships to Achieve Sustainable Solutions (COMPASS) programme, a multi-year, multi-region initiative that strengthens migration governance systems while upholding the rights of migrants.

## Parliamentarians: Intimidation, Harassment

### New IPU report: Lawmakers increasingly intimidated by the public

IPU Inter-Parliamentary Union 11/02/2026

The Inter-Parliamentary Union (IPU) released today a new global report which reveals that members of parliament (MPs) are facing a worrying rise in intimidation and harassment from the public.

*When the public turns hostile: Political violence against parliamentarians* draws on a **broad survey of 519 MPs globally** and case studies focused on five countries: Argentina, Benin, Italy, Malaysia and the Netherlands, to reflect diverse political and regional contexts.

#### **Main findings**

- **Overall, 71% of all respondents, both globally and in the five countries, reported having experienced violence from the public, whether online, offline or both.**
- Violence is heavily concentrated online, with between 65% and 77% of MPs in the five countries reporting online abuse.
- The most common forms of public intimidation overall reported by MPs are insults and degrading language, the spread of false or misleading information, and threats.
- **Most respondents believe that the situation is deteriorating.** In Argentina and the Netherlands, 8 out of 10 MPs reported an increase in violence over the past five years.
- **Online violence is frequently triggered by elections, high-profile legislative debates or polarizing political or cultural issues.**
- Women are more affected than men: 76% of women MPs across the case studies reported exposure to violence, compared to 68% of men.
- Women are disproportionately affected by gendered and sexualized forms of violence, especially online.
- MPs who belong to minority or disadvantaged groups – including racial minorities, people with disabilities and LGBTQIA+ communities – face even greater exposure to online violence...

#### **...Impact on democracy**

The IPU warns that intimidation of MPs by the public can have serious consequences for democracy.

**With the increase in hostility, many MPs report self-censorship, avoid some public appearances, experience negative side effects for their family members, and sometimes quit or decline to run again in elections.** According to the report, over time, this can corrode democratic representation, discourage diversity and weaken parliaments as democratic institutions.

The report calls on political and parliamentary leadership to set boundaries when it comes to acceptable public discourse and to ensure that intimidation does not succeed in silencing dissenting and minority voices.

## Corruption Perceptions Index

### CPI 2025: Findings and insights

Transparency International 10 February 2026

*Summary*

**:: The Corruption Perceptions Index (CPI) 2025 ranks 182 countries and territories:** the global average dropped to 42, and **122 countries score below 50, signalling widespread public sector corruption.**

:: Only five countries now score above 80 (down from 12 a decade ago), and recent slippage in high-scoring democracies shows corruption risks can rise even where institutions once looked secure.

:: **Countries that curb civic space often lose control of corruption:** 36 of the 50 biggest CPI decliners restricted freedoms, and over 90 per cent of journalists murdered for investigating corruption were in low-scoring countries.

:: Transparency International calls on leaders to strengthen independent justice and oversight, make political finance transparent, protect media freedom and clamp down on cross-border flows of dirty money.

**The global order is under strain from rivalry between major powers, and dangerous disregard for international norms.** Armed conflicts and the climate crisis are having a deadly impact. Societies are also becoming more polarised. To meet these challenges, the world needs principled leaders and strong, independent institutions that act with integrity to protect the public interest. Yet, too often, we are seeing a failure of good governance and accountable leadership.

**In many places, leaders point to security, economic or geopolitical issues as reasons to centralise power, sideline checks and balances and roll back commitments to internationally agreed standards** – including anti-corruption measures. Too often, they treat transparency, independent scrutiny and accountability to the public as optional.

Transparency International's 2025 Corruption Perceptions Index (CPI) measures perceived levels of public-sector corruption in 182 countries and territories, drawing on 13 independent data sources and using a scale from 0 (highly corrupt) to 100 (very clean). **This year, the global CPI average has dropped for the first time in more than a decade to just 42 out of 100.** The vast majority of countries are failing to keep corruption under control: 122 out of 182 score under 50 in the index.

At the same time, **the number of countries scoring above 80 has shrunk from 12 a decade ago to just five this year.** In particular, there is a **worrying trend of democracies seeing worsening perceived corruption** – from the United States (64), Canada (75) and New Zealand (81), to various parts of Europe, like the United Kingdom (70), France (66) and Sweden (80).

**Our research shows that corruption is not inevitable.** Countries with long-term improvements in CPI scores have largely seen sustained effort from political leaders and regulators to implement broad legal and institutional reforms. **Persistently low or declining CPI scores usually go hand in hand with limited or eroding democratic checks and balances, the politicisation of justice systems, undue influence over political processes, and a failure to safeguard civic space.**

It is not a surprise that countries with full democracies tend to score highly on the CPI, while non-democratic regimes largely perform the worst...

### **[Statement by the Gates Foundation](#)**

The Gates Foundation is aware of emails recently released by the U.S. Department of Justice that include communication between Jeffrey Epstein and Gates Foundation staff. We will continue to review materials released in connection with this matter.

On the basis of Epstein's claims that he could mobilize significant philanthropic resources for global health and development, a small number of foundation employees interacted with Epstein to try to

secure this potential funding. Ultimately, the foundation did not pursue any collaboration with Epstein and no fund was ever created. At no time were financial payments made by the foundation to Epstein, nor was he employed by the foundation at any time.

The harm Epstein inflicted on women and girls was horrific, and no one should ever have to experience what they did. The safety and wellbeing of women and girls is core to the foundation's mission of helping every person live a healthy and productive life, which we remain fully committed to. The foundation regrets having any employees interact with Epstein in any way.

## Science – “Trustworthiness”

#### [A framework for assessing the trustworthiness of scientific research findings](#)

##### *Abstract*

Vigorous debate has erupted over the trustworthiness of scientific research findings in a number of domains. The question “what makes research findings trustworthy?” elicits different answers depending on whether the emphasis is on research integrity and ethics, research methods, transparency, inclusion, assessment and peer review, or scholarly communication. Each provides partial insight. We offer a systems approach that focuses on whether the research is accountable, evaluable, well-formulated, has been evaluated, controls for bias, reduces error, and whether the claims are warranted by the evidence. We tie each of these components to measurable indicators of trustworthiness for evaluating the research itself, the researchers conducting the research, and the organizations supporting the research. Our goals are to offer a framework that can be applied across methods, approaches, and disciplines and to foster innovation in development of trustworthiness indicators. Developing valid indicators will improve the conduct and assessment of research and, ultimately, public understanding and trust.

##### *[Excerpt]*

#### **The Trustworthiness Framework for Assessing Research Findings**

We derived the *Trustworthiness Framework for Assessing Research Findings* framework from the literature on scientific rigor and validity, reproducibility and replicability, public indicators of scientific trustworthiness, and how trustworthiness can fail.

**There are seven distinct components that contribute to trustworthiness of research findings including whether the research is accountable, is evaluable, has been evaluated, is well formulated, controls bias, reduces error, and whether the claims are warranted by the evidence.** Those components are relevant at three levels that contribute to trustworthiness: the research itself, researchers conducting and evaluating the research, and organizations—including institutions, funders, and journals—facilitating and supporting the research. A visual representation of the framework is presented as [SI Appendix, Table S1](#). To ensure broad applicability across scientific domains, the framework has the following features:

- **Systems level perspective:** Establishing trustworthiness of research findings is not exclusively a function of the findings themselves, but is also a function of the actions by researchers to produce them, and the context and support systems in place at research supporting organizations. For example, the extent to which research findings have been evaluated depends upon factors such as peer review of research outputs, participation by the researcher in scholarly and public discourse about their program of research, and adherence to rigorous research assessment practices by

organizations.

- **Behavioral:** The trustworthiness of findings is earned primarily through actions in designing investigations, producing credible evidence, making sensible claims from that evidence, transparently sharing the research for examination by others, and providing oversight and support of that work. The framework focuses on behaviors and actions that are direct indicators of trustworthiness and not proxy indicators such as reputation. For example, accountability is advanced when researchers properly credit contributors and disclose conflicts and funders, when Institutional Review Boards (IRBs) and other oversight bodies exercise due diligence, and when universities reward trustworthy research.
- **Measurable:** The framework prioritizes indicators that can, in principle, be measured to assess research trustworthiness. Some indicators are readily measurable (e.g., sample size, statistical power, and reliability). For others, innovation in measurement is needed, such as offering indicators of the extent to which research is well calibrated, with claims that are warranted by the evidence.
- **Inclusive:** The framework prioritizes components and indicators that have broad applicability across a range of scientific research activities, including both quantitative and qualitative research. For example, Lincoln and Guba's criteria for trustworthiness of qualitative research can be mapped to the framework's components: evaluated for dependability and confirmability, well-formulated for transferability, and well-calibrated, controlling bias, and reducing error for credibility ([1](#)). Lincoln and Guba articulate more concretely how those components are operationalized in qualitative work ([1](#)).
- **Improvable:** The examples of indicators are not exhaustive. The framework is designed to stimulate further research and improvements in the components, levels of analysis, and indicators assessing trustworthiness.

This Trustworthiness Framework for Assessing Research Findings integrates trustworthiness perspectives across domains that include: research integrity and ethics, research methods, research transparency and openness, research inclusivity, research assessment and peer review, and research communication...

### ***...Conclusion***

The broader literature on trust in science emphasizes multiple criteria that readers and consumers of research bring to their evaluation of research, researchers, and research organizations ([75](#), [98–101](#)). Engaging in research practices that increase the trustworthiness of research findings are preconditions for earning trust. Here, we introduce a systems perspective that focuses on whether the research is accountable, evaluable, well- formulated, has been evaluated, controls for bias, reduces error, and whether the claims are warranted by the evidence. In the process, we focus on the task of developing and improving indicators of trustworthiness.

Trustworthy research practices are the component of earning trust that researchers can control. By adhering to practices that promote the trustworthiness of research findings, researchers contribute to a cumulative body of knowledge that can be relied upon by other researchers, policymakers, practitioners, and the public. In a world of misinformation, ideological campaigns, and motivated reasoning, producing trustworthy research findings may not be sufficient on its own to earn trust, but it is a necessary feature of an enterprise that is relentlessly truth-seeking.

**"Defend Western Civilization"**

### **Secretary of State Calls on European Leaders to Defend Western Civilization in Munich Security Conference Speech**

February 14, 2026

*Key excerpts from Secretary Rubio's speech can be found below:*

#### **It is time to unshackle our ingenuity and build a new Western century.**

"Together we can reindustrialize our economies and rebuild our capacity to defend our people. But the work of this new alliance should not be focused just on military cooperation and reclaiming the industries of the past. It should also be focused on, together, advancing our mutual interests and new frontiers, unshackling our ingenuity, our creativity, and the dynamic spirit to build a new Western century. Commercial space travel and cutting-edge artificial intelligence; industrial automation and flex manufacturing; creating a Western supply chain for critical minerals not vulnerable to extortion from other powers; and a unified effort to compete for market share in the economies of the Global South.

"Together we can not only take back control of our own industries and supply chains – we can prosper in the areas that will define the 21st century."

#### **Armies do not fight for abstractions. They fight for a people, a nation, and a way of life. That is what we are defending.**

"National security, which this conference is largely about, is not merely a series of technical questions—how much we spend on defense or where and how we deploy it. These are important questions, but they are not the fundamental one. The fundamental question we must answer at the outset is: what exactly are we defending?

"Because armies do not fight for abstractions. Armies fight for a people; armies fight for a nation. Armies fight for a way of life. **And that is what we are defending: a great civilization that has every reason to be proud of its history**, confident of its future, and aims to always be the master of its own economic and political destiny."

#### **We are all part of one civilization: Western civilization.**

"We are part of one civilization – Western civilization. We are bound to one another by the deepest bonds that nations could share, forged by centuries of shared history, **Christian faith, culture, heritage, language, ancestry, and the sacrifices our forefathers made together for the common civilization to which we have fallen heir.**"

#### **Mass migration is not some fringe concern of little consequence.**

"Mass migration is not, was not, isn't some fringe concern of little consequence. It was and continues to be a crisis which is transforming and destabilizing societies all across the West."

#### **Under President Trump, America will once again take on the task of renewal and restoration. It is our hope to do this together with our friends in Europe.**

"Under President Trump, the United States of America will once again take on the task of renewal and restoration, driven by a vision of a future as proud, as sovereign, and as vital as our civilization's past. And while we are prepared, if necessary, to do this alone, it is our preference and it is our hope to do this together with you, our friends here in Europe."

#### **Our predecessors recognized that decline was a choice, and it was a choice they refused to make.**

"But together, our predecessors recognized that decline was a choice, and it was a choice they refused to make. This is what we did together once before, and this is what President Trump and the United States want to do again now, together with you."

**We in America have no interest in being polite and orderly caretakers of the West's managed decline.**

"For we in America have no interest in being polite and orderly caretakers of the West's managed decline. We do not seek to separate, but to revitalize an old friendship and renew the greatest civilization in human history.

"What we want is a reinvigorated alliance that recognizes that what has ailed our societies is not just a set of bad policies but a malaise of hopelessness and complacency. An alliance – the alliance that we want is one that is not paralyzed into inaction by fear – fear of climate change, fear of war, fear of technology. Instead, we want an alliance that boldly races into the future."

**We do not want allies shackled by guilt and shame. We want allies who are proud of their culture and heritage and are willing to help us defend it.**

"We want allies who can defend themselves so that no adversary will ever be tempted to test our collective strength. This is why we do not want our allies to be shackled by guilt and shame. **We want allies who are proud of their culture and of their heritage, who understand that we are heirs to the same great and noble civilization,** and who, together with us, are willing and able to defend it. And this is why we do not want allies to rationalize the broken status quo rather than reckon with what is necessary to fix it."

**The only fear we have is the fear of the shame of not leaving our nation prouder, stronger, and wealthier for our children and an alliance ready to defend our people and safeguard our freedom to shape our own destiny.**

"The only fear we have is the fear of the shame of not leaving our nations prouder, stronger, and wealthier for our children. An alliance ready to defend our people, to safeguard our interests, and to preserve the freedom of action that allows us to shape our own destiny – not one that exists to operate a global welfare state and atone for the purported sins of past generations. An alliance that does not allow its power to be outsourced, constrained, or subordinated to systems beyond its control; one that does not depend on others for the critical necessities of its national life; and one that does not maintain the polite pretense that our way of life is just one among many and that asks for permission before it acts."

**I am reminded by my own story that both the history and fate of the United States and Europe will always be linked together.**

"The year that my country was founded, Lorenzo and Catalina Geroldi lived in Casale Monferrato in the Kingdom of Piedmont-Sardinia. And Jose and Manuela Reina lived in Sevilla, Spain. I don't know what, if anything, they knew about the 13 colonies which had gained their independence from the British empire, but here's what I am certain of: They could have never imagined that 250 years later, one of their direct descendants would be back here today on this continent as the chief diplomat of that infant nation. And yet here I am, reminded by my own story that both our histories and our fates will always be linked. Together we rebuilt a shattered continent in the wake of two devastating world wars. When we found ourselves divided once again by the Iron Curtain, the free West linked arms with the courageous dissidents struggling against tyranny in the East to defeat Soviet communism. We have fought against each other, then reconciled, then fought, then reconciled again. And we have bled and died side by side on battlefields from Kapyong to Kandahar."

**America is charting the path for a new century of prosperity and we want to do it with Europe. Yesterday is over. The future is inevitable. Our destiny awaits together.**

"I am here today to leave it clear that America is charting the path for a new century of prosperity, and that once again we want to do it together with you, our cherished allies and our oldest friends. We want to do it together with you, with a Europe that is proud of its heritage and of its history; **with a Europe that has the spirit of creation of liberty that sent ships out into uncharted seas and**



**birthed our civilization;** with a Europe that has the means to defend itself and the will to survive. We should be proud of what we achieved together in the last century, but now we must confront and embrace the opportunities of a new one – because yesterday is over, the future is inevitable, and our destiny together awaits.”

**The ideas and success of our shared past foreshadow the wonders that await us in our future, but only if we are unapologetic in our heritage and proud of this common inheritance.**

**“It was here in Europe where the ideas that planted the seeds of liberty that changed the world were born. It was here in Europe where the world – which gave the world the rule of law, the universities, and the scientific revolution.** It was this continent that produced the genius of Mozart and Beethoven, of Dante and Shakespeare, of Michelangelo and Da Vinci, of the Beatles and the Rolling Stones. And this is the place where the vaulted ceilings of the Sistine Chapel and the towering spires of the great cathedral in Cologne, they testify not just to the greatness of our past or to a faith in God that inspired these marvels. They foreshadow the wonders that await us in our future. But only if we are unapologetic in our heritage and proud of this common inheritance can we together begin the work of envisioning and shaping our economic and our political future.”

“In a perfect world, all of these problems and more would be solved by diplomats and strongly worded resolutions. But we do not live in a perfect world, and **we cannot continue to allow those who blatantly and openly threaten our citizens and endanger our global stability to shield themselves behind abstractions of international law which they themselves routinely violate.** This is the path that President Trump and the United States has embarked upon. It is the path we ask you here in Europe to join us on.”

“The United Nations still has tremendous potential to be a tool for good in the world. But we cannot ignore that today, on the most pressing matters before us, it has no answers and has played virtually no role. **It could not solve the war in Gaza.** Instead, it was American leadership that freed captives from barbarians and brought about a fragile truce. **It had not solved the war in Ukraine.** It took American leadership and partnership with many of the countries here today just to bring the two sides to the table in search of a still-elusive peace. It was powerless to constrain the nuclear program of radical Shia clerics in Tehran. That required 14 bombs dropped with precision from American B-2 bombers. **And it was unable to address the threat to our security from a narcoterrorist dictator in Venezuela.** Instead, it took American Special Forces to bring this fugitive to justice.”

**Controlling who and how many people enter our countries is not an expression of hate or xenophobia. It is a fundamental act of national sovereignty.**

“Controlling who and how many people enter our countries, this is not an expression of xenophobia. It is not hate. It is a fundamental act of national sovereignty. And the failure to do so is not just an abdication of one of our most basic duties owed to our people. **It is an urgent threat to the fabric of our societies and the survival of our civilization itself.”**

**Our destiny is and will always be intertwined with Europe. This is why President Trump demands seriousness and reciprocity from them.**

“And so, this is why we Americans may sometimes come off as a little direct and urgent in our counsel. This is why President Trump demands seriousness and reciprocity from our friends here in Europe. The reason why, my friends, is because we care deeply. We care deeply about your future and

ours. And if at times we disagree, our disagreements come from our profound sense of concern about a Europe with which we are connected – not just economically, not just militarily. We are connected spiritually and we are connected culturally.

“We want Europe to be strong. We believe that Europe must survive, because the two great wars of the last century serve for us as history’s constant reminder that ultimately, our destiny is and will always be intertwined with yours, because we know that the fate of Europe will never be irrelevant to our own.”

#### **Security Council Speakers Welcome Ceasefire Agreement in Syria, Call for Inclusive Political Transition with Full Participation for Women, Kurdish Minority**

Welcoming a comprehensive agreement reached between the Syrian Government and the Syrian Democratic Forces two weeks ago, UN experts and Council members encouraged that country to stay on the path of inclusive political transition, with full participation for women and the Kurdish minority.

This week's selection traces how **humanitarian protection is becoming increasingly conditional**. In Gaza and the West Bank, **violations of international law continue despite the language of ceasefire, with healthcare systems devastated and Palestinian communities steadily encircled by illegal settlers**. For the international community, **security concerns trump children's rights**. In Syria, states still leave **thousands of children unlawfully detained** in the notorious camps Al-Hol and Al-Roj.

In Tanzania, plans to accelerate the return of Burundian refugees raise serious **questions about voluntariness and non-refoulement**—and also about the role of UNHCR, in an era described as “the end of asylum”: **If protection is not upheld when politically inconvenient, what is UNHCR's role in this contested world?**

The strain extends to Saudi Arabia, where **Rohingya remain in legal limbo**. Meanwhile, **shrinking aid for women and girls, limits on diversity and inclusion priorities, and the marginalisation of trans refugee sex workers** show that protection is narrowing not only in conflict zones, but in policy itself.

Pharmacoepidemiology aims to appraise and understand the use and effects — both beneficial and adverse — of medicines in real-world settings. As such it can be considered a bridge science, linking clinical pharmacology, epidemiology, public health and the social sciences.

Medicines are public health tools. With regard to the quality and transparency of the assessment of their effectiveness and safety, they are increasingly subject to the expectations and requirements of patients, healthcare professionals and regulators. Those involved in the development and delivery of medicines must therefore take full account of the aforementioned paradigm shifts. Additionally, the arrival of novel therapeutic agents, such as gene therapy, biologics and mRNA vaccines, whose modes of action and interactions with living organisms have very little in common with those of the more traditional chemical medicines, has brought into question the classic elements of pharmacovigilance and pharmacoepidemiology, such as the dose–effect relationship, drug causation criteria and the determination of drug exposure.

International humanitarian law (IHL) represents a balancing of priorities that have often been seen as being in tension: military necessity, on the one hand, and considerations of humanity, on the other.

Inherent in this balancing act is the idea that military necessity and humanitarian imperatives are equally valid priorities that can be accommodated under the same legal framework to achieve related goals, allowing the military to fight effectively while avoiding needless suffering and

destruction.

Accordingly, the negotiation of IHL treaties involves diplomats, representatives of the humanitarian community, and the armed forces working together to find common ground. By working together, the armed forces and the humanitarian community have crafted a body of law that effectively balances oft-competing priorities and optimizes military necessity and humanitarian considerations. While many analyze military decision-making from outside the ranks of States' armed forces, ultimately, the ones applying IHL during real-life battlefield situations are the decision-makers inside these structures. Yet, for various reasons, they express themselves less publicly on matters of IHL in academic journals, including the Review. With the articles selected for this issue, the Review has created a space to put the spotlight on States' armed forces so as to hear from them— and about them first-hand, from a contemporary perspective. Through this, the Review sincerely hopes that military lawyers and operators will more often find their way to our journal's pages in the future, so as to share their experiences with its readers around the world on topics of interest to both the humanitarian and military communities.

*Abstract*

Vigorous debate has erupted over the trustworthiness of scientific research findings in a number of domains. The question “what makes research findings trustworthy?” elicits different answers depending on whether the emphasis is on research integrity and ethics, research methods, transparency, inclusion, assessment and peer review, or scholarly communication. Each provides partial insight. We offer a systems approach that focuses on whether the research is accountable, evaluable, well-formulated, has been evaluated, controls for bias, reduces error, and whether the claims are warranted by the evidence. We tie each of these components to measurable indicators of trustworthiness for evaluating the research itself, the researchers conducting the research, and the organizations supporting the research. Our goals

are to offer a framework that can be applied across methods, approaches, and disciplines and to foster innovation in development of trustworthiness indicators. Developing valid indicators will improve the conduct and assessment of research and, ultimately, public understanding and trust.

### **Artificial intelligence is creating a new global linguistic hierarchy**

Artificial intelligence (AI) has the potential to transform healthcare, education, governance and socioeconomic equity, but its benefits remain concentrated in a small number of languages (Bender, 2019; Blasi et al., 2022; Joshi et al., 2020; Ranathunga and de Silva, 2022; Young, 2015). Language AI - the technologies that underpin widely-used conversational systems such as ChatGPT - could provide major benefits if available in people's native languages, yet most of the world's 7,000+ linguistic communities currently lack access and face persistent digital marginalization. Here we present a global longitudinal analysis of social, economic and infrastructural conditions across languages to assess systemic inequalities in language AI. We first analyze the existence of AI resources for 6003 languages. We find that despite efforts of the community to broaden the reach of language technologies (Bapna et al., 2022; Costa-Jussà et al., 2022), the dominance of a handful of languages is exacerbating disparities on an unprecedented scale, with divides widening exponentially rather than narrowing. Further, we contrast the longitudinal diffusion of AI with that of earlier IT technologies, revealing a distinctive hype-driven pattern of spread. To translate our findings into practical insights and guide prioritization efforts, we introduce the Language AI Readiness Index (EQUATE), which maps the state of technological, socio-economic, and infrastructural prerequisites for AI deployment across languages. The index highlights communities where capacity exists but remains underutilized, and provides a framework for accelerating more equitable diffusion of language AI. Our work contributes to setting the baseline for a transition towards more sustainable and equitable language technologies.

The World Medical Association (WMA) invites you to attend its first Open Expert Meeting on the Revision of the WMA Declaration of Taipei (DoT), which will take place 4-6 December 2025, in Taipei, Taiwan.

...The Declaration of Taipei tries to achieve a balance between the rights of individuals giving their tissue or data for research and other purposes based on confidentiality and privacy rules while at the same time recognising that health data has become a very powerful tool for increasing knowledge.

In analysing the scenarios that already exist for the use (and misuse) of health data and biobanks, we came to the conclusion that the major risk scenarios may not result from science, but from the commercial, administrative or political use of such data. Limiting our guidelines to research only would have left us blind to the imminent risk of abuse from outside the field of medicine: commercialization, cost-cutting and potential political abuse.

Therefore, in contrast to the Declaration of Helsinki, this policy aims to address any use of health databases and biobanks excluding individual treatment and is not restricted to research. As physicians are the primary custodians of confidential health information, they feel an obligation towards their patients and other persons who entrust them with their data and specimens...
